## Reducing fire risk involves community as well as sheriff and fire

Dozens come to hear message

"Homeless is not a crime. This is not a war on homelessness," repeated Riverside County Sheriff's Lt. Zach Hall. He, with deputies from the Sheriff's Department's Homeless Outreach Team, fire officials from all the local agencies and law enforcement for several federal and state agencies, were in Idyllwild to discuss the fire threat posed from homeless camping near town.

More than 50 residents, filling the conference room, attended the Monday morning meeting at the Idyllwild Fire Station. Hall said, during and after the session, "In my 20 years, I've attended many community meetings, mostly in areas larger than Idyllwild. This community wants to be involved. This is one of the largest turnouts I've seen."

Hall emphasized that homelessness is not a crime, but homeless behavior and community actions may increase the risk of wildfire. "Using fire in close to the community poses a real risk to safety," Hall underscored.

The meeting was an endeavor to share ideas and initiate conversations between the community and public officials to find actions and ideas that would reduce the fire risk.

The community's behavior is critical to ul-

timately reducing the fire threat. "The homeless know this is a nice place to come and live off the land," Hall informed the group. "You guys feed and house them. There are only four or five months a year when it is not hospitable, and then they come back."

The homeless use campfires to cook or

to keep warm. However, the risk to the community is real. U.S. Forest Service Battalion Chief Matt Ahearn shared that in the past two weeks, 13 to 14 fires have started in these mountains and "almost all are human-caused."

## Above-average risk of fire persists for Hill

It's early July. Outside, it's dry and hot — fire season in Southern California. Despite the noticeable absence of rain, recent fire outlooks and assessments do not raise catastrophic alarms.

Do not be mistaken. Southern California is in the midst of an above-normal risk of fire, according to the National Interagency Fire Center's Predictive Services group.

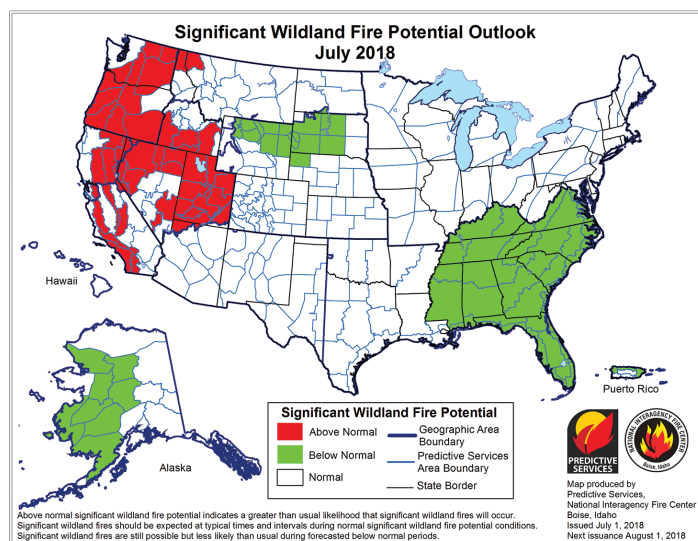
In its July 1 "Fire Potential Outlook," the authors wrote, "Above normal significant wildland fire potential is expected along the coast and foothills across Southern California and the hills and mountains surrounding the central valley in July."

Locally, the Southern California Geographic Area Coordination Center in Riverside, an interagency fire support group, wrote, "The driest fuels, in general, are located in Southern California south and east of Los Angeles County. Fuels in these areas have been close to record dry levels at times this spring which is more of a reflection of the dry winter than the moderate conditions of spring," according to its July outlook.

However, these authors did note that live fuel moisture is higher than normal for June and July. They expect it to drop to normal summer levels in August.

Most of the fire outlooks have expressed more concern for the Sierra Foothills because of the number

## Consolidation, fuelbreaks and Stage 2 water emergency discussed at Pine Cove property meeting

Consolidation of the Hill's three water districts — Fern Valley, Idyllwild and Pine Cove

— was discussed briefly at the July Pine Cove Property Owners Association meeting.

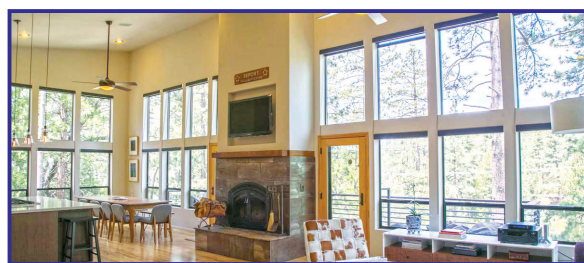
"Consolidation reared its ugly head again," said PCWD General Manager Jerry Holld-

ber. "In Pine Cove, we've worked very hard to have supplies and control our own destiny. There's not enough water to supply Idyllwild, but we can support Pine Cove."

Holldber was sharing his comments with Pine Cove residents in response to the Idyllwild Water District establishing a committee to explore

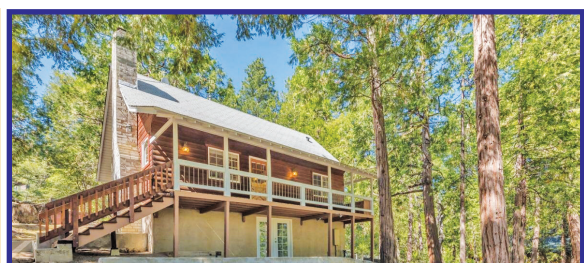

# Residents build momentum in effort to bring quiet skies back to Idyllwild

Concerned about increased commercial air traffic over the Hill, and wanting to preserve peace and tranquility in the San Jacinto Mountains, several residents have formed a coalition to fight the “Southern California Metroplex — NextGen” — the Federal Aviation Administration’s new procedures for airport arrivals and departures in Southern California.

Their organization — Quiet Skies Idyllwild — was formed in June to reverse the system and to bring quiet skies back to Idyllwild. The group has documented “an increasing number of flights over the Hill since August a year ago.”

But FAA documents indicate the [NextGen] changes “would make the airspace safer and more efficient ... and were not expected to require any ground disturbance or increase in the number of air-

craft operations.” The agency’s environmental assessment concluded the system would have “no significant impacts or reportable noise increases.”

QSI members disagree with those assessments and appear to be gaining traction in bringing attention to the issue. Membership has grown beyond the initial members — Bill Sheppard, Helle Pearson and David Pearson, Ph.D.

Pearson said, “During Idyllwild’s Fourth of July parade, we collected more than 140 signatures for our petition [to Congressman Raul Ruiz, M.D.]. Our on-line petition already has 40 signatures as of 8 p.m. Saturday.”

The group already had gotten the federal lawmaker’s attention. Ruiz called the matter “urgent” in a June 21 letter to the FAA regarding “recent changes to flight patterns over Southern California as a result of the Southern California Metroplex.”

He requested answers

from FAA regarding how “NextGen” was evaluated and how it led to a finding of no significant impact. He asked what other measures, besides altitude, were used. Was topography considered in relation to acoustical impacts? What efforts were used to engage and get feedback from the community, and what comments were received? Were noise impacts on national parks or other protected areas evaluated?

The congressman said he wants those answers by the end of July. “I am concerned that these changes are negatively affecting my constituents due to vastly increased noise pollution over the San Jacinto Mountain region, particularly the Idyllwild community.”

QSI also has conducted research to quantify the impact of “NextGen” on Hill communities. Flightradar24.com data were compiled for five days: the first Tuesdays in August and November 2017, and in February and May 2018, and

for Saturday, June 23, 2018. The number of flights over the Hill, their altitudes, paths and more were analyzed. Military planes and helicopters were excluded.

Pearson told The Town Crier, “The data show there are between 106 and 222

flights a day over the Hill. Approximately 90 percent of the flights have consistently been east-bound LAX departures ... directly over Idyllwild–Pine Cove headed from Hemet towards an FAA waypoint (GPS beacon) between Indio

and Joshua Tree.

“We know there is a lot of variation in the daily traffic with the lowest number being 106 in June. The number for May was the highest, recorded [at 222 flights], but we have not yet been able to see that.”

the districts’ consolidation, or possibly just more cooperation.

IWD took this action in response to customers’ reaction to its rate increase. Many argued that savings, for all three districts, would lower rates and possibly might have avoided the need to raise them this year.

Currently, each district has a general manager, office staff and field staff. The proponents believe that one larger district with two fewer managers, fewer office staff and buying supplies in bulk would generate savings for all water customers on the Hill.

Holldber said this has been studied more than a decade ago and is a myth. Also, the study found PCWD had the lowest costs of the three local jurisdictions.

“It is not in our best interest, especially for customers in Pine Cove, to consolidate. It is not our responsibility to take care of them,” he said.

Then he noted that several years ago, PCWD surveyed its customers’ views of consolidation. “Sixty percent responded and 87 percent of them opposed it. That’s pretty overwhelming.”

He promised to continue to work and cooperate with Fern Valley and Idyllwild, “But here, we’ll just worry about Pine Cove,” he urged.

Speaking after and in agreement with Holldber, Pine Cove resident Jeff Smith urged the PCPOA board to vote on a formal position against any consolidation. No action was taken during the meeting. Later, Marlene Pierce, PCPOA president, said the board has not yet decided if it will vote on a resolution.

Smith did raise the fear that funds from PCWD’s

telecommunication leases at Rocky Point would be siphoned off for Fern Valley and Idyllwild if the districts were to consolidate.

Closing the discussion of the subject, Pierce commented, “Idyllwild business interests are hot to get our water. They want our water for their own reasons.” She subsequently submitted a letter to editor of the Town Crier reflecting Holldber’s comments.

More work is planned on the fuelbreaks around the Pine Cove community later this summer, according to Holldber, who is also chair of the Community Service Area 38 Advisory Committee. He described the recent purchases for Riverside County Fire Station 23 that CSA 38 funds have provided, including CPR equipment that can perform automatic pulsing.

He complimented the work that the Riverside County Fire Department and the U.S. Forest Service have done to maintain the current system.

But Holldber stressed that CSA 38 has about \$300,000 available and he recommends that some be used to enhance and expand the fuelbreak system surrounding the community, even if it is necessary to hire private contractors to do the clearing.

“It doesn’t do any good or reduce fire threats leaving the money in the bank,” he stated.

He also discussed the water district’s current Stage 2 water emergency condition. Holldber emphasized that the district’s water supply is safe and more than adequate.

“We’re fine. All the wells are pumping,” he told the group. “We have a very adequate supply of water for the people of Pine Cove. I just want customers to think about it when using water. You don’t have to stop, just use wisely and efficiently.”

## Pine Cove Property Owners share with community

The Idyllwild Soroptimists will use its \$500 for the Women’s Cabinet this year.

The gifts to the Help Center and the Scholarship Fund are also intended to aid needy Pine Cove residents, Pierce added.

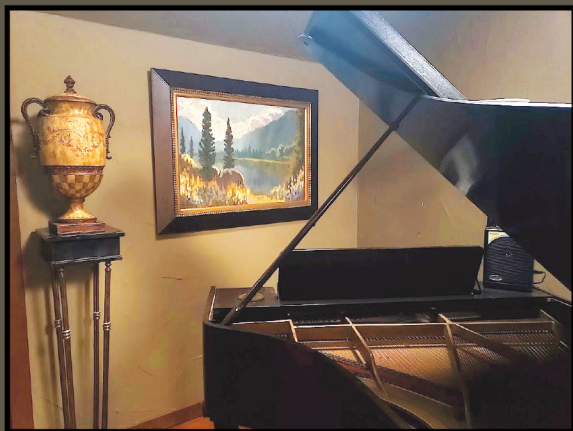

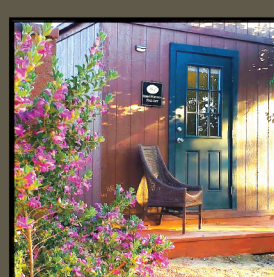
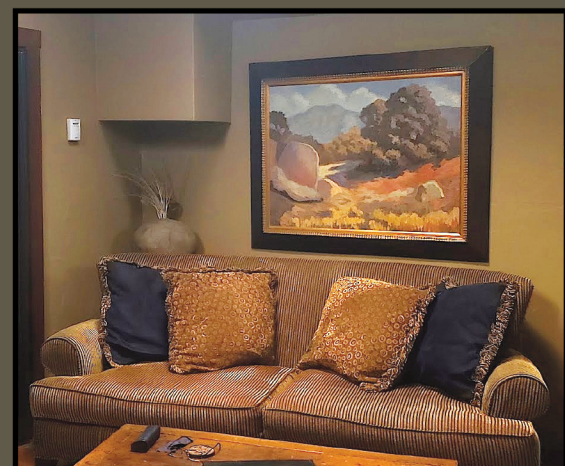

## An ambulance fee racket?

EDITOR:

Aren't firefighters paid to serve and protect? I appreciate their work in keeping fires from our town.

However, I don't appreciate what seems to be a racket, pressuring people into an ambulance ride when it isn't called for.

A couple of months ago, I called in a carbon-monoxide leak. I took my dog outside immediately learning of the leak via my alarm. I felt fine.

They sent up five trucks, and about seven or eight firefighters. That seemed a waste of time and money. After hooking me up with several tabs to check my blood pressure and pulse, I was fine — BP slightly elevated, no doubt due to the number of men in and out of my house, hovering over me on my small porch.

They wanted to take me to the hospital. I said no and said I felt fine. I did. They pushed the idea several more times then allowed me to sign a waiver. Glad to do it. The waiver protects them from any lawsuit, so that's not the reason they push for an ambulance ride. They do it for money. It's disgusting.

A few days ago, I took a friend to the fire station who had fallen, and hurt her wrist and ankle. She felt little to no pain. The swelling was not serious. I knew nothing was broken. So did they after checking her and discovering she felt no pain when she moved her joints freely.

They used scare tactics to get her to agree to an ambulance ride. I told one of them it would undoubtedly be more swollen and certainly painful to move if either were broken. He had a pat response and told me I was mistaken. It was clear he was full of crap and knew exactly what he was promoting and why. She took the ambulance ride to the emergency room. Nothing was broken.

I've heard countless stories like these. Who is responsible for this fire department? This racket has got to stop.

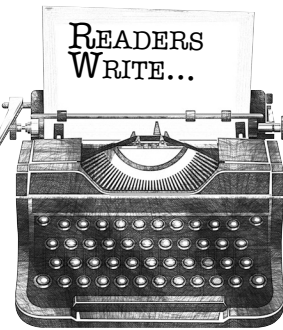
Pushing for an ambulance ride when it isn't necessary, for financial gain, isn't ethical. This needs to be investigated further. I think heads should roll. This is

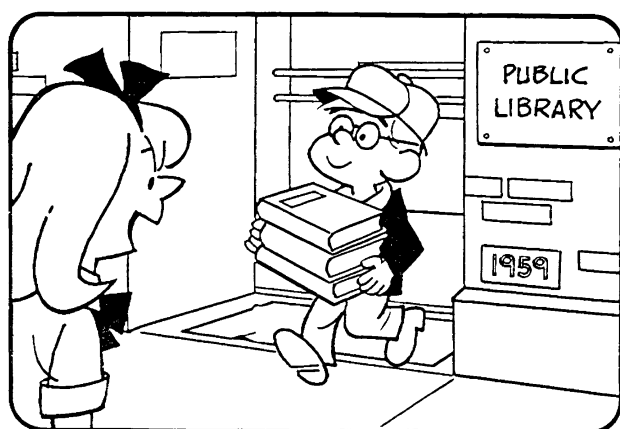

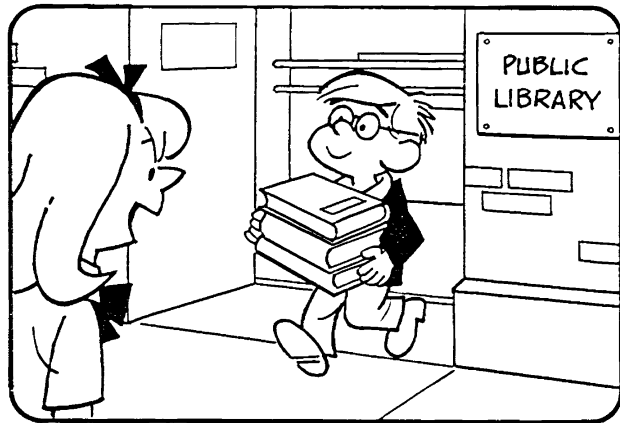

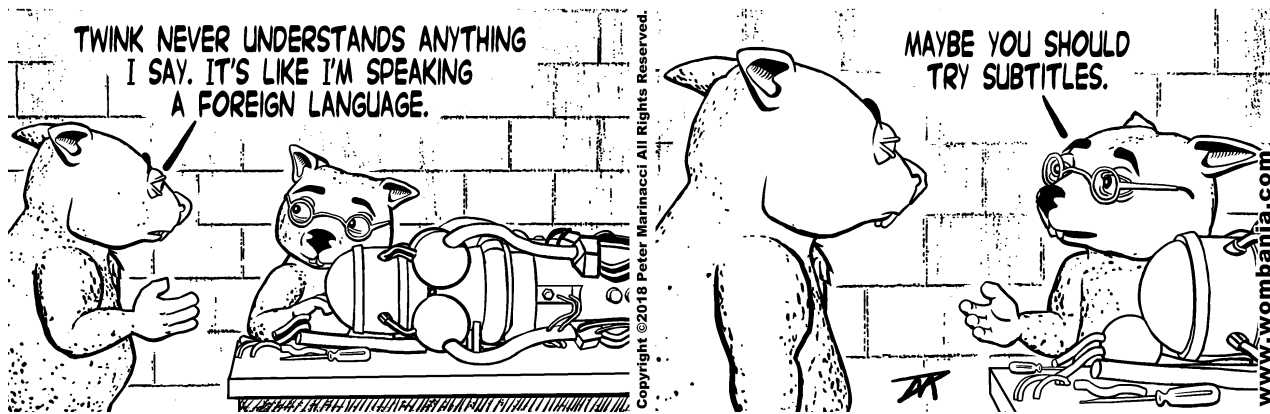

A personal recollection of the Mountain Fire near its fifth anniversary

*Editor's note: July 2018 marks the fifth anniversary of the Mountain Fire that caused Idyllwild and Fern Valley residents to evacuate. This is the personal account of one evacuee, Fern Valley resident and then-Town Crier Staff Reporter Marshall Smith.*

One can never feel safe when wild-fire threatens. That is one of the lessons I learned when the Mountain Fire broke out around 1:43 p.m. Monday, July 15, 2013. The fire spread rapidly, taking out a number of homes adjoining Apple Canyon Road near Hurkey Creek Park that first day and night.

Needing to go to a business appointment in Los Angeles on Tuesday, I packed important items — family photos, important records and cherished mementos — and put them in the trunk of my car. At that point, the fire was projected to burn toward the desert and not threaten Idyllwild.

Monitoring the fire all the while through TC dispatches and local media, I returned Tuesday evening, feeling somewhat safer because the fire threat appeared to have lessened. That relief was short-lived.

Wednesday morning, July 17, I started hearing chatter over my Mountain Disaster Preparedness radio about possible evacuation of Fern Valley. That puzzled me because in the past, as far as I knew, wildfires had not come in over the ridges from the north or northeast to threaten Fern Valley. I called a buddy who was on Riverside Mountain Rescue Unit to see if he had heard anything. He told me the Sheriff's Department was mobilizing to notify Fern Valley residents to evacuate immediately.

I then found out that the fire had taken a sharp turn to the left and was moving directly toward Tahquitz Rock and Fern Valley.

I walked out my front door to check for smoke or any evidence of approaching fire. I saw huge clouds of smoke billowing directly behind Tahquitz. My house was on Fern Valley Road almost directly beneath Tahquitz. As I watched, the smoke began rising more rapidly, towering hundreds of feet into the air.

I quickly grabbed clothes and my two rescue dogs, Molly, my blind Boston terrier, and Grace, my easily rattled and somewhat nervous rat terrier-mix. I was one of the first out of town, as I had heard about the evacuation on my MDP radio before receiving the order from the Sheriff's Department.

As I drove toward Pine Cove on Highway 243, I pulled over and looked back to see Tahquitz disappearing behind a growing wall of smoke. At that moment, having never evacuated be-

fore (I came to the Hill after the Bee Canyon Fire evacuation), I realized I might never see my home again.

As I drove, I had no idea where I was going to go. On the way, I called my sister who lived in Calabasas and told her about the evacuation order. Although she had not been keen about allowing me to bring my dogs to visit since her house was not set up for dogs, she encouraged me to come there with my anxious menagerie.

I arrived mid-afternoon on the 17th. She and my brother-in-law were gracious as they always are, and Molly, Grace and I settled into a small room on the first floor with its own entrance to the outside yard. Although Molly was fine, Grace was a nervous wreck, having never stayed anywhere but my Fern Valley home since I rescued her in 2011. Anytime I was out of the room, Grace would howl. It was difficult to reassure her given my own nervousness. My family was more than understanding.

Then began my constant Internet monitoring of the fire's development and trajectory for the next four days. Each day, the threat to Fern Valley seemed to grow.

On Friday, the U.S. Forest Service Incident Commander noted that the fire, were it to breach and crest the ridge in Fern Valley, would be difficult to stop a march into town. Forest Service spokespersons also worried about approaching thunderstorms that could bring lightning with potential for more spot fires.

That Friday was my worst day. Up to that point, more than 3,500 fire personnel had performed heroically in creating fire breaks to safeguard the town, including staging the Ernie Maxwell Trail as the last area of defense should the fire crest the ridge. The news continued to worsen. As the fire's thrust spread closer to the ridge bordering Fern Valley, I, as others

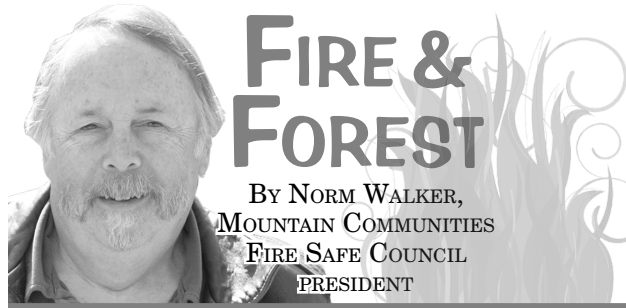
may have done, said a quiet and loving goodbye to my home.

Then, as many of us subsequently called it, the Idyllwild Miracle occurred. Tropical rains arrived on Saturday morning drenching the area with over 1-and-a-half inches of rain on Saturday and Sunday. The rain, and the dedication of firefighters, stopped the imminent advance of the fire. It did not crest the ridge. Although there was much to be done to tamp down hot spots and make certain new fire ignition did not occur, for the most part, the fire no longer threatened the town.

Residents, with proof of their residency, were permitted to come back on Sunday, July 21. After clearing the Forest Service checkpoint at Cranstons Station, I drove up Highway 74. Leaving Mountain Center on Highway 243, I passed the area where the fire started and those to which it had quickly spread. I saw a stark and sobering moonscape of desolation, and a reminder of firefighter bravery and skill in saving homes on 243, among them Dore Capitani's Art Garden.

I wondered how firefighters could protect structures during such an intense conflagration. I also began to cry. The tears came without warning. I was sad for those who had lost their homes. And I was feeling profoundly grateful at coming back and a little bewildered at what had occurred — how, at the very last minute, the town, my home and the homes of many friends had been spared by the arduous and dangerous work of brave men and women, and the saving grace of a torrential downpour of rain at a critical moment.

The next day, residents in town began greeting each other with "Welcome home." As I joined in those greetings, I felt, more than I had ever felt anywhere before, that I was welcome and that I was home.



VOLUNTEERS AND GRANTS ALLOW FSC TO KEEP COMMUNITY SAFE ...

For the past year (and every year since 2002), the Mountain Communities Fire Safe Council has been working hard to help members of our community with their fire abatement, and provide education for new residents and weekenders.

We also sponsor an all-volunteer group, the Woodies, who provide firewood for those who can't afford it and light abatement work for those who can't afford it.

As I have said before in this column, we depend on grants from the U.S. Forest Service, Cal Fire and Riverside County, donations from our community, and membership dues to pay contractors, who do the heavy lifting, so to speak, on a 65/35 percent basis for homeowners. We also use the funds for our biannual newsletter and other educational materials that are free to the public.

This year, we hope to produce a fire-safety trifold for new homeowners that our realtors can hand out and a single-page flier that our property-management businesses can utilize, such as, when dealing specifically with the handling of ashes from wood stoves and fireplaces.

From March 2017 to March 2018, 127 properties were abated on the Hill, and 95 standing dead and dying trees that posed a fire and safety hazard were removed through the efforts of the MCFSC.

The Woodies group donated 1,100 hours of labor to the community during that period. This included eight properties abated and 85 cords of wood processed for the Idyllwild Help Center to distribute.

MCFSC uses the value of this work as a match for federal grants. The total value of the wood and work hours was greater than \$51,000.

We appreciate everyone who supports the Fire Safe Council and the Woodies.

Remember, when you are vigilant about keeping your property fire safe, you are helping yourself and your neighbors. It generally takes more work to live here compared to city life, but the rewards are sure worth it.

# Idyllwild Water notifies customers of contaminations

‘Not an emergency’

General Manager Jack Hoagland of the Idyllwild Water District issued a press release to the Town Crier on Monday, July 9, indicating that this week it is mailing its customers an “Official Notice” advising that “the District has exceeded the maximum contaminate limit (MCL) for both total trihalomethanes (TTHM) of 80 parts per billion and haloacetic acids (HAA) 60 parts

per billion. The results, received June 15, 2018, showed one of the District’s sample points had a running average of 87 parts per billion TTHM and 64 parts per billion HAA.”

The notice went on to explain that “this is not an emergency” nor “an immediate risk,” and that customers do not need to use bottled water or another water supply. “However, some people who drink water containing trihalomethanes in excess of the MCL over many years may experience liver, kidney, or central nervous system problems, and may

have an increased risk of getting cancer. Some people who drink water containing haloacetic acids in excess of the MCL over many years have an increased risk of getting cancer.”

The notice further advises that “[i]f you have other health issues concerning the consumption of this water, you may wish to consult your doctor.”

According to the press release issued by Hoagland, “The potential health impact of TTHM and HAA is a result of long-term exposure. The analysis criteria is con-

suming 2 liters (about ½ gallon) of water a day for 70 years increases risk by a factor of one in a million. The analysis is not meant to minimize the impact of the exceedance or to suggest that this will not be an issue that now moves to the top of the priority list for the District, but to put into context the relative immediate risk, which is small.”

Hoagland explained that IWD adds chlorine, which is widely used throughout the country as a disinfectant, to the district’s well water. But the chlorine also reacts with natural organic ma-

terial from leaves, plants and soil to form low levels of TTHM and HAA. He stated that the persistent drought and “water supply conditions” caused an increase in the natural organic material, which then resulted in increased levels of TTHM and HAA in the drinking water served “to part of our service area.” IWD Director Dave Hunt indicated to the TC that lower Pine Crest was the area most affected.

Hoagland indicated that the district is consulting engineering professionals to evaluate potential changes to the system that would reduce the

TTHM and HAA levels. Changes may include the construction of a filtration system at the impacted wells to remove some of the natural organic material from the water.

“We anticipate resolving the problem within 6 to 12 months depending on the type of solution implemented. In the meantime we are minimizing the use of the impacted wells and relying more on wells that form lower levels of TTHM and HAA.”

# Gov. Brown signed new budget

No water tax and more funds for rainy day

On June 27, three days before fiscal year 2018-19 began, Gov. Jerry Brown signed the budget bill — his last budget.

He expressed a lot of pride on how California’s financial condition has improved in the past seven years. In particular, the state now has a Rainy Day Fund exceeding \$13 billion.

When he assumed the governorship in January 2011, California was deeply in debt and annual budgets were consistently running deficits.

“When I took office back in 2011 with the state facing a \$27 billion deficit, I pledged to work with the Legislature to fix California’s financial mess,” said Brown. “Today, the final budget I sign delivers on that pledge and prepares us for the fu-

ture.” The total state budget, including special funds and bonds money, exceeds \$200 billion, of which nearly \$140 billion comes from the General Fund.

Besides the Rainy Day Fund, the new budget provides another \$500 million for emergency block grants for homeless programs and projects. In total, funding for affordable housing and homelessness is nearly \$5 billion.

The new budget expands funding for public education in local school systems, and the state’s college and university systems,

Construction and maintenance of the state facilities such as courts, universities, flood control and others was funded at more than \$330 million. And the new gas tax and vehicle fees will provide \$4.6 billion for transportation projects such as roads and state highways.

The “water tax” proposed last August in Senate Bill 623 to fund projects in areas with contaminated water and low re-

sources was not included in the budget agreement. The Assembly and governor, however, did agree to appropriate \$23.5 million “for allocation to safe drinking water actions later in this legislative session.”

The budget agreement includes funds for Cal Fire to draft plans to remodel the Perris Emergency Command Center and to replace the Prado Helitack Base in San Bernardino County.

There also is \$30 million to fund 79 positions for six year-round fire crews to initiate and complete fuel-reduction projects. The goal is to treat 60,000 acres annually.

Another \$100 million was approved to replace Cal Fire’s helicopters. This will be the first year of a multi-year effort.

The budget package also includes \$134 million for counties to modernize aging voting equipment and \$3 million to create the Office of Elections Cybersecurity and the Office of Enterprise Risk Management, according to California Secretary of State Alex Padilla. These funds will support counties’ efforts to upgrade or replace

voting equipment, including purchasing ballot-on-demand technology, electronic poll books, and open-source voting systems, and strengthen security of the voting process.

And the Legislature and governor funded cannabis-related state activities with \$133 million.

“The budget passed by the legislature today [June 14] has much to offer, but falls far short of being the best it could be for the hard-working people of California,” said State Sen. Jeff Stone (R-District 28) in a press release after the Senate vote on the fiscal year 2018-19 budget.

“The budget is about our state’s priorities, and this budget reflects many positive priorities including increasing our Rainy Day Fund to nearly \$14 billion, a prudent savings since we know an economic downturn is inevitable,” Stone continued. “This is certainly not the worst budget I could have imagined...”

# Virulent Newcastle disease detected in Riverside County

Last month, Riverside County agricultural officials warned residents to protect their animals from virulent Newcastle disease.

Last week, they announced that a confirmed case of virulent Newcastle disease was found in northwest Riverside County on June 30. The disease affects birds, and can cause serious illness or death in an entire chicken flock in a single day.

The Riverside County location is close to other occurrences of the disease in southwest San Bernardino County. At this time, the single location is the only known incidence in Riverside County. All locations, including in Riverside County, involve backyard exhibition chickens.

“This disease is so virulent it could significantly affect the poultry indus-

try nationwide if it reaches commercial flocks,” said Riverside County Agricultural Commissioner Ruben Arroyo. “We are taking extra precautions to reduce the risk of tracking disease on and off farms by limiting farm visits to those that are essential to health and safety.”

Virulent Newcastle disease can cause serious illness or death to an entire flock of chickens within a single day. Riverside County officials urge backyard chicken owners to protect their birds and prevent the spread of the disease by taking the following precautions, known as biosecurity measures:

- Do not move chickens from your home until the situation is resolved.
- Restrict traffic onto and off of your property.
- Disinfect shoes, clothes, hands, egg

trays or flats, crates, vehicles and tires.

- Avoid visits to other poultry farms or bird owners. If you visit, be sure to change clothes, and clean your hands and shoes before entering your own bird area.
- Wash hands and scrub boots before and after entering a poultry area.
- Isolate any birds returning from shows for 30 days before placing them with the rest of the flock.

If your chickens die suddenly or show signs of illness, call California’s Sick Bird Hotline at 866-922-BIRD (2473). Symptoms of the disease include sneezing, gasping for air, nasal discharge, coughing, greenish diarrhea, reduced activity, tremors, drooping wings, twisting of the head and neck, circling, complete stiffness, and swelling around the eyes and

neck.

No human cases of Newcastle disease have ever occurred from eating poultry products, which are safe to eat if thoroughly cooked. In rare instances, people working directly with sick birds can become infected. Symptoms usually are mild and limited to conjunctivitis. People can prevent infection by wearing protective equipment, such as gloves, goggles, face masks, boots and disposable coveralls.

Oh! The tribulations of maintaining weight loss.

According to Harvard Medical School ([www.health.harvard.edu/](http://www.health.harvard.edu/)), “Eventually everyone’s weight loss slows down and levels off. This isn’t because your weight-loss plan isn’t working. Rather, it’s because your body has adapted by reducing your metabolism to support the decreased energy needs of your newer, smaller body size...”

Harvard Medical School also tells us that “...exercise is not the most effective approach for losing weight in the first place...” Yet, it’s very important in keeping weight off, and, of course, is essential in overall wellness.

One way exercise helps keep weight off is by increasing that slowed metabolism. To keep our metabolic furnaces burning, the American College of Sports Medicine recommends aiming for more than 250 minutes of moderate aerobic activity each week, plus two strength training sessions at least 48 hours apart.

Do the math and divide that 250 minutes up into manageable chunks of time. And recall that even

10-minute sessions can provide benefits if undertaken regularly and repetitively.

By the way, note that key phrase, “moderate aerobic activity.” As we’ve discussed many times in this column, walking is one of the best ways to achieve this goal.

For some of us, the rarefied atmosphere of Idyllwild offers us some extra challenges. Meeting these challenges should definitely be discussed with your healthcare provider.

Rather than maintaining healthy weight long-term by counting calories, which many of us hate doing and which gets old fast, use the new skills you’ve learned to support weight loss in the first place. Eat healthful, nutritious foods that fill you up. Check out a low-glycemic eating plan, not only for folk with diabetes. According to Harvard’s “8 principles of low-glycemic eating” ([www.health.harvard.edu/healthbeat/8-principles-of-low-glycemic-eating](http://www.health.harvard.edu/healthbeat/8-principles-of-low-glycemic-eating)), “A low-glycemic diet can help you control your weight by minimizing spikes in your blood sugar and insulin levels ... Low-glycemic diets have also been linked to reduced risks for cancer, heart disease, and other conditions.”

Plus, hunger is satisfied for longer periods of time with nutritious, often low-calorie, low-glycemic foods. We want to avoid getting so hungry that we go rampaging off on a binge.

Change the ecology of your kitchen; rid it of foods with “empty calories,” foods that are calorie dense but offer little nutritional value. If it’s not within easy reach, you’re less likely to binge on it. Fill that void in the cupboard and fridge with foods you like but meet the criteria of being nutritious and not high-calorie.

Continue that new habit of slowing the pace of eating each meal, mindfully enjoying the texture and taste of each bite. Medical science tells us that it takes about 20 minutes for our brains to register that we are full or satisfied. Imagine how many calories we can get down our gullets in 20 minutes of fast eating. (Don’t try this at home, by the way.)

extract the data for most other dates.”

Pearson added, “We’ll be doing more data analysis in the coming weeks ... to identify statistically relevant trends.”

In his letter to the FAA, Ruiz said, “... residents of Idyllwild have reported a significant increase in aircraft noise over their homes beginning daily as early as 5 a.m. and continuing as late as 1 a.m. For individuals in Idyllwild and other nearby communities, this has a number of detrimental effects ...”

A member of the House Committee on Energy and Commerce and its Subcommittees on the Environment, and Communications and Technology, Ruiz cited flights over the Hill occurring during early morning April 20.

“My office received reports of loud aircraft noise over Idyllwild at 5:04 a.m. Working with an FAA representative, it was determined there were four commercial flights in the area at the time (military flights were ruled out).

“The lowest altitude flight was a B763 flying at approximately 13,300 feet flying at Average Ground Level (AGL). The noise was enough to wake my constituent. Similar noise continued throughout the day.

“It is my understanding that ... flights are often over 13,000 feet above ground level (AGL) with a mean sea level (MSL) of 19,500 feet, which in theory should create a negligible amount of ground level noise.

“I am concerned that while this may hold true in open, flat regions, the mountainous topography in areas such as Idyllwild leads to increased amplification of aircraft noise.

“As a physician, I cannot emphasize strongly enough the importance of sleep to a person’s overall health. Lack of a consistent sleep can result in reduced energy, changes in mood, and compromised immune system function, and can also make one more prone to serious medical conditions such as obesity, heart disease, high blood pressure and diabetes.”

Pearson found that, “Planes flying over us (usually 15,000 to 30,000 feet) leave a 60- to 90-second noise reverberation signature. On a busy day, this can be every 2 to 4 minutes or more than 220 flights a day ...”

Sheppard, a Fern Valley resident and audio engineer said, “We’ve heard from visitors, backpackers and fire spotters at the lookout towers,” which stand at elevations of 4,573 feet to almost 9,000 feet overlooking Idyllwild.

“They sleep in tents and they are hearing planes go over all night long. They’re saying it’s as ‘noisy as hell.’

“Some residents may not be aware of the noise,” Sheppard added. “The topography in our area affects residents differently — what they hear — depending upon where they live. The mountain ridges surrounding our communities form a natural bowl in which sounds reverberate, particularly jet engine noise from over-flights. The frequencies ... the sound waves themselves are being caught in this bowl and then resonating.”

Many QSI members have lived under airport flight paths in L.A. or San Diego counties. Others, like Sheppard, are “musicians sensitive to the nuance and little inuendos in sound,” or they have lived on the Hill for years and can “see and hear the increase in air traffic.”

Sheppard told The Town Crier he was “pleasantly surprised when Dr. Ruiz’s office got back to us immediately and got to work on the issue. I thought that was great, and I am really pleased with what they’ve done so far — and their sending the letter with pointed questions to the FAA.”

In addition to research and data analysis, QSI members have scheduled time to talk with Riverside County 3rd District Supervisor Chuck Washington and made presentations to local community groups.

## Sunday fire in Humber Park quickly controlled

Early Sunday morning, July 8, U.S. Forest Service volunteers on their way to man Tahquitz Peak Lookout Tower discovered a fire off Devil Slide's Trail in Humber Park, according to Fire Chief Freddie Espinoza, for the Forest Service's San Jacinto Ranger District.

The volunteers reported it. First on the scene was Riverside Coun-

ty Fire Department Engine 23 from Pine Cove.

"Capt. Katherine Garver did a good job," Espinoza said. Forest Service Engine 56 and Water Tender 56 arrived quickly. Other units included RCFD Engine 53, Water Tender 53, Brush 19, Engine 4677, as well as Forest Service patrols 52 and 55.

He estimated the fire was contained to about 0.1 acre. It was reported about 5:30 a.m. and within an hour it was contained, according to

Garver. Three hours later, it was controlled and the trail opened to hikers.

Firefighters had to lay hose 1,000 feet into the forest and pump water from the water tenders to extinguish the fire, which was several hundred feet from the trail.

As of Monday morning, the cause of the fire was still under investigation, according to the district's fire investigator.

of dead and dying trees. They report some areas with tree mortality exceeding 50 percent.

"Parts of California and the Sierras [have] really dry fuels, particularly grass and brush fuels. We're also starting to see an increase in drying conditions across the mountains and foothills and some of the central valleys of Cal-

ifornia," said Ed Delgado, the national program manager for predictive services at the National Interagency Fire Center in Boise, Idaho.

And the drought conditions are returning, according to the National Weather Service.

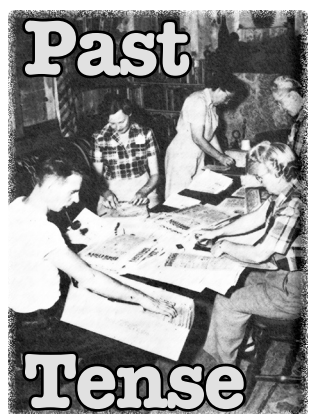
Alex Tardy, meteorologist at the NWS San Diego office, describing the winter rainfall, said, "Most areas were below 40 percent of normal [precipitation] includ-

ing all of Southern California." He added that San Diego experienced the second driest winter ever. And for Orange County, it was the driest ever.

Tardy also noted that drought conditions were worsening.

All of the reports are forecasting a moderate El Niño weather pattern to develop during the fall and into the 2019 winter.

A group of Pine Cove residents met to discuss plans for forming a volunteer fire department for the area.

For the first time, Idyllwild had a resident priest. Father Joseph Finerty came here from Fort Yuma.

### 45 years ago - 1973

Voters within the boundaries of the Idyllwild Fire Protection District were deciding on a proposed tax increase of 30.5 cents per \$100 of assessed valuation. The district claimed the increase was needed in order to maintain the quality of protection.

Hall asked participants to email him at [zhall@riversidesheriff.org](mailto:zhall@riversidesheriff.org) or to call 951-791-3420 if they identify a problem or have a concern. He described his role as project manager. He would share the information with the various fire and law enforcement resources, he would find the appropriate responsible agency, and he would track the response.

He called this "one-stop shopping" and urged writers or callers to be specific and detailed. He has 75 contacts who can handle these issues.

As an example of what Hall has done and is planning, he has already taken a night-time flyover the Hill. Its purpose was to identify camps, outside of county, state and federal campgrounds, and campfires, using infrared technology sensitive to heat being emitted.

Shortly he, with others, will visit the homeless camps. With the help of the Sheriff's Department Homeless Outreach Team, they will offer the residents services, such as shelter, health and transportation. "Homelessness is a quality-of-life issue," he stated.

While they will offer these services, Hall and Deputy Bronson Graham, a member of HOT, who has been to Idyllwild many times regarding homeless issues, were hopeful that some would accept the offer.

"But often, there are rules that go along, such as with apartments, and they don't want rules," Hall noted. "It's a free-range lifestyle enjoyed by homeless."

When asked the size of Idyllwild's homeless population, Graham replied he thought it was in the range of 10 to 15. But they do move around, he added.

The visits to the camps may identify some residents who are wanted on outstanding warrants. Illegal activities, such as drugs, may be observed and be cause for arrest, but Hall emphasized community actions will matter.

"I'm not against people helping people," Hall warned. "But be cognizant of what you're giving out." For example, food that must be cooked or heated before consumption will require a fire, he noted.

One person mentioned that they had been part-time residents for several years and recently moved here full-time. Their house oversees the transfer station. Consequently, they can see what goes on near

there when it is not open.

"I'm very worried our house will burn. People use fire without precautions. It's very scary to me how much debris is on the mountain side [along Saunders Meadow Road]."

In response, Graham urged this person and others to call 911 or the Hemet Station. "If you don't call, we don't know there's a problem."

When one attendee asked if giving the homeless a propane stove, so they would not need to start a fire, would reduce fire risk, Idyllwild Fire Assistant Chief Mark LaMont discouraged that. He pointed out that the campers would probably not clear the site and it's possible it would be abandoned or accidentally overturned.

When encouraged to make more arrests, Hall explained that trespass violations or low-level misdemeanors will not keep people in jail. "My primary concern is fire risk! We can't solve the entire problem."

After one person asked what individual residents could do, LaMont urged them to abate their property. Defensible space is what firefighters need.

Education material, guides and prevention information are available at the fire stations, and at the Mountain Community Fire Safe Council office, President Norm Walker said.

The Idyllwild Library is both a cooling center in the summer and a warming center in the winter, so Branch Manager Shannon Ng offered a slightly different perspective.

"I'm required to provide services and others who provide services should get together and identify problems," Ng said. "Tell me what we're doing that should stop?" For example, she mentioned that the library would shut off outside outlets.

Near the end, one participant offered a summary. "The homeless are not the only ones who can start a fire; we can still be good Samaritans without giving food that needs cooking, and this is a multi-agency action, and our community is one of the agencies."

"We can't work against the community; we have to work together to reduce the risk of fire," Hall's message concluded.

He promised another community meeting in about a month to discuss the actions taken and possible future plans.

## 'Nice Fish' portrays lost souls waiting to hook or be hooked

On a frozen Minnesota lake, the ice is beginning to crack and groan. It's the end of the fishing season, and two old friends are out on the ice, angling for something big; something down there that is pure need. Something that might just swallow them whole.

"Less a traditional play and more a series of vignettes," Co-director Kathleen Walker explains. "Quick scenes compel our quirky characters to exchange their musings on life, is the pattern of this prose poetry." Delivered in patchwork, with two- or three-fold consciousness, light elements of Becket or Ionesco evoke when waiting triggers whimsical pondering and humor trumps. "It's true-to-life yet magical and charming with a surreal, lyrical intensity," Walker adds.

The Idyllwild Arts Theatre production stars Scott Wilson, Jacob Teel, Rena May, Derrik Lewis and Chris Doshier. It is also co-directed by Suzanne Avalon.

In "Nice Fish," author, Academy Award-winner and former director of London's Globe Theatre Mark Rylance draws on his own teenage years in the American Midwest to collaborate with critically acclaimed Minnesotan contemporary prose poet Louis Jenkins.

"Nice Fish" has been performed at The Guthrie, The American Repertory Theatre and the LA Shakespeare Festival. Following a four-year international run, "Nice Fish" was nominated for an Olivier Award, for Best New Comedy, 2017.

"For 15 years, it's been a fundamental goal of IAT to bring quality theater to the Hill. We hope you enjoy this production," offers Avalon.

"Nice Fish" will stage at the Rainbow Inn at 7:30 p.m. Friday, July 20 and Saturday, July 21. A reception begins at 7 p.m.

A little country, a little rock 'n' roll and a lot of soul.

Lisa Lynn Morgan & the Country Gents, next at the Idyllwild Summer Concert Series, are aptly named. The Gents are respected and well-known musicians in the Coachella Valley music scene. Lisa is acknowledged as a gentle and determined force in bringing quality music to the desert, and as a mentor who helps upcoming local musicians find their voices and venues in which to perform.

She is a multi-faceted professional who wears many hats — composer, performer, concert impresario, promoter, club booking manager, marketing director, emcee and community volunteer.

Lisa and the Country Gents are repeat winners of the CV Music Award for Best Country Artist/Band. She often is nominated in multiple categories, including Best Promoter.

Morgan is known for her civility and community activism. In Morgan's case, civility is a deeply ingrained life lesson embodying kindness and respect for others. As a young mother, making heady inroads as a singer in the Las Vegas casino scene, she realized Vegas was incompatible with raising a family and her personal values. Her email tag "diva left Vegas" sums up the decision and showcases her self-deprecating sense of humor.

Her coming to terms with alcohol, and becoming clean and sober in 2011 increased her desire to help others and be a positive influence within her community. "Alcohol had pretty much destroyed my life, and I had

to start over," she recalled. "You do what you can do when the opportunities arise. I respond when my heart's engaged. I do all I can to help others."

For Morgan, that includes working with the desert's homeless, assisting at a recovery home for women, and being part of an emergency disaster team for the American Red Cross.

In her music and in her life, Morgan believes authenticity and honesty are the qualities that reach and engage others. In performance with the Gents, Morgan covers the hits of others and tells her personal story through her own compositions. She can find the grit in a Janis Joplin hit and savor the sweetness in a Patsy Cline song. "We play our music with the full level of our hearts," she said.

Her musical influences are some of the great female artists. In addition to Joplin and Cline, she credits Melissa Etheridge, Tammy Wyn-

ette, Maria McKee (of Lone Justice), Bonnie Raitt, Trisha Yearwood, Loreta Lynn and Emmylou Harris.

Her Gents include Larry Gutierrez on lead guitar and vocals, Tom Clift on bass and vocals, James St. James on drums, and Bobby Furgo on keys and fiddle. Furgo toured for years with Leonard Cohen and was profoundly influenced by Cohen's message in his songs. "His biggest concern was how we all needed to learn how to love one another," said Furgo. "Learning to be kind was his core message. It touched everyone."

So, open your hearts, dust off your country boots and show up to hear Lisa and the Gents at 7 p.m. Thursday, July 19 at the ISCS site behind the Idyllwild Brew Pub on the lower level. Erik Lingren and Friends kick off the evening at 6:15 p.m.

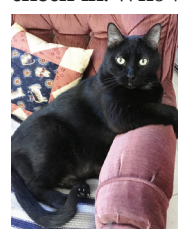

# Leopold leads knitting effort for Baton Rouge newborns

The partnership between humanitarians Karla Leopold, art therapist, and Sister Judith Brun, founder of Neighbor's Keeper, a nonprofit group in Baton Rouge, Louisiana, has been years in the making. First meeting as child well-being responders after Hurricane Katrina's devastating impact on New Orleans, they quickly bonded in service of softening the impact on families.

Soon after the hurricane's devastation, Baton Rouge grew into ground zero at Renaissance Village, FEMA's largest trailer camp, Leopold and Sister Judith working in tandem again. Initial estimates report more than 600 child evacuees were housed with their families in substandard trailers riddled with mold.

Engaged by the Community Initiative Foundation, the American Art Therapy Association began sending scores of volunteer art therapists in

an effort to help mitigate child trauma continuously for more than 10 years.

Take Care Baton Rouge is currently focusing on reducing generational poverty through neighborhood rejuvenation with specific attention to pregnant women, after care and infants. According to a recent broadcast on NPR, in the U.S., black babies die at more than two times the rate of white babies. According to the Center for Disease Control, black mothers die more than three to four times the rate of white mothers after giving birth.

Leopold, a master knitter, travels to Baton Rouge twice annually since the floods. "Knitting became a big thing in Renaissance Village and the knitting theme has continued to grow into community knitting. There's a little boy who once said to me, 'I love to knit. I can make something out of nothing and when I can't sleep, I pretend to knit and it clears the mind.' Knitting becomes the bridge between traumatized survivors

that provides the vehicle to educate," said Leopold.

Sister Judith adopted the small, low-income community of Highland Farms endeavoring to rehab the swollen town post-Katrina. Due to breakdowns in the fabric of family resulting from poverty and relocation, Sister Judith came to understand that young women are in need of nurturing into motherhood.

Blue Cross Blue Shield Louisiana has joined as a sponsor, permitting Sister Judith to recently hire a doula to assist birthing. The Women of the National Association of Women Artists generously provided

knitting supplies and Leopold's role is to continue her commitment to incorporate the arts into the community.

This is the project: Communities are invited to knit or crochet 6-inch blanket squares. Together, the new mothers will be taught how to craft personal baby blankets by picking from the assortment of knitted or crocheted squares the artists provide.

"Please ask anyone you know who knits or crochets to join this wonderful project," Leopold requests. "We will become partners to those who have so little in a fun cre-

ative manner. With our efforts to knit and crochet these squares, we will be providing added love and caring for the new mothers and their infants in Baton Rouge, Louisiana.

"Instructions: Use washable yarn either DK or Worsted weight of any colors. The 6-inch squares can be created in any stitch pattern of your choice. Mardi Gras and Carnival colors of Purple, Gold and Green are favored by most Louisianians.

"There are numerous ways to create your 6-inch squares. I encourage you to explore various stitch patterns while creating

your squares. There are numerous sites on the internet with beautiful crocheting and knitting patterns for 6-inch squares.

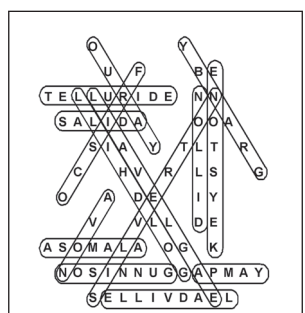
