Monsoonal moisture brings threats of mud and debris flows to Cranston burn areas

Each afternoon, from Wednesday through Friday, Aug. 15 to 17, Riverside County Emergency Management officials issued warnings of possible scattered heavy rain in the Cranston Fire area and potential mudslides. Evacuations of the Hurkey Creek, Apple Canyon, Fleming Ranch and Strawberry Creek areas were issued each afternoon.

The Cranston Fire, which was started by arson on July 25, burned much of the landscape on both sides of the highway from Idyllwild to Mountain Center, and from Mountain Center to an area close to Valle Vista.

During the storms, the major

highways — 74 and 243— were wet but free of mudslides. However, some slides did occur in the Apple Canyon areas, and running water and runoff were strong.

The rainfall can occur in small areas, not necessarily consistently over the Hill. For example, Friday's rain was very heavy in higher elevations and water flow was extremely high in town. However, in the southern edge of Idyllwild — Tollgate and Double View — the rain fall was much lighter.

For the three days, the U.S. Forest Service's Keenwild Ranger Station recorded just 0.4 inches, all of which was on Thursday. The Garner Valley site recorded 1.07 inches Friday. And equipment at Mt. San Jacinto recorded about

IWD to use carbon filter treatment to remove by-products

The Idyllwild Water District directors approved the acquiring a granular-activated carbon filter as the solution to the current high level of disinfectant by-products.

These chemicals — trihalomethanes (such as chloroform) and haloacetic acids — are formed from the reaction between chlorine, the purification chemical and natural organic material in the water. The appearance of disinfection by-products in a district's water supply happens throughout the country and can be corrected.

Based on the report from Water Quality and Treatment Solutions Inc. of Canoga Park, IWD's consultants, General Manager Jack Hoagland presented two major alternatives to the board. Besides the installation of a GAC filter, the district could modify its purification process.

This alternative would use ammonia compounds to reduce the level of chlorine in the water.

Water district consolidation? Maybe

More joint projects and planning? Yes

During the Aug. 15, Idyllwild Water District meeting, its consolidation committee reported to the full board. The committee has met once, July 16, and attended the Aug. 8, Pine Cove Water District board meeting.

At the committee's meeting, several Pine Cove residents attended and expressed strong opposition to the concept of consolidating IWD and PCWD together.

Further, on Aug. 8, the PCWD board passed a resolution expressing its opposition to any actions for this purpose.

At the IWD board meeting, Pine Cove resident Marge Muir encouraged the committee "to reach out and enlarge its focus. It's a hot issue and a lot of people have no idea the size of each district. New people need to know."

Trudy Levy, one of the founders of the San Jacinto Watershed Watchdogs group, which already has 18 members, urged the board to "change the name from consolidation."

Director Peter Szabadi announced another meeting on Aug. 28, and said, "My purpose is to involve people from the other districts. It's possible the Pine Cove board doesn't represent the view of all its constituents. We're not trying to create animosity, but to find solutions on the operational level."

Director David Hunt sympathized with Szabadi. "It's fabulous to have a watershed group. It's a mistake to have our own committee. It looks as if we're trying to

take over those districts. The Watchdogs should get the communities together and come to the districts."

Public comment

During the public comment period, two residents also addressed this issue.

Mick Lynch, who lives on lower Pine Crest, attended and spoke to the board.

"For me, when water is too toxic to drink, I have a water crisis," he began. "But the broader situation is even more critical. We're running seriously low on water. On this whole mountain, we're experiencing a crisis, whether it is from drought, fire or fear of flooding."

Lynch posed three questions to the board. First, he urged them to "... shift the dialogue to the need rather than an idea regarding the integration of the three districts."

He also urged IWD to organize a community meeting, including Fern Valley and Pine Cove water districts, to approach this issue. Finally, he asked what Riverside County's involvement might be on this subject.

Kate Sirkin spoke out, too. She began with the fundamental introduction of the Brown Act, stating, "The people of this state do not yield their sovereignty to the agencies which serve them."

She also urged the all three water districts to work closer together for greater unity. "We are asking our water districts to ... come up with a plan to save our watershed ... to ensure that far into the future we have an adequate supply of affordable, potable water."

No water shortage, according to IWD GM

Board wants to consider Stage 1 Emergency

Addressing its water quality issue was not the only issue on the agenda for the Idyllwild Water District last week. (See the accompanying story on A1 about more solutions to water quality.)

Water production for July was 10.2-million gallons, which was 660,000 gallons less than July 2017. For the first seven months of 2018, IWD production totals 52.9-million gallons, which is 0.5 percent or about 30,000 gallons more than the same period in 2017. However, the July production does include water used for or lost during the Cranston Fire, General Manager Jack Hoagland qualified.

During the discussion of the water supply status, he stated, "I am not able to make a recommendation for a water emergency." Hoagland had reported that the July demand in gallons per minute was 55 percent of the current total production capability.

The horizontal wells at Foster Lake are online and several more may be added. In the near future, Hoagland expects to add the Oakwood well to production, too.

However, the status of the Oakwood well raised some questions and concerns. While reviewing the district's payments in July, Director Steven Kunkle asked about the \$7,000 for an appraisal for easements. Hoagland said it was for extending the pipeline from the Oakwood well to Jameson Street. He had included this project in his December capital-project proposal.

He said the estimated cost of \$20,000 for two easements easily exceeded his expected costs and would likely stop the project. The district received its approval to operate the Oakwood well a year ago, but it still is not part of the production system.

Current water-shortage actions are defined in Ordinance 64. However, portions of that have been obviated with the recent approval of a new rate structure.

"If the board decides there is a water emergency, we could go to Stage 1," he said. Stage 1 requests voluntary compliance with water conservation. Stages 2 and 3 are inconsistent with the new rates.

The only issue, which a Stage 1 status might raise, is the issuance of "will-serve" letters for new construction. Hoagland noted that about 25 meters have been installed out of a total of 58 requests or letters.

After one year, the letter needs to be renewed. See Water, next page

but ammonia can produce its own set of byproducts. Hoagland recommended, "Just take the organic material out rather than change the disinfectant."

The board unanimously agreed to pursue this option.

Most of the discussion among the directors concerned the cost of the project. WQTS's estimate was a wide range, between \$700,000 and \$1.5 million. Hoagland is confident the staff can install the equipment. He estimated the total cost, if staff did the work, would likely be between \$300,000 and \$400,000 depending upon materials.

The board approved a motion for him to acquire the filter and other installation costs for up to \$200,000. If or when he may need more, the board will be receptive to a modification.

Filters for homes

All the board members were in favor of some sort of subsidy for customers who need water filters until the DBP concentrations are reduced to acceptable levels.

Director David Hunt made a motion to authorize a rebate or subsidy for purchasing a filter, which raised questions. The two most significant were the amount of the rebate and the eligible customer group.

President Dr. Charles "Chip" Schelly thought all IWD customers should be eligible and other directors were in favor of limiting the rebate to customers in the area where the DBP exceeds standards, which is the lower Pine Crest neighborhood.

The board then asked Hoagland to raise the issue with the district's counsel and offer a proposal at the September meeting.

Flushing pipelines

Several individuals and board members suggested that the DBP high levels may be concentrated in the lower Pine Crest area because the pipeline dead-ends there. In the past, IWD was known to have flushed this pipeline more frequently and the DBP levels never exceeded the maximum contaminant levels.

Dwight "Buzz" Holmes in the audience was a strong advocate for greater use of this step until the GAC filter is installed. He also recommended the district investigate whether this pipe could be connected to another, thus forming a loop, which creates consistent water flow rather than stagnating.

He also recommended similar consideration at the Idyllwild Arts area.

Hoagland replied that the volume of the Idyllwild Arts use limits the amount of time the water sits. He added that he has studied the possibility of extending the pipeline at the end of Pine Crest.

"It would have to go across Lily Creek, which is a challenge," he said. "The cost estimate would be about \$400,000." This option would also require more time, because an environmental approval for crossing the creek would be needed before work could begin.

Holmes did suggest that IWD prepare "... a two- to five-year plan to evaluate the benefits of 'looping' and what it could do for the system."

Both directors Steven Kunkle and Hunt urged more flushing of the pipeline in the Pine Crest area. Kunkle also was an advocate for exploring and drilling more wells to relieve the dependency on the Foster Lake wells where the organic material has accumulated.

She drives up Highway 243, pulls into the parking lot of a restaurant near the school. She drops her third-grader off on the playground at the main parking lot gate, then heads toward the kindergarten gate, but it's 7:40 a.m., too early to leave her daughter, so they go through the cafeteria door to find her teacher. She notices a sign: "New Safe Closed Campus Rules. Beginning Monday, August 13."

"What's that all about," she wonders? The next day, she follows the same routine, but stops to read the notice: "Parents, visitors and volunteers may not enter the school through the cafeteria door or the main parking lot gate and must check-in at the front office up to 4:00 p.m."

"Judi" heads to the front office with her daughter in tow, and sees the floor-to-ceiling, locked-door glass barrier and is taken aback.

The new barrier is one of the more conspicuous components of the Hemet Unified School District's safe closed-campus rules. Implemented Aug. 13 and 14, the rules also address pick-up/drop-off procedures, the entrances and exits to be used, closure of a street crossing, and the lack of parking on an adjacent restaurant's parking lot. The rules were posted at the school and announced in automated phone messages to the school community.

The barrier, in particular, has been the focus of attention. Some parents support it half- and whole-heartedly, while others are deeply disappointed. According to Principal Matt Kraemer, "there's somewhat of a Facebook storm brewing for the parents that are not happy."

"Students have only one entrance to the school and parents have only one entrance to the school," he told the Town Crier re-

porter Aug. 16. "We are the very last school [in the district] to be able to enforce the closed-campus rules as the culture of the school has always been an open campus and I've embraced having an open campus with the community."

"We haven't had the physical structures in place to initiate the rules, but now we do. Without the barrier, it is difficult to control who goes in and out of the office and the hallway."

"The objective is to keep the students safe in light of recent events in the news and the increase of violence on campus brought in from the outside. It's incumbent that we provide security measures to prevent any sort of violent act initiated by outside sources."

Prior to meeting with the reporter — and to emphasize the importance of the new rules — Kraemer pointed to a man standing on the other side of Highway 243, opposite the school.

"Earlier this morning, he was sitting on the school's steps," Kraemer said, "but left quietly after I asked him to leave." That man was a stranger to the school community.

When asked how the

new rules have affected the school, Kraemer said, "The culture has changed. Many parents have stopped me and said they really appreciate that the barrier was put in place and steps were taken. I have others that are having difficulty adjusting to the culture change."

Kraemer recalled the mother of a primary-grade student who was "upset ... frustrated because she is not able to walk her child to the door of the classroom everyday ... She was able to do that last year."

"That is what's hard about a shift in culture. It is a change — and I am happy about making the

campus safer — but sad that we have to lose some of those connections."

"I've been letting her sign in and walk her child to class. She still has that option for a period of time, for this transition at the beginning of the year, but not throughout the year."

"In my opinion, among the ones that have come to me, more [parents] have been in favor than against. Every school that's initiated the policy goes through a transition where you have parents that are upset by it. And we looked closely at other schools within the district and what their guidelines were."

Obituary

Joseph William "Doc" Bernier 1943-2018

Joseph William Bernier ("Doc"), 74, died Friday, Aug. 17, 2018. He was born on Nov. 2, 1943, in Chicago, Illinois. He graduated from the University of Maryland and Indiana University, where he earned his doctorate in dentistry, and he served in the U.S. Army until 1974, reaching the rank of captain.

A former president of the D.C. Dental Society, Dr. Bernier practiced dentistry in Washington, D.C., for more than 30 years and also was an educator in the field.

He was preceded in death by his parents, Major General Joseph L. Bernier and Bernice (O'Rourke) Bernier, and his beloved wife of 36 years, Shelly Lee Bernier. He is survived by his sister, Beverly (Bernier) Belzile; his two loving sons, Joseph (Lisa) and David (Amanda); and his two cherished grandsons, Finn and Joseph.

An avid reader, Doc also was an outdoorsman and nature lover. He was a master scuba instructor in the 1980s and 1990s, and earned his pilot's license in 1972.

After retiring, he moved to California with his devoted Lab, Ben, to live closer to family. He particularly enjoyed the beauty and solitude of Idyllwild and could be spotted driving around town in his golf cart ("the Goat").

'Safety is the number one priority'

"Last year at the school's 'Local Control and Accountability Plans' meetings, parents were able to voice how they wanted funds spent," Kraemer said. That's what came from those meetings. "Safety is the number one priority." They wanted the school to be more secure so it would be safer from people coming in and creating violence in the school."

Kraemer said the new barrier was paid for through the district's Safety, Operations and Maintenance budget and when asked how much it cost, he said, "I don't know; I am just glad it is not coming from my budget."

Speaking of the barrier, Idyllwild School Mom Liv Kellgren said, "I think it is tragic, but it has to be im-

plemented in this day and age. It is pretty [much] expected and appreciated; I do appreciate it."

"We just moved here ... It is our first year here and my first experience in getting our kids in school. I have a boy in kindergarten and a girl in first grade, and this is all I know. It is fine with me."

"One of the biggest reasons why we moved up here was so we could give our kids the safe, small-town experience and bring our family closer together. My husband's son committed suicide in October, and we looked at our kids and realized that something had to change. We really wanted to bring our family here and to know our neighbors. We did not know our neighbors down in Temecula Valley and in

During a Stage 1, only 10 letters may be issued. Hoagland's concern is that the currently unfulfilled "will-serve" letters will begin to expire and the property owners may request renewals, which could exceed the limit of 10.

Kunkle expressed his objection to limiting "will-serve" letters. Director Peter Szabadi felt IWD should be in Stage 1. President Dr. Charles "Chip" Schelly restated that Stage 1 is the "only part of Ordinance 64 that we can implement."

Hoagland encouraged the board to set a public hearing for September to consider going to Stage 1 and also to use its discretion to issue more "will-serve" letters than 10.

The board voted 3-2, with Schelly casting the deciding vote, to hold a public hearing at the next meeting. Directors David Hunt and Kunkle voted, "No."

The board next addressed the proposed water contingency policy and new drought rates. The subcommittee composed of Hunt and Szabadi developed the new plan to replace Ordinance 64.

On this issue, the board unanimously agreed to schedule a public hearing on the new water-contingency plan at the next meeting.

One lesson from the Cranston Fire was that the district learned it needs a larger, stand-by generator for its Foster Lake shop. Currently, there are generators for the office, the waste treatment plant, the Foster Lake well pumps and city well pumps to help when electrical power goes out.

Finally, Schelly established a committee composed of directors Hunt and Kunkle to develop a process for recruiting and selecting a long-term general manager.

Hunt stated, "Since the general manager, Jack, has done a fabulous job. He responds to emails on Sunday and I like his expertise. I do see the community wants somebody full-time and living here."

Kunkle expressed his concern that Hoagland was part-time and making about the same salary as the two

other local general managers, who are full-time.

"The committee is not just to replace Jack," stressed Szabadi, who also supported him, but noted that Hoagland may choose to retire within 18 months so the district should initiate a process for his replacement.

Social media, fake news and your local newspaper

"Fake news" is taken to mean one thing at the national level, but something quite different at the local level.

When any newspaper values its reputation, it does not report rumor as news. It uses reliable sources and it verifies them. A reliable news source is someone who not only claims to know, but is in a position to know, and has established trust with the newspaper. And verifying that news source's information means, whenever possible, finding a second news source, independent from the first, that is just as reliable.

Social media are fast, but they do not do this. They do not expend the time and energy necessary to ferret out and verify facts. What social media reports as "news" is too-often rumor, assumption and surmise on which conspiracy theories thrive.

Social media is sometimes correct, sometime wrong, and almost always incomplete and unverified. The problem is, when you read it you don't know what you're getting because social media writers have no out-front and ongoing reputations to protect. That's why they are not reliable. "I heard ..." and "My friend saw ..." don't cut it.

If we on the Hill relied on social media for our local news, we would not have known that Idyllwild Fire Protection District had no records of what were supposed to be annual audits through a five-year period (Town Crier: Sept. 25, 2008), or that IFPD was purposefully nontransparent in its attempt to set up a Joint Powers Authority with the City of San Jacinto (TC: July 7, 2016). And we wouldn't know that — exactly the opposite of what was claimed — IFPD gets a much higher percentage of the 1-percent property tax of property owners within its district than County Fire does from property owners in Pine Cove or Zone 3 (TC: Nov. 3 & 10, 2016).

And we also would not have learned the details of the Riverside County Grand Jury's findings and recommendations as to certain, serious IFPD personnel issues that the IFPD Board of Commissioners thereafter rejected (TC: July 3 and 10, Sep. 4, 2014).

If social media were our news source, we would not have known that the former general manager of Idyllwild Water District was lying about his efforts to obtain water certifications from the State Water Resources Control Board (TC: Aug. 18 and 25, 2016). We wouldn't have known the factual details, as viewed from both sides, of the ongoing dispute IWD and Pine Cove Water District were having with the fledgling Idyllwild Charter High School (TC: Dec. 16, 1999). And, most recently, we would have thought there was a serious fire in Pine Cove on Wednesday, Aug. 15, when there wasn't.

Here on the Hill, we have nine boards of public agencies, funded by taxpayers' dollars, making decisions and recommendations as to how to spend even more of our tax monies. These nine boards are monitored by nobody but the Town Crier.

This is a major reason why Becky and I are making an effort to keep the Town Crier informing for our community long after our retirement. The Membership Model, which our readers both on and off the Hill are supporting so strongly, is the key factor in making that happen. Through that model, the TC will be a viable enterprise with fully-paid employees that will attract new, younger-than-me publishers to carry on the duty of keeping our community, including our extended off-Hill community, informed with verified news and information.

This way, as long as our readers really want a reliable local newspaper, they can have one.

Adrenaline kicked right in: I shut and bolted the back door, pulled on the snake boots, grabbed the big walking stick and headed out the front door to get advice or assistance.

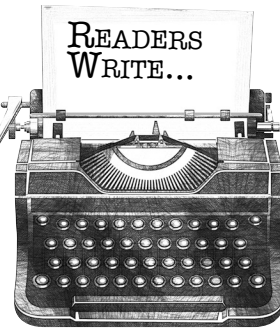
Casey, behind the counter at Mountain Center Market, introduced me to Larry [Bischof] and Luis [Marroquin], who rose to the occasion and took charge.

There is nothing ordinary about helping a total stranger, with tenacity, courage and compassion. (I read in your fine newspaper about the cooperation between folk on the Hill, but until [July 18], had not experienced it myself.)

- Leave driver window down and keys in car.

- Leave long-sleeved cotton shirt, gloves, goggles and face mask next to driver's seat for use, if necessary, to drive through fire.

- Have the following packed in car in preparation for leaving: eye glasses, personal medications, desk drawer (checkbook, bill accounting items), safe contents, jewelry, cell phones, iPads, charge connectors, flash-

lights.

Then, close shutters and drapes, turn on outdoor lights, post notice on door knob of house informing house has been evacuated of people and pets, and location where you are staying. Have a bottle of water in the car.

Evacuate when told to do so.

Some advice for emergencies

EDITOR:

My wife Elaine and I have prepared ourselves for emergency survival for the past 25 years or so, starting with the earthquake in San Fernando Valley. Since then, we have picked up a few tips that some of you might put into practice. Listed below are reflections on our last escape.

Divide emergency shelf into two sections: one section for survival in place with no electric, and/or water and/or propane; one section for emergency evacuation.

Survival in place should include:

- gallon bottles of water (four) for washing and flushing toilets
- 12-ounce bottles of water (10) for drinking and cooking
- two-week supply of food for two people and two cats
- extra batteries for flashlights, portable radios, solar charger for phone/iPad, radio.

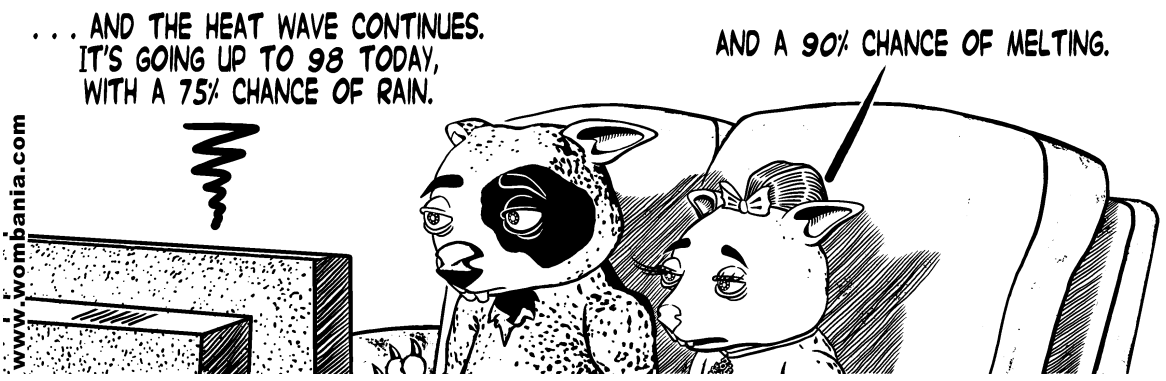

Realtor Talk

Hello from the Idyllwild Association of Realtors! What a month it's been. First off, on behalf of our association (and the community), we would like to extend our sincere gratitude to all the firefighters and local law enforcement officers who have kept our town safe once again from the most recent wildfire: Cal Fire (the heroes in the red trucks), the U.S. Forest Service (the heroes in the green trucks), the Idyllwild Fire Department (the heroes in the white trucks) and to all those who have helped in their own ways. What a very special community we live in.

Here's what's currently happening in the real estate world.

National level

National Flood Insurance Program: The House of Representatives voted 366-52 to pass legislation to extend the National Flood Insurance Program until the end of November. The NFIP expired July 31. The House vote came that day, one day before members were scheduled to leave on their August recess.

National Association of Realtors President Elizabeth Mendenhall said, "The bill passed by the House today ensures the program remains available to those Americans who rely upon it, while enabling Congress to continue working toward a long-term reauthorization and reform measure. We urge the Senate to take swift action on this bill before the program expires on July 31."

The Senate did vote to extend the program through Nov. 30, 2018. The president signed the bill into law.

"[The California Association of Realtors] thanks all of the members who sent letters to their senators/members of Congress in support of the extension."

State level

In coming weeks, CAR will launch a plan to help pass Proposition 5, CAR's Property Tax Fairness initiative, and defeat Proposition 10, the effort to repeal the landmark Costa Hawkins law. Voters will decide the fate of both initiatives in the Nov. 6 election.

Prop 5 would remove the unfair moving penalty for seniors, the severely disabled and disaster victims across the state while still ensuring these people pay their fair share of property taxes.

Prop 10 would repeal the landmark Costa Hawkins law that limits the ability of local governments to impose aggressive rent control. CAR successfully co-sponsored Costa Hawkins in 1995. Any threat to Costa Hawkins is a threat to private property rights and CAR is prepared to vigorously defend the law against Prop 10.

Local level (market stats)

Here's the question I've been asked most lately: "How's the real estate market been since the fire? I imagine it's pretty quiet."

My reply: "Well, not really."

Here's what's happening as I'm writing this today, Sunday, Aug. 19*:

- 13 escrows have closed since the evacuation order was lifted for Idyllwild (July 29, 2018.)

- 31 properties are currently pending in escrow: 25 single-family residences, three vacant lots and three mobile homes. SFR listing prices range from \$197,500 to \$975,000.

- 13 of these 31 properties went into escrow after the evacuation order was lifted for Idyllwild.

- 11 new listings are on the market since the fire.

Wildfires impact firefighters' mental health

As wildfires burn throughout California — making this the worst fire season in years — firefighters on the frontlines are working around the clock to beat back racing infernos. It's difficult for most of us to imagine the destruction they witness, and they rarely have time to regroup and process their emotions. However, not doing so can literally be deadly.

According to a recent study by Ruderman Family Foundation, 103 firefighters died by suicide; more than the 93 who died in the line of duty. And a survey conducted by the International Association of Fire Fighters

of more than 7,000 North American firefighters revealed that 27 percent have struggled with substance use issues.

In a profession known for stoicism and resilience, it can be difficult to admit you need help. The stigma surrounding mental health is so severe that many firefighters turn to coping strategies like alcohol or prescription medications. Substance use also increases the risk of suicide. We need to support those who serve their communities during and after these catastrophic events, and that's where Mental Health First Aid can help.

The National Council for Behavioral Health recently announced a new Mental Health First Aid Fire/EMS module designed to provide firefighters and EMS personnel the skills they need to support them-

selves, the people they serve and their colleagues through a mental health or addiction crisis.

The module provides a fundamental understanding of the common mental health challenges experienced by first responders, and the skills to identify and respond to people who may be in crisis. The program also teaches effective debrief and referral practices for any of the groups they serve.

As the toll on firefighters, their families and their communities continues to grow with the fire season, Mental Health First Aid for Fire/EMS offers another tool — both for outreach and wellness. Fern Valley Water contributes to stopping Cranston Fire

While the Cranston Fire burned mostly south and east of Idyllwild, its consequences still affected the Fern Valley Water District.

At the Aug. 17 meeting, General Manager Victor Jimenez reported that July's water production was more than 6.1-million gallons, "way up." In comparison, production for both May and June combined was 6.9 million. The normal production for July and August combined is about 8-million gallons.

Jimenez was not able to state how much water firefighters used. A large leak did occur during the fire. It was the result of a someone turning the hydrant off too quickly and the pressure caused breakage.

"[The leak] was pretty

substantial, as much as 25 gallons per minute for awhile," he said.

"It's an age-old problem — having fire persons knowledgeable enough about pressure differences and how to close a hydrant," observed Director Robert Krieger.

The board had some discussion about arranging training for firefighters on the use of hydrants on the Hill. However, Jimenez felt the local firefighters understood that hydrants here have much higher water pressure than the flows below the mountain.

"There were so many different departments here, they don't realize shutting down a hydrant that quickly can cause damage," he stated.

Jimenez also reported that the district will need to purchase another generator for its office. The current generator could not run all the equipment. When a new one is acquired, this equipment will be moved to the shop, he added.

Fortunately, tanks were full and FVWD had nearly 6 million gallons of water available if firefighters needed more.

The fiscal year 2017-18 initial final budget showed a positive result. Revenues were about \$100,000 greater than last year's expenditures. Revenues grew nearly \$150,000 with greater water use and the mid-year rate increase. Property taxes were nearly \$80,000 greater than the initial estimates.

Expenditures were up \$240,000 and attributable to the payoff of the district's post-employment health expenses. Another similar payment will be made this year.

Jimenez also report-

ed that there were some problems at the district's treatment plant last month, which have been resolved. However, he has someone developing software to indicate immediately when a problem may develop, since the equipment is approaching 10 years in age.

The board did approve acquiring different probes for the chlorine analyzers since the current supplier has stopped manufacturing them. These will cost about \$6,000. If new analyzers are needed, their cost may be more than \$40,000.

And plans are underway to inspect the district's water-storage tanks with divers and then begin a cleaning process.

The other issue discussed was the proposed office expansion. "I've gotten some quotes but they are about four times what we budgeted," he told the board. Director Jim Rees will work with Jimenez to try to find contractors more interested in the work.

Idyllwild Water District customers have been urging IWD to consider options for greater cooperation, if not consolidation, with the other two Hill water districts — Pine Cove and FVWD. While the San Jacinto Watershed Watchdog group did send an email to FVWD, which was on the agenda, no one from the group came to the meeting.

IWD's Director Les Gin attended and detailed the IWD Consolidation Committee's purpose. "We're inviting the different districts for a joint effort on what we can do to unite together and protect the common watershed."

Silver now ahead of Stone on campaign finance

If campaign donations reflect votes, the Democratic challenger, Joy Silver, has more than incumbent Republican state Sen. Jeff Stone. However, the Nov. 6 election is still more than two months away.

Not only is Stone the incumbent, but he has represented much of the district as a Riverside County supervisor, giving him a substantial lead in name recognition.

At this point in the 2014 campaign, when Stone defeated fellow Republican Bonnie Garcia, he had raised more than \$400,000. As of June 30 of this year, his total contributions are about 60 percent of that total.

Silver, born in Pennsylvania, spent much of her early career on the East Coast. She moved to New Mexico, and in 2007, settled in the Palm Springs, where she continues to be concerned about health care and services for peo-

ple who need help.

Silver has had far more contributors. Thirty-five contributions were greater than \$2,000. Labor unions, such as the Teamsters and Electrical Workers, and desert residents were the majority of these donors. However, the largest donor was Silver, who has loaned her campaign \$50,000.

Ten of Silver's contributors were from Idyllwild, accounting for \$1,650.

Silver has been the beneficiary of substantial out-of-state contributions, more than \$50,000. The majority has come from New York, but contributors also range from Massachusetts, New Jersey and Florida to Washington and Alaska.

Stone has gotten his share of political action committee funds, too. Associated General Contractors, Anheuser Busch, peace officers, pharmacist groups, energy companies and others from Sacramento have contributed to his campaign. Through

the end of June, Stone had received 19 contributions from outside of California, mostly corporate donors. These totaled about \$25,000 or 10 percent of his funding.

Nearly two-thirds of his expenses were paid from the balance of his 2014 campaign account.

This includes payments of about \$42,000 for campaign literature and mailings, and \$12,000 to a campaign consultant. Most of these costs were in the summer and fall of 2017 and totaled \$160,400, according to his financial reports to the Secretary of State's office.

Pape and Smith appealing murder conviction

Robert Pape, 30, and Cristin Smith, 29, are appealing their convictions for murdering three Pinon residents in 2006. In June, a Riverside County Superior Court jury found both men guilty of the deaths of Jon Hayward, Vicki Friedli and Becky Friedli, Vicki's daughter.

Pape alone was found guilty of the second-degree murder of Becky and both were found guilty of first-degree murder in the deaths of Hayward and Vicki.

On Aug. 10, Judge Bernard Schwartz sentenced both to life in prison without the possibility of parole.

Announcing the sentence, Schwartz said, "Mr. Pape, having been convict-

ed on Count 1 — that being a charge of second-degree murder — normally the sentence for that would be 15 years to life. However, because the special circumstance was found true under Penal Code Section 190.43, the crime is converted, along with the Count 2 and Count 3 findings of the jury of first-degree murder, in that there are multiple murders, the

special circumstance compels and requires the court under the law to sentence Mr. Pape to life without the possibility of parole."

On Aug. 14, Jeff Moore, Pape's attorney, filed the notice that he would be appealing the conviction and sentence, and Smith's attorney did likewise.

Trial date for Marcus Green moved to September

A trial start date in the case against Marcus Green has been set for Sept. 21.

Green, 53, of Thermal, was the driver of a car that went over the side of Highway 74 in May 2016 and resulted in the death of a 5-month-old child. The Riverside County District Attorney's office filed two felony charges — murder and willful child cruelty —

as well as gross domestic violence.

In April, Green's attorney, Michael Rowlands, deputy public defender, filed a motion to set aside the indictment because of irregularities when he was initially charged. However, on Monday, June 4, RC Superior Court Judge Dean Benjamini ruled against the defense motion and set the trial date.

Series of quakes near Aguanga continue for several days

Since late Tuesday afternoon, Aug. 14, a series of tremors have occurred in the Aguanga area. The largest was recorded at magnitude 4.4 at about 6:30 p.m. Friday, Aug. 17.

Nine were reported through 6:30 a.m. Wednesday, Aug. 15. Another five quakes, including two magnitude 3.3, were recorded, including two on Monday morning, Aug. 20.

The 4.4 quake was felt as far west as Irvine along the coast near Oceanside, east beyond Indio, north to Big Bear and south to San

Diego. This quake is on the San Jacinto Fault.

The other tremors ranged in magnitude from 2.1 to 3.3. Three of them were 3.0 or greater. In May, several similar quakes occurred in the same area.

Noted seismologist Dr. Lucy Jones, formerly with the U.S. Geological Survey, said, "These tiny quakes near Calhulla are moving very small areas and release only a small amount of strain," and added, "Thousands of tiny quakes have been occurring here for two years."

No damages or injuries have been reported as a result of this series of tremors.

IFPD engages counsel to protect emergency service area

Editor's note: The Town Crier has not reported about the Idyllwild Fire Protection District's commission meeting of July 24. The Cranston Fire primarily caused the delay due to the power loss and evacuation. Then staff vacation occurred. The following is a brief article of the meeting.

The commission approved a resolution changing its regular meeting time from 1 p.m. to 3 p.m. on the fourth Tuesday of each month.

The commission also approved the entering into an agreement with another law firm. The district's legal counsel is still Brad Neufeld of Varner and Brandt, but

the new firm, Cota Cole and Huber LLP of Ontario, will represent IFPD in the review and evaluation of the proposed Advanced Life System agreement with the Riverside County Department of Emergency Management.

The district believes the county is not recognizing IFPD's original emergency service area. The principal disputed area is the parking in Humber Park.

Assistant Chief Mark LaMont told the commission that rescues in the U.S. Forest Service area are not the issue. But when an injured party is transferred to an ambulance, IFPD believes the responsibility to transport the individual rests with IFPD.

"The attorney engagement let-

ter is for special counsel regarding the EMS issue specific to the ALS agreement and ensuring our '201' rights," Chief Patrick Reitz told the commission.

IFPD has not yet signed the agreement, although EMD was hoping to have a signed agreement by the end of August. Reitz said the issue would be on the agenda for the Aug. 28 meeting.

"I'm committed to try to have it before the end of August," he told the commission. However, the Cranston Fire has interrupted much work since the meeting.

The commission also approved an automatic aid agreement with the city of Calimesa.

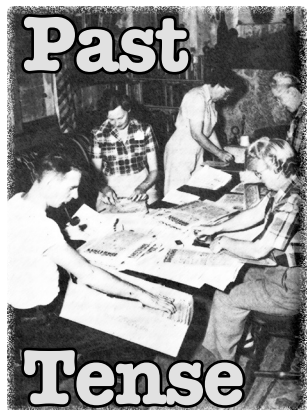

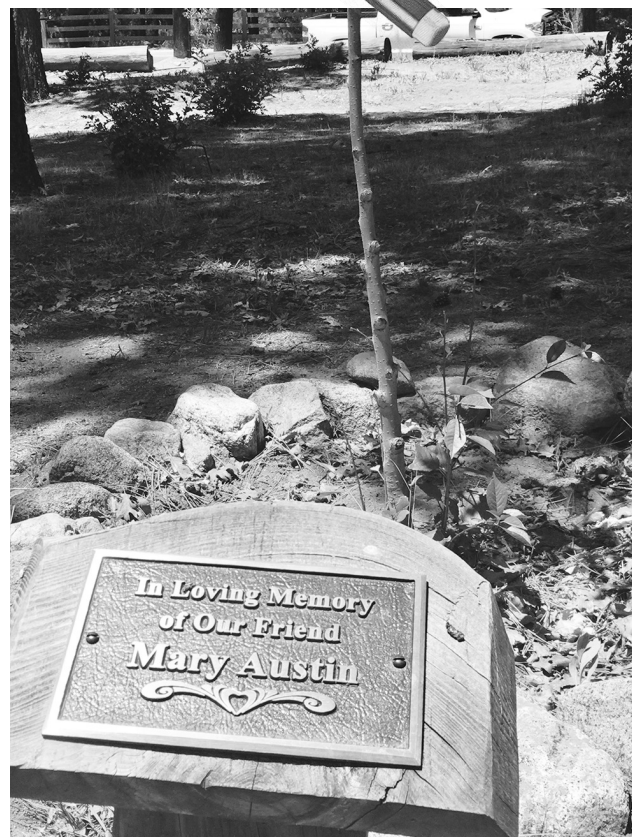

half an inch during the three days.

Excessive rainfall over the Cranston burn scar could result in debris flow, especially east of Idyllwild and southeast of Mountain Center. The debris flow can consist of rock, mud, vegetation and other loose materials, according to officials.

The Cranston Fire left the ground on the mountain-top scorched with little ability to absorb water. This means that scattered rain can result in more runoff than usual, leading to flooding, mud or debris flows, with little to no warning. There also is a threat of rockfall on steep, burned slopes.

Once the rain stops, authorities determining when to re-open roads to traffic usually wait an hour to be sure slides are not slow in occurring.

Riverside County officials urge residents and visitors around the Cranston Fire burn area to take the following steps:

- There may be little to no warning before flooding, mud or debris flows occur. Be prepared to evacuate to high ground if you feel you're in danger.

- Follow all orders by public-safety officials. Make sure you receive emergency alerts by signing up for Alert RivCo messages at RivCoReady.org/AlertRivCo.

- Monitor weather reports and consider your safety risk when a weather alert is issued.

- Know your local roads and understand that some may be blocked by debris. Have an alternate route. Never drive or walk into floodwaters or go around barricades. Stay informed of road and highway conditions by visiting the Riverside County Transportation Department's website at rctlma.org and Caltrans' website at quickmap.dot.ca.gov.

- Protect your property structures with sandbags. Limited, unfilled quantities are available at your local fire station. If you have active flooding occurring inside your dwelling or you feel you're in imminent danger, dial 911.

- Have an emergency plan and a disaster kit ready to go.

Floods and mudslides subject

One lingering result of the Cranston Fire is heavy rain can cause floods, mudslides and debris flows, which threaten Hill communities.

The Riverside County Emergency Management Department was to discuss these risks, Friday, Aug. 17. The rainstorm on that date actually postponed the meeting, so this event is rescheduled for Monday, Aug. 27 at 6 p.m., at the Idyllwild School gymnasium.

County of Riverside agencies and partners will discuss the hazardous conditions and the safety steps community members must take to prepare.

Three days last week, the County issued emergency flood warnings, then road closures and ultimately evacuations of several Hill communities as severe thunderstorms passed over the mountain.

San Diego.

"So then, to realize that on the first day of school they are implementing these safety features, it kind of felt like a 'kick-in-the-gut' because I was kind of hoping we were immune from that — from life off the Hill."

Security cameras, crosswalks and no parking at Mile High Cafe

Kraemer said that at some point in the school

year, security cameras will be installed. "Locations have not been decided, but they'll definitely be on entry and exit points of the school."

"We also have a campus supervisor and an armed deputy up here one day a week as a resource. The deputy comes as needed, too. That's why he's been here quite frequently this week in the morning helping during arrival and dismissal times in the parking lot."

"We have not received any threats against the school itself in the last 10

years that I have been here, but we've had very few cases [where] there have been threats against me and other staff members. Nothing ever happened, but we initiated and had to put some procedures in place."

"We have someone at the crosswalk. And we're helping a local business. Mile High Café has been losing business because in the past, parents have been taking up spaces in their parking lot in the mornings and people have been bypassing the restaurant thinking that the

restaurant's full."

Under the safe closed-campus rules, "Parking will not be available at Mile High Café for drop-off and pickup"

Other safety and security measures not implemented as part of safe closed-campus rules

The Lobby Guard sign-in system in the receptionist area of the front lobby has been utilized for three years. Parents like "Judi," who want to visit their child's teacher, must type their name and

the reason for their visit into the counter-top kiosk. Their drivers' licenses are scanned, their pictures are taken and backgrounds checks are instantly conducted.

"Lobby Guard triggers an alert to us if the background check comes up with a negative finding," Kraemer said. "If it shows a felony, [for example, for 'Judi'], the parent will not be allowed through the barrier until we straighten that out."

The school's Safety Plan — which is separate from the closed-campus

rules — involves monthly fire drills. Other drills, including for lockdowns, sheltering-in-place, earthquakes, evacuation and more, are scheduled during the year.

The Safety Department of the school district is developing active-shooter plans and drills, according to Kraemer. "We have to be aware that active-shooter drills for the elementary [grades] are difficult because you can create a lot of anxiety for younger kids. They are really easier to initiate in secondary schools."

New Medicare cards are arriving

The U.S. Centers for Medicare and Medicaid Services is mailing new Medicare cards to protect the safety and security of people with Medicare benefits. The cards no longer contain a person's Social Security number, but rather a unique, randomly assigned Medicare number that protects the identities of people with Medicare, reduces fraud, and offers better safeguards of important health and financial information.

CMS has begun mailing the new Medicare cards to people who currently have Medicare benefits in California. As soon as people receive their new Medicare card, they should destroy their old Medicare card and keep their new Medicare number confidential.

People with Medicare and their caregivers can visit medicare.gov/newcard to find out when new Medicare cards will be mailed to their area. They can also sign up for email notifications about the new card mailing and check the status in their state.

'Charitable' phone sales calls

"I'm not calling for a donation." (But really, I am.) Have you gotten this call?

You already may know that The Do Not Call Registry is designed to stop unwanted sales calls, but it has some exceptions. One exception allows for-profit fundraisers to call you on behalf of charities, even if your telephone number is listed on the Do Not Call Registry. But when these charitable fundraisers call you, they must still follow the Telemarketing Sales Rule (TSR).

For example:

- They can't call you before 8 a.m. or after 9 p.m.
- They must promptly tell you the charity they're calling for and tell you if the purpose of the call is to seek a donation.
- They can't make a false or misleading statement to persuade you to donate.
- They can't misrepresent information during the call, such as the fundraiser's connection to the charity, the mission or purpose of the charity, whether a donation is tax-deductible or how a donation will be used or how much of the donation actually goes to charity programs.
- They can't use a robocall or prerecorded message to reach you unless you have supported the charity in the past.
- They also can't call you again if you tell them you don't want any more calls from that charity.

If you hear from fundraisers who don't follow the rules, hang up and report them to the Federal Trade Commission at www.consumer.ftc.gov. Reports that include information about what is said during the call, and the names of the fundraiser and the charity, can help law enforcement agencies put an end to unfair and misleading practices.

Café Aroma – Hubert remembers era of inspired hip dining

Café Aroma's most recent owner, Hubert Halkin said, "It was a time in my life when I was an adventurer, primarily paragliding and hand gliding. Case in point, above Black beach is the UC San Diego chancellor's home and, as chair of the math department at UC La Jolla [UCSD], I felt it my obligation to arrive at a reception he was hosting on a paraglider," Halkin recalls. "But 50 years ago, it was rock climbing that first enticed me to Idyllwild; after that first visit nature took its course."

Halkin's adventurism doesn't stop there. With no restaurant or business experience, he bought Café Aroma in 2002. "I had no interest in anything remotely like a restaurant except that a colorful guy with a lot of style named Mark Steinfeld created Café Aroma in Idyllwild. I got the idea of a restaurant which would form the basis for a social club to support the artistry of music, painting, poetry and the retired prototypical, 'intellegencia' that occupy this forest."

"I never intended to be a business man. On my business cards I always listed myself as 'Accidental Owner,' said Halkin. Through Halkin's lens an auspicious vision took shape. Conversationalists of all ilk and idle met often to hold court on a vast array of topics. Writers could write all day on a few cups of coffee, no problem. Proposals of all manner floated in the air between friends, partners and lovers. For 16 enviable years Café Aroma served up much more than dining in an eclectic space.

Music, often extraordinary, performed by eclectic local or regional talent surrounded most every meal. The Café also benefited from reviews by the Los Angeles Times, Urban and Yelp to keep tourists in the know. Counted on for superb meals this quintessential space held a serious sweet spot for authentic connecting between locals. Halkin remembers the Caines [Geoffrey and Renate] were a fixture for a decade, sharing daily breakfast with friends come rain or shine at table 3.

"Herb Jeffries, a lyrical tenor, performed with many bands in the U.S. and Europe, owned a nightclub in Paris, made movies in the 1940s and was the last surviving member of the Duke Ellington band, lived in Idyllwild. He became so totally enamored with the town we named a room after him in the restaurant. We held his 95th birthday at Aroma only to find out that when he was 15 he lied about his birthdate and it stuck. His wife only figured out his true age at the party. He would sometimes arrive at the Café at 7 a.m. and chat with anyone who would come by, in true raconteur [story teller] fashion, he stayed one day until 11 p.m.," recalls Halkin.

"When I bought the Café Aroma, I became friends with prominent jazz musician Barnaby Finch. Barnaby often played music at the Paradise Café on the corner of highways 371 and 74. He was also an interesting person who struck a delicate balance between art and science. His was a well-founded decision to become a musician, but it was always in the offing should he decide to become a mathematician. Due to our friendship, Barnaby became my mentor in designing the musical program for

Aroma," said Halkin.

"Daniel Levy is a prominent professor of microbiology at the USC, and his wife Jane plays viola. Daniel Levy also grew up wondering whether he should pursue music or science. He flipped a coin and chose science. He and his wife are great supporters of IAA and annually held a benefit in their studio which I never missed," said Halkin.

"What I love about Idyllwild are the artists, visual, musical and literary, and most especially those rare individuals who straddle both camps, the arts and sciences ... I have a story to tell you," Halkin mused. "When we bought the Café, there were few musical events in town. Within 10 years on one weekend there were twenty seven! I think we added to that legacy.

"The cultural history of Café Aroma also includes plays, and the first play starred Mick Lynch, playing an Irish drunk, and, oh, how he nailed it! It was a sensational play. The beat poetry nights organized by Myra Dutton have been integral, so much talent lives here, they never missed a beat," Halkin added.

"We also had a hiking club who met at the Café. Dore Capitani placed one of his amazing metal bowls in a tree at the Café which we love. To see all the extremely unusual people who live here and the art shows we sponsored at the Café, plus we even own a painting by Audrey Carver, a graduate of IAA. I'm sure I am missing quite a few contributors to the scene at Café Aroma. Our manager, Ken Carter has a remarkable life as an impresario, musician, vocalist, screen writer, film maker and restaurateur. Wendy Fender is also amazing," said Halkin.

Manager Ken Carter orchestrated an incredible period in Aroma's final two year history under Halkin's ownership. He led an amazing staff, some who'd worked there for 10 years, with a management style that brought to bear southern hospitality coupled with an artist's eye.

"First time guests after a day hike who found themselves eating gourmet food on an uneven deck, listening to outstanding live music surrounded by eclectic art in a pristine forest setting, would often ask 'Where are we,' much like the way Feng Shui rules physical space design in eastern cultures. There's something special about the energies in Idyllwild," said Carter.

"Our chef Ryan Darling, aka Peanut, was a naturally

Ginger and Her Hoosier Daddys send up tunes that are the bee's knees

Danceable music of the 1920s and 1940s

Editor's note: This band was originally scheduled the week of the Cranston Fire. The Idyllwild Summer Concert Series was extended to allow the band to return for the last concert of the summer.

Ginger and bandleader Ginger Pauley does not just perform popular music of the flapper and big-band eras, she embodies the style, elegant insouciance and zest of those popular periods. She is, to quote a popular catch-phrase of the times, the "Bee's Knees." She brings music of the '20s and '40s to her rescheduled appearance on Thursday, Aug. 30, for Ken Dahleen's Idyllwild Summer Concert Series.

Yosemite-area native and trained as an actor, Pauley emigrated to the Southern California entertainment scene to develop her career. Not surprisingly, given her flapper flair and looks, Pauley landed a five-year gig playing kittenish cartoon character Betty Boop at Universal Studios in Studio City.

Since, according to many, the character Betty Boop is based on '20s singer and actress Helen Kane, it seemed natural for Pauley to hang out and sing with the park jazz band, doing many of Kane's songs. Kane became a pop icon in the '20s with her teasing renditions of tunes such as "I Wanna Be Loved by You." At the end of the first lyric, Kane added a word riff that became her signature — "boo boo ba doop." And as the phrase caught the imagination of the public, it seemed to catch the flirty flavor of the 1920s.

One of the Universal Studios Park jazz-band trumpet players, Corey Gemme, mentioned to Pauley that he had a friend with a '20s and '40s big band that needed a singer. Without even an audition, just Gemme's recom-

mendation, Pauley found herself on a plane to a jazz festival in Spokane, Washington, with musicians she had never met. "The first time the guys heard me sing was on stage," said Pauley of the start of what would become her signature style as a singer. The band embraced her. "They weren't just great musicians, they were great people," said Pauley of the Spokane festival. "I still use those guys."

In 2009, during the economic downturn, it became harder to fund transportation for big bands, and gigs became fewer. Pauley, who had transitioned from actor to big-band singer, made another transition. "I thought we could do the same music but with a smaller five-piece band," remembered Pauley. Girl singer Pauley became bandleader Pauley with the formation of Ginger and Her Hoosier Daddys.

And just as the previous big band had played danceable tunes of the '20s and '40s, so did Pauley with her smaller ensemble. "We can jump from a five- to nine-piece band depending on the gig," said Pauley, happily in command of her merry band.

Her '40s tune roster includes honeyed standards "Blue Skies," "I'll Be Seeing You" and "It Had to Be You." "We sometimes play some tunes from the '50s and some Mardi Gras favorites to show our versatility," said Pauley.

Joining her for her Idyllwild gig are Gemme on trumpet and trombone, Chris Dierl on sax and clarinet, Paul Kosmala on piano, Bobby Barron on bass and Michael Velasquez on bass.

Pauley is the host, co-producer and music supervisor of her own show "Vintage America With Ginger." The first episode can be found on YouTube and the other episodes will be airing soon on the Internet. "It's a very uplifting show about vintage America; what it was and what it is today," said Pauley. The show won an award for Best New Series for the Indie Series Awards, an international awards show for web series.

This is Pauley's first Idyllwild appearance. The music she and her Hoosier Daddys will be playing will "take you back."

"I do this music because I love the history of it and like playing it to educate new audiences about those periods, especially young kids," said Pauley. "I do it to keep this music alive and to hear comments, as we often do, 'Oh my gosh, that really took me back.'"

Ginger and Her Hoosier Daddys take the stage at 7 p.m. Popular local singer Sandii Castleberry opens at 6:15 p.m.

There is no charge for admission. Donations are always appreciated since Dahleen books and contracts acts for the series with insufficient cash on hand to fund the series.

Master violinist makes Mountain Center home

Violin virtuoso and recent Mountain Center resident Farhoud Moshfegh admits, "I collect beautiful instruments in an almost obsessive way. The history of the instruments and their players are etched in their veneer and tell a compelling story of each instrument's journey. These represent stories I cherish."

Moshfegh's intriguing journey began in the walled Jewish ghetto in Arak, Iran where he was born. By age 9, he was selling cloth in the bazaar, ultimately becoming a wealthy businessman and one of Iran's largest landowners. But the arts called to his heart and at age 19, he traveled to Munich to study violin, followed by several years playing in a chamber orchestra in Taiwan.

Continuing to follow his passion, Moshfegh graduated from the Belgium Royal Conservatory where he studied with violinist André Gertle, obtaining both a world-class education and an introduction to his future bride Dubravka, a fellow Croatian student.

Moshfegh went on to attend Budapest's Bartok Seminar; and Salzburg, Goslar, Weimar and Siena masterclasses. He studied with A. Gerller, L. Basil, J. Laurent and W. König, with performances in Europe, the U.S. and Asia, and became a director of Vivace Ensemble and a member of Duo Affetuoso. The couple traveled extensively both living and performing all over the world.

But their favorite home, if only for a short time, was in one of Persia's historic art centers, Tehran. The Islamic Revolution would soon derail the lives of countless Iranian artists including the Moshfeghs.

"I got a call that the committee wanted me to come in and explain some things," he recalled. Knowing the execution of Jews and intellectuals had begun, they migrated to Newton, Massachusetts the following week. Moshfegh continued playing in orchestras while teaching violin at the New England Conservatory and raising three children, Sarvenaz, Ottessa and Darius.

"I was attracted to teaching. I think it's a great pleasure to be presented with a blank canvas. Seeing everyday progress brings me great joy. I've even seen people confront psychological problems finding peace through music's soulful expression. Learning an instrument is like a religion, you just go with it and it practically becomes your existence. It can become your life," said Moshfegh.

"When I teach, I lose track of time. But seriously, magnetism comes from within for a violinist, and while I can excite the student or help them connect with something

hidden, the truest talent comes from those with pure emotion for the work and for the audience.

"I think for a student to put a stamp on their work with personal interpretation requires forming a connection between a person's soul and instrument, this can be attained by singing. The first thing I recommend to any instrumentalist is to sing in a chorus and to solo if possible.

"Singing connects the ear to what they want to deliver through their instrument. If they can sing musically, then they can play musically. You can play with your brain, but if you can use your brain to play through your heart... then you complete the circuit," said Moshfegh.

Teaching violin at the New England Conservatory in Boston for 38 years led Moshfegh to a 15-year role as artistic director of Project STEP (string training education program), a National Arts and Humanities Youth Program.

The program began around 1980 when the Boston Symphony Orchestra, under the leadership of Personnel Manager Bill Moyer, began wondering why few people of color were trained in classical music to the degree required to participate in this world. Moyer thought the 103-member BSO looked like a club for white people and he made it his mission to change that.

Project STEP founders envisioned a world in which the classical music profession reflects the racial and ethnic diversity of our communities. Addressing this imbalance meant identifying talent and promoting rigorous professional musi-

cal development until students entered college.

Institutional sponsors include the Boston Symphony, the New England Conservatory and Boston University. Within 12 years, similar programs were operating in Pittsburgh, Dallas and Louisville. For more than 30 years, Project STEP is considered very successful, with the vast majority of graduates going on to college or conservatory.

Upon his retirement, Moshfegh's eldest daughter Sarvenaz told her father, "I'd like to live somewhere in the rural West with some land I can farm." Sarvenaz is a cellist, an accomplished actor and creator of a genre of survivor's improv theater.

In April, Moshfegh with his daughter Sarvenaz and her two children, packed a U-Haul with a grand piano, 200 violins, 10 cellos, some furniture and paintings, and moved from Boston to Mountain Center. "My instruments have traveled with me for over 50 years," he smiled. "One of my favorite occupations is the repair of violins. I've found violins in a hundred pieces and literally brought them back to life."

Moshfegh will continue tutoring violin students in his new life. His musical favorites are Bach's solo violin sonatas. "These are really like a violinist's bible." His short list also includes Mozart, Brahms and Beethoven. "I also enjoy playing works by the Hungarian composer Bela Bartok."

passionate and gifted chef who proved in some ways his lack of training meant he didn't know you don't serve four star food produced in a kitchen designed for a coffee shop into a venue that's little more than a polished up picnic area. He just delivered the best he could come up with French, Nuevo Latin, Asian and So Cal influences. The result was a consistently four star menu served in simple style," chuckles Carter.

"You can see a parallel in this to Idyllwild itself. The Café Aroma was a distillation of all that is Idyllwild," said Carter. Hill Champion once said to me "You've relit the fire in the fireplace, it had gone out."

As a musician Carter installed a little marquee, built a small stage added a curtain and lights, invited musicians in six nights a week, and set easels on the street so chalk board art announced music. The last few years have been peak Aroma! The artistic improvements Carter made include Gary Kuscher's handmade manzanita railings, lowering a wall, a return of artwork to niches plus subtle changes to the back gallery walls to include large pieces.

"I was responding to what Hubert created by adding inexpensive elements. We began using the back deck for special events, which I'd hoped to develop into a Tapas Bar. Both the Casey Abrams room and Herb Jeffries room lent their enduring auras to the Café's unique style. This was Hubert's extraordinary commitment to have live music six nights a week and three

times on Saturday and Sunday," said Carter.

Hubert Halkin said in closing, "Now I'm unable to manage without electricity, so we escaped the recent fire with the two cats to the desert. I remember, when the electricity went out during the 2013 fire, I went to Fairway to buy ice. The manager said, "I can't sell anything the registers are down." I said here's \$500 cash for all your melting ice, we struck a deal and the ice saved all our food."

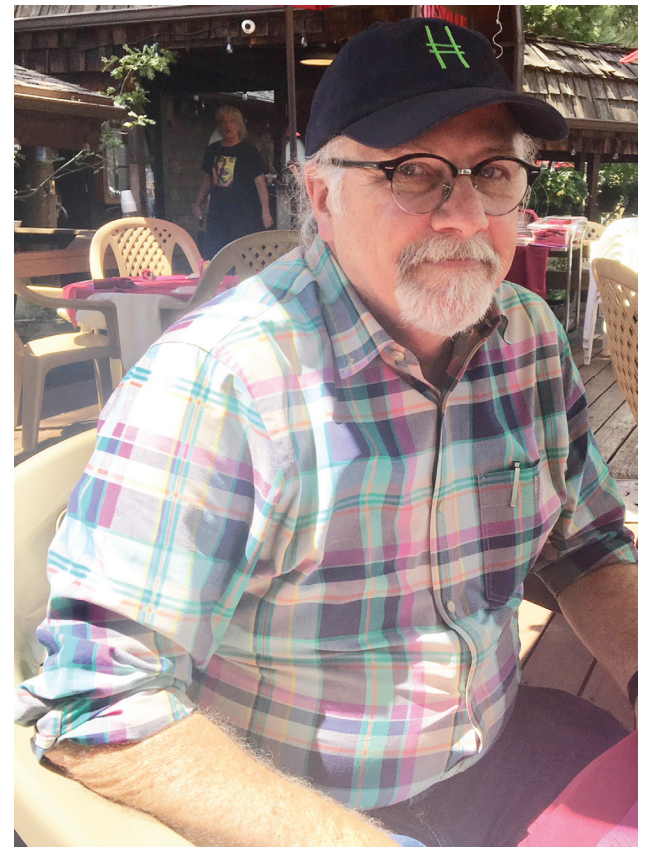
"During this recent fire, Wendy called at Ken's request to ask to take the food to Paul White at the Bake and Brew for the fire fighters. They ultimately transported it all to the portable fridge at the fire department and I recently received a thank you from a firefighter's mother for the lobster tail dinner her son thoroughly enjoyed. A fitting end I think," Halkin continued.

"My health is taking all my attention these days, and at 82 I think it's probably appropriate," he said, "The best decision I made was to marry Kathy 15 years ago, if we hadn't married I might be dead. I bought a home in La Jolla for my retirement, but I'd rather be here, gazing out my window."

"Regarding the renovation sign, the place has been for sale since March. We are receiving bites and believe an offer is coming so some redesigns are under consideration," Halkin said in closing.
