# Time-of-use rates being implemented by Edison

#### Businesses now, residential customers will shift in 2020

Microwave dinners will become more expensive beginning in October 2020. That is when Southern California Edison will begin shifting all its residential customers to timeof-use electric rates. And evening electricity will cost more than lunch time.

Beginning next month, new time-of-use periods will be applied to business accounts, most of which are already on time-of-use.

# Winter rain and snow keep falling in Idyllwild area

#### More expected this week

In the past week, 6 to 8 inches of snow and rain have fallen in town, much of the snow accumulating. More snow fell on the communities to the north. And the bitter cold weather helped snow fall in Garner Valley, the eastern edge of Anza Valley and as low as about 3,000 feet.

As of Monday morning, the U.S. Forest Service's Keenwild Ranger Station recorded about 1.75 inches since midnight Monday, Feb. 4. Most of that rain fell before the weekend, which was colder and brought more snow. From Friday through Sunday, .4 inches were recorded at Keenwild.

More rain is expected to begin Wednesday and continue through Thursday when another atmospheric river passes over Southern California.

From Oct. 1 through Jan. 31, Keenwild recorded 10.5 inches of rain. The long-term historic average for that period is 11.8 inches.

Historically, February brings about another 4.5 inches of rain. Since Feb. 1, 5.25 inches have fallen at See Winter, page A 3

## Ruiz sees potential to work with Trump

Local Congressman Dr. Raul Ruiz shared with the Town Crier his thoughts about President Donald Trump's State of the Union speech.

Ruiz acknowledged that the inconsistency between the president's actions and statements creates a basic skepticism about the intent of the speech.

Nevertheless, "There are some

topics we're very willing to work with him," Ruiz said.

Among these are Ruiz's long interest in reducing the cost of pharmaceuticals and medicine. Investing in an infrastructure for the future is another important issue, of which he feels there is room to reach concurrence.

"And important in this district is ending the HIV epidemic," Ruiz stated. The 35th District has six times the national average of HIV cases, according to Ruiz.


Ruiz attended Trump's State of the Union address Tuesday evening, Feb. 5, and brought David Sherman, a local officer with the U.S. Transportation Security Administration from Desert Hot Springs, as his guest.

Bipartisanship and cooperation between the administration and Congress is possible, Ruiz stated. His own experience with the administration's plans to combat the opioid epidemic helped him see the potential.

"I attended meetings, and offered expertise and served up ideas as a member of the minority panel, and voiced my opinion during the mark-up," he stated. But he is not convinced the ideas emanating from the SOTU reflect willingness and openness to multiple viewpoints.

Ruiz compared Trump's current statements urging a plan to reduce the cost of prescription drugs with his administration's






# Weather conditions affect Hill roads contributing to traffic crashes

# Four crashes on Hill roads


Winter conditions were partly to blame for Hill crashes over the last week, including one serious incident involving a felony DUI. California Highway Patrol Public Information Officer Darren Meyer, the source of these reports, cautioned residents and visitors alike that winter conditions on the Hill can be dangerous and require extra measures of caution when driving.

At 10:06 a.m. Wednesday, Feb. 6, David Barajas, 27, of Hemet, was driving a white 2000 F150 eastbound on Highway 74, 1/4 mile east of Southfork Trail, when he encountered a shady section of the highway with patches of ice. Even though proceeding at a low speed of 35 mph, according to the CHP report, Barajas lost control of his vehicle, struck the mountainside and overturned. There were no passengers and Barajas was not injured in the crash. His vehicle was towed by Castellanos Towing of San Jacinto.

At 10:25 a.m. Friday, Feb. 8, David Salk, 70, of Idyllwild, was driving a white 2003 Nissan Pathfinder northbound on Highway 24, 3 ¼ miles north of mile marker 19, when he hit a patch of ice and snow on the road, causing the vehicle to collide with the mountain. Salk suffered minor injuries in the crash but declined transport. His vehicle was towed by Idyllwild Garage.

At 8:30 a.m. Sunday, Feb. 10, Jose Carranza, 22, of Rancho Mirage was driving a silver 2002 Acura TL westbound on Highway 74 just west of Apple Canyon Road on an uphill stretch of the highway, when he made an unsafe turning movement, causing him to lose control of the vehicle. The vehicle struck a metal roadway edge marker, overturned and slid about 30 feet down an embankment.

There were three passengers. All suffered injuries. In the vehicle were front passenger Fernando Pichardo Jr., 26, of Rancho Mirage, back seat behind driver passenger

Christy Ledezma, 22 (residence not noted in CHP report), and back seat behind front-seat passenger Francisco Magana, 28, of Palm Springs.

Carranza was cited at the scene for driving under the influence and was arrested. Carranza suffered minor injuries and was transported by Idyllwild Fire ambulance to Desert Regional Medical Center in Palm Springs.

Pichardo suffered major injuries and was transported by Mercy Air to Riverside University Health System Medical Center in Moreno Valley.

Ledezma was transported by Reach Air to Riverside University Health with life-threatening injuries.

Magana was transported by Idyllwild Fire to Desert Regional Medical Center with life-threatening injuries.

One of the patients being transported by Idyllwild Fire became combative in transit causing the ambulance to pull over at Paradise Corners. A Riverside County Sheriff's Department car was in the area and responded to the scene at Paradise Corners, as did the CHP car that had investigated the crash

site and followed the ambulance to Desert Regional Medical Center.

Meyer noted that with head injuries, it is not uncommon for patients to become unruly or combative and his report did not note which of the injured had become difficult.

In what Meyer characterized as snow incidents that are not always logged as traffic collisions, at 6:10 p.m. Friday, Feb. 8, a Honda was noted on its side just north of Vista Grande. CHP Officer Bell requested a flatbed for towing and noted solid ice at the scene. Cal Trans went to the scene to scrape and sand ice. There was no information identifying the driver in the CHP log other than it was a non-injury

Likewise, on Sunday, Feb. 10, two vehicles were seen stuck in snow conditions at 12:14 p.m. at Marion Ridge and Highway 243 in Pine Cove. The vehicles were noted by a CHP cruiser heading to another incident. When the Riverside County Sheriff's Department patrol car arrived at the scene, the deputy was unable to locate the vehicles or document the incident.

### Life Tribute Ron Perry 1939-2019

On Saturday, Jan. 26, 2019, Ron Perry greeted the sunny morning with his usual enthusiasm and delight at living another day in paradise. After two passionate games of pickle ball with friends, he dozed off and passed away.

Born in Monterey Park on July 17, 1939, Ron served in the U.S. Air Force for four years at Nellis AFB in Nevada where he learned to program computers. He

moved to California and worked at Honeywell, Sperry Univac and the Atomic Energy Commission. For 40-plus years he ran Incompass Inc.

A pioneer of early road rallying with the Sports Car

Club of America, he won many races and owned iconic American muscle cars. His family enjoyed trips rock climbing, hiking the mountains by Lake Isabella and riding dune buggies. Ron was an avid sportsman, playing his heart out at beach volleyball, racquetball and pickle ball.

Community service included serving as president of his HOA in Irvine and working with the Irvine Police Cepartment.

In Idyllwild in 2004, he married Doris. He served on the Pine Cove Water District Board of Directors, and volunteered with Mountain Disaster Preparedness, the Idyllwild Area Historical Society and for 16 years, the Mountain Communities Fire Safe Council as vice-president, GSOB hunter and Woodie.

Survivors include his wife Doris Lombard; his son,-Jim (Marsha) Perry; daughter Renee Perry; grandchildren, Clara, Samuel and Hannah Perry; brother Ken (Ikuko) Perry; sister Lynette (David) Perry Hoffman; and brother Michael Perry.

Keenwild and the total since Oct. 1 has been 15.75.

While the National Weather Service is forecasting drier weather in the next several weeks and month, temperatures are expected to remain well below normal for late winter.

In the short-term, drought conditions are likely to be lifted, but they may return during the summer.

Cal Fire's Predictive Services unit has advised local firefighters, "Widespread heavy rainfall during the past 30 days continues to drive rapid growth of fine fuels at lower elevations. ... This will go a long way to maintaining robust growth of seasonal grasses as well as brush and shrubs below 3,000 feet ... which may pose a problem once these fuels begin to cure toward May. Therefore, there may be a spike in grass fire activity compared to most years since 2011."

# Lane plans to take on Washington again

Randon Lane, mayor pro-tem of Murrieta, has announced that he will challenge incumbent Supervisor Chuck Washington for the 3rd District seat on the Riverside County Board of Supervisors.

In 2016, Lane finished third in the June primary to Washington. Shelly Milne was second. Washington won the general election in November.

In his announcement, Lane said, "Over the last four years, Supervisor Washington has been absent from the district. During difficult times we need leaders who can make difficult decisions and we have not seen that from the 3rd District. Unfortunately, Supervisor Washington has closed the door on Riverside County's working families and it is now time for new leadership that will

show up and be a voice for every-one."

Lane has served as Murrieta's mayor in 2011 and 2016. He was first elected to the City Council in 2008. Previously, he served on the city's Planning Commission. In December, the Riverside Transit Agency Board of Directors unanimously chose Lane to lead the 22-member governing board for the upcoming year.

On the basis of his Murrieta experience, Lane also added, "The Third District needs strong leadership that supports limited government and accountability, fiscal responsibility that is fair to our working families and a bold course of action that will bring new life to the Third District and Riverside County. I believe my vision for the future of Riverside County and my track record in Murrieta demonstrates I am the best candidate for this posi-

Many women, men and healthcare providers are still unaware that heart disease is the number one killer of women, causing one in three deaths each year. Women do less well after a heart attack then men. This is true even for women un-

What are the signs of a heart attack in women? They are not the same as in men.

Women are less likely to experience chest pain with heart attack than are men. Women tend more to experience pain or discomfort in one or both arms, the back, neck, jaw or stomach; shortness of breath, sometimes without any chest discomfort; and other signs such as breaking out in a cold sweat, nausea or lightheadedness. These symptoms signal that a woman is in a health crisis and needs medical attention right away.

There also is a "silent heart attack." According to the American Heart Association, "People who have these socalled silent heart attacks are more likely to have non-specific and subtle symptoms, such as indigestion or a case of the flu, or they may think that they strained a muscle in their chest or their upper back. It also may not be discomfort in the chest, it may be in the jaw or the upper back or arms ...

"Some folks have prolonged and excessive fatigue that is unexplained. Those are some of the less specific symptoms for a heart attack, but ones that people may ignore or attribute to something else."

Women tend to sluff off any of these symptoms, insist that they are fine and rely on their natural strength to set things right. However, all of these symptoms signal a medical emergency. 911 should be contacted. (Check out the last

Knowledge plus prevention are always the keys to health. See the first link above, "Living Guidelines for Women," providing every piece of info you need to stay heart healthy at any age. Great news: Recent medical research shows that even small, incremental changes create a healthy difference

Being physically active plays a major role in heart health. If you haven't been that active for a while, then start slow and gradually work your way up to 30 to 40 minutes of exercise three to four times per week. Take as long as you need to be successful. And consult your healthcare provider.

Did you know that the more you sit, the higher your risk for heart problems? Try standing when you'd normally sit, like when you're watching TV. Try setting a reminder on your smartphone to get up and move once an hour. Walking, even short brisk walks for as little as 10 minutes per day, can provide enough physical activity to keep your heart in shape. Taking steps in place while holding onto a sturdy stable object works, too.



The purpose of time-of-use is to shift demand from periods where electric production costs are higher to lower cost periods. SCE's production and acquisition costs for electricity are now lower during the day than during late afternoon and early evening because of solar collection.

California produces a lot of solar energy. The best time for this is between morning and afternoon. As the sun begins to set, the solar source declines and disappears. Then, utilities must switch to more costly, traditional electric sources such as natural gas.

Consequently, the more demand that occurs when cheaper solar energy is available, the less cost to the utilities, which is why SCE is willing and wants to reduce electric rates during the day to shift as much usage as possible away from the high-cost periods.

Beginning in March, during the winter from Oct. 1 through May 31, from 8 a.m. to 4 p.m., will be the super off-peak hours for electricity costs for SCE business and agricultural customers. From 4 to 9 p.m., the rates will go to mid-peak. From 9 p.m. to 8 a.m., rates will be offpeak. This applies to weekdays, weekends and holidays.

Currently, business on-peak hours are from noon to 6 p.m. These hours change to from 4 to 9 p.m. next month.

The on-peak, or highest rates, will be applied from 4 to 9 p.m. weekdays during the summer months of June through September. The off-peak rates apply from 9 p.m. until 4 p.m. the following day.

This same pattern will be applied to residential customer rates beginning in October 2020. However, 400,000 customers were asked to volunteer for this system two years ago. So far, nearly 90 percent have retained the time-of-use rates.

Residential customers can visit the SCE site (www.sce.com/rates) to see how time-of-use would affect their rates. They have the option to choose time-of-use now, according to SCE Spokesperson Ron Gales. SCE will guarantee that during the first 12 months, no residential customer on time-of-use rates will pay more

Another way to gain lower rates is to agree to critical peak pricing, which businesses will be shifted to in March. This plan offers lower summer rates if the customer agrees to higher rates on 12 days throughout the year. These days will normally be the hottest expected days in the summer.

Again, this is an effort to shift demand away from high-peak usage, such as when homes, offices and businesses are all blasting air conditioning or fans. The CPP rate, which is significantly higher than normal, is only applied to electric use during the 4 to 9 p.m. period. Customers, if they sign up in advance (www.sce.com/CPPupdatecontact), will be notified a day before the CPP will be applied. The notifications can be by phone, text or email depending. It's up to the customer.

Business customers newly enrolled in CPP as of March 1 will receive 12 months of bill protection," Gales wrote. This means that if the CPP rates result in a total higher cost than the current rate schedule, SCE will credit the difference.

Shifting more demand to daytime also will result in greater usage of renewable energy sources and less dependence on carbon-based sources.

The California Public Utilities Commission approved the time-of-use rate concept in 2015 and it applies to the three major electric utilities. In March 2018, San Diego Gas and Electric began shifting its customers to the time-of-use plans. SCE and Pacific Gas and Electric have until October 2020 to move all customers.

Several tests and experiments were conducted during the interim years. The results showed that customers save money, however, they also indicated that many do not actually know the cost and understand the time periods.

SCE plans a major education and promotional campaign when it begins shifting residential customers. This winter, several information brochures and letters were sent to business customers to help them better gauge the change.

Johnson and Chief Financial Officer Don Kent presented the mid-year review for fiscal year 2018-19.

First, they described several added

costs that were already expended and, therefore, had to be funded in the budget. Examples include more funds for general assistance in the Department of Public Social Services, additional costs the county incurred during and after the Cranston and Holy fires. These total about \$1.9

In total, the board approved another \$12.9 million for programs and maintained the budget contingency account at \$20 million.

Johnson then advised the board that another \$20 million would likely be needed before the end of the fiscal year (June 30). This will help the Riverside University Health System, the District Attorney's Office and supplement (\$300,000) the Public Defender's Office.

Actually, these adjustments are a harbinger of future budget issues. Although revenues have been increasing, Kent noted that property taxes have averaged a 5-percent growth for several years. However, Johnson averred that softening the economy is inevitable in the next few

Whenever that may occur, Kent described another \$350 million already planned for budgets from fiscal years 2019-20 through 2022-23, the next four

Current budget looks stable

"The board understands the cost pressures this county is facing and the significant fiscal challenges ongoing that we must address and continue to address," Johnson said. He then began a summary of future planned and unplanned budget requirements.

The largest is the operational costs for the John J. Benoit Detention Center about to be opened in Indio. This approaches \$140 million in those four years. Also, a lawsuit ensuring the inmates health care and mental health services will add another \$38 million to future budgets. And the RUHS is constructing a new medical office building.

But the truly ominous prospect includes about \$220 million, which is not part of future budget planning, but must be addressed. Inmate healthcare will consume more than half of this estimate. The RUHS will need funding to equip the new medical building and even the fire department is projecting future increases of more than \$20 million.

Board members had few comments or questions about the budget status or forecasts. However, new Supervisor Karen Spiegel noted that the costs for the inmate healthcare and mental health services are included in the RUHS account. It was unfair to attribute the higher expenses to RUHS since it was for the coun-

Also, and not addressed during the mid-year review, is the county's growing pension costs, which could be \$50 million over this period.

past actions to reduce the healthcare insurance options for millions of people. Ruiz does not see a common path for these two efforts.

When the president says reduce or cut prescription for all, that sounds good," Ruiz said. "But look at what they have done ... He has repeatedly tried to repeal medical expenses and benefits."

his statement, Trump urged bipartisanship on the battle against HIV and AIDs. "In recent years, we have made remarkable progress in the fight against HIV and just as adamant that last AIDS. throughs have brought a once-distant dream within reach," he said. "My budget will ask Democrats and Republicans to make the needed commitment to eliminate the HIV epidemic in the United States within 10 years. Together, we will defeat AIDS in America."

Ruiz is a strong advocate of this effort, yet he noted, "The president has tried to reduce coverage for HIV medicine and HIV patient access to Medicaid."

Going further, Ruiz pointed out that eliminating the Affordable Care Act's protection for pre-existing conditions often pe-

nalizes those with HIV. "This discriminates against them by raising the cost of health insurance.'

Working together, Congress and the president, requires an acknowledgement that Congress writes and passes the laws; the president reviews signs them, Ruiz emphasized.

While he concurs that a federal infrastructure program would benefit the nation, he was not sure how Congress and the president could achieve agreement on funding. If the Republicans demanded that the added costs come from existing programs, Ruiz is Scientific break- year's tax law changes be

modified. "I think there are a lot of opportunities to look at how the tax law overwhelmingly and disproportionately benefited very few rich and powerful families in our nation," Ruiz noted. "This is not based on conservative fiscal policies." The infrastructure legislation has to ensure that everybody benefits, he urged.

Even the meaning of infrastructure may be another challenge. "Infrastructure of the future is guided by our imagination, not simply repaying dilapidated roads," Ruiz said. For example, he believes

broadband telecommunications capability is now a necessary element of current infrastructure.

This type of disagreement is similar to the stalemate on the funding for the border security, according to Ruiz. "A wall is a boondoggle and fiscally irresponsible," he stated. "We need to invest in scanning and screening equipment for ports of entry. That is where 90 percent of drugs and guns and dangerous people come through."

As he concluded, Ruiz stressed that future agreements and bipartisanship will be hostage to the details of each piece of proposed legislation. The president " ... didn't give any policy details."

Bringing Dennis to Idyllwild represents a coup for Haywood-Carter. Her entire faculty consists of film-industry veterans who understand the importance to a young artist's career, not only of skills, but of connections that permit observation of what industry success looks like close up. 





## Getting physical at Idyllwild Arts

Idyllwild Arts Academy Theatre Chair Bonnie Carpenter has no doubt about the benefits of her department's recently begun partnership with Fiasco Physical Theatre (fiascophysicaltheatre.com).

A handful of Fiasco ensemble members take turns driving up the mountain from Los Angeles to teach at the academy for two-week stints. They train Academy Theatre majors in improvisation, acrobatics, physical theater, clowning, juggling, ensemble dynamics, Alexander Technique and commedia dell'arte. These are already valuable as supplements to the more familiar acting, singing and dancing skills that Carpenter's department teaches so well.

"But it's also about teaching the self-motivation and discipline that the Fiasco members model," Carpenter said. "Our students see Moses and Kent and Yiouli using their spare time to create for their own company's performanc-

Moses Norton's wide range of physical-theater skills include mime and acrobatics. Kent Jenkins is a Youtube sensation as the Blue Man Group-inspired Snubby J. And Greek-born Yiouli Archontaki is a flamenco dancer and pianist (and much more, like both Moses and Kent).

The students have them in class, working hard to teach these physical-theater skills," Bonnie continued. "They could rest when class ends because they're tired, but instead they go straight to work on their own things. It's inspiring!"

The inspiring connection to Fiasco Physical Theatre comes through Carpenter's Theatre Department colleague Erin Crites, now in her fourth year at the academy and also a Fiasco ensemble member.

Crites' excitement about physical theater is supported by UCLA Psychology Professor Albert Mehrabian's research (tinyurl.com/yb7ds7xv) suggesting that 55 percent of our communication is nonverbal. As vice president of Clowns Without Borders (clownswithoutborders.org/), Crites has brought the power of nonverbal communication to refugee camps and other trauma-affected areas where little English may be spoken.

Happily, trauma is in short supply at Idyllwild Arts Academy. But little English is spoken by some of the new international students who arrive every year, and Carpenter points out that incorporating more physical theater into her department's curriculum "can increase our international enrollment."

Talented international students can add a lot to her department, Carpenter suggests, noting the importance of the "inclusion of diversity."

Of course, the Theatre Department's American students also benefit from physical theater. For one thing, English itself can often seem foreign to native English speakers.

"Think of Shakespeare," Crites said. "A couple years ago I facilitated a 'devised' 'Hamlet' called 'Who's There a Reimagining of Hamlet' -adapted and performed by the academy's theater students. The foreignness of Shakespeare's language meant that focusing on nonlinguistic sensory qualities was helpful even to the native English speakers as they were trying to decide on the most important elements in the original 'Hamlet' and reimagine how to tell it."

Speaking of diversity, that devised "Hamlet" incorporated six different languages.

# Sixth Children's Film Fest part of Idyllwild Film Festival

The 10th-annual Idyllwild International Festival of Cinema will present its sixth-annual Children's Film Festival.

CFF films may be seen at 2 p.m. Wednesday, March 6, and at 2 p.m. Saturday, March 9. They will be shown at the Idyllwild Library and are free.

"I hope these films inspire the kids," Charles said.

"My favorite is 'Clark'; it's hysterical," Ng advised.

The viewers (children) of these films also will be able to vote for the best child's film. This award will be among all the other IIFC awards.


