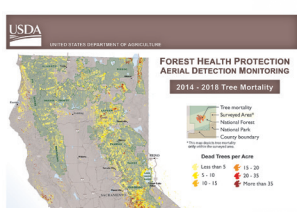

Lake Hemet Campground gets Valentine's Day flooding

Valentine's Day, Thursday, Feb. 14, was a wet day on the Hill, with 19 swift-water rescues taking place in various locations, straining the abilities of emergency responders.

Official rain total at Keenwild Station for Wednesday and Thursday, Feb. 13 and 14, was 7 inches. From Oct. 1 through late February, Keenwild recorded 24.8 inches of rain, whereas a full year of average rain is 24.5 inches.

With local soils already saturated and roads having sustained major damage, the likelihood of flooding after major rainfall was great.

On Valentine's Day morning, flooding became a challenge for certain monthly RV campers at Lake Hemet Campground.

Especially affected were those at premium sites abutting the campground meadow (Camp 1 Premium meadow view sites). Conditions changed quickly as water from a creek flowing under a bridge just east of the campground entrance breached a berm and began flooding the meadow.

Patricia Blaine, camp resident since October 2017, recounted she went out around

A season's-worth of snow in one week

It is safe to report that the drought has ended for this spring and possibly the summer of 2019. Whether it returns in 2020 is unknown.

But precipitation — rain and snowfall — data are sufficient to drench the dreaded drought for the duration of spring and early summer. While Monday and Tuesday were warmer, the National Weather Service forecasts slightly lower temperatures through the weekend and possibly more rain over the weekend.

The massive snowfall that occurred last week colored the Hill white. The first snowstorm was Sunday. Then from Wednesday through Thursday, another larger, stronger and colder storm passed


and measured in double figures. It is still melting but with marginal appearance of the ground surface.

The Idyllwild Fire Station recorded more than 10 inches, the most in Riverside County. But the temperatures were so low over the Hill that 8.5 inches of snow fell in Garner Valley. Two inches were recorded in Anza and measurable snow fell as far east and south as County Fire Station 30 in Pinyon Pines.

In fact, Highway 74 east of its intersection with Highway 371 was the scene of a major vehicle blockage Wednesday night into Thursday morning. Between 20 and 50 vehicles blocked the roadway. The California Highway Patrol and Riverside County Sheriff's Department focused on clearing the highway. The Riverside

Idyllwild Water considering incentive for employees to live near district

Village Center Drive project up for decision

When the directors of the Idyllwild Water District met last week, perhaps the imminent snow storm or the joy of the atmospheric river filling Foster Lake limited their attention.

But with only two items on the agenda, they deferred action on both until March. Further, they never discussed, at least in an open session, district goals, which had been promised at the Feb. 13 special meeting.


General Manager Michael Creighton, after one month in the job, recommended that the board postpone the pipeline project along Village Center Drive. One year ago, former General Manager Jack Hoagland had recommended that this was IWD's number one capi-

tal project priority.

Although the existing pipeline is old, the principle reason to move it along was that Riverside County was planning to resurface Village Center Drive in the summer of 2019. In order to avoid damaging a newly surfaced street and incurring extra costs for repaving, Hoagland recommended installing the new pipeline along Village Center Drive in September 2018.

For a variety of reasons, the work was



California losing millions of trees due to drought and insects

Northern California the most vulnerable area

The U.S. Forest Service reported that more than 18 million trees died in California during 2018.

As scary as that number appears, it is only two-thirds of the tree mortality in 2017, and only 30 percent of the number of trees that died in 2016. Since the recent drought started in 2010, more than 147 million trees have died in California.

But state and national foresters are not passive about this situation. Last spring, former Gov. Jerry Brown established the California Forest Management Task Force and current Gov. Gavin Newsom continues to rely upon its expertise.

More than half the forest land in California belongs to the federal government, 40 percent is privately owned and the state owns just 2 percent, which is why multiple federal, state and local agencies are involved in forest protection and restoration.

In the Forest Service press release, Randy Moore, regional forester for the Forest Service's Pacific Southwest Region, said, "The Forest Service is focused on increasing the pace and scale of ecological restoration — this includes thinning dense areas to promote healthy forests that are more resilient to wildfires, drought and bark beetle outbreaks. The Forest Service completed approximately 313,000 acres of restoration in 2018, which included over 63,000 acres of prescribed fire — the largest number recorded since the National Fire Plan was implemented in 2001."

Cal Fire Director Thom Porter noted the number of dying trees is beginning to fall. He also pointed to several problems on which both Cal Fire and the Forest Service must collaborate to protect California's forests.

"The stress of drought, insects, disease, and prolific

wildfire will continue to challenge the resilience of the state's forests," Porter said in the release. "In accordance with the 2019 Strategic Fire Plan for California, Cal Fire will continue to increase the pace and scale of fuels and forest management project work and grants."

Two days after the Forest Service announcement, the state's Legislative Analyst's Office made a presentation to the Assembly's Budget Subcommittee on Resources and Transportation.

The LAO independently supported the forest agencies, telling the subcommittee, "Most of the forests across the state are in an unhealthy condition."

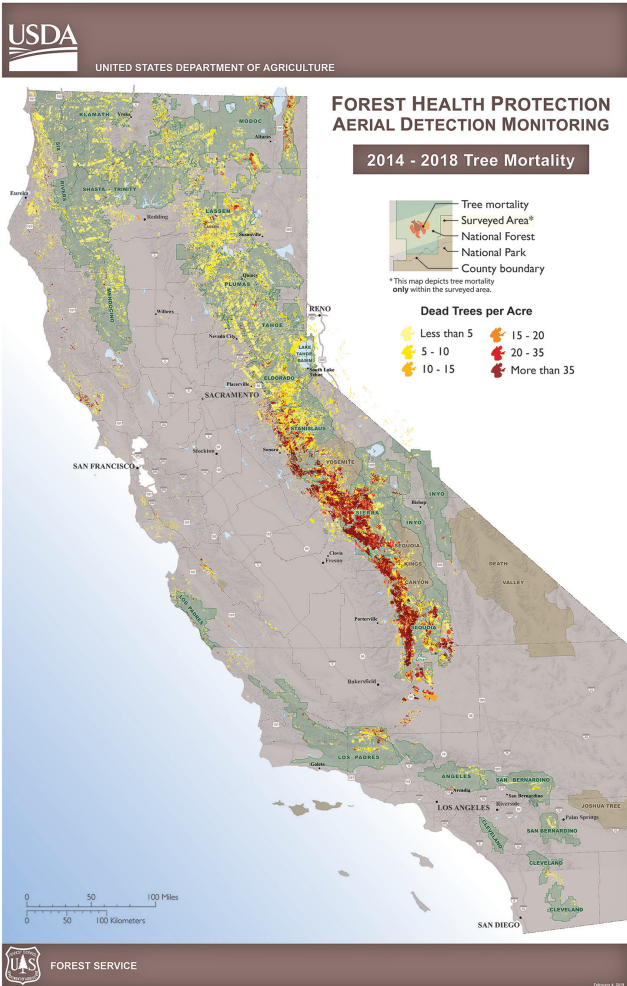
On Jan. 8, during his first full day in office, Newsom called for a five-year, \$1 billion forest management plan in his 2019-20 state budget proposal.

Locally, two major fires — the Mountain in 2013 and the Cranston in 2018 — burned thousands of trees, but the San Jacinto Ranger District is not in danger of deforestation.

On the entire San Bernardino National Forest, there are about 49,000 dead trees, according to Stephanie Gomes, the tree mortality information office for the Forest Service.

"At this time we have seen normal levels of mortality on the San Jacinto Ranger District (nothing close to the big beetle kill in the early 2000s)," district forester Charles Wentz said in an email. "Tree mortality is likely a combination of drought stress coupled with beetle attacks ... Again, I do not see widespread mortality across the district (minus dead trees caused by the Cranston Fire) ... If we continue to have a good spring I do not think we will see mortality climb above the current levels of a few small pockets of 1 to 3 dead trees here and there. Afterall, tree mortality is a natural part of nature."

The vast majority of dying trees is in Northern California. The 10 counties and the five national forests with the most dying trees are all north of Kern County along the spine of the Sierra Mountains (see accompanying map). In these 10 counties, nearly two-thirds of the dead trees were surveyed and more than 107 million trees

have died in the past nine years.

About three-quarters of the dying trees are white and red fir trees. Pines are about 10 percent. Oaks represent the balance of dead trees. While fewer than 40,000 oaks died in 2017, oaks dying from sudden oak death ballooned by five times to more than 200,000 dead in 2018. The Goldspotted oak borer, present in Riverside County and on the Hill, is the cause of about 25,000 dead trees in the past two years, according to the Forest Service survey.

County Emergency Management Department found warm shelter at the Anza Community Center and Cal Fire Station 53 in Garner Valley overnight for the stranded drivers and passengers. By Thursday morning, 13 vehicles were still trapped along the highway.

Over the weekend, CHP managed a checkpoint at Lake Hemet. Residents,

employees and renters were permitted to continue on to Idyllwild. But vehicles without any proof of need to be in Idyllwild were turned back, and many were, according to CHP.

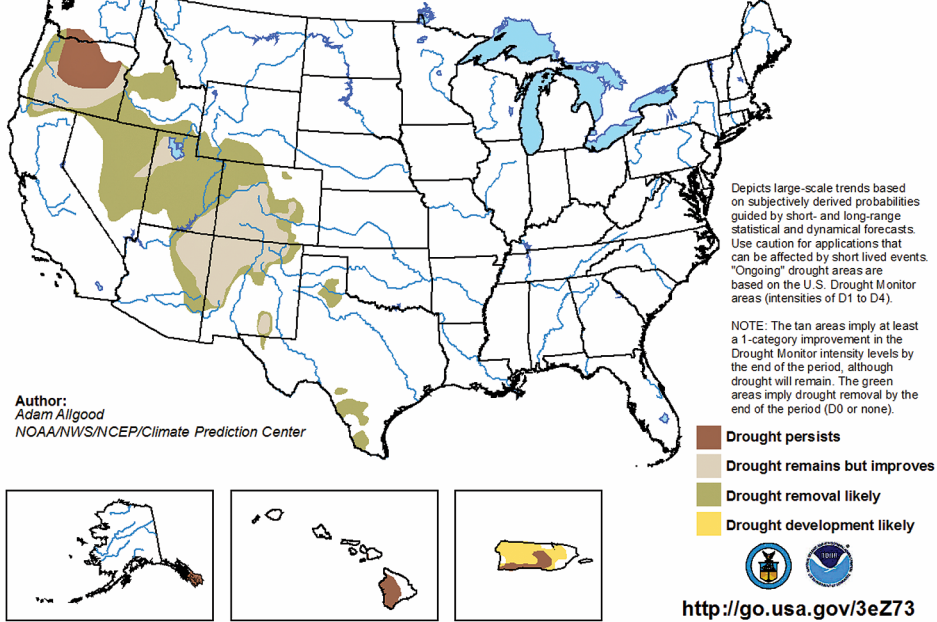
The U.S. Forest Service's Keenwild Ranger Station has recorded 24.8 inches of rain since Oct. 1. The long-term average rainfall during this five-month period is 16.3 inches and the March average is 4.1.

weeks is that the chance of precipitation is 40 to 60 percent greater than normal.

As of Monday morning, there has been no change in Caltrans' estimates of when highways 74 and 243 will be reopened. Highway 74 may be closed a month and Highway 243 may be several months from reopening. Friday's

press released stated, "long-term closure."

Idyllwild students riding the bus to Hemet High School will be driven through Anza. The ride begins one hour earlier and they arrive back in Idyllwild about an hour later than normal.

Quiet Skies Town Hall this Saturday to celebrate, commemorate, chart the course for 2019

Quiet Skies Idyllwild will hold a public meeting from 10:30 a.m. to noon Saturday, March 2 at Town Hall. The event will commemorate March 2, 2017 — the day the Federal Aviation Administration implemented new flight arrival and departure procedures at Los Angeles International Airport (LAX). The new procedures resulted in a new route that directs upwards of 250 audible commercial jets over Idyllwild on a daily basis. Speaking on behalf of the group, David Pearson said, “We lost a large part of our tranquility on the Hill that day.”

More than a dozen individuals, including musicians, business- and rental-property owners, hikers, new residents, and a naturalist, forester and aerospace engineer will discuss the impact of the FAA’s implementation of the new flight path. Attendees will be able to share their opinions, ideas and experiences during an open mic and participate in goal-setting for the remainder of the year.

The public meeting also will feature a demonstration of “over-flight noise,” informational handouts and the song “Quiet Skies Idyllwild,” written and performed by local musician-songwriter Terri Jo Stratton. The group will note its progress since its inception in May 2018.

As a part of the program, Field Representative Peter Carlstrom will speak on behalf of Congressman Raul Ruiz, M.D., who shared his concerns with the FAA regarding noise pollution and sleep loss in June 2018.

“As a physician, I cannot emphasize strongly enough the importance of sleep to a person’s overall health. Lack of a consistent sleep can result in reduced energy, changes in mood, and compromised immune system function, and an also make one more prone to serious medical conditions such as obesity, heart disease, high blood pressure and diabetes.”

At the group’s Feb. 18 meeting, Idyllwild resident Pamela Mayfield said she is “sleep deprived. I get woken up at all hours in the morning with airplanes flying over. I think I get the worst of the singing-bowl effect of [the mountain ridges surrounding our communities] and the reverberation of [jet engine] noise from the over-flights.”

Musician-songwriter and Pine Cove resident Jeff Hixon emailed the FAA Noise Ombudsman at 4 a.m., July 31: “... more than 35 noisy jets [are] flying over my mountain home ... since 9 p.m.,” he wrote.

“The noise reverberates for ... minutes, and then moments later, another one flies over. Then another ... and another ... and on and on. These constant flights are destroying our peace and happiness.”

The FAA Ombudsman responded in a form-letter Feb. 4, 2019. The Agency did not find any significant impacts to people, historic properties, parks or other applicable environmental resources when it completed its environmental analyses.

QSI members disagree with FAA’s assessment. It conflicts with QSI member observations and technical

assessments which show, “The jets come in swarms ... and are still climbing at 30,000 feet above sea level when they reach Idyllwild. Their engines are roaring and the sound from each overflying jet reverberates between two and three minutes. Ninety-five percent of the overflights are east bound departures from LAX. On a typical day, these flights begin before 5 a.m. and last until 2 a.m.”

Mayfield also described being “really annoyed while recently hiking Idyllwild’s Ernie Maxwell Trail. I made about 15 complaints to LAX’s complaint department during my half-hour hike.

“Maybe it wasn’t a good idea to bring my cell phone ... but the more complaints LAX receives [from us] the better it is for Quiet Skies.”

According to David Pearson, the group “has not found any record of the Idyllwild community being notified, nor even considered by the FAA during the planning [and] ... implementation” of the new flight path.

Ruiz helps with funding youth training program for Riverside County

Earlier this month, Congressman Dr. Raul Ruiz, D-35, and the Riverside County Office of Education announced a \$1,080,000 grant to expand vocational training and provide affordable housing for low-income families in the Hemet and San Jacinto region.

Ruiz’s funding will expand programs to train underserved youth in construction while building housing for homeless and low-income families

At the end of January, the RCOE was awarded a grant from the Department of Labor’s YouthBuild program, which provides federal funding for education and training programs across the country with the mission of helping underserved young people complete high school and learn valuable career skills. The RCOE grant was one of only six awarded in the entire state of California and 77 nationwide.

Over the next three years, this grant will supplement the labor funds and allow RCOE to expand its YouthBuild program to support another 61 underserved young people between the ages of 16 and 24. YouthBuild provides on-the-job-training for young people in the construction industry by hiring them to work alongside experts to build affordable housing for low-income and homeless families.

“This grant is a win for so many members of our community. It’s a win for our local economy, a win for young people learning valuable job skills, and a win for low-income families in need of affordable housing,” said Ruiz. “I was honored to successfully help the Riverside County Office of Education secure this grant, and I will continue to fight for grant funding that empowers young people and boosts our local economy.”

Missing man found dead

Riverside County Sheriff’s Department reported that the body of Piotr Jasinski Hopper, 62, of Idyllwild, who went missing from his South Circle Drive home Monday evening, Feb. 18, was found behind Fairway Market at about noon Wednesday, Feb. 20, according to Riverside County Sheriff’s Department Sgt. Ken Reichle.

The department posted a flier on its website and its Facebook page on Tuesday asking for any information on the whereabouts of Hopper who was considered at risk because he suffered from multiple medical conditions.

Hopper was last seen Monday evening at Idyllwild Pizza Company. He wasn’t reported missing until Tuesday afternoon. Sheriff’s officers and bloodhounds made a quick search without luck Tuesday afternoon.

Grid search was set up Wednesday and that’s when the body was found.


Reichle said he won’t know the cause of death until the coroner has released that information, but he thinks it was exposure to the elements. A spokesperson at the Riverside County Coroner’s office Monday said the cause of death is still pending.

Mountain life was stressful during and after the Cranston Fire. Like the Bee Canyon and Mountain fires, it felt like being on the outside looking in on a war zone. I have never been in a war zone. I've only lived in a war zone through tales told through books, movies and documentaries.

Looking back, the heat and adrenalin of that time seems unreal except now it's the cold and the adrenalin — dealing with frozen pipes over a three-day period when the furnace needs repair. The irony of lugging store-bought water while walking on frozen ice and snow to the house for what my mother would call “spit baths” and for basic chores.

And while we ponder the consequences of the collateral damage to our highways these past few storms have wrought, Mother Nature continues on. The mountain seemed to melt around us. We just happened to be here when it did.

Caltrans spokesperson Shane Massoud told JP today that its engineers are estimating Highway 243 to open in five to six weeks. To me, that seems like a miracle. To imagine replacing a mountainside seems an enormous engineering fete.

As to Highway 74, no estimate was given. Several more areas of potential slides were recently discovered, bringing a total of 10 areas of serious repair work needed.

Early Tuesday morning, a rock slide occurred around lower Saunders Meadow Road, blocking the northbound lane. Another storm is coming soon — not as strong but still, our mountainsides are fragile right now. If you are like me, you gaze up at those steep sides as you drive our highways and see boulders whose time to move could be at any minute — the minute you drive under them.

Several people have complained to me about not getting deliveries on time. Companies seem to be finding it a challenge to navigate around our predicament.

Last week, Mountain Center Post Office closed until further notice and residents were told to pick up their mail in San Jacinto. It seemed much easier said than done. It made more sense for the post office or its contractor to do the delivery.

And so, Ray Wilson, Idyllwild Post Office officer in charge, made it happen. He also worked on getting Amazon orders delivered to Idyllwild. He is one of our local heroes during this time.

Last week on Thursday, during that neverending snow, Jack and I made the decision to deliver the newspaper to the Mountain Center residents with carrier delivery. He managed the two in Pinyon early in the morning and we managed just one in Garner Valley before the snow forced us back on the highway when we nearly got trapped ourselves.

Emily at Mountain Center Café agreed to take the post office ones and hand them out to residents. We stopped there for lunch after getting back to MC and she told us the goods news, that Gary at the MCPO had reopened. After lunch, we dropped in with those papers not delivered, and he kindly said they would be delivered the following day.

If you don't get a delivery and it's something you can buy in town right now, I encourage you to do so. Without visitors, many businesses are hurting. The Cranston Fire was not that long ago, and so many of them are still recovering from that disaster.

Arsonist's sentence was too lenient

EDITOR:

This community deserves a further explanation, if not an apology, from the Riverside County District Attorney's office for its handling of the Cranston Fire arson case. The logical result of the “plea bargain” given to this defendant is that a relatively young convicted arsonist will be turned loose in six or eight years to prey upon this mountain area and other fire-prone communities.

The defendant pleaded guilty to two counts of arson and received a sentence of 12 years and four months. It appears that as many as 13 other counts were either dismissed or somehow lost along the way. A sentence of the equivalent of life in prison was, therefore, possible, which would have been appropriate under the circumstances.

The DA's statement contains a suggestion that a jury would somehow not be able to infer this defendant's “specific intent” to burn structures.” After hearing all of the evidence of the defendant's intentional reckless conduct in this case, I suggest no jury would have a problem with finding specific intent. After all, there is a defendant sitting on death row for killing five of our brave firefighters in the Esperanza Fire.

Under the current DA's theory, how could a jury find first-degree murder when all that the Esperanza defendant did was start a brush fire near Cabazon? Apparently, this question presented no problem for an aggressive prosecutor and 12 reasonable people.

Having practiced law for 38 years, and having served as a federal prosecutor, I understand that plea agreements are part of the criminal process.

There are limits, however. Some cases must be tried and appropriate sentences handed down. In this case, there was a dereliction of duty on the part of the prosecution. As a judge once said to me after a particularly favorable agreement was reached, “Mr. Steele, who's going to pay the gift tax?” In this case, I hope it's not us.

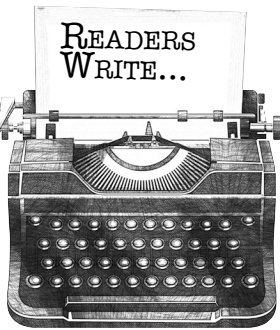

CPUC seeks volunteers for study of Internet promise vs. performance

The California Public Utilities Commission; the Geographical Information Center at California State University, Chico; and CSU, Monterey Bay, are seeking 500 volunteers to take part in the CPUC Home Internet Study, CalSPEED Home.

Many consumers of broadband Internet service wonder whether they are getting the quality of service for which they are paying. California is the first state to undertake its own Internet testing to help answer this question.

The CPUC will use data gathered from CalSPEED Home to provide information to state policymakers dealing with broadband issues such as universal service and the Digital Divide, in addition to providing money-saving information to consumers.

Volunteers will be asked to attach a small device to their home Internet router for a two-week period, during which time speed and quality tests will be performed. The study will not monitor volunteers' Inter-

net use in any way, and volunteers will have access to their own testing results.

The first phase of the study will determine whether some technologies are better than others in their ability to deliver promised speeds and analyze whether the home's Wi-Fi network is the culprit slowing down the service for which the customer is paying.

Whether a customer is receiving service from a telephone, cable, fiber, wireless or satellite company, the CPUC seeks their help to ar-

rive at meaningful results.

Interested volunteers can sign up by going to www.calspeed.net and completing a simple survey. Selected participants will be chosen in accordance with the sampling plan to ensure a statistically significant distribution of the devices. Devices will be shipped to eligible volunteers after selection.

Mark DeAntonio, 53, of Pine Cove, who was charged in June with negligently discharging a firearm, has had several hearings in January regarding his attorney's request for a mental health diversion.

Penal Code sections 1001.35 and 1001.36 authorize this review, according to the public defender's request.

The latest scheduled court hearing was to be Feb. 19, but DeAntonio did not appear. The judge filed a notice to forfeit the \$20,000 bail and scheduled another felony settlement conference and mental health diversion hearing for March 12.

Two hearings were held in January and a third

scheduled for Jan. 29. The hearing's purpose was titled "suitability/treatment." However, DeAntonio did not appear in court for that hearing either.

Riverside County Superior Court Judge Emma Smith issued a bench warrant, reset bail at \$20,000, and rescheduled the hearing for Feb. 19. DeAntonio was not present for this hearing.

On June 25, 2018, DeAntonio was arrested and charged with three felonies: negligently discharging a firearm, manufacturing a zip gun and under the influence while in possession of a loaded and operable firearm. He had been released on \$20,000 bail.

never put out for bid. Since the county still plans to repave the street either just before or just after the Fourth of July, Creighton did not think there was sufficient time for IWD to request bids, review them, select a contractor and complete the work before the county began its work.

While the pipeline is 60 years old, there have been few leaks in this area, Creighton told the board. The leak history has been very good, he added.

“We should delay until there is time to prepare, and also look at other priority projects we can do,” Creighton said. “We can replace older service lines and still get cross training on less busy streets.”

However, the directors were not convinced and asked Creighton to ask the county to postpone its project. Also, he was directed to contact Fern Valley Water District about the possibility of a joint pipeline project. FVWD is planning a major pipeline project this summer and has discussed it at recent meetings.

Leading the opposition to deferral was Director David Hunt.

“What concerns me is this was our first priority. The engineering is already good,” he said. “What really concerns me is the age and location of the pipe.”

Since this pipeline serves Strawberry Creek Plaza, Hunt wants to ensure that the possibility of disrupting businesses due to leaks from the older pipe would be minimized. “It would be catastrophic,” he concluded and asked Creighton to negotiate with Riverside County.

He also noted that FVWD was seeking bids on a pipeline project. “If we work with them, perhaps we get a better deal.”

Director Steve Kunkle, who originally opposed priority of the project, said, “There are more important areas, but we could appeal to the county to delay their work.”

Consequently, President Dr. Charles “Chip” Schelly recommended that a decision be tabled until the March meeting. At that time, Creighton should have more information for the board about the county’s and FVWD’s views.

The second action item was approval of a stipend for employees who live within 6 miles of IWD. Since Idyllwild is a resort location, housing is generally more expensive than the closest urban areas, such as Banning or Hemet, Creighton told the board.

He offered two options as an incentive for employees to live close to the district. One would be a monthly \$400 stipend and the other would be a one-time payment of \$4,000.

The directors all seemed supportive of the idea, but felt there were some questions, which should be addressed before approving it. For example, would it apply to all employees, or just field staff who are on call, which is Kunkle’s preference. Whether part-time or summer help would be included, was another question. The board also asked Creighton to set the monthly stipend at \$350.

“I think it is a really good idea, especially after this weather,” Hunt stated.

Schelly said he has been a long-time proponent of the idea. “Its purpose is to attract people here within the geographic boundary of the Hill. It’s more expensive to live here and this offsets that with a stipend.”

Again Schelly asked Creighton to follow up with a more

In lieu of water tax, Senate bill establishes water trust fund

As part of his budget recommendations last month, Gov. Gavin Newsom proposed to revive the water tax as a means to help poor and small water districts provide safe drinking water.

During the Legislature’s last session, the proposal to tax water bills throughout the state met with strong opposition, regardless of the reason and how the funds might be used. Many opponents who support improving water systems in districts that have little revenue argued that the General Fund should be the source of revenue and not a special tax on water use.

Last week, another bill was introduced to address this need and would establish a Safe Drinking Water Trust.

Funding for the trust would be from the General Fund “during a state budget surplus year, such as the current budget year.” Net income earned from the trust would be transferred to a Safe Drinking Water Fund, which the State Water Resources Control Board would administer, according to the press release from the Association of California Water Agencies.

Author of Senate Bill 669, an alternative to Newsom’s proposal, is Sen. Anna M. Caballero, D-Salinas, and both the Association of California Water Agencies and the California Municipal Utilities Association support this approach for helping disadvantaged communities.

SB 669 establishes a statewide tax on drinking water. A water tax would work against keeping water affordable and would be highly inefficient with about 3,000 local water agencies

becoming tax collectors for the state. The administrative costs for local districts would approach the amount of the tax, according to ACWA, which made this argument in its original opposition to the water tax.

“While most Californians have access to safe drinking water, certain disadvantaged communities do not, and we strongly agree with Gov. Gavin Newsom that this is a critical public health issue that the state must address,” said Cindy Tuck, ACWA deputy executive director for Government Relations in the press release. “The record budget surplus for the 2019-20 fiscal year makes this the perfect time to create and fund a Safe Drinking Water Trust and ensure access to safe drinking water for residents of these disadvantaged communities. The Trust is a better approach than a statewide water tax.”

8 a.m. to walk her dog. “The upper part of my yard was still dry,” she noted. “Within an hour the water had gotten too deep to easily get out the door.” With the water still rising, Blaine said to her boyfriend, “Maybe we’d better do something.” Power was lost around 9:30 a.m., according to Blaine.

She related that water was now above the seats on a meadow-abutting picnic bench and still rising. “We received no notification from Lake Hemet management that the situation was serious and that we should evacuate,” she said. (Camp

management did not respond to a call for clarification.)

By this point, other adjacent residents were beginning to disconnect their RVs from camp hookups, including power, gas, water and sewage. According to Blaine, people were leaving rapidly, and some campers had not properly closed sewer connections, causing sewage to begin flowing around RV sites.

By 11 p.m., Blaine was on the road out of the campground. “There was so much water that our propane tanks were bobbing in the water flow,” she said. “We did a rapid disconnect and they floated away.”

With water everywhere, it was difficult to see the road.

By noon, Blaine and boyfriend were on their way to Anza to a friend’s ranch. “Between Lake Hemet and Anza, the road was flooded in 15 or more spots.” Blaine drove her Lexus SUV while her boyfriend drove the coach. She stressed how taxing the drive was, with her car beginning to float several times before reaching her friend’s ranch. But once the weather clears a bit, she’ll return to Lake Hemet.

“I’m still paying rent for being there and plan to return,” she said. “I love the beauty and the peace and quiet.”

specific and definitive proposal for the March meeting. While he was willing to wait a month to see a complete policy, Schelly added, “I want this to go forward and I’m tired of waiting.”

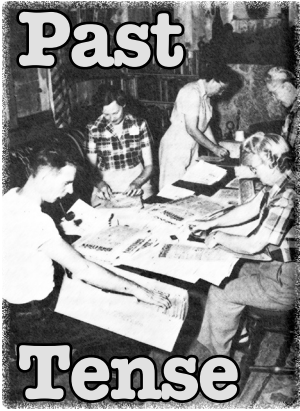
In other business, Creighton reported that both the Lily Creek weir and granulated activated carbon plant projects were near completion. The metering system for the weir should be installed by the end of March.

On the business side, IWD’s water sales for January were about \$2,700 less than the monthly expenses of

\$121,100. But the sewer fund posted a \$1,600 net gain.

During January, water production was 7.6 million gallons, which was 1.7 million greater than production in January 2018. The unaccounted-for water was 9.5 percent of total production, Creighton estimated.

The groundwater levels of the district wells, especially at Foster Lake, have been rising this year, especially in the past month. At Foster Lake, the well level was 26 feet in December and rose to 13 feet in January, before the February rains and snows.

Three Idyllwild Arts leaders to speak on March 11

The Associates of the Idyllwild Arts Foundation’s Spotlight on Leadership Series comes back from a brief holiday and winter-weather hiatus on Monday, March 11.

In the Idyllwild Arts campus’ Fire-side Room — a comfortable setting on what could be a chilly morning — three key players will share their excitement about their work for Idyllwild Arts and for its Summer Program that will be here before you know it. Health Center Director Don Lamp will be the featured speaker, joined by Mark Davis and Heather Companiott from the Summer Program.

Lamp took over leadership of the Health Center last July. His dynamic reorganization of the Health Center’s systems is invisible to outsiders. Though most of their work is for the Summer Program, the ambitious size and variety of its schedule of June-to-August arts classes and events make their jobs year-round.

But the chance to work year-round creates much of the excitement for these two devoted arts lovers. Davis will be looking forward to the April 5 to 7 Spring Writers Retreat led by “White Oleander” author Janet Fitch, who wrote much of her most recent novel, “The Revolution of Marina M.,” in Davis’ Idyllwild cabin.

And Companiott’s already formidable passion for arts in general and Native American arts in particular has recently been stoked by the chance to collaborate with Shaliyah Ben, formerly of the Heard Museum, in Phoenix. Ben has filled a position brand new to Idyllwild Arts, Native American Arts Program coordinator, and is working overtime with Companiott to make Native American arts in Idyllwild more stimulating and informative than ever.

The talks are free to the public during the Associates’ monthly meeting at 10 a.m. Monday, March 11, at Nelson Dining Hall’s Fireside Room on campus. No reservations are required, and coffee, tea and snacks are served.

Tommy: Not being so shy, that’s what. Now that I know her and her other dogs, I’m feeling comfortable.

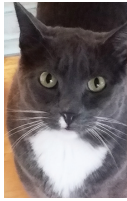

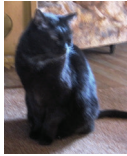

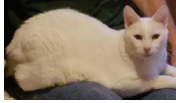

IIFC seminar provides roadmap for getting films placed in today’s market

At year 10, festival on brink of academy eligibility

The Idyllwild International Festival of Cinema celebrates its 10th year with increasing industry recognition and competition among indie filmmakers to be accepted into what has become a festival for making major placement and distribution deals.

Founder and Festival Chair Stephen Savage noted that the Academy of Motion Picture Arts and Sciences, in recognizing the festival, this year approved the festival’s application to be accredited for screening academy-eligible shorts. Savage, who is now a staff writer at Paramount Studios, as well as a successful filmmaker, declined the certification for short films and will reapply next year for academy feature film accreditation for 2020.

“To be eligible for Academy Award nomination and consideration, every film must have a theatrical release,” said Savage. “The Rustic screens first-run movies and would be an eligible theater. If we receive feature academy accreditation that puts the festival in a whole different category.”

Savage notes the festival has come into its own over a relatively short period of time. “Ten years,” said Savage. “Ten years of what indiefilm.com called ‘The Greatest Little Film Festival on Earth,’ and the LA Weekly touted as a ‘Mini Sundance.’ I couldn’t be more proud of how far this festival has come, and of my partner, Trinity Houston, and the IIFC team who have made it all possible.”

As an ongoing part of its programming, the festival offers seminars for filmmakers and festival patrons on subjects of interest to both. This year organizers are hosting one seminar — “Film Distribution, the New Frontier” at 11 a.m. Saturday, March 9, at the Rustic. The seminar will focus on how to get scripts bought, and how to get placement and distribution deals with what is becoming a totally new marketplace, with streaming

services such as Netflix and Amazon beginning to dominate during awards seasons.

Netflix is in the process of building its first studio complex in New Mexico to become even more competitive. As an example, “Roma,” a Netflix original directed by Alfonso Cuarón, was nominated for several Oscars without a major rollout in traditional academy-certified theaters. Since Netflix does not release box office numbers, there is no official take on how well “Roma” did in its limited academy-eligible theater screenings.

Savage said it’s a whole new world in film, for the most part favoring independent filmmakers. “You don’t have to have some big movie studio deal for distribution,” said Savage. “The Hollywood establishment system is changing. Only Disney makes movies in-house. Just about every film is ‘independent’ by definition. Paramount and Warner Brothers are distribution companies.”

Panelists include Eric Bork, Chris Tung, Roger Goff, Cassie Jaye and Mark Cartier.

Bork is a primetime Emmy winner for his shared work with Steven Spielberg and Tom Hanks for Outstanding Miniseries on “Band of Brothers,” and “From the Earth to the Moon” with Hanks, Ron Howard and Brian Grazer; Producers Guild of America winner for Outstanding Producer Long Form Television for “From the Earth to the Moon” shared with Hanks, Howard and Grazer; and 2018 winner Sherman Oaks Film Festival for Best Short Film, Director and Screenplay for “I Got This.” He will discuss high-end film distribution in this changed marketplace.

Tung is a producer and Netflix Originals executive who will talk about how to get package network deals and distribution with streaming companies such as Netflix. “You can go with your 10- to 48-minute film scripts to people like Chris and Netflix will start from the script,” said Savage. “You don’t have to beg some big movie studio for distribution.”

Goff is an established entertainment attorney who brokers deals on behalf of filmmakers seeking distribution, as well as music licensing for films. As an attorney in the film industry, Goff has handled financing and pro-

duction for more than 100 films, including the Academy Award-winning “Dallas Buyers Club,” “Welcome to the Rileys” (produced by Ridley Scott), “Splinter” and “American Gun.”

Jaye, familiar to IFCC audiences, began her film career as an actor but in 2008 moved behind the camera to become a noted documentarian. In February 2008, she founded Jaye Bird Productions and directed her first feature documentary “Daddy I Do.” “Daddy I Do” premiered in 2010, won numerous awards at film festivals around the world, and became an educational tool to promote Comprehensive Sexual Education in schools. Its success encouraged Jaye to continue pursuing directing.

In February 2012, Jaye premiered her second feature documentary “The Right to Love: An American Family,” which chronicled the fight for Marriage Equality in California and won four Telly Awards. Jaye has been celebrated for her attention to nuance and balanced approach when directing films about politically controversial topics.

Multiple award-winning writer/director Cartier was given his first job out of the Sundance Film Festival by Kerry McCluggage, former chair of Paramount Television. While at Paramount Pictures, he worked in development. Working as a creative executive, Cartier’s first mentor was producer David Foster, who taught him that hard work makes good luck.

Founder of the production company North of Two, Cartier continues to work as a writer, development executive and producer in Los Angeles. Savage noted that North of Two bought four films shown at IIFC 2018 and is currently brokering them to get placement with Netflix or Amazon. He also will discuss distribution in today’s market.

This year’s seminar runs for an hour and is a must-attend for anyone interested in the business of film as it is currently being conducted.

The IIFC website, idyllwildcinemafest.com, offers interested festival-goers the ability to view trailers on many of the films accepted for 2019.

IIFC feature documentary follows a dream

A young athlete with cystic fibrosis competes in tandem surfing

First you dream. Then you act. Stories that inspire us begin with dreams, often seemingly impossible dreams.

“Breathe Breana,” a feature-length documentary candidate for Best Documentary and Best Director at the 2019 Idyllwild International Festival of Cinema chronicles a young girl’s daring dream — to become a tandem surfing champion while handicapped by cystic fibrosis.

Athletes draw on reserves of oxygen to compete. When the ability to breathe deeply is compromised, as it is with cystic fibrosis, winning in a demanding athletic competition becomes even more improbable. When winning also requires elegant athleticism, as it does in tandem surfing, the victory becomes deeply inspirational.

“Breathe Breana” is made by another dreamer, writer and director Duke Addleman, honored at IIFC 2016 as co-writer, with childhood friend Greg Morgan, of the multiple award-winning feature “The Boatman.”

Addleman lives a “blended career,” with a day job as a middle school teacher of poetry, literature, film making and screenwriting, and a second career as an indie film producer, writer and director. Added to the blend is the inspiration of being a husband (to Susan) and father (to 20-year-old twins John and Grace). And rounding out the mix is Addleman’s passion for music, as a keyboardist and vocalist, with a background in making that music with his group “Ford Perfect.”

Born in San Diego, raised in Coronado and Palos Verdes, and current resident of San Pedro, Addleman has been drawn to the water around him. All his career facets are fueled by his easy-going nature and ability to understand and welcome the waves — the crests and the troughs.

He has always been a film buff, inspired first, and infused with the dream of becoming a filmmaker, by the 1978 movie “The Deer Hunter.” He has learned to follow his instincts, follow the projects he finds worthy and occasionally to take on the projects that find him.

With “Breathe Breana” the project

came to him. “I was watching sports at a bar at a restaurant somewhere in Orange County talking with the guy next to me,” remembered Addleman. “He was a retired pro-surfer, six-time world cham-

pion, who now worked with kids with cystic fibrosis in a sport called tandem surfing.” He described how Bob Friedman was partnering with a young girl, Breana Schroeder, in a sport once described as Cirque du Soleil on a surfboard or pairs figure skating on a wave. In the competition, Friedman is “the base,” the lifter on the surf board supporting “the flyer,” a woman trained in gymnastics who performs tricks while being held aloft. After describing his current project, Friedman turned to Addleman and said, “We’re going to the world championships. This is what I’m doing. So what are you doing?”

Addleman answered by agreeing to show up the next day with cameras to watch and perhaps film Friedman and Breana tandem surfing off San Onofre. “I knew it was right, from the start,” said Addleman, of what would become his next film. “The second time I brought my mom and my daughter. I knew this was it.” That was in April 2016. Addleman wrapped the project 18 months later, at the end of 2017. “I spent my entire spring break [from teaching] doing the fi-


nal edit,” he said. “I looked at it and then we all cried like babies.”

“I make movies because it’s fun and that’s it. It’s the juice, the love and collaborating with others. And with ‘Breathe Breana’ there was the added bonus that it is all for a good cause — promoting cystic fibrosis awareness and hoping to raise money and interest in finding ways to add years of life through research.”

Of his blended career, Addleman said, “When you’re in the arts, the world becomes smaller.” Things, people, resources come together, and one builds a cast, a crew and a professional family.


“Breathe Breana” has its domestic premier at IIFC at 2:10 p.m. Tuesday, March 5 at Creekstone Inn. It screens again at Town Hall at 3:45 p.m. Saturday, March 9. At the March 9 performance, Breana and her mother Karen will be present, as will Duke, his mother, wife and children.


Air quality documentary released

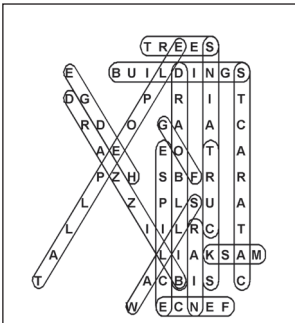
