Highways 243 and 74 changes this week

Caltrans added one more hour in morning to Highway 74 opening

Traffic flow on Highway 243 between Franklin Drive and Fire Station 23 (Pine Cove) will be slowed between 8 a.m. and 2 p.m.

Caltrans will have maintenance crews removing a boulder near Lakeview Dr. Consequently, only one lane will be available for vehicular use.

One-way flagging will control traffic on the road during the work.

Caltrans warns that traffic will occasionally be held for up to 20 minutes to remove debris from the road way. There may be loud and precedent noise in the area during the boulder's removal.

Beginning Tuesday, May 7, Highway 74 opened from 4 to 8 a.m. for traffic between Mountain Center and Hemet, according to Caltrans Public Information Officer Terri Kasinga Monday afternoon. A pilot car escort will still be leading the traffic.

This is one more hour than originally provided in April when the highway was opened to limited use. The evening hours remain 6

Board OKs special Cell tower permit followed construction fees at transfer station

A question has been raised about the legality of the construction debris fees, which CR&R, the management agency, imposes at the Idyllwild Transfer Station.

The last time the Riverside County Board of Supervisors approved these fees was June 2014. Resolution 2014-081 authorized the then transfer station management, Waste Management Inc., to continue to impose a fee for construction debris.

Responsibility for the construction debris resides with the county's Department of Environmental Health. The Waste Resources Department does not regulate these materials, which could pose health hazards, such as asbestos and lead that need to be treated differently.

Also, the acceptance of construction and demolition debris at the transfer station eliminates a trip to Lamb Canyon where this waste must eventually be taken.

The current fee structure will expire this year and the board had a new resolution on its agenda for this past Tuesday, May 7. The action was to set a public hearing on the new rate structures for Tuesday, May 21.

Verizon has constructed and installed a new cell tower in Idyllwild. It is on the Idyllwild Inn property and is not yet operational.


Learning of and seeing the completed project has worried and raised the ire of several local residents.

County homeless population growing

Fewer counted in Idyllwild this year

Homelessness is a problem through out the country and is growing in Southern California. Orange, San Bernardino, Los Angeles and Kern counties all reported increased numbers of homeless between 2017 and 2018. San Diego County reported a slight decline, but its homeless population is nearly three times the number in Riverside County.

Last week, the Riverside County Department of Public Social Services released the results of its 2019 winter homeless survey. In the past year, the number of homeless people counted in the county increased by 21 percent, from 2,310 in January 2018 to 2,811 in January 2019.

The report's author states that several reasons associated with the counting process and procedures would and did vield ments, and even included another 10 percent. more volunteers.

Nevertheless, the author stressed, "the actual number of homeless individuals is estimated to be higher than [Point-in-Timel Count results due to ongoing challenges of locating homeless individuals."

The 2017 count was 2,406, or 96 individuals more than 2018. That trend was short-lived.

In its press release, the DPSS cautioned readers about the accuracy of the count: "Annual homeless counts provide a snapshot of homelessness. Due to the challenges in finding homeless people, however, actual numbers of homeless individuals may be

higher." Most of the homeless live in unsheltered conditions. Of the nearly 2,800 homeless in the county, about 766 (slightly more than a quarter) live in some form of shelter.

Of those without shelter, 43 percent live on the streets, a quarter have



In California, Gov. Gavin Newsom proclaimed May 5 to 11 as "Wildfire Preparedness Week."

Newsom noted that he has been concerned about the consequences and threats of wildfires from his first day

Noting, "Eleven million people — approximately a quarter of the states' population — live in high fire-risk areas," he issued his proclamation on April 30.

Cal Fire is concerned about the possibility of fires in 2019. In its release, the agency reminded local residents, "California's wet winter created a sizable crop of new grass growth, but don't let the wet weather fool you as the abundant grass dries. Now is the time to act to pre-



Life Tribute Judith Mae Krug 1940-2019


Judith Mae Krug, 78, of Idyllwild, went to be with her Lord and Savior on Saturday, April 27, 2019, in Hemet.

Judy was born Dec. 31, 1940, in Matador, Texas, to Clifford and Billie Jean (Plumlee) Webb. She was raised in Los Angeles from the age of 6 months old, and graduated from George Washington High School.



She was preceded in death by her only sibling, sister Patsy Jean Nelson, and is survived by her husband Jim, her children from a previous marriage Sandy and Michael Velasco; two grandsons; and niece Donna Jean Vargas. She is also survived by her loving stepson Paul Krug, and stepdaughter Anne-Marie Krug.

A memorial service in her honor will be held at the Idyllwild Community Presbyterian Church at 1 p.m. Saturday, June 15.

Glen was born June 3, 1917, in Manly, Iowa, the third of six children.

Glen started working on cars as a young teenager. It clearly became his life passion. He quickly learned the auto mechanic trade before



being drafted into the Army during WWII.

He was enrolled in officer training school prior to the war ending and decided his love of cars was far greater than his love for the Army. When the war ended, he left the armed forces to follow his passion, something he would later often ponder if it was the right decision.

In 1937, Glen met and married the love of his life, Freda Rose Brandenberger. In 1938, Glen and Freda had their one and only child, a daughter they named Joyce. Glen worked in management at an auto dealership until the early 1950s when he and his oldest brother Forey opened Wall Custom Cars in South Gate. They specialized in selling customized, one-of-a-kind modified cars.

In the early 1980s, Glen retired from the car business, and he and his wife moved to Northern California to be closer to their daughter and her husband. Glen went to work for them as a machinery manager at their manufacturing business, Air Factors, in Pleasanton, working for another 20 years.

He finally retired at the age of 87 in 2004. During his retirement, he and his wife Freda lived a quiet life in Pleasanton. In his late 1990s, Glen proudly took on the role of daily caretaker for his wife until her death in 2016. They had been married 77 years.

Shortly thereafter, he relocated, calling Idyllwild home. Glen was honored as the oldest veteran in Idyllwild at the town's Idypark dedication ceremony in May 2018. It was a true highlight of his final year. He died peacefully at home in Idyllwild several months later.

Glen is survived by his older brother Forest "Forey" Wall (now 106) and two younger sisters, Pearl Porter and Violet Dawson; daughter Joyce Schilling; granddaughters Glenda "Sue" Schilling and Cynthia "Cindi" Hinds; five great-grandchildren, Christina Andring, Kurtis Jones, Michael Jones, Brandon Andring and Amelia Leonard; and 11 great-great grandchildren.

Glen will be remembered by his family for his very favorite things: his love of cars, hot fudge sundaes, spending time with family and motorhome traveling and his ability to "fix anything but a broken heart!"

Valentine's Day storms declared major disaster

Last Thursday, May 2, President Donald Trump concurred and declared that the damages resulting from the Feb.13, 14 and 15 storms in California, including Riverside County, to be a major disaster.

The declaration will result in federal monies to state and local governments to help rebuild and restore the public infrastructure damaged from the atmospheric river of rain during that period. Damage from landslides and mudslides also is part of the declaration.

The federal assistance can be used for debris removal, emergency protective measure and permanent restoration of infrastructure. Other eligible categories for assistance include roads and bridges, water control facilities, public buildings, pubic utilities, and parks and recre-

The federal government's share of the costs will be 75 percent. Riverside County officials will work with State Emergency Services for project cost reimbursement, according to Shane Reichardt, senior public information specialist for the county's Emergency Management De-

The county estimated its direct costs from this disaster were about \$70 to \$75 million.

"[The declaration] also makes the area eligible for the Hazard Mitigation Grant Program, where entities such as the county can apply for funding for projects that can mitigate the effects of future disasters like heavy rains and wildfire," wrote Hernan Quintas of Rep. Dr. Raul Ruiz's staff.

After Gov. Gavin Newsom submitted the state's request, Ruiz also wrote to Trump. Then on May 2, he announced, "Today the President heeded our call and issued a Major Disaster Declaration for the Valentine's Day floods that damaged roads and hurt regional business. I'm working with Governor Newsom and FEMA to ensure that our communities receive the funds and resources available for a full recovery. On April 15th, I wrote to the President calling on him to issue this declaration ..."

No private assistance was approved for this declaration. Reichardt presumes that the state didn't qualify with enough individuals. Insurance coverage probably reduces the number of potential individual claims.

Also, the final two years of former Director George Rowell's seat will be on the ballot.

cil could not have become the powerhouse organization it is without her.

When we formed the council with members of the community in 2001, our goals were small: to educate the community about the fire danger and reducing fuel on their property. We were fortunate enough to have volunteers from Idyllwild and Pine Cove who were aware of the hazards we faced in the forest and who set to work clearing properties and parts of the forest of undergrowth and some dead trees with mine and kay's

own shovels, axes and chain saws.

After Kay [Ceniceros] secured nonprofit status as a 501(c)(3) and we affiliated with the California Fire Safe Council, we got a startup grant from the CFSC to rent office space and hire an executive director. The grant wasn't large enough to pay a good salary, but Edwina took the job anyway. She was worth at least twice as much.

Soon she was getting us grants from the U.S. Forest Service through the CFSC. Thanks to Edwina and the hard work of MCFSC board and members, word of our work soon spread throughout the fire agencies locally and at the state level.

As Edwina secured more grants, the council was able to expand operations, eventually buying a truck and a shredder. Norm Walker was absolutely correct in saying, "Edwina has been the backbone of MCFSC for a long time."

One year, the CFSC was given \$1 million; Edwina had applied for and we were awarded \$800,000 of that money for our most ambitious fuel reduction project that year. MCFSC's efforts were recognized.

Kay is in the advanced stage of Alzheimer's, but I know if she were aware, she would join me in wishing Edwina well deserved happiness in retirement and our undying gratitude for her devotion to the Fire Safe Council and the community.







Rodgers admits attempting criminal threats

After nearly five years, Green trial to start

On May 2, Carl Rodgers, 45, of Idyllwild pleaded guilty to attempted criminal threats that could cause great bodily harm.

Riverside County Superior Court Judge Stephen Gallon granted Rodgers probation for three years after serving 180 days in the Riverside County jail. He also will have to pay the victim restitution and enroll in a 52-week domestic violence program.

He was arrested on April 22 and charged with the felony threats and a misdemeanor for driving without a license. The latter was dismissed.

Marcus Green's trial is scheduled to begin May 10. Green, 54, of Thermal, was the driver of a car that went over the side of Highway 74 in May 2014 and resulted in the death of a 5-month-old child. The RC District Attorney's office filed two felony charges — murder and willful child cruelty — as well as gross domestic vi-

Forest Service seeks committee members to advise on fees

The U.S. Forest Service's Pacific Southwest Region is seeking nominations to fill the 11-member Recreation Resource Advisory Committee in California.

Recreation committee members recommend recreation fee changes at national forest sites throughout California. This includes making recreation fee program recommendations on implementing or eliminating standard amenity fees; expanded amenity fees; and noncommercial, individual special recreation permit fees; expanding or limiting the recreation fee program; and fee-level changes.

Nominations are being accepted through Aug. 1.

The Federal Lands Recreation Enhancement Act, signed in December 2004, directs the secretary of Agriculture, the secretary of the Interior, or both to establish Recreation Resource committees, or use existing advisory committees to perform these duties.

Recreation committee members represent various interests. Five persons are to represent recreation users and activities, which will be dependent on the season and mechanized equipment.

These types of recreational activities include winter motorized recreation such as snowmobiling; winter nonmotorized recreation such as snowshoeing, cross-country and downhill skiing, and snowboarding; summer motorized recreation such as motorcycling, boating and off-highway vehicle driving; summer nonmotorized recreation such as backpacking, horseback riding, mountain biking, canoeing and rafting; and hunting and fish-

Three persons will represent interest groups that include motorized outfitters and guides, and nonmotorized outfitters and guides. The third person will represent local environmental groups

The other three members will represent the following interests: a tourism official representing the state; a representative of affected Native American tribes; and a representative of affected local government interests.

The secretary will appoint members for staggered terms of two and three years beginning on the date members are first appointed. The secretary may reappoint members to subsequent two- or three-year terms.

Membership appointments are based on the following criteria: qualifications to represent the desired interest group; rationale for committee service and desired contributions; and experience working successfully as part of a collaborative group.

Committee membership will be fairly balanced in terms of the point of view represented and functions to be performed. The committee's jurisdiction includes national forests and/or Bureau of Land Management managed lands, in the state of California. They receive travel and per diem expenses for regularly scheduled meetings, but do not receive pay or other compensation.

Nominees' demonstrated ability to represent minorities, women and persons with disabilities also will be considered in membership selections.

CPUC OKs Edison Wildfire Mitigation Plan

About two months after California's electric utilities submitted their wildfire mitigation plans to the state Public Utility Commission, the agency issued proposed decisions for the three largest utilities, including Southern California Edison. The two administrative law judges reviewing the documents agreed that the plans complied with the requirements of Senate Bill 901.

Tentative decisions were issued April 29 and final CPUC approval is expected at the May 30 meeting.

The SCE WMP was found to meet all the requirements specified in the law and by CPUC regulations. The judges and the CPUC stressed that SCE will have to provide regular reports on its activities to mitigate wildfires and any other related actions.

The judges did recommend that SCE bring its maps and designation of "High Fire Risk Areas" into greater conformity with the CPUC High Fire-Threat District

Secondly, the decision required SCE to ensure its en-

bution infrastructure as well as the transmission sys-Also, the proposed decision requested that SCE improve its justification for removing hazardous trees and

reduction in system faults, ignitions and down wire

SCE's plan promises more inspections, including enhanced overhead inspections. Two third parties ques-

tioned the cost and efficacy of these inspections. The iudges also questioned whether these "enhanced" inspections would simply be drive-bys, given the large number of promised inspections.

Consequently, they ordered SCE to provide the CPUC with more information about how the enhanced inspections will be conducted.

To some extent, this issue relates to the judges' concern about the adequacy of SCE's metrics and indicators. For example, one of SCE's performance metrics is "enhanced vegetation management." This will be measured by the number of trees removed. The 2019 goal is 7,500

But the third parties argued that outcomes would be a preferred means to measure the success of wildfire mitigation. And the judges agreed, "... metrics are to be used to evaluate whether the plan actually reduces the risk of catastrophic wildfire. Thus it is not enough to measure how many trees are trimmed or miles of conductor replaced. Rather, metrics must measure whether this work had an impact on the utility's wildfire risk.'

So, SCE was directed to come back with improved hanced inspections and maintenance protect its distri- metrics that can demonstrate the success of its mitiga-

Commission scheduled the permit approval. No one attended and only one objection was raised. Consequently, the commission approved the permit unanimously.

Riley Ellis, who said he has been an Idyllwild resident for 20 years, wrote, "... am very much against the proposed installation being considered for Plat Plan No. 25987." That is the reference to the commission's file name for the tower's permit.

Ellis objected to the tower because he felt it would "negatively effect the bucolic nature of the area and the view from my porch in particular." He suggested that Verizon find an alternative location for its 'ugly cell phone tower," which might also affect access to Strawberry

But many people who are listed within the 600-foot boundary and were sent notifications of the meeting do not remember receiving

Myra Dutton, one of those concerned about the process, has suggested a change that might help local residents recognize an important zoning or building permit application affecting their neighborhood.

"The county cell tower permit process was very ineffectual for Idyllwild. Notifications were only sent once almost three years ago," she wrote in an email. "The notice itself was unassuming, white with black print, and had multiple pages. Our notification was only a small paragraph on the third page.

"After a number of phone calls to the county supervisor's office [Chuck Washington], I was told that they would change the permit process for Idyllwild and issue multiple notifications for any cell tower installation plans in the future," she continued.

Then Dutton suggested, "Perhaps it is a good idea to reinstate the [Hill Municipal Advisory] Council here that was disbanded a few years

ago due to lack of interest. MAC would be notified about any cell tower plans here and then would inform the rest of us so we could respond and at least have a say in the matter. Unincorporated areas, like Anza, Winchester-Homeland and Cabazon-Whitewater have one. It would help, especially these days with so many issues at hand."

Recently, the newest member of the Idyllwild Historic Preservation District's Local Review Board Terry Shipley asked his colleagues whether they had addressed the issue since the property is within the district boundaries.

None recalled a formal involvement. And Chair Warren Monroe acknowledged that although the tower was within the district, the LRB's responsibilities are protecting existing historic resources. The tower itself is new and its placement does not affect the façade of any of the existing structures on the prop-

On July 20, 2017, Yun Baird of the county's Parks and Open-Space Department, responded to a Planning Commission request for comments about the tower. Her reply was, "No comments, looks fine. Thanks for the opportunity to re

Consistent with state law, the county planner also directly wrote six local tribes and informed them of the project. The Agua Caliente Band of the Cahuilla Indians did request a cultural inventory and consultation. Ultimately, the tribe submitted a condition stating the procedures to be followed if any human remains were discovered during the grading.

At its Feb. 21, 2018, meeting the Planning Commission adopted the staff recommendation to accept the negative environmental declaration and to approve the permit.

Eventually, Verizon's tower may support the new network protocol, 5G. However, Verizon has no operational 5G equipment in California. Its first use of this technology is in Chicago and Minneapolis.

While some people are concerned that the higher frequencies will be dangerous for humans, there is no substantial nor credible research documenting this fear. Currently, both the Federal Communications Commission and the Food and Drug Administration acknowledge more studies would be beneficial, but none are currently adequate to support the fears of its use.

"While there is no federally developed national standard for safe levels of exposure to radiofrequency (RF) energy, many federal agencies have addressed this important issue. In addition to the Federal Communications Commission, federal health and safety agencies such as the Environmental Protection Agency (EPA), the Food and Drug Administration (FDA), the National Institute for Occupational Safety and Health (NIOSH) and the Occupational Safety and Health Administration (OSHA) have been actively involved in monitoring and investigating issues related to RF exposure," according to the FCC.

The FDA does monitor frequencies emitted from microwaves, found in many residential kitchens. The FCC also tests and monitors the absorption rate of radio waves emitted from wireless devices. There is a limit, which if it were exceeded, would cause the FCC to stop the use of that device.

Nevertheless, some public officials question the safety of this technology. On March 13, the Portland, Oregon, City Council unanimously adopted a resolution requesting the FCC, in cooperation with the FDA, update its research on the health and environmental impacts of 5G radio frequency wireless emissions.

While the opposition to the new tower on the Idyllwild Inn property has recently surfaced, no one has expressed any concern or suffered health issues from the radio tower at the Idyllwild Fire Station, which was installed years ago.







Not too soon to touch the camera

Idyllwild Arts Film students show that nothing could be better

Idyllwild Arts Academy's film and digital media students will showcase their films — and show why they often ask "What could be better than this?" — on Wednesday, May 15, in the William M. Lowman Concert Hall.

At 3 p.m. and then at 6:30 p.m., six graduating seniors and one departing postgraduate student, along with their younger colleagues, will screen 25 films (some with adult language and content) for the Idyllwild Arts community and the general public.

And starting at 3 p.m., the Lowman Concert Hall lobby will feature a continuous demonstration of the 360-degree virtual reality filmmaking that academy instructor Neil Short has taught this year.

One of the students who wonders "What could be better than this?" — a tenth-grader from Bainbridge Island in Puget Sound — asked the question a few months ago, during a film shoot in downtown Los Angeles. Proximity to the movie capital of the world is part of what makes the academy's Film Department thrilling to young people. Another part is their instruction by film industry professionals.

But perhaps the greatest excitement for film students is in making their own films, even as ninth-graders. College film departments don't allow students to touch a camera for the first year or two, but the 25 movies showing in Lowman Concert Hall represent the work of students from every high school year.

Graduating seniors Theo Dröse, Adrienne Ferguson, Jozsef Lelovics, Rui Yan "Rio" Liu, Nicole Taro and Weijing "Vicking" Wang are justifiably excited about their futures. Yet the ones who go on to study film in college will, in a sense, take a step backward.

The extraordinary ambition and daring of the Film Department have even made it possible for this year's only postgrad student, Martin Gerard, to tackle a feature film. Martin's "In You We Trust" addresses domestic abuse and the marginalization of Native Americans as it follows the efforts of a young Native woman to uncover the truth behind murders committed in her community. This is a full-length work on which Martin and his academy colleagues have more work to do, but he'll show the trailer in Lowman Concert Hall.

The Film Department faculty and students have earned so much respect that the departmental awards have been judged by the forward-thinking film community Women Under The Influence. Awards will be announced after the second showing of films.

The event is free and open to the public.
