

Two major earthquakes rattle California

Tremors and shaking felt as far south as Idyllwild

After a year in which two natural disasters — fire and floods — have threatened the hill and disrupted living patterns, the Fourth of July and the evening of July 5 raised concerns of a third disaster, earthquakes.

While Idyllwild only experienced the tremors from two distance quakes to the north, Ridgecrest — near the Mojave Desert and just east of the Sequoia National Forest — experienced two earthquakes greater than 6.4 in magnitude. Both were felt as far south as San Diego.

The first occurred about 10:30 a.m. on July 4 during Idyllwild's Fourth of July Parade. Most parade spectators only detected it after reading news bulletins on their cell phones.

However, the second quake was at about 8:20 p.m. on Friday, July 5 and many local residents felt their floors quivers, the walls stretch and heard the vibration. No local damage or injuries occurred.

The second quake was measured at 7.1 magnitude. The damage around Ridgecrest was reported as much greater than Thursday's quake.

On Saturday, U.S. Geological Survey (USGS) Seismologist Dr. Lucy Jones wrote on Twitter that there was a 10% chance that Searles Valley, the actual site of the two quakes, would experience another earthquake greater than 7.0.

But she calmly added, "That is a nine in 10 chance that tonight's magnitude 7.1 was the largest."

Looking into the future Jones wrote, "Like any quake, today's magnitude 7.1 has a one in 20 of being followed by


something even bigger. Smaller quakes - magnitude 5s are likely and a magnitude 6 is quite possible."

After Friday's 7.1 magnitude quake, three quakes greater than 5.0 magnitude occurred in the Ridgecrest Little Lake area in a 16-hour period. Twelve greater than 4.5 magnitude shook the area and another 22 between 4.0 and 4.5 magnitudes were recorded.

A total of more than 270 quakes occurred in Southern California during that period. In total, thousands of quakes in magnitude from less than one to over five have occurred since the first 6.4 magnitude quake on Thursday.

"The number of aftershocks goes down with time, but not the magnitudes! The ratio of large to small quakes is constant," Jones wrote on Twitter.

Center for Disease Control and Prevention

The recent earthquake activity has been a reminder to everyone that we need to be ready for emergencies, especially for those of us living on a mountain. The Center for Disease Control and Prevention compiled a list of necessary items to keep in a basic disaster kit, provided tips on how to maintain your kit, and recommended storage locations.

Make sure your emergency kit is stocked with the items on the checklist below. Most of the items are inexpensive and easy to find, and any one of them could save your life. Once you take a look at the basic items, consider what unique needs your family might have, such as supplies for pets or seniors.

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for at least 72 hours. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency.

Basic disaster supplies kit

To assemble your kit, store items in airtight plastic bags and put your entire disaster supplies kit in one or two easy-to-carry containers such as plastic bins or a duffel bag.

A basic emergency supply kit could include the following recommended items:

- Water: one gallon of water per person per day for at least three days, for drinking and sanitation
- Food: at least a three-day supply of non-perishable food
- Battery-powered or hand-crank radio (local emergency alert station is WNKI-AM 1610) and a NOAA Weather Radio with tone alert
 - Flashlight

Pine Cove Water reviews water rules ordinance

Ordinance 9 is the district's rules and regulations for setting water policies that replaced Ordinance 4, originally adopted March 16, 1957.

The major difference between the two ordinances is that ordinance 9 expands the section and rules regarding cross-connections, which water districts limit and monitor to prevent private water sources from polluting the public system.

Since you do not know where you will be when an emergency occurs, prepare supplies for home, work and vehicles.

Home: Keep this kit in a designated place and have it ready in case you have to leave your home quickly. Make sure all family members know where the kit is kept.

Work: Be prepared to shelter at work for at least 24 hours. Your work kit should include food, water and other necessities like medicines, as well as comfortable walking shoes, stored in a "grab and go"

Vehicle: In case you are stranded, keep a kit of emergency supplies in your car.

Cal Fish and Wildlife failing to adequately review environmental documents

Audit faults agency implementation of environmental law

The California Department of Fish and Wildlife (CDFW) has failed to meet its responsibilities under the California Environmental Quality Act (CEQA). This is the overall finding from the State Auditor's report released June 27.

The audit found fault with how the department reviews CEQA documents, including environmental impact reports. The report stated that the CDFW was not accurately accounting for the use of environmental filing

During 2018, CDFW responded to about 20% of the requests for consultation from lead agencies. The depart- be completed sooner. ment responded that it did not have sufficient sources to respond to all CEQA documents.

However, CDFW has no policies or procedures for setting priorities to determine which requests will be answered, according to the audit report. Further, late responses or no responses result in more time needed during later steps such as permit review applications.

The auditor recommended that CDFW develop and implement a policy for determining how it will review



Life Tribute Ben Killingsworth 1929-2019

A gentleman has joined the moon and stars.

Handsome, hilarious, deeply humane, and brilliant, Ben Killingsworth passed away in his Idyllwild Home on June 7 with his wife Nanci and his beloved animals at his side.

Ben was born June 25. 1929 in San Diego to Benjamin and Lois Killingsworth.



Facing a wartime housing shortage in Indio, where Ben's dad was now an officer with the CHP, the family joined an aunt and uncle on their hog farm in Perris. Ben and his siblings attended a one-room schoolhouse. Once they settled in Indio, Ben thrived in wide-open country life, tending to an assortment of dogs, homing pigeons and chickens.

During Ben's teen years, the family resided in Riverside and his grandpa built a cabin on Pinecrest in Idyllwild. Visits up the mountain were in his "hoppedup" hot rod navigating the early perilous roads with some very frightened family members.

Ben served in the US Navy from 1948 until 1952. He was assigned to the USS Essex as a combat air crewman during the Korean conflict. During an early mission headed to North Korea, the plane malfunctioned and Ben and the crew had to eject into the Sea of Japan.

Ben followed his father's career path and entered the CHP Academy in 1954. Upon graduation, he was assigned to the Compton area as a state traffic officer and then transferred to the Riverside area. He subsequently served in San Bernardino, CHP headquarters, San Diego and Fresno in various ranks and assignments. In January 1978, he was appointed Border Division Chief where he served for 10 years prior to his retirement in

CEQA, which was enacted in 1970, "requires state agencies to give major consideration to preventing environmental damage when regulating activities under their jurisdiction. Both public and private development projects — such as community centers and apartment building — are generally subject to CEQA.

Complying with CEQA allows state and local government agencies to inform decision makers and the public about the potential environmental impacts of proposed projects and to reduce those environmental impacts to the extent feasible.

When the CDFW does not reply, the lead agencies may not be aware of an environmental issue that should be included in their CEQA documentation. This issue may then become controversial during a later stage, such as a permit approval.

If aware of the issue, the research and studies might

The report authors found that CDFW was not only derelict responding to preliminary stage requests, but its response to draft documents has "dropped significantly over the past five years."

CDFW's response to the audit finding agreed with the audit acknowledging that it does not have sufficient staff to respond to all requests. Consequently, CDFW is balancing the need for staff with the establishment of



The Hampsons have been volunteering since their arrival 18 years ago. Their duties at the Nature Center consist of almost anything and everything that needs to be done.


Richard prides himself on keeping the windows, doors or anything to do with glass clean.



HEALTH BENEFITS OF STRETCHING

Last month, we promised more information on stretching, so here we go...

Harvard Medical School tells us in its September 2013 Harvard Health Letter "The importance of stretching" (The link is at the end of the article.), "Stretching keeps the muscles flexible, strong, and healthy, and we need that flexibility to maintain a range of motion in the joints."

Without it, the muscles shorten and become tight. Then, when you call on the muscles for activity, they are weak and unable to extend all the way. That puts you at risk for joint pain, strains, and muscle damage.

Regular stretching keeps muscles long, lean, and flexible, and this means that exertion "won't put too much force on the muscle itself," says Nolan. "Healthy muscles also help a person with balance problems to avoid falls."

Stretching is something one benefits the best from if it is practiced daily.

But as we noted in last month's "A healthy Idyllwild" article, not all stretching is equal. There are types of stretching used by kinesiologists and physical therapists for different types of training or rehabilitation.

There are also types of stretching to enhance athletic performance. There are types of stretching for general fitness, including yoga and Tai Chi or Qigong. There are also types of stretching for the art of dance.

We might say that safe, effective stretching has a common link in that all of these varied types of stretching are adroitly managing the muscle stretch reflex. The importance of managing the stretch reflex repeatedly pops up as a central theme in health and fitness literature discussing the most effective forms of stretching.

What is the stretch reflex and why should we be aware of it?

Quail team looks for citizen scientists

Allison Roth, a postdoctoral researcher in Professor Nick Keiser's lab at the University of Florida, will be launching a project with Dr. Jennifer Gee, the resident director of The James Reserve, on California quail. Roth comes to us fresh from the University of Oxford where she studied how animal personalities affect reproductive

performance in two species of birds, the great tit and the red junglefowl. We are thrilled that Roth will be spending much of 2019 and 2020 in Idyliwild and at the James Reserve, as she

explores the environmental factors that shape social interactions among individual California quail.

As with extroverted and introverted people,

animals seem to differ in the degree to which they are social. Roth is interested in understanding why some individual quail are very social

(extroverted) while others PHOTO COURTESY OF JENNIFER GEE are less social (introverted).

She notes that these social strategies often remain consistent over an individual's lifetime — even when the strategy may seem detrimental to the individual. For instance, an individual who is extroverted may have

contact with lots of other individuals and be at a disadvantage when a contagious disease breaks out.

Nevertheless, when disease hits, this individual often does not change its extroverted tendencies of socializing.

Roth equates this phenomenon in wild animals to a school child who has a lot of friends being more likely to come home sick with the flu than a child who spends more time by themselves. In contrast, when disease levels are low, extroverted quail may be at an advantage, compared to introverted individuals, because they may be more likely to acquire information about food or predators from other birds, which would increase their chances of survival.

The stretch reflex is our bodies natural response to protect muscles from injury. So, it's a good thing. Nevertheless, over-stimulating this protective reflex may cause loss in the range of motion (ROM) in our muscles.

An example of stretching that may well over-stimulate this reflex is ballistic stretching. On the other hand, as noted above, not stretching will also likely result in loss of ROM. Either way, loss of ROM and shortened, inflexible muscles are what we do not want.

If possible, do consider consulting an expert in body mechanics such as a physical therapist or kinesiologist before starting a stretching regimen if you have not already established a daily routine.

This gives you the chance to start with a strategy that takes into consideration where you are now regarding flexibility and that guides you into a practice that allows you to slowly recondition muscle tissue while avoiding any injury.

"Gradually, you can train your stretch receptors (the stretch reflex) to allow greater lengthening of the muscles," states a MIT website.

Please don't forget that it is not a good idea to stretch before warming up. Five to ten minutes of light activity is an adequate warm-up.

Roth will be comparing the social interactions of California quail in Idyllwild with the social interactions of this species at other southern California localities, including Anza-Borrego and Royal Carrizo (just below Pinyon Crest).

She predicts that extroverted individuals living in localities with high disease abundance (specifically avian malaria) will be more likely to die or will have lower reproductive success than introverted individuals. Furthermore, she predicts that if ex-

troverted individuals are more likely to die or produce fewer offspring in environments with higher disease risk, then this should result in a higher prevalence of introverted individuals at these locations. She predicts that this will feed back onto the overall social structure seen in quail coveyscoveys in high-disease environments being less tightly knit than coveys in low disease environments.

The quail team involved in this work is looking for citizen scientists who might be interested in helping out with this project. If you have lots of quail around your property, we would appreciate if you would let us use your property as a field site. Steele T54 at Wells Fargo

Brendan Steele fired a 9-under-par 66-68-73-68 — 275 at the 3M Open in Blaine, Minnesota, last week for a share of 53rd place. The native Idyllwilder's drives averaged 307.8 yards while finding 76.79% percent of the fairways, and he hit an excellent 84.72% percent of the greens in regulation. Putting hurt, though, as he averaged giving away 1.564 strokes to the field each day with the putter. Had he been just even with the field in putting, he likely would have finished in the top 20.

Brendan currently is ranked 158th on the FedExCup points list and is 208th in the Official World Golf Ranking. This season, a rough one for him, he'll not qualify for The Open Championship in Northern Ireland. So his next tournament is expected to be July 25 on the Montreaux Golf & Country Club course in Reno: the Barracuda Championship, which is played in Modified Stableford format, which B likes.

Under Modified Stableford format, a par is worth zero points, while a birdie is worth +2 and a bogey is -1. This system encourages aggressive play, since the reward for a birdie is larger than the penalty for a bogey. Similarly, an eagle counts +5 and a double eagle (aka albatross) counts +8, while a double bogey or even worse counts only -3. Of course, in Modified Stableford, the highest score wins.





"The big ones just become much less frequent. Large, late aftershocks show up in most sequences. The last magnitude 5 aftershock to 1994 Northridge was in 1997."

Saturday morning, the USGS posted the following probabilities: "The chance of an earthquake of magnitude 6 or higher is 27%, and it is most likely that as few as zero or as many as two such earthquakes may occur... The chance of an earthquake of magnitude 7 or higher is 3%, such an earthouake is possible but with a low probability."

By the afternoon on July 4, Gov. Gavin Newsom had declared a state of emergency for the Ridgecrest area. Shortly after midnight Saturday, he issued a state of emergency for all of San Bernardino County and wrote President Donald Trump requesting federal assistance for Kern and San Bernardino counties.

reasonable and appropriate fees.

The audit report also found that CDFW was using CEQA fees to supplement non-CEQA work in recent years. To correct this problem, the state auditor recommended several changes to the CDFW financial system. CDFW agreed with these recommendations and will improve its financial reporting systems.

Besides the lack of specific policies for determining the priority for responding to a CEQA request, the auditors also noted that CDFW provides insufficient training to staff on how to review documentation. Consequently, consistency across the state is inadequate.

While Charlton Bonham, director of CDFW, generally agreed with the audit results and agreed to embrace the recommendations, he did say in his June 7 letter, "...we would be remiss if we failed to acknowledge that some of the language in the report is unduly provocative and without critical context.'

The state auditor replied, "We stand by the language we use to describe the department's challenges related to CEQA. Our report provides appropriate context and sufficient evidence to support our report's headings and conclusions."

Black bears are back in action

California's black bears are waking up hungry from their winter downtime. To help minimize unwanted bear foraging behavior, the California Department of Fish and Wildlife is reminding those living in or visiting bear country to store food and dispose of garbage properly.

Black bears typically prefer remote mountainous areas. However, as more people frequent or live in natural bear habitat, the abundance of food and garbage associated with human activities is a temptation hungry bears find hard to resist.

"Over the years, we have seen bear behavior change significantly in areas where more people live and recreate in bear habitat," said Vicky Monroe, CD-FW's Conflict Programs coordinator. "Beginning with spring and into late fall, we receive a steady stream of calls from the public reporting anything from bears breaking into cabins and tents to bears stealing food off picnic tables."

Black bears, like other bear species, have a highly specialized sense of smell, which can sometimes lead them to towns and recreation areas where they may quickly find an overflowing garbage can, or someone's leftover hamburger and French fries.

Rick Michel sings Sinatra July 18

Second ISCS features American Songbook

On July 18, Frank Sinatra classics will be heard at the second concert of the Idyllwild Summer Concert Series (ISCS). He will be here in the person of Rick Michel, who will be joined by the Harry James 12-piece band.

Michel does "Sinatra Forever: A Salute to Frank Sinatra" around the world. He also does a Rat Pack tribute. "Sinatra Forever" will bring the American Songbook with all the original arrangements to Idyllwild.

But Michel stresses this is not an impersonation show, it's his interpretation of Sinatra's works.

"I am not trying to impersonate Frank Sinatra, just pay homage to the man's music, and share the stage with the original members of his band," he has written on his website.

Michel is well known in Las Vegas and performs around the world. This is Michel's second concert in Idyllwild. He performed during the 10th anniversary concert series and has visited Idyllwild several times.

Ken Dahleen, the ISCS producer, and Michel have worked together many times. "But it began long ago and the exact moment is buried in memory," Dahleen said. The show business bible, "Variety," has described his performances as the, "closest thing to Frank Sinatra we have ever heard."

"I think Frank Sinatra was the most articulate of all the pop and standard singers," said Michel on his web-

site. "He made songs his own by uniquely phrasing the words to wrap around the melody line like no one else before him or since."

The audiences recognize many of the song selections in the show. "I have tried to touch upon all aspects of Mr. Sinatra's life by choosing the variety of music that best represents his career," Michel explains on his website.

When asked how he got interested in singing Frank Sinatra songs, Michel replied, "In 1961, my mother took a picture of me with a Brownie camera. I was seven years old and I was doing an impression of Stan Laurel, he began.

"As a teenager, I could do Sinatra, but I began as a stand-up in Las Vegas comedy clubs," he continued. "By 1980, I was singing. I've been doing this for 40 years."

Sentimentally, "You Make Me Feel So Young" is his favorite Sinatra piece because his mother introduced him to it.

"But I have so many songs I love," he said. Michel does Sinatra in a variety of contexts from small groups to large bands, and sometimes just with strings.

Dahleen emphasized that the audience should pay attention while Michel is performing — Sinatra is not the only voice Michel sings.

"He also does Dean Martin and he may actually do a couple of other voices. So if you are not watching, you may think other singers have returned," Dahleen cautioned.

The ISCS starts at 7 p.m. at the Butterfield Amphitheater. Dahleen is anxious to present his concerts there.

"The Amphitheater sound should be good," he said. "People will enjoy it."




