Locals express concern over short-term rentals and non-essential business operations

California Gov. Gavin Newsom issued a “Stay-at-Home” order and the closure of non-essential businesses that the majority of locals are working to adhere to in order to slow the spread of COVID-19 and protect fellow residents from infection.

Idyllwild residents took to social media to express their frustrations regarding visitors coming up to utilize short-term rentals.

Another frustration had to do with the continued operation of non-essential businesses.

Locals are worried that visitors could spread COVID-19 to the community. A sign was posted on Highway 243 near Marian View Drive last week that read, “Visitors Go Home!”

Riverside County Third District Supervisor Chuck Washington posted the following on social media last week: “The governor’s stay

“The governor’s stay home order makes hotels, inns, vacation rentals and other short-term lodgings nonessential unless they are used for COVID-19 mitigation and containment. If you own one of these businesses, it must be closed for now with very few exceptions. If you are thinking about traveling to stay in a short-term rental or hotel, DON’T!”

COVID-19 testing increases county-wide

As COVID-19 testing increases in Riverside County, so does the number of confirmed cases, but that is expected. As of 3 p.m. on Tuesday, March 31, there were 371 confirmed cases (up from 59 last week) and 13 deaths (up from six last week) related to COVID-19. There are no confirmed cases in the area of Idyllwild-Pine Cove. The age range with the largest number of confirmed cases is 40 to 64, according to the county’s COVID-19 website. Thirty individuals have recovered.

When asked how many tests have been conducted county-wide Riverside University Health System – Public Health Public Information Officer Brooke Federico responded

Saturday: “We don’t have the commercial lab information, which is when someone goes to their doctor to get tested from a Quest [Diagnostics] lab or LabCorp. We only know when a test comes back positive from these sources, not overall testing numbers.

“However, from the county side, we have tested more than 3,000 people. That includes the two drive-up locations and the county health clinics.”

We also noticed there are no confirmed cases for the Idyllwild-Pine Cove communities on the county’s COVID-19 website. “Most of the unincorporated areas in the beginning were grouped to the nearest city,” Federico wrote in an email on Monday. “We’re working on getting it updated as best as possible with some of the unin-

corporated areas broken out, however, for some of our smaller unincorporated areas it can be a matter of patient privacy to not separate them. I’ll check the status of the Idyllwild area and let you know.” The website now has cases broken down by area including the mountain communities of Anza and Idyllwild-Pine Cove.

How many tests can each drive-up testing site administer daily? Federico responded Monday: “On the community testing sites, the Lake Elsinore site tests around 300 people a day. The Coachella Valley location, which will be moved to Indio [Fairgrounds] tomorrow [Tuesday], tests around 120-150 people a day.”

One of the deaths was a 25-year-old pharmacy technician who resided in La Quinta.

PCT becoming more dangerous for hikers

According to the Riverside County Sheriff’s Department (RCSD), a male hiker was with three other hikers along the Pacific Crest Trail (PCT) near Apple Canyon Road and Bonita Vista Road in Mountain Center on Friday, when he lost traction and fell into a gorge.

The other hikers were unable

to access him due to the topography, and set off their emergency beacons at 9:38 a.m. so emergency personnel could locate them.

RCSD, Cal Fire, the Riverside Mountain Rescue Unit (RMRU) and the California Highway Patrol (CHP) responded.

CHP used its helicopter to assist in the rescue. According to Cal Fire, poor weather conditions made it difficult for CHP to access the hikers, having to land

and re-evaluate.

After re-evaluation, CHP took flight and transported RMRU as close as possible, while avoiding

cloud cover, so RMRU could continue on foot to reach the patient.

Unfortunately, the male hiker

Medicare does not give out DNA kits
The FTC is getting reports that callers claiming to be from Medicare are asking people for their Medicare numbers, Social Security numbers, and other personal information in exchange for DNA testing kits. The callers might say the test is a free way to get early diagnoses for diseases like cancer, or just that it's a free test, so why not take it? But the truth is, Medicare does not market DNA testing kits to the general public. This is yet another government imposter scam.

Equifax data breach settlement: What you should know
In September of 2017, Equifax announced a data breach that exposed the personal information of 147 million people. Under a settlement filed today, Equifax agreed to spend up to \$425 million to help people affected by the data breach.
If you were affected by the Equifax breach, you can't file a claim just yet. That's coming. But you can sign up for FTC email alerts about the settlement at ftc.gov/Equifax. Not sure that you were affected? The breach claims site will have a tool to let you check. Sign up for an FTC email update to find out when that tool is up and running.

“Health officials said the individual was exposed to COVID-19 outside Riverside County and was in self-quarantine in La Quinta when he died,” according to Friday’s press release. “The current [as of March 27] eight deaths in Riverside County had been residents older than 70 and most had underlying health conditions. The pharmacy technician had no underlying health issues.”

Residents may still call 800-945-6171 to make an appointment over the phone for testing at the Coachella Valley and the just added Harvest Christian Fellowship church site in Riverside. Those seeking tests at the Lake Elsinore location are encouraged to use the website <https://www.projectbaseline.com/study/covid-19/> for appointments but may use the above-mentioned phone number. You must have symptoms and an appointment to show up to the drive-up test sites. Some of the symptoms include fever, sore throat, cough, runny nose or congestion. Those who have risk of exposure may also be tested, which means exposure to a confirmed case.

Hemet Global Medical Center opened the first private COVID-19 drive-up testing site in Riverside County Tuesday. You can make an appointment by calling 951-765-4757.

The Idyllwild local who exhibited COVID-19 symptoms and contacted the county for testing received negative results.

Monthly Food Distribution will be held on Tuesday, April 7 outside the wood fence of Town Hall. All cars need to line up on River Drive toward Town Hall.

If someone is picking up for someone else, they need to have the new EFA15 2020 form showing the income below. Visit <https://www.foodbankofsocal.org/wp-content/uploads/2020/01/2020-TEFAP-Income-Guidelines.pdf>. No form, then no food for someone not there to sign in person verifying they are low income.

Vehicles need to have trunk space for the food to be safely placed inside. Food will not be placed on a seat inside the car to maintain social distancing. If there is good weather and the delivery truck is not delayed, distribution will begin at 10 a.m. and stop at noon. Extra food is expected because of our critical need here in Idyllwild.

“There certainly are repercussions,” wrote Chief of Staff to Riverside County Third District Supervisor Chuck Washington Michelle DeArmond. “County Counsel had been actively engaged with Dr. Kaiser in cracking down on businesses who violate the order.”

“The County Environment Health Department is actively enforcing the Order against all restaurants and bars in the county. The County Counsel’s Office has taken and will continue to take aggressive enforcement action against significant public health threats by seeking emergency restraining orders and seeking contempt citations if violations continue.”

“We spoke to county counsel this morning [March 30] about the enforcement process and were told that county counsel continues to seek temporary restraining orders and preliminary injunctions against businesses that are operating in violation of the order,” wrote DeArmond when asked the timeline from submitting a complaint to action being taken. “They are working to prioritize complaints based on those that pose the greatest health and safety threat to the public, so the timeline varies depending on the type of business in question. For example, private schools and churches that have continued to operate have been targeted first as they attract large gatherings of people far exceeding the social distancing limitations.”

The amended order released March 30 reads: “Violators are also subject to civil enforcement actions including civil penalties of up to \$1,000 per violation per day, injunction relief and attorneys’ fees and costs.” This was added to the original “Violation of or failure to comply with this order is a crime punishable by fine, imprisonment or both.”

The order “will remain in effect until April 30, 2020, pending further Order of the Public Health Officer.”

“The fastest way for people to get attention to their complaint is to go through that website and/or phone number,” said DeArmond. “They need to be prepared to provide detailed information on the location.”

Idyllwild Fire Protection District: The front office is closed to the general public, but all administrative operations will stay the same, such as building permits and inspections. The district is operating business as usual. When responding to calls where patients exhibit COVID-19 and flu-like symptoms, personnel will be using personal protective equipment. The patient will be handed a mask to put on themselves and personnel will then evaluate the patient in the back of the ambulance. If personnel need to go inside a residence, they will limit the length of time they are inside.

Idyllwild Garden Club: The April 7 kick-off meeting is canceled.

Idyllwild HELP Center and Thrift store: The thrift store is closed until April 30 and not accepting donations at this time. The office will remain open for client services and food/supply donations from 9 a.m. to noon Tuesday and Thursday by appointment only. This is subject to change.

Idyllwild Library: The library is closed to the public through April 30. All online services are still up and running. Staff are available for Live Chat or Ask a Librarian reference from 9 a.m. to 6 p.m. Monday through Friday through the Riverside County Library System website at <http://www.rivlib.info>. Branches are currently not answering phones. All books currently checked out are being automatically renewed through at least April 30.

Idyllwild Pharmacy: Contact the pharmacy at 961-659-2135 or by sending an email to idyllwild-pharmacy@verizon.net to request prescriptions or over-the-counter items. Please allow 48 hours to process requests. Pick-ups will be made in the parking lot only. Check the Idyllwild Pharmacy Facebook page

for updates.

Idyllwild Town Crier: The newspaper is still open, but our office is closed to the public. Printing, faxing and all in-person services are on hold until our office can reopen. Riverside County offices: Most county buildings are closed to in-person visits. County government will continue to perform the vital services relied upon by residents and visitors. Visit county department websites, or call for assistance on how to complete requests online, over the phone or through the mail.

Riverside County Parks: Riverside County Regional Park and Open-Space District (RivCoParks) closed recreation facilities, nature centers, historic sites, parks headquarters, open-space areas and regional parks to the public.

State parks: All campgrounds, museums and visitors centers are closed and all events are canceled until

A bill for economic relief finally passed Congress. The backbone of Idyllwild is small business. Congress took advantage of taxpayers by using the desperation of the people to push through a bill that was not a good deal for the taxpayers. We are paying for this!

This is after the government shut down our businesses without first passing a relief bill so workers and small business owners could rest easy knowing they could pay their bills and do their part in keeping their communities safe. Limiting public access to White House briefings?

I am very concerned that the New York Times, with the support of some prominent media figures, recently suggested that the White House daily briefings on the efforts of the COVID-19 Task Force no longer be carried live by the major networks.

Supporters of this idea have alleged that too much misinformation is being given in these sessions, while other observers suspect the real reason is more obvious: President Trump is getting a lot of air time out of the situation while his political opponents are isolated in their homes with little access to their supporters. It doesn’t seem fair.

However, like it or not, Trump is president and he is therefore the one to take charge of the federal government’s response to the crisis. Any president would be in the same position and would respond in the same way.

It is important for our leaders to give the anxious public as much information as possible, as well as give valid hope and encouragement. Moreover, the daily briefings are not all about Trump. Most of the detailed presentations are given by task force members who are true authorities in their fields, not politicians or journalists.

Many of us, especially those in the so-called vulnerable population, are intensely interested in the day-by-day progress of this fight. We’re isolated at home and we have plenty of time to sit through two hours of pre-

sentations as well as the questions and answers. And there are lots of us out there, apparently.

According to recent Neilson ratings, more people are watching the White House daily briefings than normally watch Monday Night Football and that doesn’t count those, including many in my family, who watch on the internet.

Understandably, this daily TV exposure is galling to the anti-Trump members of the media. But their proposed solution is to deny the public easy access to the briefings. They apparently want us to rely on journalists, who, in most cases, know no more about the various relevant subjects than we do, to watch the briefings for us. They would presumably then filter out the parts they think are “true” and that they believe we, the public, need to know and feed us those tidbits along with commentary to help us interpret what they tell us.

The vast majority of people in this country, regardless of their politics, want to see events first-hand and think for themselves. People know if something doesn’t pass the sniff test they can switch the channel or go online and check facts or find another intelligent view.

And certainly, most people believe the proper role of the media in this country should be to provide information, not restrict or censor it.

One of the dangers posed by this pandemic is that people can make rash decisions when they are afraid. Few things would be more rash than setting the precedent of denying American citizens direct access to a newsworthy event so that the press can filter it first.

ACA positive effects, but many problems remain

The Affordable Care Act (ACA), nicknamed Obamacare, turns 10 this month [March], and what a tumultuous run the health care law has had! The law’s rocky existence hasn’t smoothed out yet and it faces additional scrutiny by the U.S. Supreme Court next fall, the result of more legal challenges to its future. Nevertheless, the occasion of the law’s 10th birthday is a good time to take stock of what it has done and what it has not. How have Americans been helped? What serious challenges facing the health care system remain?

No matter what happens to the law on its latest trip to the Supreme Court, some changes have resulted that will continue to benefit millions of Americans. The biggest one in my mind is that surveys show the public now generally believes everyone, sick or well, is entitled to buy health insurance. No longer is it acceptable to exclude people with preexisting health conditions. That’s a huge step forward in our collective thinking about the country’s health insurance arrangements, and it is allowing us to begin a conversation about universal health coverage that I have never seen in my decades-long career covering this stuff.

Before the ACA passed, sick people who tried to get insurance were denied if they had any kind of pre-existing ailment, even a minor one like an ear infection. If they did find a carrier to insure them, they often discovered that the very ailments they had were excluded from coverage.

Even if the ACA disappears, the principle that anyone, sick or well, must be able to buy insurance is likely to be enshrined in the country’s insurance arrangements. So are a few other changes like allowing young adults to remain on their parents’ policies until age 26 or lifting the caps on lifetime benefits, something that undoubtedly helps families with catastrophic illnesses.

But without a doubt the biggest plus under the law was to extend coverage to some of the country’s poorest citizens by making more of them eligible for Medicaid, a program passed as part of Lyndon Johnson’s Great Society reforms that now covers some 71 million Americans. About 40% are children.

“Childless adults got a major improvement in access

to care,” says Dr. Steffie Woolhandler, distinguished professor of public health at the City University of New York. In 2012 the Supreme Court allowed states to decide whether to expand Medicaid coverage as the ACA provided. To date 14 states mostly, in the South and Midwest, have not done that, still leaving many of their poorest residents without medical help. The biggest hole in the ACA was the absence of any way to control medical costs, a problem now threatening the law itself as well as family budgets across the country. “People can’t afford their care,” says Woolhandler. “Many people have insurance they can’t afford to use,” noting that last year families borrowed \$84 billion to pay for medical care.

An NBC News/Commonwealth Fund poll released a few weeks ago found that nearly half of likely voters with medical bills have used their savings including retirement savings to pay them, and 28% worry about receiving a surprise medical bill in the next year.

That’s a pretty grim result for a law whose official name is the Patient Protection and Affordable Care Act, sold with the slogan “affordable quality health care” a phrase crafted in the PR shop of a Democratic pollster. The law subsidized low-income people to help them buy insurance and pay the deductibles and coinsurance. “If your income is below 250% of the poverty level, or \$65,500 for a family of four, “you’re feeling no pain,” says insurance consultant Robert Laszewski. “If your income is over 250%, you get no subsidies. You’re screwed.” This year, the law says insurance companies may require families to pay as much as \$16,300 and individuals to pay as much as \$8,150 in out-of-pocket cost sharing. That includes deductibles, coinsurance, and copays. Many policies set lower limits. Still, families incurring medical bills are likely to be on the hook for significant amounts of money.

With premiums for family policies exceeding \$1,000 a month, it’s easy to see how the middle class is screwed. Earlier this year it looked like Congress might re-evaluate parts of the ACA along with solutions to the high price of drugs. The health agenda has moved in a different direction for now, so the troublesome aspects of the ACA are likely to remain.

I know, 60-year-olds. You're not old. In fact, we've found that when people think "old," they think of someone about 10 years older than they are right now. But, because we've been warned about the effects of the Coronavirus on people 60-plus, listen up. Because scammers follow the headlines and know you might have this on your mind.

Right now, scammers are scuttling out of their dark corners to offer false hope (Home test kits! A cure!) and use fear (Your social security number is about to be revoked! Your loved one is in trouble!) — all to get your money or information. None of those things are real, by the way. They're asking for your bank routing number to "help" you get your relief money — which is not how you'll get it, by the way.

They're sending fake emails that look real, but those fake Centers for Disease Control and Prevention or World Health Organization emails are trying to steal your personal information — or, if you click a link, put malware on your computer,

tablet or phone. Scammers are calling (and calling ... and calling ...), using illegal robocalls to pitch you the latest scam. They're texting and they're all over social media.

So, while you're washing your hands and working to stay safe, here are a few ways you can help protect yourself — and those you love — from scammers.

- **Don't be rushed.** Whatever the call, email, text or social media post is about remember that scammers try to rush you. Legit people don't.

- **Check it out.** Before you act on something or share it — stop. Do some research. Do the facts back up the story?

- **Pass it on.** If you get offered something great or you're worried about something alarming talk to someone you trust before you act. What do they think? •

- **Keep in touch with the FTC.** Sign up for Consumer Alerts to help spot scams: ftc.gov/subscribe. Watch for the latest at ftc.gov/coronavirus.

- **Report scams to the FTC.** Go to ftc.gov/complaint. Your report can help us shut the scammers down.

One collision on Highway 74 last week

According to CHP Officer Matt Napier, at approximately 2:45 a.m. on March 22, Elena Galo Santillan, 51 of Calexico, was driving a black 2009 Chevrolet Malibu westbound on Highway 74 near Devils Ladder Road when she fell asleep at the wheel.

Her vehicle drifted to the right through the intersection and collided with an electrical communications box. Her vehicle continued moving also colliding with a traffic sign, a post and a wood

fence on private property. After the collision, Santillan reversed and fled the scene in her vehicle. Her front license plate was left at the scene, allowing CHP to find her address and contact Santillan who admitted to falling asleep at the wheel. No one was injured in the incident.

succumbed to his injuries before rescuers could reach him. The victim's identity was not released as of press time. The investigation is ongoing and being overseen by RCSD.

Another rescue

According to Cal Fire, on Saturday, March 28 at 1:19 p.m., two more hikers in the same area of the PCT became stuck due to snow and ice and called for help. Cal Fire's helicopter was able to extract the hikers and transported them to awaiting ambulances to be evaluated for injuries as a precaution. Both were uninjured. The Trail Hunter (<https://www.thetrailhunter.com/>) interviewed Jon "San Jac Jon" King Saturday about the current PCT conditions, posting the interview on YouTube. King is very knowledgeable about local trails. According to his website, he volunteers as a wilderness ranger for Mt. San Jacinto State Park and also volunteers for the Pacific Crest Trail Association and U.S. Forest Service.

King spoke about why the PCT is so dangerous right now. "The current situation, we've had a pretty weird year

weather-wise," said King in the interview. "In the last week or so, it's been icy and then rained on, and that led to a very serious fall. San Jacinto has the highest number of fatalities than anywhere else on the PCT partly because the weather has got more erratic." While the PCT has advised hikers to cancel their hikes due to COVID-19, the U.S. Forest Service is in charge of closing that portion of the trail if they see fit. "Trails are open on the [National] Forest, including the PCT, at this time," wrote Zach Behrens, public affairs officer for San Bernardino National Forest-USFS, in an email. "We recommend, however, that potential visitors follow state and local guidelines regarding public and personal safety measures."

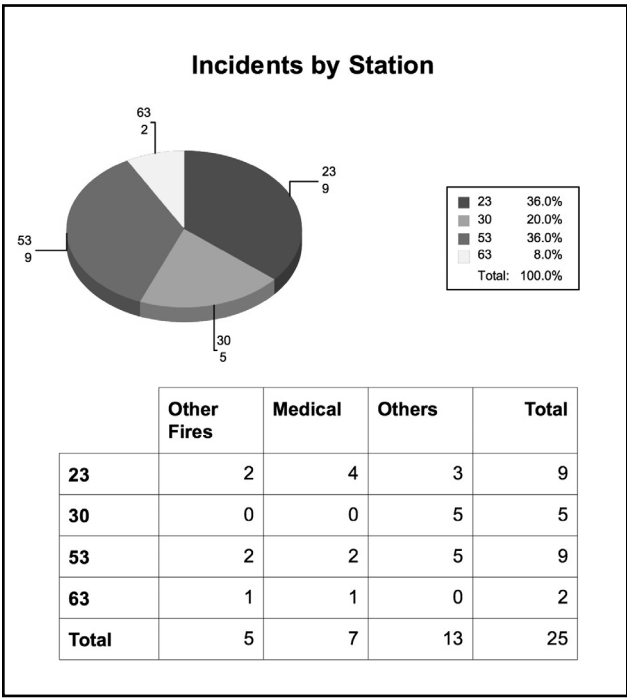
focus on specific tasks (navigating traffic and interacting with strangers), then grab our attention to "Look over there!" when we hear the sound of an ambulance siren or step off the sidewalk. The forest environment demands very little vigilance, yet it is compelling and ever-changing. Our attention is involuntary and requires no mental effort. "Soft fascination" describes the way we listen to birds singing, view the trees, smell a flower or observe the clouds overhead. Humans became an urban species in 2000, when more than 50% of the world's population lived in cities. By 2030, its predicted 75% of humans will be urbanized. Currently, most Americans spend 95% of their time indoors, yet natural landscapes still have meaning to us and are full of signs that calm and guide our minds and bodies. In the 1980s, Stephen and Rachel Kaplan, environmental psychologists at University of Michigan, developed the theory of Attention Restoration. They proposed that being in a natural setting increases focus and decreases mental fatigue. They identified the four basic properties of a restorative environment:

- Being Away — a temporary escape from the routine
- Extent — the opportunity to explore without effort
- Fascination — the appeal of the place
- Compatibility — a place that supports a person's intent and expectations

The forests, meadows, and hiking trails that abound in the San Jacinto Mountains provide the four characteristics of a restorative environment. Henry David Thoreau reminds us of the "soft fascination" offered by proximity to nature. He said, "I am alarmed when it happens that I have walked a mile into the woods bodily, without getting there in spirit."

Behind the jokes of April Fools’ Day

Pranks, practical jokes and various goofs abound at the start of April, when celebrants around the world mark April Fools’ Day — a tradition that dates back several centuries.

Though April Fools’ Day, also known as All Fools’ Day, has been celebrated for centuries, no one is completely sure of its exact origins.

According to History.com, many historians speculate that April Fools’ Day traces its origins to the transition from the Julian calendar to the Gregorian one in 1582. At this point, the start of the new year had been moved to Jan. 1 from the last week of March. Those who were slow to get the news still celebrated the new year from late March into April and became the object of pranks as a result. One of the more notable pranks included having a paper fish placed on the backs of unsuspecting individuals and being referred to as poisson d’avril (April fish). This symbolized a young, easily fooled or hooked fish.

During the 1700s, April Fools’ Day spread northward throughout areas of Britain. In Scotland, the tradition became a two-day event. One feature was sending people on phony errands called “hunting the gowk.” Gowk refers to the cuckoo bird, which often has been used as a symbol for fools. Tallie Day followed, which included pranks like pinning fake tails or “kick me” signs on unsuspecting people.

The earliest mass April Fools’ Day hoax on record occurred in 1698, according to Alex Boese, curator of the Museum of Hoaxes.

“People in London were told to go see the annual ceremony of the washing of the lions at the Tower

of London,” said Boese. “They showed up at the Tower of London, but there was no annual lion-washing ceremony.”

Mass media later became a prime vehicle for some April tomfoolery. In 1957, the BBC told viewers there was a great spaghetti crop in Switzerland that year due to the disappearance of the spaghetti weevil, and people of Britain, who were largely unfamiliar with spaghetti at the time, believed it. Faux advertisements, broadcasts and interviews eventually cropped up as well. National Public Radio did a piece on how Richard Nixon was going to run for president in the 1992 race and used the voice of a man who sounded like Nixon. People were outraged, and thousands believed it.

Many companies have gotten in on the foolishness in recent years. The popular dating app Tinder once announced they put an end to men lying about their height on the app with a “height verification feature.” And Lego purportedly introduced a “Find My Brick”

app to make building more efficient. Even National Geographic got in on the fun when, in 2016, the media company announced via Twitter that it would no longer be publishing photos of naked animals, stating “the media group will no longer degrade animals by showing photos of them without clothes.” Those who clicked through were greeted with “April Fools” and photos of adorably dressed puppies and kittens.

April Fools’ Day is an opportunity to have some lighthearted fun, even if that fun comes at the expense of others.

Jennifer McKee, owner of the Candy Cupboard, is doing her part to keep that sweet tooth satisfied for the whole family by creating some fun candy boxes.

“We are putting together a gummy bear box,” explained McKee. “It’s two pounds of gummy bears with four flavors for less than \$25. The COVID-19 Survival Candy Kit is a box filled with fun, assorted candy for \$25! Our littles are important. So, if they can have this memory during all of this crazy, it’s worth it. We will get through this.”

Even some essential medical care professionals are taking to the virtual world, drastically lowering the possibility of contracting or spreading COVID-19.

Jodi Sutherland, the Health and Wellness Coach-Lifestyle Educator at Fern Creek Medical Center, is now using telemedicine for virtual visits.

“I work with patients to improve their health

by guiding them through lifestyle changes, reducing the risk of disease by promoting a preventive approach to patient care,” said Sutherland.

Wax Apothecary has taken precautionary measures since the first week of March and has since closed the storefront altogether and encouraged customers to order online. They started offering no-contact pick-up orders. Customers can shop online and select “pick-up in store.” Customers receive a call when their order is ready and can schedule a pick-up time then.

“We have a responsibility to our community and our customers to do everything possible to flatten the curve as no person has immunity to this new virus and much of the Idyllwild population falls into the high-risk category,” wrote Diana Orr, co-owner of Wax Apothecary. “We at Wax Apothecary are doing our best to stay informed and to be proactive.

“We wear masks while we work, wash hands between every workstation change and san-

itize our workspace daily with 99.1% Isopropyl alcohol spray. We haven’t visited friends or family and have only been keeping in touch through phone/text exchanges.

“We thought that our business would be diversified enough (via website, wholesale and retail) to survive a local disaster. We ship our products to retailers nationwide and we never thought that we would be hit with a global pandemic, much like everyone else. Our online orders have slowed. Our retailers are also closing their storefronts and not restocking. It has hit us hard, just as it has hit our customers hard.”

With all the uncertainty, there is still some positivity and many options to help make this Stay-at-Home order more bearable. Whether you want to indulge in some candy, learn how to do Pilates, check in on your spiritual side, do some retail therapy or enjoy a fresh cup of coffee, it’s all available right here in town. Support local businesses, and remember, we are all in this together.

- Mimic and repeat. Listen to the language of choice as much as possible and mimic what you hear. This not only helps to develop your vocabulary, but it also can

be a great exercise for your mouth and can help you fine-tune any accents you may have.

- Immerse yourself in the culture. One way to learn a language is to dive right in without a safety net. Once travel is clear, visit a country where they speak the language you're studying and try to converse with the locals.

Learning a new language is possible and speaking multiple languages can be great for your career.

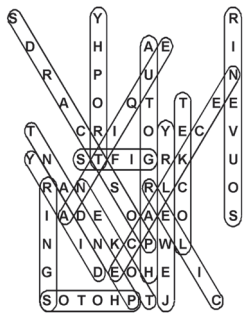

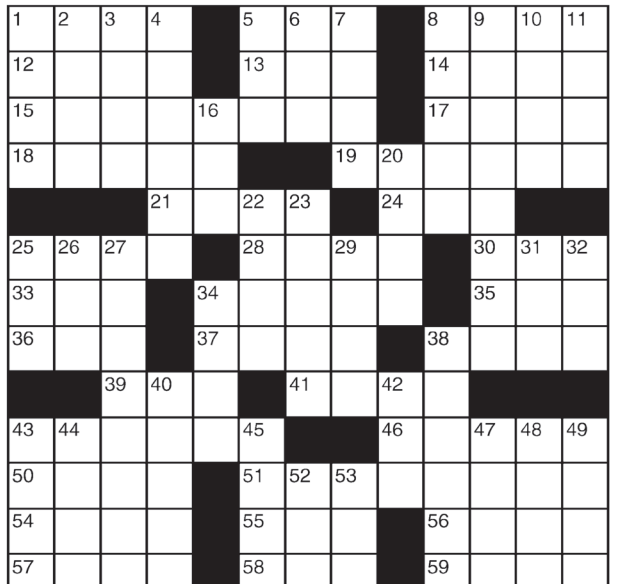

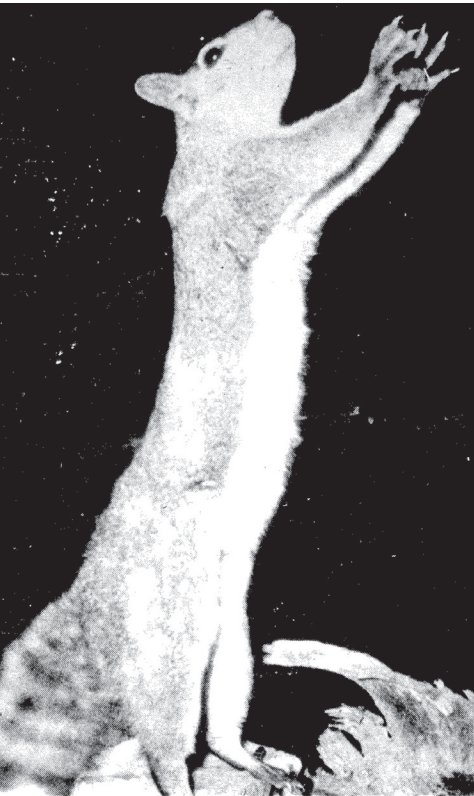
40 years ago - 1980

According to the New England Board of Higher Education, various studies have found that consistent music education can improve vocabulary and reading comprehension skills. In addition, the National Association for Music Education says that research has found a significant relationship between arts participation at school and academic success.

Parents who want their children to reap the benefits of being involved with music can try the following

strategies aimed at fostering a love of music in young people.

- Turn the television off and turn music on. Exposing youngsters to music is one of the simplest and most effective ways to get them to embrace it. Let youngsters pick their own songs or mix it up by including some of mom and dad's favorites as well. Such exposure can be incredibly valuable for youngsters. In fact, a 2016 study from researchers at the University of Southern California found that musical experiences in childhood accelerate brain development. Music is especially effective at helping children in language acquisition and reading.
- Replay kids' favorite songs. Another way to build kids' enthusiasm for music is to replay some of their favorite songs. While mom and dad may cringe at the prospect of hearing "Baby Shark" several times in a row, they should take note of how enthusiastic their kids become when hearing a favorite song. And that enthusiasm can benefit their language skills as they listen closely to the lyrics in an effort to memorize the words. Youngsters may not be so receptive if they don't like what they're hearing.
- Dance to music. Kids are bundles of energy, and dancing is a fun way for them to expend some of that energy. Dancing also provides a great reason to play music. Physical activity set to music can help kids burn off some extra energy as they develop their brains, making dance sessions a win-win for both parents and children.

Music enriches people's lives in various ways, and exposure to music at a young age can be especially valuable to children.
