# State preps for wildfires

On July 9, Gov. Gavin Newsom held a press conference at McClellan Air Force Base in Sacramento about the state's wildfire preparedness efforts.

According to Newsom, there were 628 fires the first week of July in the state of California and 4,112 wildfires from fuly of last year to July of this year, as of

the press conference. It's no secret that wildfire season has

extended over the years. We almost don't come out of fire season anymore and living in a mountain community like Idyllwild, we have to be aware and vigilant.

"We were able to pass a \$54.3 billion budget this year," Newsom said. Of that \$54.3 billion, \$285 million will go towards the purchase of a dozen and Technosylva services. (Technosylva is a company that "provides advanced See Wildfires, page A2



# Want to be an IFPD commissioner?

Another Idyllwild Fire Protection District (IFPD) commissioner resigned, the second one this year.

Jerry Buchanan resigned last week and IFPD is soliciting resumes with a cover letter to fill the position. The deadline to submit a resume and cover letter is 5 p.m. on July 23. The next IFPD board meeting is 3 p.m. Tuesday,

After nearly nine years of serving on the board, it is time for me to spend

The board will determine how to July 28 meeting. Buchanan's seat is up for election in November.

Earlier this year, Larry Donahoo, whose seat is also up for election in November, resigned for personal reasons. His seat was filled at IFPD's June 30 meeting. Only one person, Dan Messina, submitted a resume and was unanimously approved by the board to fill the vacant seat left by Donahoo.

# Plans for the new school year in progress

The 2020/21 school year is just around the corner and the Hemet Unified School District (HUSD) will be updating its plan in response to the governor's press conference last Friday.

As of press time, there are still no COVID-19-related deaths reported for the area of Idyllwild-Pine Cove and there are a total of 10 reported cases since the outbreak, according to the Riverside University Health System -Public Health (RUHS) website.

Because Riverside County is unable to provide recovery data by area, it is unknown how many of the 10 total cases are active since the area's first reported case on April 3.

HUSD was set to discuss its reopening plan for the 2020/21 school year at its board meeting Tuesday, July 21. The Town Crier goes to press before the meeting so we will cover that update in next week's edition. HUSD families received the following communication from the district over the weekend: "In light of the most recent California Department of Public Health order the District is anticipating opening the 2020-2021 school year via an online learning model. At the next regular-Black Hawk helicopters (capable of fly- ly scheduled Board Meeting, Tuesday, July 21, the Goving at night), new camera equipment erning Board will take action regarding the instructional model that HUSD will implement at the beginning of the new school year. This marked his fourth top-20 finish in 16 PGA Tour starts this pandemic-impacted season. Three of the four were top-six finishes — two of those he finished in the



GIS-enabled [geographic information system] software solutions for wildfire protection planning, operational response & firefighter and public safety," according to their website).

While a majority of fire personnel are seasonal and not full-time, Newsom added, "We are also adding an additional 172 full-time permanent staff members to Cal Fire. It's a significant increase."

COVID-19 has added an extra layer while dealing with fire season. During these COVID times, things have had to change to keep fire personnel safe.

"One thing we recognize is if we are going to count on our front-line employees and make these kinds of investments, we have to keep them safe and COVIDfree," Newsom added.

"It is of the utmost importance that we keep our crews healthy so they can continue their work and that we adjust evacuation and shelter plans to protect communities from the spread of COVID-19," Cal Fire Director Chief Thom Porter said.

Porter also pleaded with the public, "We need you as the public to wear your masks. Your mask is what's going to keep you safe from infections coming into your

# FVWD board pushes back on vehicle purchase

Almost a month after the Fern Valley Water District (FVWD) board passed its FY 2020/21 budget which included the up to \$60,000 expenditure for a new vehicle equipped with safety lights and radio for newly appointed Assistant General Manager Jessica Priefer when out in the field — the board pushed back on the allocation.

However, during the meeting the board made suggestions such as equipping Priefer's own personal vehicle with safety equipment and questioned how insurance would play into that plan.

General Manager Victor Jimenez fired back, asking the board what is the price of Priefer's life in the event an accident did occur? The item was tabled to the August board meeting so more detailed information regarding all-available options could be gath-

The district's office will remain closed for the time being due to safety concerns amid the pandemic.

With respect to the pipeline replacement project, the board voted on a payment for the remaining change order in the amount of \$97,273.86. Board member Jim Rees voted against the approval of the extra work completed by El-Co Contractors, Inc., citing it was too much money.

Jimenez gave his general manager's report that included the repair of a small leak on Cougar Road, inspecting properties affected by the upcoming pressure change in the system and preparing to imple-

ment the new pressure regulating stations.

Jimenez wrote in his report, "El-Co Contractors,
Inc. has completed the pressure regulating stations and we will be placing them in service as soon as we complete our due diligence regarding pressure regulators and confirm and plan existing main alterations."

The administrative staff, which includes Priefer and Jimenez, worked on completing the FY 2019/20 year-end reports, preparing new fiscal year projects and purchases, assisting field crew and printing and mailing the 2020 Consumer Confidence Report to all customers.

community and keep our firefighters and emergency responders safe from taking infection out into their population."

According to a press release, some of the actions Cal Fire has been taking to help protect fire personnel from COVID-19 are holding virtual briefings and keeping non-essential base camp staff off site. The California Department of Social Services (CDSS) and California Governor's Office of Emergency Services (Cal OES) have updated mass care and sheltering protocols to include health screenings, pre-packaged meals and dedicated cleaning staff and medical professionals on-site, including mental health professionals.

Another critical action that has been taken this fire season is holding utility companies responsible if they don't follow safety shut-off orders. The governor signed SB 350, which put into place heavy consequences if com-

panies don't act safely, including a company takeover if seen fit, according to the press release.

"We have much more oversight at the Public Utilities Commission," Newsom said. "We also have a new capacity that allows us to take PG&E over if they are not performing on the expectation and mandates we have set forward. We are about safe, reliable and affordable

service, more oversight and more accountability."

With the officials doing their part, they also ask the

"We will continue to commit to aggressive initial attack," Porter said. "If we can keep fires small, we will do everything in our power to do so. We will make it happen. We have the air fleet to do so."

If an evacuation happens, agencies are planning on how to evacuate the public safely and doing their best to make sure everyone's health is accounted for.

"This year, we are doing some things a little differently," Cal OES Director Mark Ghilarducci said. "We may be putting you into hotels for families and individuals so they aren't congregating. If you do go to a shelter, there will be requirements. There will be temperature checks, mandatory mask-wearing. We will set up shelters with social distancing."

According to the press release, not only are hotel rooms a possibility for evacuation shelters, college dormitories, Airbnbs, fairgrounds, and campgrounds are also a possibility that would allow individuals and families to shelter in non-congregate settings.

"This is a partnership that also includes all of you," Ghilarducci said in closing. "It's not just a government

With fire season here, please be aware and as vigilant as possible. Pay attention, have an evacuation plan in place, and if you're told to evacuate, do so. It's for everyone's safety.







for errors after first insertion.

to answer. It is now a matter of public record that as a result of IWD Directors' firing of General Manager Michael Creighton last year, IWD is now financing the legal defense of Creighton's \$578,476 damages lawsuit for wrongful termination. Yet Hunt objects to the costs to IWD of responding to our editor's requests to view public records regarding this and other unusual IWD matters?

We do note that Hunt is the sole member of the IWD Board of Directors to be mentioned by name in Creighton's complaint against IWD—no less than three times in Exhibit B thereto.

A story in last week's TC issue related that not long after Creighton's firing, IWD Chief Financial Officer Hosny Shouman self-authorized a \$12,083 payout to himself by cashing out 160 hours of his own accumulated Paid Time Off. We note that in 2014 a similar such payout authorization to Shouman required two approving signatures those of the GM and the IWD board president. So, what changed at IWD since then that allowed Shouman to solely authorize a payout to himself? No longer a need for the board president's signature? One would think that in the absence of a GM the board president's authorization would be even more necessary.

The Creighton firing also deserves, and will receive, public investigation. On Sept. 17, 2019, Creighton, the top executive at IWD at that time, wrote a formal letter of reprimand to IWD Chief Financial Officer Hosny Shouman regarding an independent investigation that was adverse to Shouman. IWD paid the law firm Aarvig & Associates to investigate accusations that Shouman had been harassing and bullying members of IWD's fe-

A week later, on Sept. 25, 2019, Creighton wrote a letter of unacceptable performance to Shouman reprimanding him for granting an employee's "Supplemental Pay Authorization" request without the authority to do so and for giving employees incorrect information and advice regarding how to use their Paid Time Off.

Later that same day, the IWD Board of Directors fired Creighton.

These are curious circumstances indeed. The general manager formally reprimands the chief financial officer for harassing and bullying employees, which was confirmed by an independent investigation paid for by IWD's directors, and the directors fire ... the

general manager?
The GM then sues IWD for well more than a half-million dollars ... and the local newspaper is remiss for investigating this? We would be remiss if we did not.

There is now a great deal of taxpayer and ratepayer money on the line at IWD due to the decisions of its board of directors, of which Dave Hunt is a member.

And, yes, the Town Crier is investigating.



30,890 confirmed COVID-19 cases. There are 589 deaths related to COVID-19 and 11,058 people have recovered. There are 536 individuals being hospitalized and of those 135 are in the intensive care unit (ICU).

was going to press that a "team of federal doctors and nurses are arriving at Eisenhower Health hospital Thursday [July 16] to support the facility as the hospital copes with the influx of coronavirus patients."

"The federal support will provide much-needed assistance to Eisenhower at a time when the entire medical system deals with the rise in coronavirus cases," said Bruce Barton, director of the County of Riverside Emergency Management Department. "That assistance will make a difference for those who are being impacted by this virus that has taken so many lives."

"The hospital is nearing capacity in our ICU and on our COVID-19 units," says Alan Williamson, M.D., chief medical officer at Eisenhower Health. "Currently, we only have three more 'staffed' beds available in the IČU. Additionally, we are approaching 80% of bed capacity within the hospital, but are at virtually 100% of our staffing capacity. We are grateful for the support from FEMA and its Air Force Medical response team. It comes at a critical time."

The county is urging residents and visitors to follow the state's face covering requirement in common and public indoor spaces and outdoors when distancing is not possible. In addition to covering your face, the county also urges everyone to keep 6 feet of distance and wash their hands. The county is on the state's COVID-19 watch list due to the increase of case numbers and hospitalizations.

In a recent press release, Riverside County health officials reminded all residents there is still a statewide stay-athome order. Businesses have been allowed to open only to be shut down again.

70 years ago - 1950

Model T clubs chugged up the Hill to the County Park and attended the second Woodsman Breakfast of the season.

#### 55 years ago - 1965

Noise from Town Hall dances was a problem for folks living nearby. Irritations like this didn't exist when the town was more sparsely populated, they said.

#### 50 years ago - 1970

Despite protests from thousands of people, the green light was given for Great American Land Company to begin its 3,911-lot development in Garner Valley.

#### 45 years ago - 1975

Smith Richard Idyllwild was injured in

Jameson Road. It was the third local motorcycle crash within a 10-day period.

40 years ago - 1980 Hikers through the Mt. San Jacinto State Park were rewarded with sights from another time period, such as a logging wagon from 1900. Lumbering on the Hill was at its peak between 1880 and

#### 35 years ago - 1985

The U.S. Forest Service and California Department of Forestry and Fire Protection were investigating the cause of the 1,800-acre Cabazon Fire that wounded 28 people. Nearly 1,600 firefighters battled the blaze. A Southern California Edison work crew was thought to be responsible for starting the

#### 30 years ago - 1990

Birchard Studio on the Idyllwild Arts Academy campus was remodeled. Birchard was the first building to be constructed on what was then, and is now, the sprawling campus of Idyllwild Arts Academy.

#### 25 years ago - 1995

Due to budget reductions in the county Public Library System, the İdyllwild Branch was again fighting for hours. The Riverside County Board of Supervisors was looking at 40% cuts across the board.

#### 20 years ago - 2000

Two visitors to the Hill fell from Tahquitz Rock during a climb and died tragically.

#### 15 years ago - 2005

#### 1 year ago - 2019

Gabriel Calvera, wilderness park aid, had started his trek up Marion Mountain looking for a horse, Monty, who had supposedly died the day before. His concern turned to delight after finding his lost victim. To his surprise and happiness, he found Monty weak and thirsty, but alive.
