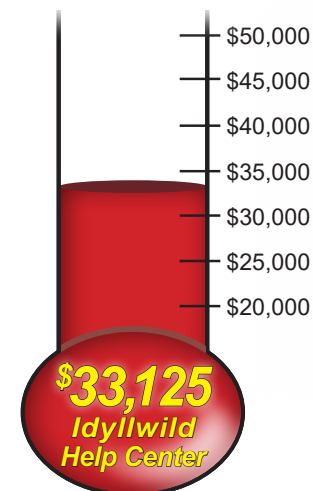

So...Will you contribute your COVID relief dollars to folk who really need them?

By now, most of us have received our Covid-relief dollars from the \$1.9-trillion American Rescue Plan Act and many Hill folk realize they really do not need their allotted money for their own relief during these COVID times.

If you fit that description, how about transferring those dollars to the Idyllwild HELP Center (IHC) for the relief of those who really do need them. You'll obtain a nice tax deduction since the IHC is a section 501(c)(3) nonprofit charitable entity.

Colleen Meyer, the executive director of the HELP Center, told us their clients really do need that money — not just for food and clothing but for rent, utilities, fuel, repairs and more, including laptops and better internet connections required for the virtual education of their children during these rough COVID times.

In addition, Bruce Ross, the newly elected board president of the Idyllwild HELP Center, and his wife Eileen Gallo-Ross, the owners of the Red Kettle in Idyllwild, are teaming with their restaurant to match dollar-for-dollar the first \$15,000 raised by this campaign for the donations of those \$1,400-per-person COVID relief checks, or any partial amount.

Idyllwild Arts students hold protest

Idyllwild Arts Academy (IAA) students staged a protest regarding allegations of sexual assault, predatory behavior and racism. According to Pamela Jordan, president of Idyllwild Arts Foundation, about 120 students participated in the protest outside of the academic administration building on campus last Monday.

The students read a list of demands and allegations at the protest which are included with this story on page A3. The list has circulated throughout social media.

The newspaper contacted every individual listed with the exception of three, whose contact information could not be located and the minors whose names were redacted, asking for comment. A copy of the letter, which Jordan sent out to parents in an email after the protest, was included. The newspaper also contacted Jordan asking the following: the reasoning for sending the email to parents, steps IAA is taking regarding the allegations and if law enforcement is involved, when the allegations were originally brought to faculty/administration attention, if the students who were allegedly raped the ones disciplined and if she had a comment regarding the allegations.

The people who responded (outside of Jordan) to the request for comment referred the paper to Jordan because she was the point person for all external communication.

Jordan responded, "Idyllwild Arts Academy is committed to providing a safe and secure environment for our students that is free of discriminatory or improper behavior of any type, in particular, sexual violence. When we became aware of alleged sexual misconduct among students, we immediately took the matter seriously and began implementing a series of steps to reinforce our policies — and our expectations — regarding appropriate conduct within the Idyllwild Arts community. These steps include providing information through All School, our weekly assembly, and other forums to clearly delineate our policies around Title IX and sexual misconduct. As we move forward in the coming weeks, we will identify steps or changes to strengthen our institution

No results in Sunday's search for Roy Prifogle

On Sunday, April 18, a search and rescue team from the Riverside County Sheriff's Department (RCSD) conducted a search in the area of Pine Cove once again looking for Roy Prifogle.

Prifogle originally went missing in March 2020. After searches were conducted in the days following, Prifogle's backpack was found, but no sign of Prifogle himself.

Kendra Johnson, Prifogle's daughter, posted on her Facebook page April 17 that citizen volunteers were welcome to search east of Highway 243 in the Pine Cove area.

Johnson said, "This is far from where Daddy went missing, so I think it would be most beneficial if anyone that wants to search would go out on a different day. While the SAR [search and rescue] teams are searching tomorrow [April 18], they don't want any inference or anything with the area they are searching. They want to avoid anyone else getting lost or injured and they also want to make things as uncomplicated as possible for their search. I'm sorry that they had given me a different directive before, but I talked to them recently and this is how they want the search handled now."

When the department first conducted searches in March 2020, the RCSD asked volunteers not to participate. They said they did not want anyone to disrupt any evidence that could be in the area.

Johnson expressed her gratitude to everyone who has supported her and her family.

"Thank you so much to everyone that does want to search or has searched before," Johnson wrote. "Remember to stay safe and thank you again."

The Town Crier contacted the RCSD media information bureau (MIB) twice this past week asking for information regarding where exactly in Pine Cove the department was going to search and if there were any new updates available regarding Lydia "Dia" Abrams, Diana Perez Gonzalez or Melissa Lane. The MIB responded writing, "A search was completed on Sunday in the area where it was believed Roy was last near. No evidence and or items were located during the search."

Four people remain missing

Eight people have gone missing in the area since March of last year and four remain missing.

On Sept. 10, an RCSD SUV was spotted hauling an off-road vehicle near Highway 243 and Saunders Meadow Road.

The newspaper was told, "They were conducting follow-up searches for Melissa Lane."

While it was unclear exactly where on the mountain deputies were searching for Lane, it was also confirmed that the search didn't provide any further information or evidence of where Lane may have gone missing.

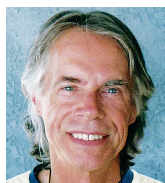
Lane, 41 at the time she went missing, was last seen June 15, according to a poster that was displayed in the Mountain Center area. The Town Crier spoke to Kathy Lamont, Lane's mother, right after she was reported missing.

"She was an avid hiker but didn't have a destination," Lamont said. "She was last seen in Pine Cove. I don't know if she's dead or alive."

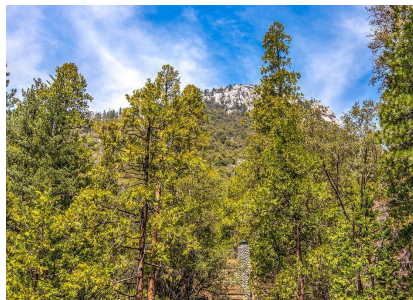
In December 2020, Lane's cousin Todd Gilliland told the Town Crier, "I miss her a

COVID-19 LOCAL UPDATE:

Local COVID-19 numbers stabilize

According to the Riverside University Health System – Public Health (RUHS) website, the area of Idyllwild-Pine Cove has a total of 115 reported COVID-19 cases since the outbreak and two deaths reported. One hundred and thirteen of the 115 people have recovered.

As of press time on April 20, Riverside County has 297,620 confirmed COVID-19 cases, 4,547 deaths related to COVID-19 and 291,022 people have recovered. Eighty-two individuals are being hospitalized, and of those, 14 are in the ICU. The county’s positivity rate is 2.0%. The current adjusted case rate per 100,000 is 3.6. The county is reporting that 24.9% of its population has received the full dose of the COVID-19 shot.

As of press time on April 13, Riverside County had 296,801 confirmed COVID-19 cases, 4,504 deaths related to COVID-19 and 290,048 people had recovered. Ninety-five individuals were being hospitalized, and of those, 22 were in the ICU. The

county’s positivity rate was 2.0%. The current adjusted case rate per 100,000 was 3.5. The county was reporting that 21.8% of its population had received the full dose of the COVID-19 shot.

As of press time on April 6, Riverside County had 295,631 confirmed COVID-19 cases, 4,417 deaths related to COVID-19 and 288,924 people had recovered. One hundred and two individuals were being hospitalized, and of those, 21 were in the ICU. The county’s positivity rate was 2.0%. The current adjusted case rate per 100,000 was 3.5. The county was reporting that 18.1% of its population had received the full dose of the COVID-19 shot.

To date, 2,863,772 total tests have been given for COVID-19 in Riverside County, according to RUHS. According to the U.S. Census Bureau, Riverside County has an estimated population of 2.47 million.

The county announced last Tuesday that it has placed a “pause on the administration of Johnson and Johnson vaccines at its clinics, following a recommendation from the Centers for Disease Control and Prevention (CDC).” Issues with blood clotting are reported.

The county’s Idyllwild one-day clinic to administer the Johnson & Johnson COVID-19 shot last weekend was changed to Pfizer. The second dose will be administered May 8.

The CDC defines vaccine as “A product that stimulates a person’s immune system to produce

immunity to a specific disease, protecting the person from that disease. Vaccines are usually administered through needle injections, but can also be administered by mouth or sprayed into the nose.”

Supervisor Chuck Washington’s office let residents know “the program will provide one-time rental assistance support to cover up to 12 months of unpaid rent during the period between March 13, 2020, until the time of application, plus an additional three months of future rent. Eligibility is limited to renters in Riverside County with a current lease agreement who are earning 80% or below of the area’s median income and can document a loss of income due to COVID-19 economic impacts that leave them unable to make their rent. Assistance is provided without regard to immigration status.”

Two collisions on the same day

Two traffic collisions occurred on the mountain last week, according to California Highway Patrol Accident Review Officer Ben Bolon.

On April 15 at 4:03 p.m., Richard Greenwood, 75 of Idyllwild, was in his blue 2014 Toyota Prius facing eastbound on North Circle Drive stopped in the right-hand shoulder. Donald Lee Rumler, 69 of Idyllwild, was driving his white 1993 Ford Explorer eastbound on North Circle Drive. When Greenwood pulled out to merge into the eastbound lane, he sideswiped Rumler. The left side of Greenwood’s Prius hit the right side of Rumler’s vehicle. Greenwood suffered minor injuries but was not transported to a local hospital. Both vehicles were towed by Idyllwild Garage.

On April 15 at 9 p.m., Andrew Dobbs, 25 of Hemet, was driving his silver 2003 Ford Escape while off-roading southbound on Fobes Ranch Road, north of Highway 74. For unknown reasons, Dobbs made a turn and collided with a large dirt mound. Dobbs was uninjured. His vehicle was towed by Idyllwild Garage.

and help prevent future incidents of sexual misconduct.

“As an educational institution, we have a legal obligation to investigate any clear claim of misconduct, of any type, that does not align with our community’s standards. As we conduct an investigation, we will do so fully and with a strict focus on impartial fact-finding to learn the objective truth. This is the surest way possible to extend our support to anyone who comes forward, as well as to anyone who has been accused to ensure the facts come to light. It is important to note that because a person is the subject of an inquiry it does not mean they are culpable.

“We appreciate the community’s patience as we swiftly, rigorously, and thoroughly follow our inves-

tigatory procedures under the law. We also appreciate the ongoing commitment of the Idyllwild Arts Academy faculty and staff. They are a supremely talented group of individuals who are committed to our students’ success and we value their contributions greatly. Going forward, we will provide as much information as appropriate and as we are allowed under the law to our students, parents, faculty, and community as it becomes available.”

Dear Parents,

I am writing to inform you of a student protest that took place on campus on Monday.

Approximately 120 students staged a protest in front of the academic administration building, Log Lodge. Myself along with several administrators and a few teachers and staff were present and listened as the students expressed their concerns and read a list of demands. The protest lasted about ninety minutes.

We in no way wish to stifle the voices of our students. Attached, please find the list of demands that the students presented to administration. I understand that this list has also been posted on various social media sites. You may note, however, that I have redacted the names of the students who are minors.

It was very brave for the students to confront administration. Their collective voices were heard and I promised to respond to their demands at an All School gathering. I also said that I would have my response in writing so it could be shared with you, the parents. In the meantime, Marianne and I are in the process of engaging counselors who can help provide assistance to our counseling staff and support for our students as needed.

It may be difficult for students and teachers to go into the classroom, following the events of Monday. Therefore, we have given permission for students to miss class or teachers may cancel class on Tuesday. We are working to provide the support that everyone needs to return to the classroom to finish the remaining weeks of the semester.

Several members of our community have expertise and a background in trauma and prevention work. They have been valuable resources as the school works to provide a safe and healthy environment for the students.

Marianne and I will contact you regularly to keep you apprised of campus activities and administrative updates and actions. We will also schedule a parent meeting within the next two weeks to share with you any plans that are available at that time.

We will work to keep you informed and connected with the activities occurring on campus. Most importantly, we will work to keep your child safe, emotionally and physically, while they attend Idyllwild Arts.

Here are the collective demands for the betterment of the Idyllwild Arts community and students as a whole

1. [REDACTED] two known rapists enrolled at the Academy. The administration has proof and also grounds for reasonable belief that [REDACTED] is a rapist and harassed/assaulted multiple women in and out of the IAA community. The administration has grounds for reasonable belief that [REDACTED] is a rapist and stalked and impersonated women in the IAA community online. Both have no place in this community and their presence in any capacity compromises the safety of all IAA students.
2. The immediate implementation of a Zero Tolerance Policy for sexual assault on campus: In the U.S., one in five women have experienced sexual assault, and one in three native women. Globally, one in three women have experienced harassment and/or assault. Recent studies show that 5% or less of rape allegations were untrue, which includes women who redacted their original claims due to social ostracism. Women. Do. Not. Lie. You need to believe us and keep us safe. Drugs do not implicate what kind of person you are like sexual assault does and it should not have a harsher punishment.

These administrators/faculty members must be removed, preferably by firing so that their future employers understand their characters: **Allen Riedel** (for continued racism and sexism, for knowingly keeping a child rape a secret from administration and law enforcement, for the intimidation of survivors and the protection of abusers), **Marianne Kent-Stoll** (for the intimidation, silencing, and threatening of survivors and the protection of abusers, for the refusal to remove racist and unsafe personnel from positions of power such as academic and arts faculty), **Maggie Lam** (for the continued homophobic comments and actions, for the intentional misrepresentation of survivors on official reports and the manipulation of the Title IX process), **Monique Riedel** (for the mishandling of sexual assault on campus, including not providing legal representation for parties involved in Title IX), **Karin Obermeier** (for the continued and EXTREME racism despite all intervention, including the continual use of any form of then-word, the silencing of Black students and students of color when advocating for their safety and inclusion in the classroom, showing videos and movies of Black people being lynched and terrorized [at all and] especially without trigger warnings), **John Goulding** (for the continued racism and insensitivity in the classroom, including citing "benefits" of slavery and anti-Asian bombings, the use of any form of the n-word), **Angela Horn** (for continued racism in the classroom, including asking students to pretend to be slaves for a writing assignment and describing herself as "desensitized" to slavery when challenged by traumatized students), **Bonnie Carpenter** (for continued racism on campus, including telling a student they were "acting too Black," targeting and singling out Black students and students of color for degrading roles, and for choosing intentionally racist plays including "Ten Little N'ggers", **Andrew Moss** (for continued racism against students, including saying that people could "say whatever they want in the car when rapping," when referencing then-word, and discrediting historically Black colleges and universities to seniors curious about these schools), **Lori Stinson** (for continued racism, including asking students to sing racist and anti-Asian songs and

asking students to appropriate Asian cultures and enforcing racist Asian stereotypes), **Ellen Rosa -Taylor** (for continued xenophobia and racism against the IAA community and the constant enforcement of Eurocentric beauty standards and setting extremely racist ballets on IAA stages, such as Bayadere), **Jonathan Sharp**, (for continued racism and anti-Blackness including the constant statement that the natural hair of Black women is "unprofessional" and ugly, telling Black students they looked better with straight hair, and the general enforcement of European beauty standards and the shaming of natural Black features, also the sexual misconduct of asking students to be backstage with him while they were changing, targeting specific students to sit next to him on bus trips, making comments about students bodies and "beauty" and inappropriate and unwanted compliments, also the intentional encouraging and normalization of eating disorders), **Megan Kenyan** (for continued racism's comments and behaviors, for the refusal to apologize or acknowledge hurt and wrong, for trivializing students of color's concerns for their inclusion and safety, and intentionally empowering the stereotype that brown women "over dramatic" and use the "race card" as an excuse, when in reality we deserve to feel safe and protected and our concerns are valid). Get better teachers and replace offensive, racist, sexist, and unsafe ones who trigger students and make us want to leave this school.

4. Continued sexual assault prevention education: We need mandatory training at the beginning of every semester for all IAA admin, faculty, and students

Karen Bailey’s 20-year-old daughter has struggled with depression and anxiety for years. Since 2017, she’s been in three intensive group therapy programs and, each time, the family’s insurer cut her coverage short, says Bailey.

“At a certain point, they would send us a form letter saying: We have determined that she is all better, it’s no longer necessary, so we are not covering it anymore,” says Bailey, 59, who lives in Los Angeles. “And believe me, she was not all better. In one case, she was worse.”

In making coverage decisions about mental health and addiction treatment, insurers frequently use “their own kind of black box criteria, not knowable to enrollees and not consistent with standards of care,” says Julie Snyder, director of government affairs at the Steinberg Institute (<https://steinberginstitute.org/>), a Sacramento-based mental health policy and advocacy group.

A California law that took effect Jan. 1, SB-855 (https://leginfo.ca.gov/pub/99-00/bill/asm/ab_0051-0100/ab_88_cfa_19990309_113734_asm_comm.html), should make it much harder for state-regulated commercial health plans to do so. It requires them to use nationally recognized clinical standards established by nonprofit associations of clinical specialists (<https://dmhc.ca.gov/Portals/0/Docs/DO/APL21-002-SB-855MHSUDCoverage.pdf>) to determine which mental health and addiction treatments they’ll cover — and for how long.

This means, for example, that insurers will find it more difficult to limit a client to only a week of residential addiction treatment when 30 days is the clinical standard, or to treat only the most immediate physical symptoms of anorexia and not the underlying psychological drivers, says Snyder.

“It’s a very strong law, and it has the potential to really be a game changer,” says Karen Fessel, executive director and founder of the Mental Health and Autism Insurance Project (<https://www.mhautism.org>), which supported the legislation.

There could hardly be a better time to beef up mental health coverage, as we approach the anniversary of a pandemic that’s been tied to an increase (<https://www.cdc.gov/mmwr/volumes/69/wr/mm6932a1.htm>) in depression, anxiety, substance use and suicidal thoughts.

Crucially, the new law, which updates and replaces California’s previous mental health parity statute, dramatically expands the number of conditions insurers must cover.

The state law in force until this year required coverage for only nine “severe” mental illnesses (http://www.leginfo.ca.gov/pub/99-00/bill/asm/ab_0051-0100/ab_88_cfa_19990309_113734_asm_comm.html), including schizophrenia, bipolar disorder and major depressive disorder, and for “serious emotional disturbances” in children. SB-855 mandates coverage for conditions (<https://www.psychiatry.org/psychiatrists/practice/dsm>) ranging from mild to severe.

Federal law already required broader coverage, but in vague terms that health plans have frequently circumvented with their restrictive definitions of what’s medically necessary, patient advocates say.

By expanding the range of conditions health plans are obliged to cover and holding them to stiffer standards on the type and amount of care they must pay for, the new law closes “loopholes you could drive a Mack truck through,” says state Sen. Scott Wiener (D-San Francisco), who authored the legislation.

For years, many health plans declined to cover mental health treatment until a patient was in crisis, Wiener says. The new law “makes sure people will be able to get care early while they still have a home, a family, a job.”

Another key aspect of the law is that it requires health plans to cover out-of-network providers at in-network costs if an enrollee is unable to find timely treatment a reasonable distance — generally, 15 miles or 30 minutes (https://www.dmhc.ca.gov/Portals/0/Docs/DO/TAC_accessible.pdf) — from their home.

“That is something we run into all the time,” Bailey says. The family has spent \$100,000 over the years on out-of-network mental health providers for their two

kids, she says.

Opponents of the new law, including the California Association of Health Plans and the California Chamber of Commerce, have argued it will significantly increase health care costs, subject insurers to continuous litigation and — through its stringent definition of medical necessity — impede the ability of providers to decide what’s best for their patients.

Proponents say the medical necessity guidelines spelled out by the specialists’ associations allow providers wide discretion to decide the best treatment for each patient. An analysis (<https://californiahealthline.org/wp-content/uploads/sites/3/2021/02/SB-855-CHBRP-analysis.pdf>) conducted for state legislators by the California Health Benefits Review Program estimated that in the first year of the law’s implementation, premiums and enrollee cost sharing would rise a mere 0.002%.

The new law won’t help everybody: It applies only to state-regulated commercial health plans covering some 13 million (<https://californiahealthline.org/wp-content/uploads/sites/3/2021/02/SB-855-CHBRP-analysis.pdf>) Californians — about one-third of the state’s population. It excludes Medi-Cal, which insures another third of state residents, as well as federally regulated commercial plans, which cover nearly 6 million (<https://www.chcf.org/publication/2020-edition-california-health-insurance-enrollment/>).

Because only a minuscule share (<https://www.kff.org/private-insurance/issue-brief/claims-denials-and-appeals-in-aca-marketplace-plans/>) of patients fight their health plans over denials of care, mental health advocates hope that diligent enforcement by the Department of Managed Health Care, which regulates plans covering the vast majority (<https://www.chcf.org/publication/2020-edition-california-health-insurance-enrollment/>) of commercially insured Californians, will discourage insurers from denying necessary care in the first place.

Rachel Arrezola, a spokesperson for the agency, which opposed provisions of the legislation last year, said it fully intends to ensure compliance and has begun to do so.

But if your health plan still denies you the care you believe you need, fight it, patient advocates and health care attorneys say.

“You need to be vigilant, and you need to advocate for yourself and you need to appeal denials, and you need to do it in writing,” says Cari Schwartz, a Los Angeles lawyer who represents patients.

If you appeal a decision over the phone, take detailed notes, write down the time and day of the conversation and get the name of the person you spoke with, Schwartz says. Build a file of all communications and other information related to your case, she says.

And be persistent. “I think insurance companies bank on individuals giving up the fight,” Schwartz says. If you need help, contact the Health Consumer Alliance (1-888-804-3536 or www.healthconsumer.org), which offers free advice and legal services.

If your mental health provider requested a certain type of treatment in 2020 that was denied by your health plan, ask the provider to resubmit it this year, because the changed legal landscape might work in your favor, says the Steinberg Institute’s Snyder.

With most commercial health plans, you have 180 days from the date you receive a denial to file an appeal. You must first appeal to your insurer. If it fails to respond after 30 days, or upholds its decision, you can take it to the agency that regulates your policy.

In most cases, that will be the Department of Managed Health Care (www.dmhc.ca.gov or 1-888-466-2219), which has a help center and allows you to file a complaint online. If your regulator is the California Department of Insurance, you can call its helpline at 1-800-927-4357 for advice, and file a complaint on its website (www.insurance.ca.gov).

Most Californians enrolled in commercial health plans are entitled to a review by independent medical experts if they are denied care because the insurer deems it unnecessary, or it’s experimental — or the insurer won’t reimburse them for emergency care.

County siren alert system update

With the Idyllwild Fire Protection District standing up its emergency siren alert system last week, the newspaper contacted the county about the status of its siren alert system.

“I reached out to our team for an update,” wrote Shane Reichardt, senior public information specialist for the county’s Emergency Management Department, in an email Monday morning. “We are still in the awarding process for the Mountain Top Project Request For Proposal [RFP] bid. I’m told we are close to awarding the project and are currently ironing out the details of the agreement.”

Reichardt added, “One note, though Station 23 [Pine Cove] is an option, the team is still making site visits to determine the best locations and those have not been confirmed yet. Idyllwild’s siren is free standing and separate from what the county is working on.”

The newspaper previously reported, “The county is also still looking to expand WNKI across the mountain.

regulators, are well worth the effort: About 60% of Independent Medical Reviews filed through the Department of Managed Health Care result in the patient getting the treatment that was initially denied, Arrezola says.

Be sure to open an archive on the managed care department’s website (<https://wpso.dmhc.ca.gov/imr/>), in which you can search past decisions for cases similar to yours. They can help you frame your arguments.

Ultimately, the utility of the new law depends on the will of regulators to enforce it and of consumers to avail themselves of it.

“With any luck, it means people won’t have to take out a \$50,000 mortgage on their house to pay for their children’s opioid treatment,” says Snyder. “Unfortunately, that is all too common.”



lot. I wish we would get some kind of word about her. It’s nerve racking.”

Outside of the search for Lane, the community has not received any updates on the other three missing people. Friends, family and the community have been left in the dark.

Prifogle was reported missing after going on a hike in the Pine Cove area Wednesday, March 4, 2020. He left home at about 1 p.m. and was last seen at the Pine Cove Market at 6:30 p.m. the same day. He was last seen wearing a red backpack and jeans.

RCSD Deputy Jeremy Parsons said, “After six full days of searching in between inclement weather, searching 8 to 10 hours per day, Prifogle has not been located. The Riverside Mountain Rescue Unit (RMRU),

as well as search and rescue volunteers from San Bernardino County, Orange County and San Diego County, were assisting. In total, about 150 people have been searching during those six days.” Also adding, “On the second or third day of the search, we found his backpack, but have found no other clues as to his whereabouts.”

On Sunday, June 7 at approximately 8:24 a.m., Hemet Station deputies were dispatched to the 58000 block of Bonita Vista in reference to a missing person. Abrams was placed into the system as a missing person. Abrams was 65 years old at the time she went missing. She is 5’ 5” tall, 130 pounds with blonde hair and blue eyes. She was last seen wearing a black and turquoise jacket, yellow shirt and blue jeans.

On June 6, Abrams was last seen by her self-proclaimed live-in boyfriend/fiancé Keith Harper at her ranch in Apple Canyon (between Mountain Center and Garner Valley). Since the initial search efforts eight months ago, the RCSD has not provided new information or updates regarding her disappearance despite weekly inquiries from the Town Crier.

Gotfredson has also been following the case since the beginning. In a previous broadcast, Gotfredson reported that News 8 and drone pilot Steve Jensen made their way out to Grand Wash Cliffs in Arizona to do some searching of their own.

Gotfredson and Jensen spent multiple hours over a two-day period searching the cliffs and surrounding area for remains or clothing that match what Abrams was last reported wearing. Unfortunately, they didn’t find anything.

According to Gotfredson’s story, Harper was in the Grand Wash Cliffs area a few weeks before Abrams went missing. He owns about 85 acres of land. While Harper lived with Abrams at her ranch, two days after she went missing, Harper left the state, driving through Arizona to get to New Mexico.

Gotfredson reported that the San Juan County Sheriff in New Mexico obtained a search warrant and deputies impounded the RV Harper drove to New Mexico taking evidence from inside. However, the RCSD has not provided any persons of interest or suspects regarding Abrams or any of the other missing people.

There are many ways parents come up with names for their children. Sometimes, it's a family name that is passed down. Other times, it's a name they found in a book, or perhaps, it's a name they always had in mind. For this couple, however, they chose to name their first little girl after Idyllwild.

Bronwyn Lewis Friscia and James Friscia moved to San Diego in October of 2020, but discovered Idyllwild while living in Venice Beach years before when they made a trip up for Valentine's Day. They fell in love with the community, so much so, they chose to name their first child after it.

Bronwyn said, "Ages before we were even thinking about having children, we looked at each other and said, 'Wouldn't Idyllwild be a cool name for a woman?' When we found out we were pregnant with a daughter, we looked at each other and said, 'Idyllwilde?'"

The decision stuck, and they welcomed Idyllwilde Bryony Lewis Friscia into the world in early May of 2020. She will be celebrating her first birthday in less than a month.

"We have been coming to Idyllwild for many years," Bronwyn said. "We loved the town and when we think about the name Idyllwild, it kind of captured Idyll meaning peace, and Wild capturing adventure." James added, "Those are two things we aspire for her to be — a free adventurer — and we went with it."

While the town is spelled Idyllwild, the Friscias wanted to give their daughter a little something of her own and decided to spell her name Idyllwilde.

While there's been some debate on when exactly the Friscias first made their way up to Idyllwild, they know they fell in love immediately.

While Bronwyn thinks it was in 2016, James said, "I think it was much sooner than 2016, but I know it was on Valentine's Day for sure. We've had some debate on when exactly we first came up."

Regardless of when, the Friscias wanted to escape the city and had been promising each other a trip up to Idyllwild for a long time. A quick get-away to somewhere new was their goal.

"The name [Idyllwild] just captured our imagination," Bronwyn said. "It looked like a lovely, artsy, spiritual change of pace from Los Angeles. It was all of that and a lot more."

AN INTERVIEW with Adam Rubin

Many students have read the books **Dragons Love Tacos** and **Dragons Love Tacos 2: The Sequel**. Kindergarten students at Strobridge Elementary in Castro Valley, CA put together a whole lot of questions for the author Adam Rubin and they loved these books so much, they went on to read more of Adam's books.



Q: How did you make the book?

A: I get this question a lot and I think some students are under the impression that I actually physically produce the books in my apartment ... I only write the words.

I use Google docs (just like a lot of students I know). After I'm finished writing, Dan draws the pictures and then all the digital files are sent to a factory in China where they print out the copies of the books for people to buy. The front and back cover are hard because there are thick pieces of cardboard hidden under the paper.

Q: How did you think of the idea?

A: When I was a kid, my dad had a little statue on his desk that looked like a dragon eating a taco. It made me think of the phrase "Dragons Love Tacos" which stuck in my head until I was an adult and it sounded like a good title for a picture book. I have the statue on my writing desk now.

Q: Where were you when you wrote the story?

A: I wrote *Dragons Love Tacos* at my kitchen table at night after work while I was working at an advertising agency in Chicago. I had a day job and wrote stories at night for the first seven years that I was an author.

Q: Why do dragons love tacos?

A: Dragons love tacos for the same reasons I love tacos. Tacos are delicious, nutritious, fun to make and easy to eat. There are endless varieties. They are the perfect food!

Q: Why don't dragons like spicy salsa?

Dragons have a special sensitivity to spicy foods, just like my Uncle Morris. Luckily, I have a stronger stomach and love to eat spicy salsa. The spicier the better, in fact.

70 years ago - 1951
The last troop of Marines left Dark Canyon after completing several months of cold weather training to prepare for combat in Korea.

65 years ago - 1956
Members of several community groups — the Hilltoppers, Chamber of Commerce, Lions Club and the PTA — met to discuss the development of recreational activities for young people on the Hill.

60 years ago - 1961
Pine Cove residents were organizing support for a post office.

55 years ago - 1966
The Riverside County Board of Supervisors approved 18 streetlights for Idyllwild.

50 years ago - 1971
As a maneuver to prevent a proposed subdivision in Garner Valley, a bill was introduced in Congress to permit the federal government to purchase 2,200 acres of land as an addition to the San Bernardino National Forest.

45 years ago - 1976
The U.S. Forest Service was pondering the question of whether Lake Fulmor should be made safe

for swimming or if swimming should be allowed there at all. Although it was not permitted and was not considered safe for swimming, no restrictions to swimming were posted. According to a Forest Service official, this is still the case.

40 years ago - 1981
Hillcrest Market in the Strawberry Creek Square was advertising bacon at 89 cents per pound, bananas at 29 cents per pound, avocados at 29 cents each and three loaves of bread for \$1.

35 years ago - 1986
No objections to a proposal for a collection station to replace the Idyllwild dump were raised at a Town Hall meeting that county officials called.

30 years ago - 1991
Softball leagues for adults and kids were brought back to the Hill after a four-year absence. Town Hall organized the kids’ teams and the Amer-

ican Legion coordinated the adults’ teams.

25 years ago - 1996
After a short-lived increase to 65 mph, the speed limit on Highway 74 from Hemet to Palm Desert and on Highway 243 from Pine Cove to Banning reverted to 55 mph.

20 years ago - 2001
Idyllwild’s Lioness Club met for the last time, ending almost 13 years of community service. Some of the Lionesses were invited to join the men’s Lions Club, which held its last meeting in June 2008.

15 years ago - 2006
Nearly two months after a heated community meeting about Idyllwild recreation, representatives of the Idyllwild Chamber of Commerce and the Idyllwild Community Recreation Council met to begin discussions about how to peacefully transfer the county’s recreation contract from the Chamber to ICRC.

10 years ago - 2011
Idyllwild’s Casey Abrams risked it all on Wednesday’s “American Idol” telecast. Rather than follow the advice of Idol coaches Jimmy Iovine and will.i.am and cover Phil Collins “In The Air Tonight,” Abrams sang “Nature Boy,” a Nat King Cole song, again accompanying himself on bass.
