More thoughts on STR draft **Ordinance 927**

Editor's note: Riverside County's Planning Department has proposed major changes to Ordinance 927, "Regulating Short Term Rentals" (STRs). The draft is available for public

The March 10 edition of the Town Crier describes the significant differences between the current ordinance and the revised draft. The March 17 issue has a story discussing the draft ordinance from the perspective of local residents who see the need for more control of STRs, particularly on the Hill.

The existing ordinance was approved six years ago when STRs were raising hackles mostly in the county's cities. However, the attraction of Idyllwild, a mountain, forest, quiet, and, perhaps, quaint, continued to draw weekend visitation.

When the "work from home" trend became popular after the COVID pandemic trapped people at home, the number of STRs continued to increase faster on the Hill. With this expansion of opportunities, visitor comportment began to degrade, and occasionally disturb and disrupt longtime residents.

The issue of greater regulation of STRs was on the Riverside County Board of Supervisors' agenda two years ago. And just last June, the county's grand jury issued a report on the ineffectiveness of the current Ordi-

A controversial town meeting about STRs, attracting more than 100 people on both sides of the issue, was held in November.

The county has released a second revision to Ordinance 927, which has incorporated many major changes, but not all the recommendations. This draft is scheduled to be addressed at the April 20 Planning Commis-

While Vacation Rental Owners and Neighbors of Riverside County (VRON) says its representatives "meets directly with executives in the Riverside County Planning Department to discuss Short Term Rental ordinances," local STR owners feel they are unheard at the county level.

Idyllwild's STR owners recognize the problems that unruly and inconsiderate visitors can unload on a neighborhood. Many have dealt with renters before STR became an acronym.

And they emphatically agree that improved enforcement is critical to resolving the problems; however, to some extent, they feel ostracized, almost, like pariahs in

'STR owners, in general, are not opposed to more or new regulations, but we feel left out of the conversation to the detriment of everyone," said Jon Brown, a longtime resident and STR owner.

Another local STR owner, Melanie Bomar, separately expressed a similar sentiment. "I am saddened by the increased division in the community about STRs. Although, I think many have no idea that is going on ... No one wants divisions. I dislike the push against STRs and their owners. It is frankly strange."

They stressed that STR owners do care about renters' behavior. They don't want their houses or cabins, which are investments, damaged.

Ronn Kilby described how most STR owners treat the community and deal with renters. "We do everything by the book (and better), play by the rules, pay our taxes, and make sure our neighbors are in no way inconvenienced," he wrote in an email. "In [two] years we have had one... noise complaint. The guests were immediately told to pack up and leave. End of problem."

He is not the only one to describe this reaction to a complaint.

The solution to the problem disorderly visitors cause has a common answer.

U.S. Senate passes bill for permanent daylight saving time

Tuesday, March 15, the U.S. Senate approved "The Sunshine Protection Act of 2021" Florida Sen. Marco Rubio introduced last year. The bill would make daylight saving time (DST) permanent. Beginning in 2023, we would no longer have to remember which Sunday in March is "spring forward" or when we "fall back" in No-

While we have sprung forward in 2022, eliminating bi-annual clock and watch changes still requires the House of Representatives to pass the bill and then President Joseph Biden must sign it before it becomes law.

March 9, the Subcommittee on Consumer Protection and Commerce of the House Energy and Commerce Committee held a hearing on the advantages of permanent DST. No action was taken by the subcommittee during the hearing.

But the chair of the full committee, Frank Pallone (D-NI) sent a letter to Secretary of Transportation Pete Buttigeig requesting an analysis of how time changes impact productivity, traffic, energy consumption, consumer activity, and other societal and economically relevant factors.

In his statement, Pallone wrote, "While I have yet to decide whether I support a permanent switch to Standard or daylight saving time, it's time we stop changing our clocks. I believe that any justifications for springing forward and falling back are either outdated or are outweighed by the serious health and economic impacts we now know are associated with the time changes"

Pallone subsequently wrote on Twitter, "I'm pleased to see momentum building after our hearing last week on the impacts of springing forward and falling back. It's clear to me that it is time to stop changing our clocks twice a year."

While there was little debate on the Senate floor about this momentous legislation, public opinion and state legislatures have been trying to provoke a change for several

According to the National Conference of State Legislatures (NCSL), "In the last four years, 19 states have enacted legislation or passed resolutions to provide for year-round daylight saving time... "

In 2018, Florida approved a bill authorizing a permanent DST when Congress would approve it. This was Rubio's motivation to draft the federal bill.

"Just this past weekend, we all went through that biannual ritual of changing the clock back and forth, and the disruption that comes with it. And one has to ask themselves after a while, 'Why do we keep doing it? Why are we doing this?'" Rubio said on the Senate floor.

"So we're doing this back-and-forth clock changing for about 16 weeks of Standard Time a year. I think the majority of the American people's preference is just to stop the back and forth changing. But beyond that, I think their preference is - certainly at least based on today's vote, and what we've heard — is to make daylight saving time permanent."

The other 18 states that have passed legislation to eliminate time changes are, according to the NCSL, Alabama, Arkansas, California, Delaware, Georgia, Idaho, Louisiana, Maine, Minnesota, Mississippi, Montana, Ohio, Oregon, South Carolina, Tennessee, Utah, Washington and Wyoming.

The first national effort to synchronize local times occurred during World War I, as an effort to save fuel and cooperate with European countries. After the war, legislation to extend this new national concept failed.

While many attribute its initial passage to agricultural interests, the opposite is true. Farmers' lives and work are organized around the Sun, not a clock. And live-

COVID-19 LOCAL UPDATE:

U.S. expecting rise in less-serious Omicron strains

Last week's COVID story related several European countries and the U.S. have reported finding new COVID variants, originally referred to as Deltacron, but designated by the Centers for Disease Control (CDC) as Omicron variants with several subvariant "lineages." Omicron currently consists of five lineages sweeping Europe and, potentially, the U.S., but appear no more serious than the originally discovered Omicron while also being vulnerable to existing vaccines. They seem to be less likely to cause severe disease than earlier variants, such as Delta.

With serious COVID on the wane, CDC's emphasis is now on persons who are at high risk for severe illness, hospitalization and death. So, who is most likely to die or become very sick from COVID? As reported by CDC last week: the aged and those with underlying medical conditions are most vulnerable, particularly if they're not up to date with vaccinations. Underlying medical conditions include, but are not limited to: cancer, chronic kidney disease, chronic liver disease, chronic lung diseases (including asthma and COPD), cystic fibrosis, dementia or other neurological conditions, diabetes (types 1 and 2), disabilities, dementia, heart conditions (possibly including high blood pressure), HIV, weakened immune systems, obesity and overweightness, physically inactive persons, pregnancy, sickle cell disease or inherited red blood cell disorders, smoking (former or current), stem cell or organ transplant recipients, stroke or cerebrovascular disease, substance use disorders and tuberculosis.

As of Tuesday, March 22, Riverside County Public Health (RCPH) was reporting a total of 312 COVID cases in Idyllwild-Pine Cove resulting in six deaths and 306 patients recovered, leaving no active cases in this com-

As of Tuesday, March 22, the state of California reports 589,657 total cases in Riverside County with 4.2 new cas-

es per 100,000 residents over a seven-day moving average. There are 2,418,185 residents in our county as of the 2020 census, so that works out to about 102 new cases over the current seven-day moving average period in our county, a 28% reduction from last week. The state reports 6,376 confirmed COVID deaths in Riverside County. The state also reports 92 hospitalized COVID patients with 105 ICU beds currently available in our county, 55 more than last week.

As of Tuesday, March 22, the Dashboard of the Hemet Unified School District (HUSD) reported active cases (last two weeks) of COVID at Idyllwild School as being no students or staff members — down to zero cases, the same as last week. At Hemet High, five students and no staff members were reported as active cases, which is 0.19% of its combined student/staff population. Hamilton School reported one student and one staff member with active COVID, which is 0.44% of its student-staff population.

CDC has replaced reporting "transmission areas" with "community levels." A community level takes into consideration the number of people admitted to local hospitals during the past week, the number of total hospital beds with COVID patients, and new COVID cases during the past week.

As of Tuesday, March 22, RCPH reports that in Riverside County, 19.7% of the population ages 5 to 11 are now "fully vaccinated" — while 50.6% of ages 12 to 15, about 55.6% of ages 16 to 24, 59.8% of ages 25 to 44, 73.2% of ages 45 to 64 and 75.6% of ages 65-plus have been fully vaccinated. Currently, the term "fully vaccinated" still does not include boosters.

As of Monday, March 21, California reported 8,465,358 total confirmed COVID cases statewide (27,038 more than reported last week, which is a 3.9% increase in new cases from the previous week) with 87,485 total resulting deaths (691 more than reported last week, which is a 26.9% reduction in new deaths from the previous week).

As of March 16, the CDC current seven-day national moving average of daily new COVID cases was 30,040, a 19.1% reduction from the previous week's seven-day moving average. The Omicron variants account for virtually all new cases in the U.S., with the more serious Delta variants at zero. A total of 79,486,762 COVID-19 cases and 965,575 COVID-19 deaths have been reported in the U.S.

CDC advises that vaccination, along with other important prevention strategies, continues to be the best defense against severe COVID disease. Everyone aged 5 years and up is recommended to be vaccinated, with boosters for everyone aged 12 and older — specifically the Pfizer-Bi-oNTech booster for those ages 12 to 15. CDC now recommends that people with weakened immune systems get their booster doses three months after their second dose instead of waiting five months.

HUSD issues statement to families

The Hemet Unified School District (HUSD) has released a notice informing parents that the California Department of Public Health (CDPH) has issued revised COVID guidance that "strongly recommends" school districts follow a "Group-Tracing Approach" to students exposed to COVID in grades kindergarten through 12th (K-12).

It then informs:

"• HUSD will notify all students who spent more than 15 minutes with a 24-hour

timeframe in shared airspace (e.g., classroom) with a person who is COVID-positive.

Notifications will be provided to all individuals

exposed, including those who are vaccinated or those that are within their 90day post-positive

window. Notification will occur electronically through email with detailed

instructions and next steps to keep your child(ren)

well. "• CDPH recommends that exposed students, re-

gardless of vaccination status, get at least one diagnostic test [three to five]

days after known exposure. Exposed students may continue to take part in all

aspects of K-12 schooling, including sports and extracurricular activi-

ties, unless they develop

symptoms or test positive for COVID-19."

The district further explains:

"• If your child is exposed, he/she may remain in school including sports and

extracurricular activities, regardless of vaccination status unless your child

develops symptoms or tests positive for COVID-19. Your child may test for COVID-19 within [three

to five] days after the date of last exposure. If you desire your child to participate in a test after exposure, HUSD will offer this testing at your child's school site.

"• If your child develops symptoms of COVID-19

or tests positive for COVID-19, please ensure he/she isolates at home immediately and notify your child's school right away. When you notify HUSD, we can take additional steps to keep our school community safe.

It is strongly recommended that your child continue to wear a mask indoors in the school and community for 10 days following the exposure."

The district further advised that Head Start programs have different federal requirement, referring parents to a communication from Hemet Preschool Principal Alice Chung, and added that HUSD would continue to provide parents with regular updates as needed, assuring parents that it was committed to facilitating an optimal learning experience ensuring the safety of HUSD's students, staff and community.

The above HUSD notice was provided in Spanish as well as in English.

Gas increase relief considered

In California Sunday, March 20, the average price for a gallon of gasoline was \$5.85, 37% higher than the national average. In Riverside County, it was \$5.86 per gallon, but in other areas of California the price per gallon exceeded \$6 per gallon and approached \$6.50 in Mono County

While the Russian invasion of the Ukraine and President Joseph Biden's stopping imports of Russian fuel have driven prices up sharply in the past two weeks, many people are looking for help from the government — much like in the COVID-19 aid.

Gov. Gavin Newsom alluded to some relief in his March 8 State of State address. "Look, no one's naive about the moment we're living in, with high gas prices and the geopolitical uncertainty fueling them.

'In January we proposed to pause the gas tax increase. Now, it's clear we must go further. That's why — working with Legislative leadership — I'll be submitting a proposal to put money back in the pockets of Californians, to address rising gas prices," Newsom continued.

The details of how and how much money would be returned to Californians' pockets have been scarce in the past two weeks.

Current state tax on gasoline is 51 cents per gallon and fuel supplies pay that. It is indexed to inflation rates and will increase by 3 cents July 1.

In his January budget proposal, Newsom suggested this increase of 3 cents could be repealed for this year, which would cost the government about \$525 million for road and

infrastructure projects. Further, there is no guarantee that gas suppliers, who pay the tax, would commensurately reduce the price of gas.

Early last week, Californian Republican legislators proposed rescinding the full gas tax for the year. This didn't

Thursday, March 17, a group of state legislators suggested sending a \$400 tax rebate to California taxpayers.

"Soaring gas prices are hitting Californians at the pump. We know our constituents are hurting," said Assembly-woman Cottie Petrie-Norris (D-Irvine). "That is why we are here today to announce a proposal to deliver a \$400 tax rebate for California taxpayers. To put this in context, for most vehicles, for most Californians, this \$400 rebate is equivalent to a one-year gas tax holiday."

In the news conference, Petrie-Norris said their hope is to get the rebate to Californians this spring and they would discuss the proposal with the Newsom administration.

While bipartisanship is tenuous on this issue — Democrats stopped Republican Kevin Kiley's bill to suspend the full gas tax, Republican Assembly Leader James Gallagher wrote on his Facebook page about the rebate proposal: "Capitol Democrat's Plan = Everyone gets a check from the government at some undetermined date in the future... Whether you own a car, or not. Whether you use gas, or not. Whether you are a billionaire, or not.'

The rebate proposal is favored as a means to get the relief directly to the public rather that reducing the tax for suppliers who may not pass it onto drivers. Initial estimates of the cost are \$9 billion.

stock, particularly dairy cattle, do not adjust to new schedules very quickly or well at all. So farmers were instrumental in the failure to continue DST.

Then World War II occurred and another shift was approved, which was repealed three weeks after the war ended.

Finally in 1966, the Uniform Time Act was passed. DST would return for six months of the year. Then the 1973 gas crisis occurred and President Richard Nixon and Congress established DST for 12 months. That change was also imperma-

In 2007, the nation began starting DST in early November and ending in early March — about four months was all the public could tolerate.

Public opinion favors a permanent time but is divided between Standard and DST. According to AP-NORC Center for Public Affairs Research, an October 2021 poll found that "43[%] want to stay on standard time year-round, while 32[%] prefer to see the clocks remain on daylight saving time. Only 25[%] like the existing state of affairs in most of the country, shifting back and forth between daylight saving time in the summer and standard time in the winter.

Of those favoring DST year-round, 37% were adults 60 years or older. Of those respondents between 18 and 29 years, only 24% favored this alternative. Of those who are satisfied with the twice a year time adjustment, 32% were in the younger age group and only 22% were over 60 years.

If permanent DST is established, many youth sporting events will not be called because of darkness in the early spring. This was one of Rubio's talking points — more daylight in the evenings.

Since daylight is fixed, and not legislated, more of it in the evenings means less in the mornings. So school children will be waiting for buses in the dark until after 8 a.m. in some lo-

Sleep experts prefer making Standard Time permanent, rather than DST.

"The [American Academy of Sleep Medicine] [(AASM)] cautions that making daylight saving time permanent overlooks potential health risks that can be avoided by establishing permanent standard time instead," the academy wrote in its recent press release.

"Data clearly show that the sudden change from standard time to daylight saving increased risk of adverse cardiovascular events, mood disorders, and motor vehicle crashes," the academy continued.

AASM concluded with the following position, "... current evidence best supports the adoption of year-round standard time, which aligns best with human circadian biology and provides distinct benefits for public health and safety."

Making DST permanent still awaits action, but none has been scheduled in the House of Representatives. While waiting for the next step, Sen. Patty Murray (D-WA) wrote to House Speaker Nancy Pelosi (D-CA), "I write to urge the House of Representatives to consider and pass S. 623, a bill to make daylight saving time permanent ... as soon as possible."

tent enforcement," Brown stated. "The county needs to step in and enforce the regulations.... We realize that code compliance is very important."

"The ordinance doesn't have teeth," or "it's a convoluted legal process" were the opinions of several residents concerned about the nuisances STRs created. Everyone wants the county to have an active role in limiting the problems and providing satisfactory resolutions.

Brown was pleased that the board of supervisors approved more funding for more Code Enforcement

Idyllwild," he opined.

Many of those concerned about the Hill's STR growth urge the county to place a numerical limit, similar to what some cities have done. After the number of STR certificates reaches this limit, the county will not issue any new certificates, unless an existing STR returns its certificate.

But Brown and Bomar made several counter arguments. First, vacation rentals have always been an attraction to Idyllwild for residents in the desert and western valleys.

Today, renting a cabin has a special appeal that complements its location — mountains, forest, blue sky and a rustic, sometime romantic, setting. This was its initial attraction. What's different is that more people, especially the millennials want to have this opportunity.

"The vast majority of visitors want to stay in cabins," Brown believes. "The people who visit Idyllwild want cute cabins in the woods." While some visitors prefer the comfort and service of an inn or lodge, the demand and growth of these facilities has not matched the growth of vacation visitors, he opined.

Brown argued that the increase in work-at-home opportunities began before COVID-19, which merely accelerated the trend. Young people forming families have a difficult time finding affordable housing in Los Angeles, Orange and San Diego counties. But they can find family housing here.

He opined that complaints, such as noise, parking or other, should be registered on a county website. This would ensure that people would know how the problem was resolved.

The draft ordinance expands on the requirement that owners post signs, with pertinent information, in the front of an STR.

The sign, limited to 2 square feet, must be posted on the site and visible from the street. It should have the name and telephone number of the person responsible for answering any complaints. The maximum number of occupants is also required.

Emergency numbers for the sheriff's department, local emergency medical services and Code Enforcement's 24-hour number also are to be visible.

But these signs may attract crime rather than Parking and noise are common and legitimate help neighbors. Scott wrote, "I understand the logic behind erecting signs in front of STRs, but I honestly don't think anyone is going to like it if it happens... STR signs are practically an advertisement to criminals and thieves that a house is often empty and that neighbors don't know who might look out of place. It's an invitation for an increase in theft and vandalism in our quiet community, and I think everyone would eventually recognize that it's a mistake."

And Kilby had a similar opinion, "We have very little concern about the proposed revisions to the STR regulations. With one major exception, — we think posting a sign on our property that basically tells all that the house is often empty (and a prime burglary opportunity) is way beyond the pale.



New book highlights famous local artist Jon Gnagy

By David Jerome Correspondent

Charles M. Province's list of published works include no less that 11 titles about General George Patton, (including one focused on the allegation that he was assassinated by the powers that be). His latest work is "Jon Gnagy — America's Art Teacher." Gnagy, to those not old enough to remember, hosted a long-running series of art lessons that were a staple of early television. The book comes to the Crier for review, and we present it to our readers because Gnagy spent a long spell on "the Hill," residing here, teaching and making art from 1960 until his death in 1981. At various times he had a studio (since burned down) near present-day Mile High Cafe, and gave regular public demonstrations at the old Welch's Carriage Inn.

Gnagy's story is one worthy of an artist: his birth to a Mennonite family in Kansas in 1907, the early recognition of his talent and vocation, the years of hardship during the Great Depression, and his bout with depression and shock therapy. From this he emerged more

dedicated than ever and more sure of his mission.
Gnagy's motto was "You are an artist." His televised lessons and books taught that the student could draw anything with four basic shapes (cube, cylinder, cone, sphere.) He was a great encourager, leading generations to pick up a pencil (or order a kit) and follow along.

What viewers could never guess was that these relaxed, intimate, 15-minute lessons in which a drawing appeared line by line, each action explained to the student, were intensely rehearsed. Each week he would write a script of 2,000 words, memorize it, and practice delivering it while sketching in front of a mirror. Then he would try his lesson out on a "lay person," a studio technician, asking them to stop him if anything he said was not clear. Only then was the program broadcast. Most viewers found it impossible to keep up with the church. He said, 'I know your son is an artist. We've got master, but the purpose was to get people started, to John Gnagy." teach that even their first drawing could be fun, recognizable and, maybe, beautiful.

Gnagy was a true TV pioneer; when NBC began commercial telecasts in 1946 from its studio in the Empire State Building, the first show included celebrity gossip, comic skits, a chef and Gnagy. He always treasured the floor manager's compliment when he walked off the set after his first segment; "Jon, that was great. Your show was pure television." Gnagy understood the technical and emotional aspects of the new medium like few others. He also understood the business end; his shows were unpaid work, but he advertised his books lighthouses, my favorite is the mission. Always that eland art materials (available at an art supply store near you.) His sketches he donated to be auctioned for chari-

His ambition never flagged, and when TV went color, he experimented tirelessly to perfect a quick color painting process, but never made the transition. Gnagy retired from the TV shows, fished more, and moved to

Several chapters consist entirely of reproductions of the artist's work, spanning beyond ic art for advertising clients. Sixteen pages of plates iling in Arizona now] lived in Banning at the time and

lustrate "game" fish, both salt and fresh water, illustrations from "Peterson's Field Guide to Pacific Coast Fishes" and "Field and Stream" magazine, and a thick collection of Gnagy's own fish stories, some of which gear manufacturers commissioned (and a beer company he was a marketing genius.) A few delightful teasers are sprinkled among the over 400 pages, including the quote from Andy Warhol, that "Jon Gnagy taught me to

The book also includes profiles of two students of his who still live in the Inland Empire — Mike Bennett in Beaumont and Henry Balzer in Redlands. Bennett only had a few contacts with his mentor but Balzer studied privately with him in his Idyllwild home studio. Both artists are advocates for their mentor and helped to "sketch" him for this article.

Mike Bennett, then aged 11, met Gnagy at the 1966 grand opening of the San Bernardino May Company, where the artist was doing a demo lesson for children. He still has the drawing he completed that day, and has since done many variations on it. Gnagy's paintings are like that; iconic compositions that several generations of

aspiring artists have "covered" repeatedly.

MB: "He reached into people's living rooms. I was a kid in the 60s watching reruns; he was flawless. I got hooked. At least 10 of these old programs are now on YouTube. Gnagy was the greatest influence on my artistic talent. God gave me the talent, but Gnagy lit the torch. The rest was just practice and observation.'

Bennett was inspired not just to be a professional artist (those licensing payments add up) but also an educator. He now works for the Yucaipa/Calimesa school district and each year shows his students some of Gnagy's video lessons.

TC: "How did you come to study with Gnagy in

MB: "We knew a priest at the Idyllwild Catholic

Five years after that first meeting the family came to Idyllwild during Christmas break of 1971, where Gnagy gave regular "performances" at Welch's Carriage Inn.

MB: "We just thought he'd be there; the management called him to come down. He left his warm house and trudged through the snow. He asked, 'What do want me to draw?' I chose a cabin in the woods, with snow on

the roof."
TC: "Can you tell us anything about Gnagy's technical teaching?'

MB: "He did a lot of building pictures. Goldmine, ement to put you in the picture. Landscapes, too, but the buildings... and how to use the right colors for different times of day. Atmospheric perspective. Everything becomes muted, the colors and shapes blur with distance. Basic composition. perspective. Big trees in the foreground so you felt like you were there, to welcome you to the picture."

My lessons took most of Sunday morning. I didn't realize that he was a famous artist. Ironic[ally], I never saw his show on TV. He was a nice guy and obviously a good painter. He had developed his techniques with pastels, flexible

techniques for blending."

TC: "Can you give an example of Gnagy's technical

teaching?"
HB: "One of the things I remember learning from him is the idea of reflected light. The way that he introduced that to me we would add direct light on one side. A tree is brown; we would put a highlight on one side that was white-ish or yellowish white. But on the other side there would be this light reflected from the atmosphere that would be blue. I was hesitant; he said you have to think about all the light, all sources of illumination, each would have its own color. It looked pretty good when we added the main illumination, but then he had me get out the blue." Henry doubted, but, "Of course he was right."

Both artists share with the author the hope that Idyllwild will have an annual Jon Gnagy Day where youngsters can learn one of Gnagy's lessons in an outdoor class-like setting and introduce them to the wonderful world of art and Gnagy. They both hope the Idyllwild Area Historical Society can find a spot for the artist and "famous Idyllwilder" in the muse




