Zambranas in need after serious collision

Idyllwild Help Center (IHC) Client Services Administrator Skve Zambrana and her husband Mike are recovering from serious injuries they both suffered in a traffic collision Monday night, May 2.

According to IHC Executive Director Colleen Meyer, the Zambranas, who moved to Hemet a year ago because they could not find housing in Idyllwild, were returning home from picking up sandwiches when a 16-year-old unlicensed male driver's vehicle T-boned their vehicle, causing their vehicle to flip upside down. This occurred on the Ramona Expressway in San Jacinto.

Skye was airlifted from the scene with a broken pelvis and right arm, said Meyer. Mike has four broken vertebrae. Both were in the same hospital room at Riverside Regional Medical

California Highway Patrol's Jeff Osteen said the report was incomplete as to the details of what occurred but he did say that a 16-year-old male of San Jacinto was involved, driving a white 2011 BMW 328I, and he was either unlicensed or did not have a license in his possession. The Zambranas were in a gray 2010 Nissan Murano. He confirmed the collision occurred on the Ramona Expressway in San Jacinto at 6:18 p.m.

Mike said he was in the hospital until May 5 and Skye was in for a week.

"I don't remember the moment before the impact," said Mike. He remembers being cut out of the seatbelt. "When I woke up, I was upside down in the car. Skye wasn't there." He said it was very surreal. I kept asking, "Where's my wife? Where's my wife? Is she OK? They wouldn't tell me."

He could only think the worst had happened. He said he then heard her breathing in an odd way outside of the vehicle

She may have been ejected, he said, but neither of them know for sure.

Skye broke both her pelvis and her right arm in two places. He said she just started taking her first steps Monday. "I'm still walking with a walker," Mike said but if he's on his feet for too long, his back swells. Now that Skye is home, he needs to take

"Both Skye and Mike will be out of work for a period of time and their only car was totaled in this accident," wrote IHC employee Kim Negrete. Mike has no estimate as to when they will be able to return to work. Doctors estimate 12 weeks

for Skye's pelvis to heal. "Skye firelessly helps others all day for our community, so let's all rally together to help them as they have a long road to recovery. No amount is too small and all donations are appreciated," said Negrete.

The Zambranas have been married for 21 years and have two children: Zoe is a junior at the University of California, Santa Barbara, and Zach works with his dad at Pino Tree Service where Mike is a safety director.

Humber Park closed from May 16 to 20

The Humber Park trailhead and parking lot, which includes the Devil's Slide Trail (3E05) and Ernie Maxwell Scenic Trail (3E07), will be inaccessible from the afternoon of Monday, May 16 to Friday, May 20 due to contractors mitigating an infestation of Goldspotted oak borer beetles (GSOB).

With windy or rainy weather, this work and the closure may be postponed until the following week (May 23 to 27) or June 6 to 10.

Alternative trails into the San Jacinto Wilderness include:

Deer Springs Trail (3E32)

• South Ridge Trail (3E08)

• Marion Mountain Trail (2E14) To manage the already-infested trees and limit further spread and tree mortality, the San Jacinto Ranger District will be spraying a California-registered insecticide on large, high-value oaks in this area. Spraying must be done at or before the beginning of the "flight season" (mid-May through October) when adult beetles emerge from beneath oak bark and spread to un-infested trees.

GSOB has caused extensive oak mortality in San Diego County and is now spreading north throughout Southern California. There is a potential for significant economic, ecological, cultural and aesthetic losses in the region as well as threats to public safety from hazardous dying trees.

Brian Nash seeks first elective office

Editor's note: On June 7, Riverside County will hold a primary for the two candidates to represent District 32 in the California Senate. The only candidates in the primary are Brian Nash (Democrat) and Kelly Seyarto (Republican). Both will move to the General Election ballot in November. Interviews with both candidates are in this issue of the Town

Brian Nash, the 42-year-old Democratic candidate for Senate District 32 seat, should overwhelm any opponent since he stands 6 foot, 7 inches tall. However, the size of a candidate is no longer how the voters judge them. Nash will have to convince voters of his merits through his statements and positions on the various campaign issues.

Nash is a Michigan native and now lives in Murrieta. This is his first race for elective office and he says his motivation was Donald Trump and the antics of his devoted followers.

"I could never imagine this happening. I can't believe all that is going on," he said with angst. On his website, he wrote, "The pandemic has depleted our patience and kindness. Cowards, grifters, and sociopaths are trying to move us closer to autocracy.

Nash addressed all the major issues — education, health care, climate change and taxes — that are prevalent in current political races. Influencing his view on these and other issues is his belief in Punk Rock ethics. On his website, he noted, "The punk community was decades ahead of the general public on many significant social issues."

On education, he wants to increase state funding, if elected, particularly teachers' pay and

add more teachers to reduce classroom size.

"People are not going into the profession as they should. They're underpaid," he contends.

"And there are a lot more challenges." He believes that greater school funding will help meet current needs and ultimately lead to significantly increasing student score results.

While the state Department of Education (DOE) is reporting falling student populations, Nash argues that is simply a temporary phenomenon of the pandemic. Parents were concerned about their children being exposed to the COVID virus in groups.

Consequently, more parents chose to home school. "At the beginning of the next school year, it should start to return," he maintained.

In an April press release, the California DOE reported, "The annual snapshot of fall enrollment shows a fifth year of decline as the state emerges from two challenging years of the COVID-19 pandemic ... California enrollment declines are consistent with national trends that show enrollment is dropping across the country. These declines began prior to the pandemic and are projected to continue into the future in California."

Climate change is a problem that Nash said "can't just be ignored. We have to work with it."

One of his indicators of the problem and eventual improvement will be wildlife conservation. He

strongly feels there needs to be a balance. More data assessing the risk mitigation of new projects needs to be used more in decision making.
"Every being within the environment plays a role," he said.

Health care is another issue for which Nash has strong feelings and seeks change. He favors a See Nash, page A6

Kelly Seyarto seeks to move to state Senate from Assembly

Kelly Seyarto lives in Murietta with his wife, Denise. For 35 years of his 62 years, Seyarto was a firefighter. In 2015, he retired as a battalion chief for Los Angeles County Fire Depart-

Besides raising three daughters with Denise, he currently is finishing his first term representing the voters of the 67th Assembly District. He also has served as a Murietta City Council member and mayor.

As a former firefighter, Seyarto understands what State Responsibility Areas are and how Cal Fire, the U.S. Forest Service and local fire agencies must work together to reduce the risk of wildfires and to suppress a fire if one starts.

"Working for LA County Fire, I've had a lot of interaction

Kelly Seyarto between the Forest Service and us," he noted.

"And it's important to have local fire departments," he

added. From his own experience, he mentioned that the local departments know every nook and cranny of the locale and are crucial to evacuations and initial attacks. More fiscal resources for Cal Fire is one of his goals. He recognized the importance of

Hemet Ryan Airbase for fighting wildfires in the San Jacinto and San Bernardino mountains. "They have a new helicopter to deploy for aggressively fighting against fires," he acknowledged.

And as an Assembly member, he has already introduced legislation (Assembly Bill 380) addressing some fuel reduction issues.

"One major issue occurs when fuel reduction contracts [are being developed] by any agency. The [California Environmental Quality Act (CEQA)] can sometimes be frustrating. And it may take years and years to get the contract through," Seyarto asserted. "Sometimes you can't wait that long."

His bill builds on Gov. Gavin Newsom's 2019 Emergency Proclamation that exempts certain fuel reduction projects from various legal requirements, including CEQA review requirements. Seyarto wants Cal Fire to identify critical fuel reduction projects each year that need to be completed soon and would qualify for these exemptions.

Unfortunately, the Assembly Natural Resources Committee did not hear the bill, but Seyarto noted that more members are supporting it and he hopes to gain approval if elected to

Besides the Natural Resources and Emergency Management committees, he is vice chair of the Assembly's Elections Committee. When asked if he believes the 2020 election was stolen, Seyarto replied, "We didn't focus on that day. We address issues that originated with See Seyarto, page A6

Christy Holstege Gary Michaels, a seeks to move from city council to state Assembly

Editor's note: On June 7, Riverside County will hold a primary for new State Assembly member from the 47th District. The Democratic candidate is Christy Holstege of Palm Springs. The Republicans have two candidates in the race — Gary Michaels and Greg Wallis. The two candidates with most votes will face off in the November General Election. All three have spoken Christy Holstege to the Town Crier and the in-



terviews are in this issue. Christy Holstege, a member of the Palm Springs City Council and former mayor, announced her intention to seek a California Assembly seat in July 2021. After the State Redistricting Committee finished its redistricting work in December, she then officially announced her candidacy for the Assembly District 47 seat.

The 47th is very similar to the previous 42nd seat, which Assemblyman Chad Mayes represents. It includes many desert cities — Palm Springs, Cathedral City, Palm Desert and Yucca Valley, and Oak Glen, Cherry Valley, Banning and Cabazon, as well as the additions of Idyllwild, Pine Cove and Mountain Center. In January, Mayes announced his intention not to seek reelection to the Assembly.

Holstege, 35, is mother to an 18-month-old son and is a fourth-generation Palm Springs resident, she said proudly. She is the first woman to serve as mayor in the history of Palm Springs — and is also the first openly bisexual mayor in the country.

When asked if elective office had been a lifetime ambition, given her four years' experience on the Palm Springs City Council and her July announcement to seek an Assembly seat, "No," she quickly replied.

"I went to law school [Stanford Law School] to help my community and make a difference," she said. "As I

grew up, I saw discrimination, especially as a girl." As a lawyer, her practice has been focused on providing community aid to individuals needing help. Her clients range from tenants, homeless, discrimination victims, disabled, domestic violence and sexual assault survivors, LGBTQ clients, seniors, veterans, Spanish-speaker, and minority groups seeking legal advice and assistance.

And as a council member and mayor, her focus continued to be this constituency. She helped obtain a \$10 million federal grant to build housing for the homeless in Palm Springs. During the COVID pandemic, she gained Council approval for hero pay for essential workers, \$1 million in small business relief, and for the use of the Palm Springs Convention Center as a COVID-19 testing site.

for local projects and efforts.

"I will be a fighter for our fair share of jobs and investments in our region," she said. "It's important that our voice be heard as a desert or mountain community. For example, the state's COVID relief for our region was considerably less per person than the large cities nearby."

conservative Republican, seeks **Assembly seat**

Gary Michaels is making his second run for state office. In November 2020, he was the Republican nominee against Democrat S. Monique Limon, the winner, for the 19th District State Senate seat. Michaels garnered about one-third of the vote.

In 2022, Michaels, 65, is seeking to become the representative of the Assem- Gary Michaels bly's 47th District that in-

cludes Idyllwild, Pine Cove, Mountain Center, as well as many desert cities — Palm Springs, Cathedral City, Palm Desert and Yucca Valley, and Oak Glen, Cherry Valley, Banning and Cabazon.

It overlaps largely with the previous 42nd seat and in early January, the current incumbent, Assemblyman Chad Mayes, announced his intention not to seek reelec-

Michaels is a Chicago native but has been in California since 1984. Early in his career, he worked with media and then with TimeWarner Cable where he oversaw the late-1990s fiber optic build out. In recent years, he has become an entrepreneur and owns his own company.

On his website and during the discussion, Michaels describes himself as a "constitutional conservative." This is his distinction between himself and current state Legislators who enact legislation which, he believes, appears to have no relation to the U.S. Constitution.

"It's like they never read the Constitution and care less about it. They're oblivious of some issues," Mi-

He strongly opposes ideas such as "defunding the police" and "sanctuary cities." If elected, Michaels will devote effort to "securing our border" from the "invasion of immigrants."

This invasion, in Michaels' opinion, is being supported, if not sponsored, by the Democratic Party in order to "replace many of us by bringing the illegals to re-make America."

When asked if he, like his fellow Republican Greg Wallis, distinguishes between national Republican issues and local or state Republican issues, Michaels acknowledged no difference.

While he lists President Ronald Reagan as someone whom he looks up to and would like to follow, Michaels clearly had disdain for Reagan's 11th Commandment "Thou shalt not speak ill of any fellow Republican."

"Greg Wallis is right there with [Mayes] supporting legislation repugnant to Republicans. They haven't advanced or articulated a conservative view," Michaels said with scorn.

In Michaels' opinion, Mayes and Wallis are the same She seeks the Assembly seat to gain more state funds and epitomize the problem many Republicans have in California. He argued that since Mayes stepped down as Assembly Republican leader in 2017, the Republicans have been "bleeding seats."

His familiarity with Idyllwild and the Hill is little since he admitted, "I have driven through it quickly." But he plans to do some campaigning here.

Greg Wallis seeks to replace boss, Chad Mayes, in **Assembly**

Wallis, Greg third-generation Californian, is one of two Republican candidates seeking the nomination for the 47th

Assembly District seat. The 31-year-old is currently district manager for Assemblyman Chad Mayes (NPP 42nd District), who announced in January he would not seek reelection.

ing as Mayes' district man-



ager, Wallis was intrigued with the opportunity to seek the seat for himself. "I really never thought of myself as running for office. I thought my career would be behind the scenes," he disclosed. But after a discussion with his wife, Desiree, he entered the race. "I'm originally from Silicon Valley. The cost of liv-

ing and housing is driving young folks out. I've seen too many leave the state because of high prices," Wallis said, describing his motivation to work at the state level. One of his major priorities will be "affordability." He

argues that housing prices are a statewide issue. "[This] stems from policies coming out of Sacramento," he said. "There is not enough supply to meet the demand we need to build more housing.

He attributes the decline in new home building to the misapplication of the California Environmental Quality Act (CEQA). "While CEQA is well intended, it has been used to drive up costs to consumers. We've got to streamline the regulations to make them business friendly," Wallis declared.

He will work to make health care more accessible and affordable. While he offered no specific changes, he feels this can be accomplished through better efforts to increase nonpartisanship of the legislative process.

From his experience as staff, he has seen close-up how partisan behavior can push aside possible effective compromise and solutions. "I want to get everyone the California Medical Association, insurance companies and regulators — in the same room. That's how we can reduce the costs of health care," he believes.

His thoughts about improving public safety are similar. "Public safety has been under attack the last couple of years. Instead of looking for ways to reform the process, we point fingers. Eliminating the funding is the wrong direction," Wallis stressed.

Although a Republican, Wallis recognizes climate change is "a real threat" and needs to be addressed. And again, he offers bipartisanship and compromise as the path to improvement and a better future.

"Some policies do more harm than good. We have to get the stakeholders together and work toward a common goal," he said.

Wallis highlighted that all politics are local. Consequently, state and local party leaders can have different priorities and views than party officials in Washington.

"It may be the same for the Democrats. But what they value in D.C. is not specifically relevant to issues in California. Sacramento's focus must be on issues related to the state," Wallis emphasized. "It's frustrating to be put



single-payer system for California. However, when asked about the estimated cost of \$350 billion, he quickly replied, "I never said we should move to single-payer immediately. But people don't feel confident with it because of a lot of disingenuous arguments."

People who have health insurance have it through their jobs, Nash noted. Consequently, they are tied, almost permanently, to those employers, because of the need for health care.

Also, their insurance policies often dictate which doctors or services they can use. Nash wants to break this connection between insurance and employment so that people have more freedom and ultimately can chose their own doctors and health care. He is confident this approach would be successful and accepted. "We saw it with "Obamacare." As time went on, more and more people saw its value," he assured.

To pay for these programs, Nash advocates finding the means to tax what is currently capital gains of entrepreneurs as ordinary income. This would avoid their ability to accumulate wealth without paying taxes, he argues.

Nash has not been to Idyllwild yet, but he plans a visit. He acknowledges the concern about wildfires and sees a parallel with the damage and destruction the Camp Fire caused in Paradise in 2018.

"As someone new to the area, as a candidate, it's my responsibility to get out, not just to Murrieta, Temecula and Corona," he replied.

On the Secretary of State's Campaign Financing website, Nash has no financial reports posted. He admitted, "So far we have minimal donations. I feel confident we'll do well after the primary and people will donate."

Theater company presents 'Chapatti'

With "Chapatti," Idyllwild Actors Theatre (IAT) brings a heartwarming Irish tale of older animal lovers finding each other to the Rustic Theatre. The title refers not to the delicious Indian flat bread, but to a man's best friend, an adopted stray dog.

The play, set in Dublin, has been described as a "deft mix of heartache, despair and gentle comedy" by the Chicago Sun Times. IAT has once more dipped into the Irish stream (after most recently Conor McPherson's ad-

tale of older animal lovers connecting, the perfect vehicle for two actors, and the perfect benefit for local charity Animal Rescue Friends of Idyllwild.

O'Reilly has a long list of stage, TV, film and radio theater credits in the UK, including at least 12 plays.

Actors Kathleen Walker and Robert W. Norman bring a gentle and honest script to life, finding that "while dogs and cats can aid us through the lonely rough spots in our lives, there is no substitute for tender human connections."
