## **Supervisors** denounce antisemitism with resolution

The Riverside County Board of Supervisors unanimously approved a resolution denouncing acts of antisemitism and religious bigotry in all its forms. And it affirmed its support of and solidarity with the Jewish community against anti-Jewish bigotry.
Supervisors Manuel Perez (4th District) and Karen

Spiegel (2nd District) brought the resolution forward at the Nov. 1 meeting. He referred to the recent incident where someone hung antisemitic banners over the 405 Freeway and demonstrated with Nazi salutes. Perez then mentioned that "something similar has occurred in the 4th District and in Temecula a few months back ...

"This just incites violence against Jewish people," Perez stressed and mentioned a recent Anti-Defamation League comment about this being "an all-time high in antisemitic incidents in the U.S.'

In her remarks, Spiegel mentioned that her mother-in-law's father had been taken from his home in Germany on Kristallnacht (Nov. 9-10, 1938) and died in a camp. The Holocaust, which began when the Nazi party took command of Germany in 1933, did not end until Germany was defeated in 1945. During this period, millions of Jews throughout Europe were killed.

"It's important to speak out and to say such acts are not tolerated and we stand up for human rights," Perez emphasized. "We use our voice to educate and work to stop antisemitism.

'I believe we all have a light we can share. A light that can dispel darkness and hate. We can use our light to stand up and to root out hatred, bigotry and prejudice." He continued, "In Riverside County, we stand for inclusion and diversity. In this county with folk of many different diversities, religions and backgrounds, everyone should feel safe, respected, and live together

## **Covered Cal** enrollment period ends Jan. 31

Open enrollment in California's Covered California (Cal) began Nov. 1 and will end Jan. 31, 2023. Signing up soon will ensure coverage beginning Jan. 1, 2023. Open enrollment is the time of year when eligible consumers can sign up for health insurance.

Although nearly 1.7 million Californians already get health insurance through Covered Cal, an estimated 1 million people remain uninsured and eligible to get insured at low-cost or no-cost through Covered Cal or Medi-Cal.

Also, middle-income consumers — both uninsured and those who purchase coverage directly from a health insurance company — may save thousands of dollars a year if they sign up through Covered Cal, according to its press re-

"Millions of Californians now have access to affordable health coverage and now is the time to go sign up for health insurance to keep yourself and your family healthy," said Gov. Gavin Newsom. "... more Californians than ever before are insured with quality health coverage through Covered California. We won't stop until every Californian regardless of income or immigration status — has the health insurance they need and deserve."

## What was in the candidates' coffers?

Nov. 8, Election Day 2022, the races for governor, attorney general, congressman, state Assembly and Senate and seven propositions all being decided while this paper goes to press that day. We may be aware that the advocates and opponents of the sports betting propositions have spent hundreds of millions of dollars to gain their

Gov. Gavin Newsom's campaign for reelection, only one year after an attempted re-call, is costing more than \$14.5 million. Alex Padilla, who was appointed to the U.S. Senate after Kamala Harris assumed the vice presidency, is running for a full-term. His campaign has collected \$11.8 million and spent \$4.2 million through Oct. 19.

So, what could congressional or state legislative races cost? Well, locally, two races are already in the millions for both candidates.

Will Rollins, the Democrat, is challenging a 30-year veteran Congressman Ken Calvert for the newly designed District 41.

From Jan. 1, 2022, through Oct. 19, both Rollins and Calvert have raised slightly

less than \$3.4 million each. Calvert has spent \$3 million on his reelection effort and Rollins has expended \$2.6 million to try to unseat him.

Nearly \$2.3 million of Rollins's contributions have come from individuals compared to \$1.9 million of Calvert's. Calvert has received nearly \$1 million from political committees and Rollins has received about \$250,000 from groups.

For the remaining three weeks, both had about \$750,000 cash available for ads and mailers. This would not include other contributions during this period. And the new state Assembly District 47 race is highly competitive and expensive. Democrat Christy Holstege and Republican Greg Wallis are spending millions to rep-

resent the desert cities and the Hill. Between Jan. 1 and Oct. 22, Holstege received about \$2.3 million in contributions, while Wallis received about \$1.6 million. Most of the donations (about half for both

candidates) came since July 1. During that same period, Holstege's expenses totaled \$2.25 million. Wallis has spent \$1.6 million to defeat her. That left her cash total on Oct. 22 at \$210,000 while

Wallis had \$145,000. Since Oct. 22, Holstege's supporters have given another \$460,000. Her contributions at this point are mainly from Democratic Party organizations, The state party

Since Covered California's first open-enrollment period in 2013, federal data shows that California's uninsured rate fell from 17.2% to a record low 7% in 2021, which is the largest percentage point drop for any state in the nation over this time period.



## **Veterans Day events** this Friday, Nov. 11

The American Legion Post 800 honors Veterans Day at 11 a.m. Friday, Nov. 11, at the post.

Post 800 Commander and U.S. Marine Corps veteran Paul White is the key speaker. Free sandwiches and refreshments will be served for lunch after the ceremony.

To show gratitude for veterans' selfless service, the U.S. Forest Service will waive standard amenity fees for all visitors to national forest and grassland day-use areas on Veterans Day,

"Many veterans spend time with their families and connect with nature while hiking, hunting, boating, and exploring the range of outdoor recreation opportunities national forests and grasslands have to offer," said Nancy Parachini, acting regional director of Public Services for the U.S. Forest Service, Pacific Southwest Region.

Making Veterans Day a fee-free day gives everyone an opportunity to reflect on the service of the nation's veterans while spending time on America's public lands. The Forest Service offers fee-free access a few times each year to encourage everyone to explore educational and recreational opportunities available on national forests and grasslands.

On fee-free days, standard amenity fees charged for day use sites such as picnic areas, developed trailheads, and destination visitor centers are waived. The waiver does not apply to special recreation permits, cabin rentals, campground reservations, expanded amenity fees on certain highly developed sites, and service fees assessed by independent concessionaires operating on national forest land.

About 98% of national forest land can be enjoyed fee-free, year-round. Where fees are assessed, more than 80% of these funds are reinvested at the site where they're collected, to provide necessary maintenance and services or to pay for future improve-

Fee-free public lands access is available year-round to U.S. military service members and their families, veterans and Gold Star family members. The Interagency Military Pass is available at no cost to all active-duty military personnel and their families. This pass is honored nationwide at all Forest Service, National Park Service, Bureau of Land Management, Bureau of Reclamation, and U.S. Fish & Wildlife Service sites charging standard amenity or entrance fees.

docino and San Luis Obispo counties gave her \$125,000. Most the remainder was  $sent from \ political \ action \ committees \ and \ other \ Democratic \ candidates.$ 

In the same period, Wallis's campaign has garnered about \$240,000 including \$90,000 from the Tulare County Republican Central Committee, \$76,000 from the state Republican Party and about \$20,000 from the Sacramento and Orange counties Republican organizations.

In the other local Assembly race, Democratic incumbent Eduardo Garcia's campaign chest significantly exceeds the size of Ian Week, his Republican oppo-

In the first 10 months of 2022, Garcia has received nearly \$660,000; whereas donations to Week's campaign totaled \$125,000, less than a quarter of the gifts to Garcia. Even as the election approached, contributions to Garcia, \$150,000, far outstripped Week's \$12,500.

Since Oct. 22, Garcia has received another \$62,000. These donations have come from private corporations, such as Exxon Mobil Corp., Eastman Chemical, Golden State Water Company, Tenet Health and Uber, as well as individuals and the United Nurses Association of California.

Garcia has used his campaign chest to donate more than \$225,000 to candidates in other races. This includes \$30,000 to the state Democratic Party and another \$18,000 to local Democratic groups. His donations to other candidates ranged from Assembly and Senate races to local school districts, recreation districts, city councils, a mayoralty race and a Superior Court

And for the final three weeks, Garcia had more than \$450,000 for late expenditures and Weeks had \$25,000 for last minute challenges of Garcia.

The state Senate race, District 32, between Republican Assemblyman Kelly Seyarto and Democrat Brian Nash, is similar except that the money is flowing to the Republican in this race.


Since Jan. 1, his contributions have totaled slightly more than \$325,000. The Secretary of State's Campaign Finance website has no data for Nash. However, on May 27, prior to the primary, he reported \$330 in campaign contributions to the Riverside County Registrar of Voters. And in an email, he said he had reported a \$2,000 contribution from CADEM in late July to the Registrar's Office.

Seyarto's expenditures have been about \$180,000 of which nearly \$60,000 have been contributions to other candidates or to the state Republican Party and another \$55,000 for campaign consultants.

#### Life Tribute Betsey S. Whitman 1938-2022

After a valiant battle with Alzheimer's disease, Betsey Whitman passed peacefully Wednesday, Sept. 21, 2022.

Born Betsey Ruth Sellner in Wilmington, Ohio on April 21,



It was in academics where she stood out. Just seven years after graduating from middle school, she already had a bachelors in arts from Shimer College and a masters degree

According to one of her best friends, Mary Jean Roach, Betsey was the brightest in her cohort and would have been valedictorian had she not left early (after three years) for college. She needed just three years to graduate college

She then received the prestigious Dupont scholarship award, allowing her to attend Harvard, where she obtained her masters in education in 1959. She then began teaching at West Hartford High School in Connecticut and while teaching there met her future husband, Harrison Carlton Whitman, who also was teaching there.

They wed in 1960, moved to Gainesville, Florida, and both attended graduate school at the University of Florida and obtained masters of science degrees in mathematics.

Betsey and Carl then moved to St. Petersburg, where Betsey taught for a year at Gibbs Junior College and for a year at Notre Dame

It was time to move again; this time the family settled in Tallahassee where Betsey and Carl both began teaching at Florida A&M University, an HBCU. They both taught there for 25 years. 1975 was a big year, for, in addition to raising four children (Bill, Eliza Jane, Harrison and Rebecca), both Betsey and Carl were to earn their doctorates simultaneously on Aug.

Betsey was the department chairperson at Florida A&M for many of the years she taught there. When the department needed to expand to include biostatistics and there were not qualified candidates to teach such, Betsey took a sabbatical, returned to Harvard and obtained a masters in biostatistics.

After 22 years in Tallahassee, Betsey and Carl moved to Framingham, Massachusetts. Betsey took a professorship position teaching at Framingham State University. However, it was not long before she obtained a Fulbright scholarship to teach at Malawi University in Zomba, Malawi.

She loved teaching there, so much so that she reapplied for the scholarship and taught a second year as well. She might have continued to do so but was told by Framingham State that she had to return if she wished to keep her position. She did so, but this in no way lessened her commitment to Malawi and the people there that she had come to know. For many years following her return to the states, she and Carl would return to Malawi in the summer, to volunteer at Malawi Children's Village and to visit with friends and colleagues.

Just as was the case at Florida A&M, Betsey was the department chair for mathematics at Framingham State. Her teaching at FSU expanded into an international teaching program that had many two-week overseas assignments. Her assignments took her throughout South and Central America, Europe, Asia and to the South Pacific. Nothing surprised Betsey's children to hear of her latest travel

Betsey finally retired from teaching in 2015

after 56 years of teaching.

In her later years, she moved first to the Palm Desert area in late 2012, then in 2015 to Idyllwild where she lived for a year and a half on Tahquitz Lane. She and Carl returned to Palm Desert and lived for 20 months in an assisted living facility before returning to Idyllwild for good in 2019.

A hybrid Zoom/in-person memorial is planned for 1 p.m. Sunday, Nov. 13, at the home of her son Bill Whitman.

In lieu of flowers, the family requests that individuals make donations to a nonprofit or faith community of their choice.





I also was shocked when I heard one of my grandchildren come home and announce that there was a tampon machine in the boys' bathroom at Idvllwild School.









## Pelham brings back 'Art of the Guitar' concert series

Editor's note: The correspondent has worked with David Pelham for many years, first as guitar teacher and then helping him with his compositions for the guitar, and has been to Paracho, Mexico, with him.

At 2 p.m. Sunday, Nov. 13, Idyllwild's "Art of the Guitar" concert series will resume. This year's concert will feature Alberto Daniel Quintanilla (Mexico) and Aysegul Koca (Turkey.) The concert is in Idyllwild Arts Academy's Lowman Concert Hall and is free to the public.

The concert series is the brainchild of David Pelham, whose love of the guitar and the community has shaped his busy retirement years. Pelham has become a part of the international classical guitar scene through his trips to Paracho, Michoacan, Mexico, to attend the annual Guitar Festival there and to meet the many accomplished and respected luthiers who are residents of that city.

it cost thousands of dollars or a few, it most likely bears a label inside that reads "Paracho." Factories there turn out (often very serviceable) souvenirs, and fine craftsmen practicing an art handed down through generations.

Although funding is often uncertain, a museum there is dedicated to guitar building, workshops in which visiting luthiers share their techniques to improve the state of the art and a festival that invites both builders and players to compete for honor and prizes. The guitars entered are displayed in a church where they can be tested by interested visitors, and the competition rounds are open to the public.

The Crier interviewed Pelham through phone and email about the genesis of the "Art of the Guitar" series and its mission.

TC: "How did the trips to Paracho begin? Were you going to hear concerts or talk to builders?'

DP had a vague knowledge that there was a festival. "I primarily went because I wanted to meet some of the guitar builders. We (my wife Barb was with me) happened to arrive right on schedule for the festival by acci-

TC: "What inspired you to begin this project?"

DP: "Mexico has a massive classical guitar culture, with many conservatories and universities with top-level classical guitar programs. Many young guitarists that emerge from this system, with the addition of many competitions and master classes, are worldclass, and deserve the attention and focus of the classical guitar world. I am happy to help with that. I began going to Paracho for the guitar festival in 2002. I have been back almost every year since. I met so many great musicians (and great people), as well as seeing a parallel with Idyllwild: Little towns in the mountains with ukuleles and one U-bass, along with my 14 classical guipeople and so many incredible musicians. Paracho is at 7,300 feet and surrounded by extinct volcanic hills. There are hundreds of guitar builders there, many world-class, and many guitarists who are Paracho natives, as well as many others who make a pilgrim-

age to Paracho, Capital Mundial de la Guitarra, as it has become known."

TC: "How many times have you brought these players to Idyllwild?'

DP: "I brought Mariana Gomez and Juan Sixtos here to perform in 2017; Abel Garcia and Jaime Soria here in 2018; and Pamela Arellano and Jesus Serrano here in 2019."

TC: "How have you chosen players for the series?"

DP: "Most of these great young guitarists I have known from childhood or at least their teenage years, and I have watched them mature from prodigious beginnings to become the mature musicians they are today. Examples would include Mariana Gomez, Juan Sixtos, Abel Garcia, Jesus Serrano, as well as this year's performer, Alberto Quintanilla. I know many of their families, and have grown close to them over the years. And there are no shortage of more great candidates. It has been such a rewarding experience ...

"Aysegul Koca is a different case. She was certain-If you or a friend has a guitar from Mexico, whether ly a prodigy and had amazing early achievements. But when I met her in Paracho she was already a visiting professor in Mexico and an invited performer at Paracho. Her Turkish and Middle Eastern background informed her unique performance of several of her pieces. I was impressed."

TC: "What about bringing the players here; what kind of challenges have you encountered?"

DP: "The process of bringing these folk here has not been smooth. In 2017, there were no visa issues, but in 2018, one chosen guitarist, Pamella Arellano, was arbitrarily denied a visa, and had to be replaced with another, the excellent Abel Garcia, who already had a U.S. visa. In 2019, she applied again and was approved so she was able to come, and her whole family came along. Then came the pandemic, and two years of no concerts. Then in 2022, İ invited two wonderful guitarists and both were denied U.S. visas without the consulate clerks even looking at their documentation. I quickly found another who had a visa, was excited to come, but he then won an important competition in Spain, and part of his award was a sponsored 20-concert world tour, so then he could not come to Idyllwild.

"My 2022 trip to Paracho focused on finding a great guitarist that had a U.S. visa, and a tip that Alberto Quintanilla had a visa paid off. About then, I had a contact from another great guitarist whom I met when she played a wonderful concert in Paracho. Aysegul Koca would be coming to New York, and would be able to add a trip to California. I had invited her early in 2018 but she was not able to come at that time. I jumped at the

TC: "How many guitars have you built so far?"

DP: "I have made 18 instruments including three tars. I have sold most of them, but have saved a couple for myself, and still have a couple of them for sale."


TC: "And about your compositions. You have put together a book of pieces that have circulated among the guitar community internationally?"

DP: "My pieces have been performed in several different cities in Mexico, here in Idyllwild and in Hemet, in Barcelona, Spain. In my early years, when I was practicing regularly, I thought I was going to be a good guitarist. I didn't pick up on the fact that in the group I was in I was the worst in terms of speed and accuracy. But I was already composing. I still value my first few compositions; they may appear yet ..."

TC: "People can find videos of your music?"

DP: "YouTube and Spotify; Mariana Gomez playing 'Hymn for the Earth' and 'Ashes and Tears' by several different people, Jaime Soria and Edgar Camargo."

Although reticent to talk about funding, the series has been funded by Pelham himself. When a crash ended his aviation hobby, he rolled the insurance money into starting the concert series. No donations can be solicited at the Idyllwild ARts concert venue, but there is talk about a reception afterward and what might be needed to guarantee the continuation of this tradition.







what about this silly time change? **Pepper:** I think what some humans don't realize is that dogs and cats follow their own circadian rhythms. Their internal clocks override humans' ridged time

Cuddles: I hope humans realize it's typical for pets to need a couple of days to adjust after the time change, but some take longer than others. Pets with a strong internal clock are heavily influenced by sunrise, sunset and predictable feelings of hunger.

Don: We pets are rather complex. Because we respond to human cues (the alarm clock, people getting out of bed, the sound of food being put in the bowl), our guardians can help us adapt to the change.

Atlas: It can be helpful to guardians to meet their dogs or cats in the middle as they adjust to the time change. If they can break up the hour difference and adjust the pet's schedule (walks, feeding time, bedtime and waking up) by 15 to 30 minutes each day, the transition can be nearly seamless.

**Phil:** Then they can count the days until the clocks go back to a sunny existence.






