Still one too close in election counts

As of Saturday evening, Nov. 19, in Riverside County about 15,000 ballots from Election Day Nov. 8 remain to be counted. About 10,000 of these ballots are provisional. Based on total ballots already counted and the uncounted ballots, total turnout in Riverside County appears to have been about 44.9%. Turnout for each race could be different because some voters may leave that choice blank or more voters in that district cast a ballot.

For several days after the election, several races legislative races, which included the Hill neighborhoods, were very close. And the contest between Democrat Christy Holstege and Republican Greg Wallis for a state Assembly seat remains too close to call and may require a recount.

Local representatives

The state Assembly 47th District (AD 47) seat race is still close and a winner has not yet been declared. Holstege continued to lead Wallis.

But with nearly 166,481 ballots counted within the whole district, Holstege's election night lead of nearly 10,000 votes has eroded to 97 votes as of Monday evening.

Within Riverside County, she has a 10,437-vote lead with nearly 132,000 counted. But the San Bernardino portion of the district, which is about 30% of the total district voters, is strongly supporting Wallis. In San Bernardino, where 37,480 ballots for AD 47 have been counted, Wallis has outpolled Hostege by 10,340.

As of Saturday, Riverside County has about 8,000 ballots to count, but they are not identified by precinct. San Bernardino County has about 12,300 ballots remaining.

Turnout in this district in both counties is about equal, 54.7% in Riverside and 53.6% in San Ber-

The local Congressional race for District 41, which includes the Hill neighborhoods, had national implications. After the initial ballot count Tuesday night, Democratic challenger Will Rollins had a 9,000-vote lead over incumbent U.S Congressman Ken Calvert. By Thursday morning, Calvert had taken the lead from Rollins and it has slowly but steadily grown. With about 237,865 votes cast, Calvert's lead is about 10,364 votes. He has 52.3% of the counted votes.


After Monday night's vote totals were posted, The Associated Press called the race for Calvert. Earlier in the evening, Calvert had issued his own victory press release, saying, "I want to thank the Riverside County voters for once again choosing me to be their voice in the U.S. House of Represen-

In this district, the number of registered voters is 463,351 and turnout, based on ballots counted, has been about 51.3%. Total county turnout appears to be about 44%, including the uncounted ballots.

This was a very competitive race. Both candidates collected more than \$3.3 million in contributions by Oct. 19. Data for the weeks leading up to Election Day have not been reported yet.

In other state legislative races, Eduardo Garcia, the Democratic Assemblyman, maintains a lead over his Republican opponent Ian Weeks for the District 36 seat, which includes Garner Valley

Garcia's total districtwide vote count is 53.5%. Within the entire district, his lead is about 6,060 votes over Weeks. Within just Riverside County, Garcia and Weeks are much closer. Only 728 votes See Election, page A2

State budget status flips in six months

In May, the state estimated that Fiscal Year (FY) 2021-22 would start with a projected surplus of \$97.5 billion. That rosy forecast has failed to blossom and now the state may have a \$7 billion deficit for the current fiscal year and a possible \$25 billion deficit for the fiscal year beginning July 1, 2023.

"It's the economy," as James Carville said in 1992. With inflation significantly greater than it had been for years, the Fed has taken actions to stop it and lower it. The Fed's principal tool to moderate inflation is interest rates.

The fed began raising interest rates earlier this year and as rates increase, demand for borrowing, for goods, for houses declines. The effect of these declines should corral inflation; however, the accompanying pain will be less demand and fewer jobs with lower profits and wages.

The stock market falls as interest rates rise and that affects capital gains, which is a significant source of California revenue.

The Legislative Analyst's Office (LAO) released its latest budget and revenue projects on Nov. 17. Its report warned state Legislators, "Some impacts also can be seen in state tax collections. For example, estimated income tax payments for 2022 so far have been notably weaker than 2021, likely due in part to falling stock prices."

The LAO cautioned that these estimates are only based on the current level of interest rates and economic growth. If the country were to slip into a recession, then the revenue estimates would fall further.

In fact, the LAO acknowledged that it is pessimistic about the economy's future. "The chances that the Federal Reserve can tame inflation without inducing a recession are narrow. Despite recent interest rate increases, inflation remains well above the Federal Reserve's stated price stability goal ... heightened inflation pressures could remain for some time. These observations suggest that the Federal Reserve will take additional steps to curb inflation in the coming months, further raising the risk of a recession."

As the state's revenues fall, there is a budget problem, which the LAO defines as "a deficit." This is a problem because the state constitution requires the Legislature to pass a balanced budget.

The tools to achieve a balanced budget include reducing spending, raising taxes and using the reserves. During the past several good years, the state has built a reserve of nearly \$24 billion. However, this would not be sufficient to cover the full deficit projected for the next three years.

So, some combination of budget reductions and increasing revenues are likely in the near term. Gov. Gavin Newsom will release his proposed FY 2023-24 budget in January and the Legislature will hold hearings, a revised budget project will come in May and a final budget in June.

Some specific suggestions were included in the LAO report. The state's retirement payments to CalPERS may be higher than required and if reduced, some savings would occur. However, the federal augmentation of Medicaid due to the COVID pandemic will likely end next year and require increased state funding for these health programs.

The LAO did recommend preserving the reserves unless an actual recession occurred.

separate Weeks from Garcia, who has a 5,700-vote lead in the Imperial County portion of the district.

In 2018, 63,000 votes were cast in Garcia's district. This year, already more than 90,000 have been counted with more to be counted.

The first announcement of the votes counted for the 32nd state Senate District had Republican Assemblyman Kelly Seyarto leading Democrat Brian Nash. Since election night, Seyarto has continued to build on his lead. As of Saturday evening, he had 62% (about 179,400 votes) out of nearly 289,000 votes counted in the four counties that comprise the district.

Riverside County makes up about 80% of the district, which includes portions of Orange, San Diego and San Bernardino counties.

As more votes have been counted, the status of the race for Idyllwild Fire Protection District (IFPD) commissioner remains unchanged from election night. With 1,283 votes counted for the three Idyllwild Fire Protection District seats, challenger Stephanie Yost is still first, ahead of incumbent Commissioner Rhonda Andrewson by 91 votes. Commissioner Dan Messina is third followed by Commission President Henry Sawicki, who trails Messina by 60 votes for the third seat and appears to have been upset.

As of Saturday evening, the turnout is 69.2%. In 2020, a presidential election, turnout for the last IFPD commission race was 92%. In that election, another newcomer, Christina Reitz, was elected commissioner

In the Hemet Unified School District race for District 7, which includes the Hill communities, former law enforcement officer Jeremy Parsons leads incumbent Megan Haley and challenger Al Fernandes. Parsons has a 690-vote lead over Haley with about 6,730 ballots counted.

In the only Riverside County office race, challenger Brian Benoit has expanded his lead over incumbent Paul Angulo. On Sunday morning, Benoit had 54.3% of the vote and about a 40,000-vote lead over Angulo (45.7%).

Monday, Nov. 14, Benoit issued a press release acknowledging his victory. "While there are still ballots that must be processed, the current results show that we are leading with a large enough margin to officially declare victory," he said in the release.

In the race for 5th District supervisor, incumbent and Board President Jeff Hewitt still trails his challenger Yxstian Gutierrez, Moreno Valley mayor, by nearly 7,400 votes with 85,360 counted. About 38.9% of registered voters in the district cast ballots.

Statewide

It appears the Democrats swept the statewide races. Every Democratic candidate from Gov. Gavin Newsom and other state officials, including U.S. Senate, are still ahead. With the exception of Malia M. Cohen, Democrat for controller, all of the Democratic statewide candidates have garnered at least 59% of the vote. Cohen, with a lead of more than one million votes, had 55.5% of votes in her

retary of State Shirley N. Weber, Attorney General Rob Bonta, Treasurer Fiona Ma and Insurance Commissioner Ricardo Lara were all reelected. Incumbent Tony K. Thurmond will continue as superintendent of Public Instruction.

And Sen. Alex Padilla won his election to finish the term of former senator now vice president Kamala Harris, and won his reelection for a full term beginning in January with 61.2% of the vote

However, in Riverside County, the majority of voters favored the Republican candidate in all of these races. Only in the most recent counts did Republican Mark Meuser take the lead from Democrat Alex Padilla. The Republican advantage in Riverside County will not be nearly sufficient to offset the statewide results.

Propositions

The most recent statewide vote counts have not changed the results for the propositions on the ballot. Three (Props 1, 28, and 31) appear headed for approval and four (26, 27, 29 and 30) are losing.

California voters overwhelming declined Prop 27, the online sports wagering measure. So far, 82.5% of voters chose "No" for Prop 27. Its companion, Prop 26, the sports wagering on Tribal lands, garnering 67.3% "No" votes, also appears defeated.

Prop 29, the kidney dialysis proposition, could only capture support from 31.4% of voters. The third consecutive defeat for a dialysis measure.

Prop 1, the reproductive freedom amendment to the state constitution, received a "Yes" from 66.9% of voters. Both Prop 31, prohibition on sale of flavored tobacco products, and Prop 28, directing more funding to art and music education in schools, each garnered more than 63% support

The closest proposition contest is Prop 30, the tax on high incomes to fund zero emission vehicles, is trailing with 57.8% opposed.

Local agencies to operate under modified Brown Act

On Sept. 13, 2022, Gov. Gavin Newsom signed into law Assembly Bill No. 2449, which modifies the Ralph M. Brown Act under which the local water districts, fire protection district and historical review board must conduct meetings open to the public. These modifications go into effect Jan. 1, 2023. (Pursuant to other bills previously enacted, additional modifications will take effect in January 2024 and January 2026.)

California's Legislative Counsel has provided the following digest of Assembly Bill No. 2449

summarizing the changes:

"An act to amend, repeal, and add Sections 54953 and 54954.2 of the Government Code, relat-conferencing provisions and, until January 1, 2026, ing to local government.

'AB 2449, Blanca Rubio. Open meetings: local agencies: teleconferences.

Existing law, the Ralph M. Brown Act, requires, with specified exceptions, that all meetings of a legislative body of a local agency, as those terms are defined, be open and public and that all persons be permitted to attend and participate. The act generally requires posting an agenda at least 72 hours before a regular meeting that contains a brief general description of each item of business to be transacted or discussed at the meeting, and prohibits any action or discussion from being undertaken on any item not appearing on the posted agenda. The act authorizes a legislative body to take action on items of business not appearing on the posted agenda under specified conditions. The act contains specified provisions regarding providing for the ability of the public to observe and provide comment.

'The act allows for meetings to occur via teleconferencing subject to certain requirements, particularly that the legislative body notice each teleconference location of each member that will be participating in the public meeting, that each

teleconference location be accessible to the public, that members of the public be allowed to address the legislative body at each teleconference location, that the legislative body post an agenda at each teleconference location, and that at least a quorum of the legislative body participate from locations within the boundaries of the local agency's jurisdiction. The act provides an exemption to the jurisdictional requirement for health authorities, as

"Existing law, until January 1, 2024, authorizes a local agency to use teleconferencing without complying with those specified teleconferencing requirements in specified circumstances when a declared state of emergency is in effect, or in other

situations related to public health.

"This bill would revise and recast those telewould authorize a local agency to use teleconferencing without complying with the teleconferencing requirements that each teleconference location be identified in the notice and agenda and that each teleconference location be accessible to the public if at least a quorum of the members of the legislative body participates in person from a singular physical location clearly identified on the agenda that is open to the public and situated within the local agency's jurisdiction. Under this exception, the bill would authorize a member to participate remotely under specified circumstances, including participating remotely for just cause or due to emergency circumstances. The emergency circumstances basis for remote participation would be contingent on a request to, and action by, the legislative body, as prescribed.

"The bill, until January 1, 2026, would authorize a legislative body to consider and take action on a request from a member to participate in a meeting remotely due to emergency circumstances if the request does not allow sufficient time to place the proposed action on the posted agenda for the meeting for which the request is made. The bill

the IFPD meeting room.





Cal Trans severs IWD sewer line

At Idyllwild Water District's (IWD) board meeting Wednesday night, Nov. 16, General Manager Leo Havener reported that Cal Trans broke a sewer line on Oct. 29 where it has been installing a culvert near Village Market, despite IWD having marked the sewer line. IWD fixed the line the same night as it has no turn-off

"How do we get paid for that?" asked Vice President Peter Szabadi. "They're not done yet," said Havener, implying that they may do it again. "These guys are bulls in a China shop."

Havener has been developing a new method for determining conservation stages, a request the board has been making over the past year. The board reached consensus that the current system does not make sense.

Havener's new water policy applies standards to each well individually. "Each well will have its own triggers," he said. "[We're] going about trying to find triggers ... so we don't have water quality issues. Each well is different." The standards will include both water quality and water quantity triggers.

Water loss was 4% for October though Havener said he is concerned that people have been hooking up to fire hydrants who shouldn't have. "We're seeing more and more of that."

He also said the U.S. Forest Service and Cal Fire all any reason or notifying IWD. "They're not obligated to report it," he said.

Havener gave an overview in his general manager's report with photos of project work, some aerial. He said IWD has a drone it uses to check on tanks rather than climb up them, preventing safety issues. Also, if roads are washed out, IWD can use the drone to examine IWD

Projects on which he reported included the Strawberry Creek Diversion Pipeline, anticipated to be completed by Nov. 25; the administration buildings' solar project being done; negotiations continuing on land purchase from Idyllwild Arts for wastewater treatment plant (WWTP); and WWTP sludge removal comple-

He also reported that pipeline from Fern Valley Well 1A to Foster Lake is anticipated to be completed by the end of November; and fire hydrant maintenance is in process and more than 50% complete.

Bartle Wells Associates, hired to do the rate study, is in the analysis process. "Once we approve, then we'll set up meetings with the public," Havener said.

The board approved \$25,000 to be invested in California Cooperative Liquid Assets Securities System that is seeing about a 3% return. "If it does well, we can invest more," said President Charles Schelly.

The board also heard from Scott Manno of Rogers, Anderson, Malody and Scott LLP regarding the audit of IWD's financial statements for fiscal year 2021-22. Manno gave an unmodified opinion, the highest it can give, of the district's finances.



Meet Kelly Seyarto, our next state senator

Editor's note: The Town Crier interviewed Kelly Seyarto for the May 12, 2022, and Sept. 29, 2022 issues.

Kelly Šeyarto, a Republican, will be the next person to represent the Hill in the California State Senate. Until January, Melissa Melendez represents District 28, which was primarily Riverside County. She could not run again because she reached her term limit in the Leg-

The California Citizens Redistricting Committee drew new lines last year and the Hill was moved to the new Senate District 32, which also includes small portions of neighboring counties - Orange, San Bernardino and San Diego. However, the majority of the district's voters were in Riverside County, including Idyllwild, Pine Cove, Garner Valley and the Anza areas.

Seyarto, who is currently representing Assembly District 67, chose to try for this Senate seat since much of his current Assembly district is in this new Senate district, too. Brian Nash chose to challenge Seyarto. Nash is a novice politician and the election results from the first count clearly supported Seyarto as the district's choice.

When asked how this victory felt compared to his previous races for council and mayor of Murietta and the Assembly, Seyarto said, "It feels similar to the other races. But it was not quite as stressful as previous races

"My opponent has much less experience," Seyarto added. "And a lot of the [Senate] district is in my Assembly district." This also is why he did not feel there were any surprises in the voting results as the counts were re-

Congressional District 41 and State Assembly District 47 were and are much closer races than Seyarto's. He believes, however that, while this reflects the role of Independents, it also reveals how polarized voters are today and thus their tendency to vote Republican or Democratic.

'This district had about 11% Republican advantage from the start," he noted. "This influenced how much the Democratic Party would invest in this race and no experienced Democrat was willing to step up to run."

As of Oct. 27, Seyarto had about \$145,000 remaining in his campaign coffers. He said this would be a start for his reelection if he decides to do that in 2026.

Just before his talk with the Town Crier, Seyarto had returned from Sacramento where he had some training to begin his Senate term in January. At his point, he hopes to be a member of the Housing, the Public Safety, and the Energy and Utilities committees.

'Also, Natural Resources and Water Committee affect us the most, especially folk in Idyllwild, Julian and Anza," he added. "These issues are very important to these constituents."

His first bill will likely address the fentanyl crisis, he said. It will be similar to the one he introduced in the Assembly. But some changes are planned based on the response to it.

"I'll adjust the language. I want a bill and the make up of a task force to drive the process," he said.

A celebration is not planned soon, but in January after his swearing into office. He hopes to take his family out to dinner.

"I'm mostly looking forward to meeting with the communities and their leaders," he stated. "I'm anxious to get back to work."


Free class on backyard composting

On Aug. 26, 2017, an employee arrived there at work to find that the post had been broken into and the safe, con-

taining \$1,200 to \$1,500, was missing.
On March 25, 2012, Legion employees closed the facility that night and found the next day that it had been burgled during the night. An empty cash register and a "Girls ight Out" tip jar, containing around \$300, were taken.

No suspects have been identified in any of these cases.



would define terms for purposes of these teleconferencing provisions.

"This bill would impose prescribed requirements for this exception relating to notice, agendas, the means and manner of access, and procedures for disruptions. The bill would require the legislative body to implement a procedure for receiving and swiftly resolving requests for reasonable accommodation for individuals with disabilities, consistent with federal law.

"Existing constitutional provisions require that a statute that limits the right of access to the meetings of public bodies or the writings of public officials and agencies be adopted with findings demonstrating the interest protected by the limitation and the need for protecting

"This bill would make legislative findings to that effect.

"The California Constitution requires local agencies, for the purpose of ensuring public access to the meetings of public bodies and the writings of public officials and agencies, to comply with a statutory enactment that amends or enacts laws relating to public records or open meetings and contains findings demonstrating that the enactment furthers the constitutional requirements relating to this purpose.

"This bill would make legislative findings to that effect."



Workers' comp will be required

Starting Jan. 1, 2023, concrete (C-8), HVAČ (C-20), asbestos abatement (C-22) and tree service (D-49) contractors will be required to have workers' compensation insurance, regardless of whether they have employees, according to the The Contractors State License Board (CSLB).

The new requirement is the result of CSLB-sponsored Senate Bill 21 Gov. Gavin Newsom signed into law Sept. 30, 2022. The bill also requires that all contractors — with or without employees will need to have workers' compensation insurance by Jan. 1, 2026.

CSLB research confirms that many of the approximate 50 to 60% of licensed contractors who currently claim an exemption to workers' compensation insurance do use employees.

This problem creates an unfair competitive disadvantage for law-abiding contractors who are subject to higher business costs and puts employees and the public at risk for workplace inju-

New feature on Caltrans app

Caltrans launched a new push notification feature on its QuickMap app that allows drivers to automatically receive real-time notifications about nearby road closures, emergencies and other traffic updates.

"With this new QuickMap upgrade, Californians now can receive instant traffic notifications based on their location," said Caltrans Director Tony Tavares. "Drivers can use this information to adjust their plans when needed, comparé route options, save time and travel safely to their destina-

QuickMap is a mobile app and website available to the public at no cost for travel planning.

When a device with the QuickMap app enters an area within 10 miles of a road closure or other traffic-related event, a pop-up message will appear alerting travelers of the incident, including time, location and reason for closure.

Caltrans reminds drivers to use their mobile device responsibly, including only in hands-free mode when operating




