County plans park and road work on the Hill

At its May 23 meeting, the Riverside County Board of Supervisors unanimously approved funding proposals from both the Regional Parks and Open Space District (RPOSD) and the county's Transportation and Land Management Agency (TLMA). The request from both agencies included projects on the Hill during the next fiscal year (July 2023 through June 2024).

RPOSD requested approval to use \$11.8 million the county received from the American Rescue Plan Act of 2021 (H.R. 1319). In two payments, the county received a total of \$479.9 million to be used for infrastructure, housing and homelessness, workforce development, neighborhood revitalization, business revitalization, child care facilities and nonprofits.

Of the six RPOSD projects, the district plans to spend \$1.5 million to improve accommodations at Lawler Lodge. This work will make the site much more accessible for visitors with disabilities.

Lawler Lodge was built in 1919 and is a Riverside County Historical Landmark. The site, north of Idyllwild on Highway 243, consists of a large lodge building and several ancillary cabins. The lodge is located at the bottom of a hill and access is difficult for those with mobility disabilities. This project would restore two of the ancillary cabins located above the lodge, making them available for use and making one adjacent to the parking lot an ADA accessible short-term lodging

Some of the other RPOSD projects include boat launch repairs at Lake Skinner, paving at Rancho Jurupa Regional Park, and trails work and habitat restoration along the Santa Ana River.

The TLMA plans to do many road projects throughout the county. This funding is from the state's Road and Repair Accountability Act. During fiscal year (FY) 2023-24, the county expects to receive \$45.1 million for road work.

In the request, TLMA stated that the average pavement condition in unincorporated Riverside County was given a C- rating in 2020, by the American Society of Civil Engineers. This is the focus of the work to be funded.

Senate Bill (SB) 1 was passed in 2017 to improve the state's aging transportation infrastructure, particularly roads and bridges. Without SB 1, these needed road repair projects would have been shelved until funding became available. These funds are restricted to a "Fix-It-First" approach. Local agencies are required to focus on roadway rehabilitation and maintenance to improve the condition of their existing infrastructure, according to TLMA.

Among the dozens of projects TLMA will work on during FY 2023-24, three are in Idyllwild. North and South Circle drives, from Village Center Drive around to Highway 243, will be resurfaced as will Fern Valley Drive from South Circle Drive to Humber Park. The agency estimates the work will be completed this October. Total cost for resurfacing the three streets is projected to be \$3 million.

Perez offers own comments on STRs at listening session

Wednesday, May 24, Riverside County 4th District Supervisor V. Manuel Perez held his third recent listening session at Town Hall as he and the community become acquainted with each other. It was the second one dedicated to Idyllwild's short-term rental (STR) situation and the amendment of Ordinance 927.1. As before, Planning Director John Hildebrand and members of the local STR Committee Jon Brown, Woody Henderson, Anna Duitruk and Mark Dean joined him. Committee members Jane Oliver and Joel Feingold were unable to attend. Other county officials present included representatives of Transportation and Land Management, Code Enforcement (CE), Sheriff's Department and Idyllwild Fire Chief Mark LaMont. The hall was mostly full, but not as crowded as previous sessions.

In the three meetings so far, comments have circled around a number of issues: Neighbor complaints of noise, nuisance and road blockage, fire evacuation concerns, and the loss of the real but nardto-measure value of having actual neighbors. On the other side of the ledger, STR proponents espouse their economic benefits, not just to owners, but to housekeepers and other support crew, and downtown businesses. Owners spoke of their right to benefit from their investment, the unfairness of the STR certificate moratorium, and attribute the problems to a few badly managed STRs. Owners and realtors expressed concern with the "bust" that has followed the COVID-related "boom," and suggest that the market will correct the density issue. Many speak of how STR income allows them to realize the dream of owning a cabin in Idyllwild, and those who came here before ask the STR owners to consider how that affects the "dreams" of long time, often retired, neighbors.

Perez' opening comments acknowledged that not all attendees may feel comfortable filling out speaker forms with personal contact information. He said the forms could be filled out anonymously and all would be read. Wishing to hear from people who had not previously spoken, tonight he would recognize speakers from back to front.

The supervisor discussed his thinking about changes to the ordinance. He said he was "leaning toward" a cap on new STRs, but was unsure of numbers, and supports better enforcement, with an "actual sheriff," especially after 10 p.m.: "one (deputy) sheriff full-time and maybe another part-time to back him or her up." This officer should be able to "hand out strikes," fines and penalties that could escalate to loss of license. Perez said he hoped to finish work on the ordinance by September and would like to see the moratorium on new STRs lifted in Mountain Center "even sooner." In previous sessions, STR owners from there maintained that they do not have the density problems Idyllwild has.

Perez said new enforcement, either CE or sheriff, should be paid out of TOT taxes (10% in the unincorporated county) and he is looking at the amount of tax money coming out of the area. He has asked the tax collector to provide these numbers; that promises to be a coming attraction for the next session. "Making sure that that money stays here" was the supervisor's applause line.

CE gave an update on notifications for STR owners. With 1,300 STRs in the county, and approximately 500 in this area, "we are working toward, by the end of June, notices for parking and signage ... that everybody's been put on notice that is in violation, and then from there we'll work forward on the enforcement." Asked for clarification, the officer said CE counts 501 STRs for Idyllwild "in the system" and 20 "Notices of Violation" going out for unregistered units. In response to a question about motels having or being counted as STRs, Hildebrand explained that motels are zoned as commercial properties and are outside the STR system. They are often advertised on the same platforms as residential STRs, leading to some confusion for citizens trying to count them.

Brown asked about the 24/7 nature of nuisance issues, and was told CE's hours are until 10 p.m., and that complaints have to be ongoing, repeated problems, like a late-shift resident who blasts loud music at predictable times, for CE to "flex-shift" and respond outside normal hours.

 $Hild \hat{e} brand\ addressed\ a\ common\ complaint\ from\ \hat{S}TR\ owners: not\ receiving\ notifications\ from\ the$ county. He said many accounts include incorrect addresses and contact information in the system created by their "previous partners," and this information is migrating to the new system (run by Deckard Technologies). STR owners need to visit www.RCTLMA.org/shorttermrentals and open an account. Only 40% of STR owners have activated an account. Renewal notices mailed out have been returned for bad addresses, including property address instead of PO box. Later, during public comments, the CE officer explained that logging in and entering their information is "a requirement" for all STR permit-holders, and that the county does not enter information on paperwork into the system.

Public comments began with an STR operator pointing to "many more issues beyond" the bad ad-

Newsom underestimates deficit dangers, LAO says

On May 12, Gov. Gavin Newsom announced his revised budget proposal for fiscal year (FY) 2023-24, which begins July 1. The Assembly has to pass a balanced budget by June

As in January, the Legislative Analyst's Office (LAO) is pessimistic about the administration's revenue projections for the next several years.

"Based on our [revenue] assessment, there is a roughly two-thirds chance revenues will come in below May Revision estimates. As such, while we consider the May Revision revenues plausible, adopting them would present considerable downside risk," LAO wrote in its initial comments

In a report last week, LAO was more specific. Between this FY (2022-23) and next, LAO's revenue estimates are \$11 billion less than the administration's estimates.

In the budget summary, the administration did acknowledge the possibility of bigger problems if the economy turns negative. "Based on a moderate recession scenario in fiscal year 2023-24, revenues could decrease by \$40 billion in 2023-24 alone, largely driven by losses in personal income tax. Revenue declines relative to the May Revision forecast could reach an additional \$100 billion through 2026-27."

Without accounting for those possibilities, LAO states, "... assuming the Governor's May Revision policies were adopted, the budget problem for this year is \$34.5 billion — \$6.2 billion higher than our estimate under the administration's projections."

"[To] eliminate the operating deficit in 2024-25, revenues would need to be roughly \$30 billion higher than our forecast," LAO wrote in its latest report on FY 2023-24. "Our analysis suggests that level of revenue is very unlikely —

May Revision spending level across the five-year period."

Therefore, LAO warns the Legislature that future nearterm budgets will need "revenue increases, cost shifts, and other spending reductions."

For FY 2023-24, LAO urged the Legislature to stop funding one-time spending and approving future appropriations. "Most of this spending no longer appears to be affordable," according to the LAO report, which recommends eliminating \$18 billion for these promises.

Newsom's proposal projects the state to have \$42 billion the effects of COVID-19 on sales and staff.

there is less than a one-in-six chance the state can afford the in reserves on June 30 and \$26.5 billion at the end of FY 2023-24. The difference is the dwindling budget surplus.

LAO recommends using \$22 billion of reserves to help offset the growing deficits. However, the combination of eliminating one-time spending and using reserves still leaves a \$14.5 billion amount to be eliminated through revenue increases (such as taxes) or spending reductions.

Nevertheless, demands for a greater share of budget continue to be extoled for hospitals, transportation, homelessness needs and, even, businesses still recovering from



Idyllwild resident overturns fire policy cancellation

While wildfires are not an annual event, the threat is always present, especially since fire season is now year-round. And fire insurance is critical security for residents and homeowners on the Hill if a fire occurs near their property.

As recently as July 2018, the Cranston Fire resulted in evacuations of several Hill communities and destroyed seven homes while damaging four others.

Insurance companies gamble. They do research and bet that the premiums they collect for coverage, such as fire damage, will be greater than the costs to them when they lose the bet.

However, as the number of wildfires throughout California has increased in this century, many insurance companies are canceling fire insurance policies in areas called "wildland urban interface." The Hill communities, surrounded by the San Bernardino National Forest, are in such a location.

Last week, State Farm General Insurance Company, provider of homeowners insurance in California, announced, "[It] will cease accepting new applications including all business and personal lines property and casualty insurance, effective May 27, 2023 ... State Farm General Insurance Company made this decision due to historic increases in construction costs outpacing inflation, rapidly growing catastrophe exposure, and a challenging reinsurance market.

"We recognize the Governor's administration, legislators, and the California Department of Insurance for their wildfire loss mitigation efforts . . . However, it's necessary to take these actions now to improve the company's financial strength," the Company said in a late Friday news release.

State Farm's withdrawal of property insurance affects new policies. It is not yet canceling existing policies, which has been a common reaction to the increasing number of wildfires.

But the good news is that the government — California and its Department of Insurance — is here to help — not tax us, not regulate us, but ensure that our protec-

tion continues in the time after a wildfire and enabling us to secure alternatives if necessary.

Specifically, if the governor proclaims a state of emergency during a fire, which Gov. Gavin Newsom did Sept. 8, 2022 for the Fairview Fire, fire insurance policies are protected for one year. Companies are not permitted to cancel fire policies within the declared area.

Sometimes they ignore this law and the policy owner As recently as July 2018, the Cranston Fire resulted in needs to respond and to challenge the cancellation.

This is exactly what Jeri and Walter John of Idyllwild had to do this spring. They have lived in Idyllwild for more than 40 years and Allstate has provided their fire insurance coverage nearly the entire time. He is a former U.S. Forest Service firefighter and she is a retired Idyllwild School teacher.

Despite a dispute with Allstate in 2022, they have multiple insurance policies with the company. Their fire insurance policy term is June to June.

On March 3, they received notice that Allstate was not going to renew their fire insurance policy this June. The letter stated, "We are writing to inform you that we will be unable to renew the Allstate policy identified above."

The letter said the reason for the nonrenewal was "Dwellings located in a wildfire area must meet Wildfire Hazard underwriting guidelines." Among the problems Allstate alleged was inadequate defensible space.

"This is a huge problem. Even with premiums growing, we need the protection," Jeri said. Yes, they were stressed, but she handled it by initiating efforts to reverse the nonrenewal. "I'm retired and don't like injustice."

Allstate sent the letter despite the reminder and notice that California Insurance Commissioner Richardo Lara sent to insurers Sept. 22, 2022. The very beginning of the notice restated California Insurance Code, section 675.1, subdivision (b)(1), "An insurer shall not cancel or refuse to renew a policy of residential property insurance for a property located in any ZIP Code within or adjacent to the fire perimeter, for one year after the declaration of a state of emergency as defined in Section 8558 of the Government Code, based solely on the fact

that the insured structure is located in an area in which a wildfire has occurred. This prohibition applies to all policies of residential property insurance in effect at the time of the declared emergency."

Later, Lara specifies that the prohibition applies to "notice of cancellation or non-renewal due to wildfire risk for any policy of residential property insurance ... that are located in a ZIP Code identified by this bulletin."

The Fairview Fire Proclamation included 22 Zip codes, including 92549, all of which were listed in the Sept. 22 bulletin.

Fortunately, the Johns were aware of this prohibition. (The Town Crier did explain it in a December article). Jeri's first step was to contact her insurance agent, Richard Mount, in Riverside, whom she said was very kind about this issue.

He responded March 14. While he was sympathetic to the John's objections, he had been unable to convince Allstate to rescind its nonrenewal notice; even though, Mount had, on his own, sent the company a copy of the Lara's September bulletin.

"Underwriting denied the appeal. They stated the decision to non-renew was based on an unacceptable inspection, not due to wildfire risk," Mount wrote in his response to Jeri. "I argued that the more stringent in—See Fire insurance, page A6

County's budget is in good shape after three quarters

At the May 23 meeting of the Riverside County Board of Supervisors, County Executive Officer Jeff Van Wagenen presented the fiscal year (FY) 2022-23 third quarter

Although the state budget development is encountering increased concerns about future revenue, Van Wagenen told the board, "At third quarter, the county's financial position remains unchanged compared from the midyear report. While we are showing no change in projected discretionary revenue, our revenues are still anticipated to be significantly higher than they were at the time of the adopted budget.

Since the FY 2022-23 budget was approved in June 2022, revenue growth is exceeding the original budget projection by \$89 million, while county costs have grown only \$16 million, resulting in an estimated \$73 million

The greatest revenue growth has been interest earnings. In June 2022, the county anticipated \$11 million from interest. This has grown 300% to the current estimate of

Besides the added \$34 million from interest, the county expects property taxes to increase by \$18.2 million (3.9%) and sales taxes to grow 25%, for an extra \$11.1 million.

Van Wagenen is proposing adjustments totaling \$2.6

million to the current budget, which will reduce the contingency fund from \$10 million to \$7.4 million. The Registrar of Voters Office needs \$1.5 million to cover a portion of its recent election expenses. The total cost is about \$5.9 million and the state is reimbursing the county 75% of the

There also are added expenses for court reporting transcripts and a transfer of Transient Occupancy Tax (TOT) revenue to March Air Base.

The fourth adjustment is \$600,000 from TOT to Code Enforcement for its enforcement of short-term rentals (STR). Ordinance 671.1, which was enacted in October 2022, increased STR application fees. The STR fees before Dec. 17, 2022, were \$250 with a \$100 annual renewal fee. Currently, the fees are \$740 for new registration and the

According to Van Wagenen, Ordinance 671.1 is intended to provide an ongoing funding source for Code Enforcement's efforts related to STR inspections and pro-

"As a result, the Executive Office was directed to set aside 50% of the increase in Transient Occupancy Tax generated by Short Term Rentals (using FY 2021/22 as a baseline) to further fund ongoing Code Enforcement activities associated with enforcement of Ordinance 927.1 [Regulating Short term Rentals]. The Executive Office is currently working with the Office of the Treasurer Tax Collector to determine the FY 2023/24 increase in TOT to

He is incarcerated at the Southwest Detention Center on \$5 million bail. A slight adjustment (\$3,100) was made in the county's fund for the Idyllwild Community Center (ICC). A partial reimbursement from the ICC will now be available to the fund in FY 2023-24.

Addressing future budgets, Van Wagenen concluded his report with this comment; "As of this report, the near-term outlook appears stable, however challenges are looming in years to come. While we continue to project increased revenues compared to the adopted budget, it should be noted that the pace of growth is slowing down significantly while costs continue to rise to maintain the status quo, let alone increase service levels."

Van Wagenen added that he will present the FY 2023-24 budget proposals to the board on June 12 and, if needed, June 13. He expects the board to approve and adopt next year's budget at its June 27 session.

Feingold told the Crier that the committee held a Zoom meeting with county representatives Tuesday, May 30, and there is one more Zoom session scheduled in two weeks. At this point, there is no mention of another Town Hall meeting.

dresses. Having paid on time, he received "several notices in the mail saying I am at risk of losing my permit." Calling in, he was told the office was overwhelmed and that he could safely ignore the notices. "It's great to hear the flexibility in the county ..." but the ordinance is "confrontational" and the threats "stressful."

Hildebrand acknowledged the system has problems and said a new version of the online payment system is being tested and would be available this week. The same operator asked about inspections. Their impression was that an operator may be given a half-hour notice to be present for an inspection. The CE official clarified that there is a one hour required response time for the "listed contact individual" for

ČE reaches out to that person to schedule inspections, trying to fit several in the area for each trip. The 60-minute response is still a "fall back" if an operator repeatedly delays and misses appointments but is "not the norm." A later question elicited a clarification: Inspections are exterior only, to verify the listed parking, the contact signage, and the presence of a noise meter. They are not health and safety inspec-

A citizen who identified themselves as a "disabled veteran from the Vietnam era," described his situation living on an unmaintained road with 10 houses, five of which are STRs. "There's no fire lane on that road ..." Support crew "workers who have five or six different trucks," and "five propane trucks a month" not only block but damage the road.

"I don't see any of those houses compliant with the Americans with Disabilities Act." He said businesses need wheelchair access, many have added ramps and larger bathrooms. Why not STRs? Perez asked for and noted the name of the road. One STR operator offered that Airbnb and other platforms included ADA information, but the veteran was not placated.

STR operators present said regulations for outside investors do not fit locals with a spare cabin, while those who manage a string of STRs argued that absentee individual owners are less responsive to complaints than full-time managers. A neighbor who floated the idea of banning owners from LA or other urban centers was countered by an STR owner who brought up the Fair Housing Act. Several speakers who identified as responsible STR owners said they "vet" their renters carefully.

Several speakers mentioned a "three strikes" approach, suggesting that increasing fines for violations should lead to loss of certification. Ordinance 927 includes this language: "The responsible operator of a short term rental shall report any such complaints, and their resolutions or attempted resolutions, to the Riverside County Planning Department within two business days of the occurrence. Failure to respond to complaints, meet a code enforcement officer within sixty (60) minutes, or report complaints to the planning de-

partment within two business days of the occurrence shall be considered a violation of this chapter, and may constitute cause for revocation of the short term rental certificate."

This has not come up yet in the meetings — that owners must notify the county if they receive complaints from neighbors, even if those complaints are resolved, and "may" lose their license if they fail to do so. It should be noted that this penalty would only come after an "administrative hearing." The ordinance otherwise refers problems that the owner/operator/contact person fails to remedy to the sheriff, reserving "all administrative, legal and equitable remedies available to the County for failing to respond within 60 minutes." The fines for "administrative citations" issued for violations are \$1,500 for the first, \$3,000 for the second and \$5,000 after that. The county has, in response to written requests by citizens and the Crier, and questions at these meetings, not yet provided an answer to these questions: Have any fines been issued to Idyllwild STR owners, and if so, how many?

Another recurring theme has been the STR market cycle: In addition to property owners whose plans were frustrated by the moratorium, there are those who obtained a permit only to watch their occupancy rates drop. At the last STR meeting, Martha Sanchez of Idyllwild Vacation Cabins spoke of occupancy over 70% during the pandemic, and 28% now. Marge Muir, perhaps Idyllwild's longest-serving Realtor, said she had spoken with three people in the last few days who told her they could no longer hold on to their STR properties because of falling revenue.

Shane Stewart, identifying himself as owner of Idyllwild Realty and one of the town's largest landlords, echoed this, calling the last two years "an anomaly." He noted the highest vacancy rates he has seen as a landlord, attributing this to an exodus of STR support workers moving on as occupancy falls and owners sell, this in turn hurting other businesses.

Another STR owner dismissed the idea that banning or limiting STRs would bring down long-term rents, claiming communities who had capped or eliminated them had seen no such decline. Others mentioned fire insurance and the legal environment for landlords as greater drivers of high rents.

LaMont answered the concerns of those who invoke Paradise, California, and the 86 people who died in the Camp Fire there. He attributed the success of Idyllwild's three full evacuations since 1996 to "decades and decades of planning." He directed the public to the Mountain Area Safety Task Force (MAST) and its "Evacuating to Safety" pamphlet, available at the fire department office. He said that while MAST meetings ceased to be public during COVID, the local, state and federal fire and law enforcement agencies continue to meet quarterly to update prevention and evacuation plans. These plans include the ability to "shelter in place" people and vehicles in a variety of locations, including the highway itself. LaMont also said that contrary to what some members of the public tell him, the department has not seen an increase in calls due to STRs. He attributed most of last year's 11% increase to this winter's "beneficial snowpack." In parting he asked, or pleaded, for all homeowners to do their abatement.

County sets July public hearing for CSA fees

At its May 23 meeting, the Riverside County Board of Supervisors set 9:30 a.m. Tuesday, July 11, for a public hearing on the fees applied to parcels within the Riverside County service areas. State law authorizes these fees.

The intent was to give county boards another means to finance and provide needed public facilities and services within unincorporated areas of the county.

County Service Areas (CSA) provide municipal services to residential neighborhoods such as landscape maintenance, street lighting, street sweeping and road maintenance; the services each community receives are determined during the planning phase of new development.

Consequently, depending upon the CSA's authorized purpose, the fees vary by

In Idyllwild, this fee is for lighting, and parks and recreation within CSA 36. It adds \$35 to the property tax bill for the 3,568 parcels within Idyllwild. Pine Cove parcels are not included in CSA 36.

Full Moon Drum Circle

A Full Moon Drum Circle for a "Strawberry Moon" is scheduled at 6 p.m. Sunday, June 4, at the Spirit Mountain Retreat Sacred Garden. Everyone is invited to the free event.

June's full Moon — typically the last full Moon of spring or the first of summer — has traditionally been called the Strawberry Moon.

The origin of the name "Strawberry Moon" has nothing to do with the Moon's hue or appearance.

A Moon usually appears reddish when it's close to the horizon because the light rays must pass through the densest layers of atmosphere.

The name has been used by Native American Algonquian tribes who live in the northeastern United States as well as the Ojibwe, Dakota and Lakota peoples to mark the ripening of "June-bearing" strawberries that are ready to be gathered.

The Haida term Berries Ripen Moon reflects this as well.

On the Department of Insurance's website (www.insurance.ca.gov), she found the following information, "If your ZIP code is included in the moratorium and you received a notice of cancellation or non-renewal for wildfire risk, you should contact your insurance company to seek a reinstatement of the policy. If your insurance company refuses, you are encouraged to contact us and file a Request for Assis-

And on March 17, she filed her request for assistance at the site www.insurance. ca.gov/01-consumers/101-help/index.cfm.

The state website was very helpful," Jeri said. "All my dealings with the state agency" were very positive."

In less than a week, the state acknowledged the request in a letter from an insurance compliance officer. Among the many things the writer said was, "Do not be concerned if you do not hear from me during the next several weeks; I will contact you once I have received and reviewed your company's response and documentation."

On April 5, less than two weeks later, the Johns received a letter from Allstate acknowledging its error. "... it has been determined that the policy was scheduled to non-renew in error. On March 31,2023, the non-renewal was rescinded and coverage will continue." The Johns have already paid the premium for the June 7 renewal for a year.

As a result of her effort, Jeri recognizes that the fire insurers are not going bankrupt, they are just offloading their higher risks. So she suggests that the state consider making a broader investment in fire insurance than the current FAIR program, which is operated by a consortium of insurers. Her suggestion was to treat fire insurance as some are suggesting for health insurance — a single payer. In this case, the state would take over the complete fire insurance activities.

"Ît must be profitable because the companies are still doing it," Jeri added.

But Allstate's finances did dip in 2022. The annual report stated that net earnings for last year were a negative \$1.4 billion compared to a positive \$1.4 billion in 2021 and \$5.4 billion in 2020. This might be due to property and casualty claims increasing \$15 billion during this period, which were mostly attributed to auto losses. Fortunately for shareholders, the company's stock price grew 45% in the past five years.

California also offers the FAIR plan (www.cfpnet.com), a syndicated fire insurance pool comprised of all insurers licensed to conduct property/casualty business in Califor-

While the governor and Legislature created the FAIR Plan, it is a private association whose day-to-day operations are controlled by insurance companies, not taxpayers.

The FAIR Plan is available to California residents and businesses in urban and rural areas who cannot obtain insurance through a regular insurance company. As of 2020, the FAIR Plan covers less than 3% of residents, meaning more than 97% of Californians have a competitive option for fire insurance.

ural light, day after day.

"I'm also walking the PCT to learn how strong I am. Even in the short time I've been on trail, I've learned hiking is life. My faith in people had been shattered. Urban life jaded me with all its rushing and rushing — on trail I'm one with nature. I have learned kindness still exists. On the trail, I've met hikers, angels, locals — very many good people."

This story begins with his ascent at mile marker 151 near the Paradise Valley Cafe. "I planned to traverse the San Jacinto Mountain range in Southern California heading to mile marker 179.4 at Devils Slide Trail leading into Idyllwild for a zero day — I'm giddy with excitement. Fortuitously, I left a box of supplies and an ice ax with a trail angel who goes by Dispatch. I met at the Paradise Valley Cafe. We arranged for her to pick me up at the base of Devils Slide in Humber Park in a few days and drive me into the village.

"At first, the trail seemed quite manageable careening through tall grass and overgrown bush. Quickly the path veered strongly upward. Trekkers I met commented this is the roughest ascent since leaving Campo at the Mexican border. I had no clue what was coming. Most of my information was coming from the Blazin Bakers YouTube videos of the PCT 2022. This had been a difficult snow year, I kept hearing, but was certain that by May the snow on the San Jacintos would have melted.

"I also knew parts of the forest burned years ago — but presumed there had been effective trail maintenance. Soon enough I'm shocked to find myself crawling over an endless obstacle course of downed trees; I estimate well over 60. Looking for alternate trails around the trees on very steep ravines was very dangerous. I told myself this requires slow going, think twice before each step. 3 miles per hour was not possible without great risk. One wrong step and I could be off a cliff face.

"The day progressed until I finally found a cell signal at the top near mm171. I called Dispatch and asked her to meet me at 6 p.m. at Devil's Slide for a ride into Idyllwild. The late afternoon sun was low − I thought great, no more fallen trees. Then, like a bad dream, fallen trees were everywhere; the terrain was super steep and I noted a single patch of snow. I tried to call Dispatch again to move my pickup time back an hour because I knew I

Then the patches got bigger; within 15 minutes everything was covered with snow. Not wearing waterproof boots on slushy snow, I quickly attached my micro spikes to a pair of Speed Goat 5 Trail Runners. I was only wearing a pair of Nike shorts and a long-sleeved synthetic hoodie - and double socks, the Darntough socks with Injinji liner toe socks. My long pants were in my supply box — it was hot when I packed it at the cafe. I put on my

puffy.

"The sun is now setting and the winds are up.

"To page of 1 mile per hour due to dangerous hiking conditions. I slipped a few times on slushy snow; pulling myself forward on tree limbs was the only way through. If I fell, I'd be impaled on the many dead tree limbs lurking below. Thoughts were racing in my head. Why am I hiking alone? If I'm lost, or fall, or become injured, no one will know. The danger was becoming intolerable. I knew if I stopped hiking for five minutes to think, the cold would set in. I had to keep moving.

"The snow was 3 to 36 inches and higher with occasional dry patches. I'm beginning to fret, then my FarOut App malfunctions — the zoom feature on the offline maps would not expand. I couldn't see the trails. Concerned to get to my trail angel as scheduled, I began rushing. The decision to follow others' tracks proved a useless maze to nowhere. It seemed everyone was lost. On balance, I again realize the danger if I hurry. My wise inner voice pointed out a dry patch, suggesting I camp here just before total darkness.

"I pitched my tent, simultaneously taking a cold upper sponge bath. Forget about my filthy legs. I put on my Merino wool sleep wear. It was a couple of degrees above freezing, my toes were numb and the wind through the pines was howling. I attempted to cook a warm meal when my gas depleted. My drink was lauw, our Dutch term for barely warm. Stay positive man, better lauw than cold! Just before climbing into my inadequate quilt [from Enlightened Equipment recommended for PCT hikers] I zipped my tent, donned boxer shorts for impeccable warmth on my head and still froze.

"I considered every possibility all night — until I heard nearby rustling. Fear raced through every cell. Instantly, I recalled a story told in graphic detail by a solo woman hiker who heard a mountain lion scratching and found claw marks near her tent in the morning. I'm terrified, and in that moment, my tent collapsed.

dead I might be safe, for hours I never moved. At 6 a.m. a call from nature forced me out from under the tent. Only then did I realize the sun was rising. Seeing the cherished picture of my dog hanging on the rim of my pack brought comfort. At this point I activate my Garmin inReach Mini navigation/sat communicator and for an exorbitant price, called my closest friend Alex at home letting him know I'm distressed so he can note my

"It was a hell of a nervous night. By morning I was learning skills on the fly. One wrong step and I could break a limb. At 7 a.m. I met Clouds, a hiker from the states; he offered water which I gratefully accepted and kept walking. I made it out on the Devil's Slide trail with the snow crunching under my soles, making the trek more manageable. On the walk out I met hikers ascending and I warned them about my experience. But I think they are all the same — like me. Aw, it's not such a big deal."

Sunflower indeed resumed his trek, heading north from Saddle Junction catching up with a group two days after this interview. He'll soon head north into the challenges sun and heat present on the high desert paths to Kennedy Meadows, where the Sierras await to continue the adventure of a lifetime.
