

County responds to grand jury 'wait time' report

Last week, the Riverside County Board of Supervisors approved its response to the April grand jury (GJ) report titled, "You Call 9-1-1: Then What? Riverside County Emergency Department Delays May Impact Your Care."

Without any discussion, the board approved the response unanimously.

The report had four findings and three recommendations to address its findings. The county agreed with

the majority of findings and recommendations.

The first finding related to the GJ's concern about patients remaining on gurneys for a long period before their transfer from the ambulance to the hospital facility. However, the county's response corrected this slightly.

While a hospital may not have immediate room to place a patient, the transfer of actual care occurs when "... EMS personnel arrive in the [emergency department] and provide a patient report to ED staff. Universally, ED medical staff are using that report and visual assessment to 'triage' patients upon arrival."

The response also noted that hospital emergency department staff will assess the patient's condition and apply triage based on the conditions provided in the patient's report that the ambulance EMTs provide.

The county's response to the recommendations was positive, but qualified. The first recommendation was "Riverside County Board of Supervisors to review. approve, and support programs, including telehealth and Safety-Net Ambulance Programs, throughout Riverside County to alleviate ambulance patient off load de-

While the county acknowledged agreement with the concept, its response noted this needed further analysis. The Emergency Medical Services Agency already collaborates with all the partners — hospitals and fire departments. These steps would benefit from an update to the current EMS Strategic Plan which the county hopes to have completed by the end of July 2024.

For example, telemedicine is already implemented in some county areas and nearly all hospitals and insurers offer some form of telemedicine, according to the county. With regard to EMS telemedicine, the county said models have been tested and it continues to look for viable telemedicine solutions.

These agreements will be presented to the Board of Supervisors within the next year. The GJ then recommended the county encourage other hospitals to implement procedures to reduce ambulance wait times similar to the Riverside University Health Systems' and other high-performing hospitals'.

In this case, the county responded, "The recommendation has been implemented." Senior county officials for EMS have held multiple meetings with leadership at hospitals that have a poor record on wait time.

During these meetings, the county said extensive discussions and reviews were had of the hospitals' offload performance, data collection and metrics, improvement best practices and REMSA expectations for im-

However, the county EMS is not sure which hospitals have made the recommended changes.

The third and final recommendation proposed an interim solution: "RCFD [Riverside County Fire Department] and AMR [American Medical Response] to utilize available personnel to relieve delayed fire and/ or ambulance teams at the hospital emergency depart-

However, the county evaluated this recommendation and replied that it would not be implemented since it is not warranted.

The principal reason is that the governor's State of Emergency during the COVID pandemic was rescind-See Grand jury, page A6

U.S. Forest Service to raise campground fees

The U.S. Forest Service (USFS) has announced fee increases for recreational sites in the San Bernardino National Forest (SBNF). Comments on the proposal should be submitted by Oct. 1.

Seven of the sites are in the San Jacinto Ranger District. Six campgrounds — Black Mountain group, Boulder Basin, Dark Canyon, Fern Basin, Marion Mountain and Pinyon Flat — will see fee increases if approved. The seventh recreation area is the Ribbonwood Equestrian Camp.

Basically, the current fees will double. For example, a camp site at Boulder Basin is \$10 per night and would increase to \$20. Also, the fee for an extra vehicle will go

The same changes are being proposed for single sites at the Fern Basin and Marion Mountain campgrounds.

The new fees would be the same at Dark Canyon and Pinyon Flats, but the current fee at Dark Canyon is \$12 and at Pinyon Flats it is \$8.

groups. A group of one to 24 people currently pays \$50 a night and the Forest Service wants to double that to \$100 per night. For groups of more than 24 people, the fee would go from \$75 to \$150 a night.

At the Ribbonwood Equestrian campground, eight are spaces capable of accommodating large vehicles and trailers. The current fee is \$15 and would increase

The other two sites are located in the San Bernardino Mountains. In the Front Country District, the Applewhite Campground fee would increase from \$10 to \$25 for a single site. At the Mountain Top fs.usda.gov/sbnf.

District, the Big Pine Flat OHV Staging Area fee would go from free to \$5 per ve-

These fees will benefit the SBNF and will be used to operate, maintain and improve its facilities.

Pursuant to the Federal Lands Recreation Enhancement Act, all new fees and any fee changes must be proposed and approved by a citizen's advisory committee. Committee members represent a broad array of recreation interest groups to help ensure the Forest Service is proposing reasonable and publicly acceptable new fees and fee changes.

After public involvement, the proposed fee changes will be reviewed by a Recreation Advisory Committee, who will submit their recommendation to the Regional Forester for a final decision, the USFS release stated.



IWD voters to decide board's fifth director in March

The Idyllwild Water District (IWD) Board of Directors met last week with all four directors present, as well as the two candidates for the open fifth seat on the board — R. Mitch Davis and Jessica Priefer. When the board was split on the two applications, they were sent to County Supervisor V. Manuel Perez' office, but Perez declined to choose. The directors approved a resolution handing the question to the ratepayers, setting an election for

An update on the Servpro mold remediation project in the lower administrative building of General Manager Leo Havener and Chief Financial Officer Hosny Showman was given. Drywall and floor covering have been removed, and now the extent of the damage can be seen. The studs for about 70% of the walls do not touch the floor (plate) as they have rotted out. Mold is everywhere, with some concentrated areas.

The ad hoc committee dealing with this, made up of directors Steve Kunkle and Steve Olson, reported that the repairs would have to include some exterior concrete work to keep water from entering the wall again. They recommended getting bids from local contractors for the work. Meanwhile, the district will continue to rent office space in the Courtyard Building. The lease is up in September, and Havener expects to renew that for six months.

Havener presented the Operations Report and Olson had questions regarding how wells are listed in the report; in one place it listed 11 wells, one full-time and 10 part-time, but in another place it mentions 12 wells, and on the next page, 20. Havener agreed that one well was missing, and explained that the longer list includes monitoring wells and wells that have not been used for years; the 12 are wells that are available for production "today."

Olson also asked about the depth of wells and the depths of the pumps in them. Havener reported that this information is buried in the files and uncovering it is a process the staff is "trying to resolve." The information "should be" in the files, and this is the "first time [he has] ever ran across this" type of situation. Havener said he was looking into acquiring video equipment that would allow the district to find this and other information di-

Present production from all wells averages out to 333 gallons per minute. Olson asked if the district could pump more than that and Havener said, "A lot more." Olson also drilled down on

system's maximum capacity. "We pump, the wells refill ..." He ible in the background. Cracks like these are the source of I and I. called the criteria being used to determine water conservation stages "nonsense," and asserted that we should be on Stage 1 water conservation. Havener agreed, and President Charles Schelly pointed out that the district is at Stage 1, and there is "no level 0."

Olson pointed out that well levels are not clearly meaningful; when you stop pumping, how fast do levels rise? Later it was mentioned that some of the wells are "artesianing," or spouting when uncapped, and that Foster Lake is full.

Schelly noted that the question of well depths has been brought up regularly in past meetings, and that determining these numbers is an essential part of producing a new plan for water conservation levels.

Havener presented his general manager's report. These showed annual revenue of \$2,492,165 and expenses of \$1,988,030, a surplus of \$504,135. Olson noted a few variations from the financial reports, pointing out that he had spotted similar errors in past months, and asked that in the future, with a new fiscal year starting, make sure that the numbers agree.

Revenues for water showed as \$1,747,291 on the revenue vs. expenses graph, but as \$1,761,338 on the statement sheet. Expenses showed a smaller discrepancy: \$1,485,029 on the graph, but \$1,486,538 on the statement. The graph for sewer expenses gave \$503,001, while the statement showed \$450,310. Havener promised to "straighten this out."

Olson also pointed out that because accounting is done on a cash basis, when the audited statements come out, some of the surplus will disappear due to "accrued liabilities and expenses that are not reflected."

Havener noted that more revenue is going into the reserve

Last fiscal year's production, 279 acre feet (almost 91 million gallons), was about average, 268. In the last 10 years, this has varied between 231 and 284. A discussion of production and sales led to the interesting information that "nonwater sales" is actually "water not sold," for instance water drained from a tank before

Havener also mentioned "I and I," the influx and infiltration from stormwater that swells the intake into the wastewater treatment plant (WWTP). Last winter's I and I was the highest since 2010, increasing the intake from the normal 0.95 million gallons

Later in the meeting, he showed a photo from a recent visit by Houston and Harris, a company that provides cleaning and video inspections of sewer pipes The image showed a clay 8-inch

The blockage, according to Havener, was too large for the company to remove, and so TWD will have to buy equipment to do this. Said Havener, "It's probably worse past the blockage." The company will go maintenance hole to maintenance hole looking at laterals and mainlines, but not the lines from individual houses. The examination will continue. There will be a list of needed repairs. Some repairs IWD can take on, others may require outside contractors. These repairs could take "months to years" to

Another set of pictures showed a padlock, used by the district to lock a residential meter closed, that had been cut with bolt cutters. This happens occasionally, and when a house with locked service shows water usage this is often the cause. The district, Havener told the board in answer to a director's question, has a dozen or more locked meters presently. There is a protocol; contacting the owner, trying to ascertain responsibility. Owners "95% of the time" have no idea who could have done such a thing. There are fines.

The board increased rates last month that will begin showing up on bills received in August.


Other expenses included re-coating Foster Lake Tank #1 (in process) and the purchase of a new blower (included in the capital improvement projects) for the WWTP The blower is on order and is expected to arrive in November.

The Vehicle Maintenance Report discussed three crashes this year: In January, truck #27 hit black ice inside the company yard and hit a corner of the shop, causing \$4,000 damage to a headlight and fender. In March, truck #3, on the way to the WWTP, also hit black ice on "an easy corner" and hit a tree, also causing \$4,000 damage. Both these repair bills were paid by the district.

A few weeks ago, while exiting the WWTP, a driver operating truck #13 bent over to pick up a "dropped object" and lost control, hitting a tree and causing \$22,500 worth of damage. An adjustor will determine if the truck is totaled. The air bag was deployed, and that alone costs \$5,000.

The three crashes involved three different drivers. Havener explained that all employees are now required to take defensive driving class, and to have a commercial license so they can operate all the vehicles the district owns. This includes a dump truck and trucks with air brakes. Employees are presently completing the training to fulfill this new requirement.

In closed session, the directors discussed two land purchases and an employee performance evaluation for Havener. There was no reportable action. The next scheduled meeting is at 6 p.m. Wednesday, Aug. 16.

Open letter to Readers Idyllwild and Supervisor Perez DEAR EDITOR: While I've debated speaking out publicly one last time in reference to the short-term rental (STR) de-

ously chosen to do so. We are down to the wire, and by that, I mean Supervisor Perez has made his initial recommendation to the county planning board who has written up their recommendation that will be presented in the near future at a county planning board meeting, followed by said recommendations to then be presented to the five Riverside County supervisors for a

The amendments to the STR ordinance are a disappointment at best, but feel more like a slap in the face to the majority of the town who is looking for some relief once the moratorium is lifted.

I sat for many, many hours and listened to the opposing side talk about fairness and their right to do what they pleased with their house, while we pushed back talking about our right and the rights of the residents of Idyllwild to live in peace and quiet in their homes in residentially zoned neighborhoods. The ironic part about the whole thing is the two folk that we had to continue to listen to do not have to deal with the situation that the average homeowner does who lives across the street or next-door to an STR, since one lives in a homeowners association that does not allow STRs and the other industry rep doesn't even live in our town, yet both of them spoke at length about how the impact their industry has on the average Joe was minimal.

Perez chose to side with industry and while yes, it appears we will get some type of a cap, it may be higher than the actual current registered STR count, and the pathetically small distance he's allotted for the density means folk can still be inundated by STRs and it will offer little, if any, help to those that already are surrounded.

Idyllwild has the highest percentage of STRs in Riverside County by a long shot. We were never pushing to shut down registered, existing, good-standing operators; we always agreed they would be grandfathered

Candidates already seeking contributions for 2024 Congressional race

The 118th U.S. Congress began in January. It will end in December 2024 - 17 months into the future. The next congressional election is 16 months away in November 2024. The spring 2024 primaries have not even been scheduled, but candidates already have solicited and collected millions in contributions to prepare for the next election.

Since January 2023, Republican Ken Calvert, representing California's 41st District, which includes the Hill communities, has already raised \$1.6 million for his next race. And his 2022 opponent and likely opposition in 2024, Will Rollins, has raised nearly \$900,000 during the past six months.

nearly \$1.6 million in donations and has a cash balance of \$1.5 million in his campaign coffers. At the of June. But he will have to win a primary since two ing at them. end of 2022, following the tight race with Rollins, which he won, Calvert was left with only \$70,000 in cash.

He defeated Rollins by 4.7% of the vote in a close election. And he expended nearly \$3.9 million to earn this victory. This was his 16th Congressional election.

Calvert was first elected to the U.S. House in 1992. Since then, various redistricting plans have modified the area he has represented. But all included some portion of western Riverside County. The 2022 election was the first where Hill communities were part of his district.

Nearly 45 political action committees (PAC)

several defense contractors such as General Dynamics, Textron, Boeing and Honeywell. Calvert does head the House Defense Appropriations Subcommittee. Other PACs include Amazon, Sierra Nevada and PG&E employees.

Also, more than 300 individuals have contributed from \$3,300 to less than \$100. Another 150 contributions came from the online RedWin site. Total contributions from individual donors to Calvert was \$925,000 in the first six months of 2023.

"Our campaign continues to receive extraordinary support from people who understand what's at stake in this next election," Calvert said in a press release.

have already given him \$5,000 each. This includes other Democrats have filed and submitted financial reports to the Federal Election Commission (FEC).

Rollins is a former federal prosecutor and now

More than 90% of Rollins' contributions have come from individuals, but only six names were

identified on the FEC report. Rollins ended his 2022 campaign and the year with \$45,000 in cash. But for the election, he raised more than \$3.6 million in contributions, nearly 90%

from individuals. The other potential 2024 Democratic candidates are Timothy J. Sheridan and Brian Hawkins. Their fundraising has been paltry compared to Rollins

and Calvert. Sheridan has \$7,115 in cash and Hawkins has \$250.



County assessments exceed \$400 billion

By IP Crumrine Correspondent

Last week, Peter Aldana, Riverside County's assessor-county clerk-recorder, announced that the county's total real estate assessment valuation has exceeded \$400 billion for the first time. The 2023 assessment of \$404 billion is \$35 billion (9%) more than the 2022 total.

'Surpassing the \$400 billion mark is a historic achievement for Riverside County," Aldana said. "It signifies the remarkable growth of our county and reflects the confidence individuals, businesses, and investors have in our region. Plus, once again, I have to give credit to the coordinated team effort that completed a growing assessment roll on time during another busy year."

This is the second consecutive year that valuations grew more than 9%. Only four years ago in 2019 was the first time valuations exceeded \$300 billion, but it took 13 years to reach that level from \$200 billion in 2006. Overall, the real estate valuation in all unincorporated areas rose 12.7%.

Aldana's press release provided the following information for property owners who may have questions: A review of the 2023 assessment roll value is available on the Riverside County assessor's public access online services website at ca-riverside-acr.publicaccessnow. com/or calling 951-955-6200.

For concerns about a valuation, owners may file a free decline-in-value application online by visiting ca-riverside-acr.publicaccessnow.com/E-Forms/DeclineinValueApplication.aspx. The decline-in-value objections are due by Nov. 1.

Property owners also may request a formal hearing before the Assessment Appeals Board. The deadline to file is Nov. 30. The application is available on the clerk of the board's website at Assessment Appeals Online (aao.countyofriverside.us/).

ed in March. During its application, more paramedics could be found through various channels, such as AMR and the State Medical Mutual Aid System and they $could\,help\,local\,hospitals\,with\,emergency\,patients.$

With the termination of the emergency order, though, the county expects local hospitals to hire their own EMTs. But confirmation of these steps is not available.

'... REMSA and all EMS system partners wholly disagree that it should be EMS provider agency staff that is utilized. All EMS providers within the County are currently experiencing staffing shortages. Utilizing their staff to support underperforming hospitals would further degrade EMS system resource availability."

But extended wait times are not a unique Riverside County problem. In January 2021, the state Assembly Committee on Emergency Management held an oversight hearing on the impact of ambulance patient offload delays (APOD) on emergency responses.

This year, Assemblymember Freddie Rodriguez ly and effectively."

(D-Pomona) introduced Assembly Bill 40 to address this issue. In May, the Assembly passed the bill and forwarded it to the Senate where several committees have reviewed it.

Besides telling local EMSAs, such as Riverside County's, to set an ambulance patient offload time (APOT) of 30 minutes, AB 40 requires acute care hospitals with emergency departments to meet that standard 90% of the time. Also, hospitals would be required to develop an APOT reduction protocol by June 1, 2024, file the protocol with EMSA and require EMSA to monitor monthly APOT data to ensure the standard is being

After the Assembly passed AB 40, Rodriguez said in a press release, "Our communities expect and deserve immediate emergency transport and a hospital ready to receive them for treatment when they call 9-1-1. Unfortunately, non-urgent calls and other factors put immense pressure on our EMS system. AB 40 and AB 296 will alleviate these pressures, getting our first responders off the wall and enabling our system to run efficient-

The Mountain Fire posed hardships on people who did not have gas money to evacuate and people who lost wages due to the evacuation. The Help Center was challenged in giving enough aide to these people.


