

County proposes changes to STR ordinance

Caps and density limits added

Last week, Riverside County announced a special meeting for its Planning Commission to review revisions to its short-term rental (STR) ordinance (927.1).

Following a winter and spring of public meetings and small group sessions, the Planning Department has prepared a revision to the STR ordinance. This can be found online at https://idyllwildtowncrier.

com/2023/08/14/riverside-county-planning-department-short-term-rental-ordinance-revision/.

The Planning Commission's special meeting is scheduled for 9 a.m. Wednesday, Aug. 23, and will be at the Administration Center board chambers. To provide comments on proposed Ordinance 927.2 prior to the Planning Commission meeting, email Planning@RivCo. org, according to Darin Schemmer, communications director for Supervisor V. Manuel Perez of the 4th District. The proposed Ordinance 927.2 is 35 pages, an in-

crease of more than 50%. The new language is almost exclusively the result of the Planning Department organizing separate groups of residents and STR owners from Idyllwild and the Wine Country to discuss their unique issues about STR regulation.

That is easily found at the very beginning of the proposed ordinance. Section 1, Findings (a) specifically notes that the increase in STRs has been greater in Idyllwild and the Wine Country.

The proposed ordinance now references a court case (Protect Our Neighborhoods v. City of Palm Springs (2022) 73 Cal. App. 5th 667) to justify its intent that STRs are an ancillary and secondary use of residential property and one purpose of the ordinance is to ensure that remains an STR's purpose.

Not only are there some general changes, such as specifying how many violations in one year (three) or total violations (seven) will result in suspension of an STR certificate or that "responsible guests" may also be subject to receiving a violation, but many of the new sections and provisions specifically address Idyllwild and Wine Country, either together or separately. For example, "caps" and density limitations are being proposed in both communities.

These communities are defined in the ordinance. Idyllwild includes Pine Cove, as designated in the Riverside County Comprehensive General Plan.

Also, the draft identifies three separate Wine Country districts — Winery, Equestrian and Residential with unique applications of the ordinance. All are specified in the Temecula Valley Wine Country Policy Area, a part of the county's Comprehensive General Plan.

The draft ordinance provides several reasons for treating these two areas differently than the rest of the unincorporated area of the county. First, it states that number of STRs in these areas far exceeds the concentration in any other area.

Secondly, as a result of this high volume of STRs, the price of housing and the cost to rent is pushed higher. And finally, it notes that Idyllwild is adjacent to a national forest, consequently more attention must be paid to potential evacuations because of wildfires or mudslides.

While some are not happy with the proposed changes, others, such as Joel Feingold, a longtime Idyllwild resident who has frequently spoken to the issues of STRs, recognize that some progress will happen.

"If I think back to day one, a few years ago, when I entered the STR battle so to speak, I believe we did OK," he wrote in an email. "It appears we will get a cap, even

Abatement for all, says MCFSC

The Mountain Communities Fire Safe Council (MCFSC) is the recipient of a new and generous state grant to help improve and create defensible space on the Hill, and also to remove more dead and dying trees from within the Hill neighborhoods.

The grant's amount is \$3.62 million and the funding will be available for five years, through the end of 2028.

"This is the largest grant our organization has ever been awarded," Callie Squires, MCFSC office manager, said proudly. "We're pretty pleased."

The funds come from Cal Fire's Wildfire Prevention Grants Program. Last week, Gov. Gavin Newsom announced that 96 recipients throughout California will receive a total of \$113 million. Almost all the work will be invested in hazardous fuels reduction and wildfire prevention planning and education.

"These kinds of projects save lives and livelihoods, and we're scaling it up," Newsom said in the announcement. "It was work like this that helped communities like South Lake Tahoe and Pollock Pines avert unknowable destruction. Our goal is to stop devastation before it happens — to keep Californians safe, and preserve our communities and shared history."

The grant will allow MCFSC to assist local homeowners to improve or to create defensible space and to removal dead and dying trees, according to Squires.

However, this award has one big difference from past MCFSC projects. With this money, MCFSC also can do work on vacant parcels throughout the residential neighborhoods, Squires stressed. Previous grants were limited to properties on which there was an existing structure, primarily a residence.

"But this grant is open to everybody, including property owners without structures," Squires said.

This new option is not accidental. Squires described the grant application MCFSC submitted. It included a Geographical Information System map of the Hill, which showed that many vacant lots were interspersed among properties with houses and

"This highlighted the checkerboard nature of the distribution of the vacant lots," she added. "And this will complement the work being done along the perimeter by other agencies such as Cal Fire and the Forest Service.'

Another difference is that these awards will have no socio-economic limitations, such as elderly or low- or moderate-income property owners. Nor does it have to be See Abatement, page A4

More on the investigations of **Garner Valley deaths**

David Gotfredson, who lists his title as "Investigative Producer" and who works out of CBS News 8 and KFMB, San Diego, continues to follow and dig into the circumstances surrounding the death of a Garner Valley woman, Jodi Newkirk, in December 2021

The death took place at the same Bonita Vista Ranch owned by La Jolla millionaire, Lydia "Dia" Abrams, 65, who went missing in 2020. On Dec. 24, 2021, Gotfredson reported that back on June 9, 2020, Riverside County Sheriff's detectives had written in a search warrant that, "Abrams went missing under suspicious circumstances and foul play is suspected." Neither Abrams nor her re-

mains have been found.

Continuing to pursue the Newkirk story, Gotfredson obtained a video tape, shown on CBS News 8, made by a female photographer identified only as "Rosselinni" three months before Newkirk's death. Rosselinni had been invited to the ranch during a chance encounter with Keith Harper, who was the boyfriend of the missing Abrams and who himself still lives on and is acting trustee of the ranch from which Abrams went missing and on which Newkirk was killed. Newkirk took Rosselinni on a walking tour of the ranch during which the video was shot.

On later occasions, Harper accompanied Rosselinni the death of Newkirk.

on several photo shoots at the ranch, until Rosselinni, 28, says she began getting weird vibes, in the nature of Harper, in his 70s, "hitting on" her.

Harper called the Sheriff's Department around 5 p.m. Dec. 23, 2021, and reported Newkirk had been killed on the ranch in an ATV rollover crash. He apparently told sheriff homicide investigators that Newkirk had been riding a quad on the property, during a rainstorm, because she wanted to cut down a live Christmas tree. He also related that he had discovered the quad on top of the woman and had performed CPR on her before authorities arrived and found Newkirk deceased.

The next day, in sheriff's statements and press releases republished by Gotfredson, the incident was described as a "crime scene" and a "suspicious death investigation ... with unexplained injuries" that were inconsistent with an ATV rollover. Gotfredson recounted detectives questioned Harper. No arrests were made regarding Newkirk's death.

Gotfredson's recent piece now reports that autopsy results and toxicology testing on Newkirk listed her cause of death as "acute methamphetamine toxicity." He also reports that court records indicate Newkirk had had a long criminal history that included the possession and use of drugs.

Two hazardous collection sites

The Riverside County Department of Waste Resources has scheduled two free household hazardous-waste collection events from 9 a.m. to 2 p.m. Saturday, Aug. 19, at the Anza Transfer Station and the Lamb Canyon Sanitary Landfill. The collection is open to all Riverside County residents.

The events will accept residentially generated household hazardous waste. Waste from businesses or nonprofits will not be accepted. Typical waste includes used motor oil, paint, antifreeze, household and automotive batteries, pesticides, cleaning products, sharps (needles/syringes or lancets), unused medication (except controlled substances), fluorescent lamps, and electronic waste such as TVs, computers, VCRs and telephones. Limit the amount of waste transported to no more than 15 gallons, or 125 pounds maximum per vehicle. Individual containers should be no larger than five gallons nor weigh more than 50 pounds.

Not accepted are explosives, radioactive material, ammunition, asbestos, compressed-gas cylinders over 40 pounds, or infectious or medical waste other than sharps.

The event is subject to cancellation during inclement weather or for other hazardous conditions as determined by the county.

Caltrans working on Highway 371


Caltrans will begin work on a \$5.2 million slurry seal and rumble strips maintenance project on Highway 371 from Aguanga through Anza. This project will involve dig outs, slurry seal operations, striping and installation of safety rumble strips on the inside and outside of the lanes in both directions, weather

The project was awarded to VSS International of Sacramento. Crews will be working from the junction of highways 79 and 371 to the junction of highways 74 and 371. The project length is 20.67 miles.

Construction begins the week of Monday, Aug. 14, and will occur Mondays to Fridays from 5 a.m. to 7 p.m. with occasional weekend work.

Highway 371 will remain open for the duration of the project. One-way traffic control with flagging and pilot vehicles will be in place. Motorists must wait for the pilot vehicle to escort them through the construction zone. Expect delays up to 15 minutes.

The project is expected to be complete by late winter





Is Idyllwild large enough for two soccer groups?

It appears that Idyllwild will soon have two competing youth soccer programs. In addition to Idyllwild Community Center's (ICC) program, Bob Lewis, former director of recreation programs for ICC, and Town Hall Recreation director under the earlier Idyllwild Community Recreation Council, is starting a program for the greater Idyllwild area. He and his wife Kathy, better known as "Teacher Kathy" from her L'il Critters pre-school, have teamed up with Kat Wilson's local nonprofit Young Idyllwild Inc. Under that organization's umbrella, the new venture will be known as Idyllwild Sports and Activities.

A call to Idyllwild School confirmed that its present enrollment stands at 270. The school does not have an intramural soccer team, although it does have teams for other sports. Many home-school families also are in the area, but time will tell if enough of these children will sign up to justify the existence of two leagues. This week, the Crier sat down with Bob and Kathy, and also reached out to ICC President Stephanie Yost for her perspective on this development.

And Jon Brown, also of Idyllwild, noted that the exiting ordinance largely affects existing STR certificate holders, while the proposed 927.2 will have greater effect on STR owners without a certificate.

ed in this section. The provision states, "The Short Term Rental Cap for Idyllwild shall be determined by a percentage of the existing single family residential units in Idyllwild, as of the effective date of this ordinance.'

And then it explicitly limits the number of STRs in Idyllwild to 500, or 14% of the current single family residential units in Idyllwild. Once this limit is reached, the county will not issue new STR certificates until the number of approved certificates falls below the limit.

Brown felt this number was reasonable and in line with the number of existing certificates in Idyllwild.

In the Wine Country, the percentage cap is different for the three districts. The cap for the Winery district is 114 STRs, which is equivalent to 15%, for the Equestrian district the cap is eight units or 8%, and in the Residential district, the cap will be 105 STRs or 10.5%.

Density

The next paragraph, Section 10 (e), requires, at least 150 feet between STRs. Any new application for an STR certificate will be denied if that property is within 150 feet of an existing certified STR.

However, if an STR owner, with an existing and certified STR within 150 feet of another certified STR, applies for a renewal of the certificate, the county will make an exception. As long as the owners of these STRs comply with the

ordinance, their certificates will continue to be renewed.

Limits on owning STRs

Another new restriction is owners ("Owner, Owner Entity, and any ownership interest, or responsible person for the ownership interest of the Owner or Owner Entity") may not hold more than two STR certificates in the Idyllwild area. They may have STRs in other unincorporated areas of the county.

If and when the ordinance is passed with this language, existing owners with three or more STRs will be exempt for three years. At that time, any request for renewal of an STR certificate must comply with this lim-

Temporary events

The proposed ordinance prohibits any temporary events, as defined by Ordinance 348, until the responsible operator has received a permit for the event.

Occupancy

The existing occupancy limits of 200 square feet per person still apply. The total number of guests depends on the size of the property. Lots of a half-acre or less will be limited to 10 guests. From a half-acre to 2 acres, the limit is 16 guests. And for properties greater than 2 acres, the maximum occupancy will be 20 guests.

Regardless of the outcome of potential changes to the STR ordinance, the county is planning to establish stronger enforcement of the ordinance. The recently approved fiscal year 2023-24 county budget provides new funds for both the Sheriff's Department and Code Enforcement to establish dedicated staff to its enforcement.

There was no change in the level of fines for violations. The initial fine is \$1,500 and a second, if within one year, is \$3,000 and \$5,000 for added violations within the same year.

Mark Dean, president of the Pine Cove Property Owners Association and neighbor to five STRs, intends If the number of STR certificates in Idyllwild or the to continue to urge the board to modify some of the proposed changes. For example, he said, "I believe the density issue is the most important, since it most directly affects the peace and quiet of every resident. The 150 feet between STRs is not what the town wanted (300 feet) but at least it's something.'

But Dean is not satisfied that existing STRs that violate the density limit can be renewed without limit. "Going forward, İ will be working to revise the ordinance before it is finalized to reflect a three-year phase out of STRs that won't meet the density restrictions using the same language that is being added to reduce the number of STR multiple ownerships to the max number of

"I will continue to fight hard for this as I see it as the linchpin toward improving our STR dilemma," he promised.

Moratorium

Sept. 9 is when the current moratorium for issuing new STR certificates for Idyllwild and the Wine Country expires. Since the special Planning Commission meeting is Aug. 23, it is unlikely that the new ordinance can be approved before the moratorium's expiration date. Consequently, according to Felisa Cardona, the Planning Department's public Information officer, an extension of the moratorium will be requested at the Aug. 29 board of supervisors' meeting.

The extension timeframe is tied to when the revised version of Ordinance 927.2 becomes effective," she wrote in an email to the Town Crier. "Meaning, once the new ordinance is in place and the CAP/limits to STR certificates for Idyllwild and Wine Country are effective, the moratorium is lifted. This however assumes the

Board approves these changes."





Friday deadline for P-EBT Residents whose children qualified for, but didn't use extra pandemic food benefits in 2021 now have more time to request a reissuance.

Pandemic EBT (or P-EBT) is a federal program that provides food assistance to eligible young or school-aged children in addition to free or reduced-price meals at childcare or school.

P-EBT benefits that remain unused after a year expire. California officials say if your child received a P-EBT 2.0 card in 2021 and didn't use any of the benefits for a year, you may be eligible for a reissuance of expired benefits. The state extended the reporting timeframe, allowing families until Aug. 18 to request reissuance of expired

To qualify for the reissuance, customers must have received a P-EBT 2.0 card in 2021 and have not used any of the benefits on the card, causing

"Riverside County DPSS encourages fami-California Child Support Services lies who may be eligible for replacement benefits to contact the P-EBT helpline by the deadline," said Assistant Director Allison Gonzalez of the department's Self Sufficiency Division. "These food benefits help children and families reach and sustain nutritional well-being."

PCWD expected to buy Pine Cove county park soon

The Pine Cove Water District (PCWD) Board of Directors met Wednesday, Aug. 9, with all directors present except for Rose Vernard was absent.

The board reviewed the fouth quarter budget comparison. Director Lou Padula asked about the budgeted \$48,000 for liability insurance. Office Manager Becky Smith pointed out that that was last year's number. This year the district has a new carrier, Allied. The July financial report shows a check for \$40,338, which is a prorated payment. The old carrier billed the year beginning in July. The new one bills the year beginning in April. This payment thus covers July to March, nine months. The new full year policy will cost \$53,582. This financial year's report will show two payments, because of the difference in terms.

Rates keep climbing, and Smith is asking for a quote from the company PCWD uses for worker's compensation to see if there would be savings from bundling the two policies. The last time she checked it was not cheaper. The liability policy also includes fire, vehicles, errors and omissions and the wells, but not water. "Water you can't insure," she said. Director Vicki Jacubac asked, "Where will it end?" Smith could only answer that the district must be prepared for insurance to continue rising.

The budget review showed income of \$1,356,590, \$125,590 more than budgeted, and expenses of \$1,044,306, \$186,694 under the budgeted \$1,231,000 — this in spite of the purchase of a low-mileage used truck, for \$60,000. The board approved the review.

The July financial statement elicited few questions from the board. Smith pointed out that a \$54,266 payment to CALPERS is the unfunded liability payment for the entire year, and the lump payment saves the district a "couple thousand dollars.

Padula asked about a payment of \$973.60 for legal ser-

vices regarding the district's rental of space to a communications services company, Comtronix, that had fallen in arrears. President Robert Hewitt said Comtronix is "on schedule to resolve" the matter.

General Manager Jeremy Potter said current payments were in order. July financials were accepted.

Potter presented the operations report. July production was down almost 1 million gallons from last year; from 4,180,072 to 3,181,072, something he attributed to a wet winter. People are watering less. Another factor in declining demand is the rising levels of private wells; Buckhorn Camp is able to pump its own water again.

Smith added that for three years Buckhorn did not buy water from PCWD, but did last year. Static well #10 is up another 1.9 feet. The rise, although slowing, continues.

The two-month total of production showed a 6% loss, water not accounted for. The new smart meters are helping with leak detection, even small ones. Coulter Pines is losing 70 gallons an hour, with no way to tell how long this has

Padula expressed his thanks for the "nice job" the crew did in replacing his meter. An item discussed later in the meeting under public correspondence, echoed this sentiment. A customer, with a long history of public comment on water district issues, wrote to thank staff and board for installing the new meters and for the "timely followup on detected leaks." The customer and their neighbor both had "unnoticeable" leaky toilets which have since been fixed.

Meter installation continues. The first of seven "books" is almost finished. Usually, the crew manages 10 meters a day. Smith reported that only seven meters in that first book remain. These are under asphalt, and so a little more

Hydrant flushing and maintenance is done. No major issues remain, and those hydrants requiring minor work are close to others. Information on pressure and flow was logged for all hydrants.

Potter also reported on the mowing of high weeds at the district's Dutch Flats facility. Ted Johnson was hired and spent 14 hours, billing \$2,315 for the work. The area "directly affects us and customers;" there are residences, PCWD has a plant, there is a building for fire operations and a helicopter dip tank. Smith noted that, when deer passed through, residents could only see the "very tips of their ears."

Potter said he would like to look into a "brush hog" attachment for the district's skid steer. This would cost \$3,000 to \$6,000, and would allow staff to do this type of abatement more frequently, but would not mean another motor or drive-train to maintain. He also noted that the snow blower attachment recently purchased has arrived and will be ready for next winter.

The purchase of the Pine Cove Park parcel from the county is expected to be approved by the board of supervisors on Aug. 31. Smith added that the agreement is with the district's attorney to "make sure the district is covered." Potter said he would like to develop the land as a catch basin for recharging the three wells there. The attorney also will weigh in on the plan to have signage allowing public use, but not as a recreation area.

Smith noted that she has started the process to have the park removed from the county's map of snow-play areas. Potter explained that this was over concerns of liability and trash. The board authorized Potter to sign documents and cut the check for the parcel, \$140,000, and escrow fees.

The board also voted to approve a pro-forma resolution on the "appropriations limit" for the district. This is a limit on spending, (the "Gann limit") determined by population and per capita income figures provided by the state. The new limit is \$19,791; 4.8% higher than last year. The amount is moot, as PCWD is well within the limit. The board approved the resolution.

The next meeting is Wednesday, Sept. 13.

Come early this week to concert; starts at 4:30 p.m.

Idyllwild's free Summer Concert Series (ISCS) continues with the USMC Division 1 Concert Band this Thursday, Aug. 17, and next week, on Aug. 24, Nathan James opens for Lisa Lynn and the Broken Hallelujahs.

The Aug. 17 concert will not begin at 7 p.m., as stated in last week's Crier. At 4:30 p.m, series producer Ken Dahleen will play a recording of last year's performance by the Marine Concert Band as a sort of "call to the faithful," inviting visitors and residents to the Butterfield Amphitheater. Then, at 5:30 p.m., Emmy Award-winning NBC meteorologist and stand-up comedian Fritz Coleman will en-

Coleman has been the master of ceremonies at many festive events in Idyllwild, and people still remember him as a weather forecaster, but his career as a comedian is more than a second act. In his earlier days he appeared eight times on the Tonight Show with Johnny Carson and Jay Leno. These days, he is enjoying an extended residency at the Monroe Forum, the intimate theater-in-theround venue within North Hollywood's El Portal Theater.

Coleman traces his love of stand-up back to his youth. His bio mentions an uncle's gift of tickets to see George Carlin during Fritz's senior year of high school. Although he had followed closely the short bits comedians did on the TV talk shows, he was thunder struck by Carlin's genius as a long-form performer. "This was one person ... controlling a huge stage ... wielding the mic like his Excalibur ... for 90 minutes ... in front of 3,000 convulsing people. Fritz couldn't believe what he was seeing. "It was the most creative, most effortless display of power one person could have over a group. Not an exaggeration to say ... it was a religious ... almost evangelical experience."

In keeping with the evening's theme, Coleman also is a proud veteran of the armed services.

Conducting the USMC Divison 1 Concert band this year is Chief Warrant Officer 2 Eric Kyne. He'll be leading a 45-piece ensemble. He told the Crier, "We'll be playing pieces from the 1800s to the swing tunes of the big band era." Kyne added that he will have a special guest, retired CWO2 Stephen Glove. "He's conducted several Marine Band concerts at the Idyllwld Summer Concerts and currently teaches at a school in Georgia." Kyne also shared this teaser: "I have to mention that we will have a mystery hometown hero performing with us onstage as well."

Aug. 24, ISCS will welcome back the double bill that began last year's line-up: Lisa Lynn and the Broken Hallelujahs, with local globe-trotter Nathan James opening. As with most of the series, the opening act will take the stage at 6:05 p.m. and the headliner at 7 p.m.

Lynn told the Crier about the band she will bring with her. "Our staffing is a bit different because a couple of our guys are touring. We have Bobby Moses Nicoles on guitar, all the way from Joshua Tree. He's been with us before. He's a highly revered player who has opened for Hall and Oates, shared the stage with members of the Allman Brothers Band, Mickey Thomas of Starship, Terry Reid and more. We have Jeff Bowman on drums showing off how versatile he is. He was primarily known for playing with members of Queens of the Stone Age, Mondo Generator, Unsound and People of the Sun (a tribute to Avenge Sevenfold) so, even though he's a phenomenal guy, I was a little nervous about him at first hiring him to play country and blues, but he is a wizard and has been an incredible new addition.

'Mike Wylie, a retired police officer, has come in on bass and completed our rhythm section beautifully (some may remember him with the Cole Withers Band). This ensemble was with me when we opened up for American Idol winner Jordan Sparks in December, and I couldn't have been prouder. We'll have Eric Frankson on keys and fiddle, and well ... Eric is a force of fiddle nature. He

played with me the very first time we had the honor of playing this incredible series.

Asked about this year's program, and her past visits to Idyllwild, Lynn said, "We've got some surprises up our sleeve that should light the place up, including introducing some original pieces. This is by far one of our favorite shows to play because of the beautiful mountain, but most especially because of the people ... I think this is the sixth time playing for them here. We fill up for the whole year on the love they pour into us every time. And it's no joke when they say the concert is only as good as the crowd - Idy folk bring out our best every single time. "

Öpening act James is a recent Idyllwild transplant. A Fallbrook native, his childhood included camping and hiking here, and these mountains have always been a "big inspiration" to him. Moving up here is as much a dream come true as playing music for a living. James performs as a "oneman-band," playing a variety of familiar and homemade instruments. In real time he creates wild, rootsy grooves that grow into dynamic song

James added, "I'm excited to play the concert series again this year. It was really cool to play for such a large crowd of locals last year and great to see them dancing and having fun. This is my last local show in town before heading out to tour in Europe (Austria, Italy and Switzerland.)"

These concerts are free to all and supported entirely by donations. This year's budget is \$36,900. The team "passes the hat" at the event, and those who can give more are invited to send contributions, checks payable to Idyllwild Summer Concert Org, to P.O. Box 1542, Idyllwild, CA 92549-1542, or call (760) 413-4638.


Steele T11 at **Bedminster**


