IWD GM cleaning up issues

The March 30 meeting of the Idyllwild Water District (IWD) Board of Directors included the swearing in of Mitch Davis to fill a seat that has been vacant for the last

This also was the first meeting at which interim General Manager (GM) Curt Sauer was able to give a report of his management style in action. Sauer began his service the first week of Feb., after the board voted to terminate then-GM Leo Havener, first putting him on one month's administrative leave.

The longest public comment came from John Jacobs, longterm resident and IWD ratepayer. Jacobs expressed appreciation for the difficult decisions the board has made recently including the "need for a change in leadership and management" and the "the reinstatement of a couple of key employees that had honorable histories here and deserved more opportunity." This was the first public reference to the return of Tyla Wheeler to the office and Brian Wilson to the field. Fired by the last GM, Sauer put both on administrative leave as he began to sort through the district's personnel issues. Later, President Charles Schelly confirmed that the former GM's chief water operator has been placed on administrative leave.

Sauer began his operations report with a recap of the all-employee team-building meetings he had called. He said he had asked staff two questions: "What do you need to be better at what you do?" and "What do you need to turn the district into something you could be proud of?" The top three answers to the first were: Office staff need to go into the field to see operations, better communications and radio communications, and improved record keeping and documentation. The top answers to the second question were: customer relations, cost savings, and improving communications between field and office.

In a sign that these exercises are leading to action, Sauer noted that "office staff is shadowing field staff to gain a better understanding in the field." This will take up to four hours once a month. Sauer underlined that the office staff is the face of the organization, and he hears calls from ratepayers with concerns. "We can do a better job training [office staff about operations] so they can relay that to the public."

Sauer noted that work had finally begun on the lower office, with the foundation in progress and heating and AC being installed that day. The parking area will be repaved and the district's field crew has voluntarily cleaned up the property in preparation for landscape improvements.

Planning for the largest undertaking, replacing the aging Waste Water Treatment Plant (WWTP), is going slowly. The firm in charge of the initial plans is still three months away from finishing 30% of the engineering, a benchmark that allows the application process for grants and loans to begin. Sauer noted three things that have held this up: the geotechnical report, "which we have received;" the 30-day period for California Environmental Quality Act (CEQA) tribal consultation, ending April 13; and another 30-day comment period for the entire CEQA, which will be "about the end of May."

Although most of IWD's meters were recently replaced, there were still a few old units in service, all in especially difficult situations. Four of these tricky replacements have been completed, and now only seven remain. About 15 of the new meters each month do not read remotely; "We are looking into changing out their MXUs, the signal producing box on top of the meters." This will save time staff spends manually reading these. Sauer's "housecleaning" includes some literal housecleaning: the maintenance shop has been inventoried and staff has identified "surplus property," also known

Perez heads State of the 4th District

State of the County addresses were annual events in Riverside until COVID. Supervisor V. Manuel Perez decided to create a State of the 4th District event this year to bring together people he calls partners. Idyllwild was joined to the 4th District, and Perez, in 2021. Every 10 years, the county adjusts these boundaries.

The event, Monday, March 18, occupied a large hall at Fantasy Springs Event Center in Indio. Tables were set for over 500 people and were mostly full. The title of Perez's address was "Place Matters," meaning "where you live determines how well you live."

In introductory remarks, Perez recounted briefly his public service career: He served on the Coachella Valley school board, and in the state Assembly before becoming the first Latino on the Riverside County Board of Supervisors, a county that is now majority Hispanic/Latino (52%.) He said he had brought more money into the district in his seven years than had come in the 12 before. Throughout the fastpaced morning, the emphasis was on partnerships between governments at all levels, businesses, nonprofits, faith organizations and labor. "Government cannot do it alone" is one of his mottos; also, "The county can do anything, but it cannot do everything.

The 4th District covers 75% of the county by area, 5,406 square miles, and includes both very wealthy areas like Palm Springs and Palm Desert, and a vast desert, stretching to the Colorado River, spotted with unincorporated communities that often lack access to basics like clean water. Perez name-checked Idyllwild several times, first as among its scenic and creative attractions, and later when speaking of roads.

County Executive Officer Jeff Van Wagenen touted the county's balanced \$8.6 billion budget and growing General Fund reserves. Growth, and the challenges and opportunities it brings, were the recurring theme of the day. Van Wagenen called the county's growth "truly staggering," saying that between 1990 and 2020, Riverside County has doubled in population. "Between 2010 and 2020, more people moved to Riverside County than any other county in the state of California, and during 2021-22, the county was behind only Maricopa in Arizona in new residents. This growth is our greatest opportunity; it also becomes our biggest challenge ... With customers, with employees, with dollars, comes 20 to 30,000 people a year who need services."

Van Wagenen said the county has been "blessed" by over \$480 million from the

Possible state deficit getting Legislature's attention

When Gov. Gavin Newsom released his proposed \$300 billion fiscal year (FY) 2024-25 budget in Jan., he acknowledged that there would likely be a deficit. Twice since then the Legislative Analysts' Office (LAO) has advised the Legislature of the deficit potential and the likelihood of it increasing by May.

On March 14, the state's Senate Democrats agreed with release of their "Shrink the Shortfall" proposal to address the impending and increasing deficit for the FY starting July 1.

Four days later, Newsom, Senate Leader Mike Mc-Guire (D-North Coast) and Assembly Speaker Robert Rivas (D-Salinas) announced that they had collectively agreed to a plan to address the pending deficit.

"Thanks to leadership in the Assembly and Senate, California is stepping up with a balanced approach that will take a significant chunk out of the projected shortfall," Newsom said in the news release announcing the executive and legislative agreement. "Despite the uncertainty due to the federal tax deadline delay last year, historic reserves and fiscal responsibility will assure a balanced budget that meets California's needs."

While the Senate had previously released its "Shrink the Shortfall" plan, the Assembly has taken no action nor offered any alternatives other than despair of the consequences of the expanding red ink. Neither the speaker nor the Assembly Budget leaders have announced any specific proposals.

"The Assembly is committed to a deliberative, transparent budget process that protects hard-working Californians," Rivas said in the press release, without sharing any details. "I appreciate our partnership with Governor Newsom and Pro Tem McGuire to finalize this preliminary and initial budget package in early April, which is an important first step. But the Assembly's budget work continues, including more than two dozen budget and oversight hearings scheduled next month. There are tough choices on the horizon, which is why our process is so critical."

However, not quite in accord with the Democratic leaders' budget actions, Senate Republican budget leader Roger Niello (R-Fair Oaks) issued the following statement, "The budget process has been degraded in

Prop 1 back and forth barely passes

Elections, including referenda on propositions and constitutional amendments, can be won overwhelmingly or they can be close and undecided for several weeks.

Surprisingly, Proposition 1, for mental health services on the March 5 ballot, has taken three weeks to reach a consensus on its final disposition. As of Saturday morning, March 23, "Yes" is leading by 28,000 votes, less than half of a percent, out of 7.2 million ballots counted. And during this period, the opponents have conceded, reversed this position, and conceded a second time.

On March 12, the opponents issued a concession statement. At that time, "Yes" was ahead by 19,600 out of more than 7 million votes.

Six days later, on March 18, Prop 1 opponents withdrew their concession and revived their campaign against the proposition. At the same time, Gov. Gavin Newsom, who proposed and strongly supported the proposition, urged voters to verify that their ballots had

Californians Against Prop. 1 said it would join Newsom in battling to get some mail ballots counted after they were rejected over signature mismatches and other is-

Their news release stated, "Prop. 1 opponents have overhauled their campaign website, prop1no.com, to focus on helping voters confirm whether their ballot was counted, and to help those whose mail ballots were reject-

"We believe all ballots should be counted," said Paul Simmons, a director of Californians Against Prop. 1. "We know that many Democrats voted against Prop. 1, so the governor's effort is no slam dunk ... If your ballot was rejected, don't ignore the notice."

Then on March 20, the Associated Press (AP) called the election, indicating that the final vote tally would be in

In the news release with the AP's call, Newsom said, "This is the biggest reform of the California mental health system in decades and will finally equip partners to deliver the results all Californians need and deserve. Treatment centers will prioritize mental health and substance use support in the community like never before. Now, it's time to roll up our sleeves and begin implementing this critical reform — working closely with city and county leaders to ensure we see results."

Then, the opponents released their second concession accompanied with the following statement, "Prop. 1 is not a 'huge' win for Gov. Newsom. It's an embarrassing squeaker of a victory that contains a strong warning."

Proposition 1 is multifaceted. It combines a \$6.4 billion bond with changes to the Mental Health Services Act, initially approved in 2004. Not only do these proposals intend to provide mental health care and drug or alcohol Fern Valley to consider bigger capital budget

Financial questions, plans and a notable local official were the major topics of discussion during the March 21 meeting of the Fern Valley Water District (FVWD) Board of Directors.

Idyllwild Fire Chief Mark LaMont visited the FVWD meeting to leave a copy of the latest International Organization for Standardization (ISO) report for the fire district. He was both proud and disappointed with the latest rating for the Idyllwild Fire Protection District (IFPD).

est is 89.33, an incredible jump.'

However, a fire department needs a rating of 90 to qualify as "exemplary fire protection," the highest ranking. He thanked the Board for Fern Valley's contribution to the recently improved rating.

"There is a large number of points for water systems," he told the board.

Nevertheless, he is collecting more water data from both FVWD and Idyllwild Water District (IWD). With this information, he will then request an interim audit with the goal of nudging the score above 90. This accomplishment should assure fire insurance companies and underwriters that Idyllwild is a safe location to provide fire insurance.

"The state of insurance coverage is rough. No one wants to underwrite in the high threat of the west coast," he opined in an email to the Town Crier.

LaMont shared that the chances of improving the ISO rating were somewhat better with more water district data. To improve the rating based solely on IF-PD's activities would most likely require more staffing, which is not feasible with the current budget resources, ... so we're turning to water districts for help."

This would include the water districts increasing the number of fire hydrants tested on an annual basis, he suggested in response to a question.

"Reliability and maintenance are options to get us more points," he said and added, "There's not a lot of room for your district to do more."

But he shared that he is working with IWD "... to help us get additional points as we work toward a Class1 rating. The earliest we can ask for that is 18 months," he wrote in an email.

While the current and future years' budgets were not on the agenda, there were several financial questions and preliminary discussion on the schedule for preparing the fiscal year 2024-25 budget, which is effective July 1.

One director asked about the recent expenditure of \$21,000 for added testing. FVWD General Manager Victor Jimenez replied that the payment to Babcock Laboratories in Feb. was greater than normal because of the need to do more testing for synthetic organic compounds (SOCs).

"We had to test all sources for SOCs due to the fact that the system had never been sampled for SOCs before," he wrote in an email to the Town Crier." Since they came back good, we will apply for waivers going

During the review of the district's assets and invest-"Five years ago, it was 80.36," LaMont said. "The latments, the board discussed the longterm liabilities for both its retirement plans and other post-employment benefits. The district has no current liability for the latter, but almost \$700,000 for the retirement plans. The board expressed interest in fully funding these as future budget plans are developed.

During his monthly report, Jimenez suggested the board investigate the merits of increasing its capital investment program (CIP) over the short-term in order to reduce future costs, which could likely be greater than doing the work now.

"It's just something to consider being that costs have increased as much as they have over the last 5 years," he

While this may require some short-term loans, he believes that long-term savings would easily offset these interest costs. He stressed that bigger projects yield savings by being completed sooner which reduces the time contractors need to deploy equipment on the Hill. But he added, "It will depend on the kind of interest that we will pay on the loan.

"It's worth exploring," Jimenez told the board. "I'll update the CIP for the next 10 years as we begin the budget process." This will be the initial step in his evaluation of whether to borrow now in order to manage a larger portion of the CIP sooner rather than in the future as costs continue to grow.


During the Jan.-Feb. billing period, FVWD's water production decreased nearly a million gallons to 4 million from the same period in 2023. Groundwater supplied about 60% of the total water in Feb. compared to only 20% in February 2023. The other districts also had decreasing usage this winter.

When asked what the cause might be, Jimenez replied, "I'm really not sure. I would guess it's a combination of different factors, less visitors, more conservation awareness, perhaps a cooler climate for the same period, possibly a reduction in construction activity.



American Rescue Act, and that the supervisors have made different decisions than those of many counties, opting to "invest the bulk, over \$400 million, back into our community" on things like infrastructure, housing and homelessness, workforce development, economic development, and childcare. Part of that investment is the county's Unincorporated Communities Initiative, \$5 million annually. "We recognize a significant portion of our residents live in the unincorporated areas."

Perez pointed out that those small communities each have their own culture and values and affirmed that they deserve solutions based on collaborations with local organizations. "Not my way, our way."

Dr. Jeffrey Leung, Riverside County health officer, spoke to "highlight how Riverside University Health System is working to make a healthier Riverside County." Perez and Leung were classmates at Harvard from 2000 to 2002. Perez earned a master of education degree in Administration, Planning and Social Policy there. Before COVID, Leung said, the health of a community was seen "primarily driven by medical conditions, by healthcare workforce, by access to care. Now we see that those communities that did best though different crises were those with tight human connections, good transportation, good jobs, resilience." These factors are what informs the "Healthy Places Index."

The Public Health Alliance of Southern California, whose website describes it as a "coalition of 10 health departments ... representing 60% of the state's population," produces the index. The index put Riverside County at 39 on a scale from 0 to 100. (A look at the map shows that the only part of the 4th above the 50th percentile is the west end. The rest is below 25%, although Idyllwild seems to be an area excluded from the data.) The map uses data to rank communities' conditions in eight categories: economic, education, social, transportation, neighborhoods, housing, clean environment and healthcare access.

Leung said he finds hope in that Riverside County outperforms in terms of life expectancy what would be expected from its economic conditions. He believes this may be because the county does a better job of connecting the services it can provide. Instead of a "fragmented" approach to areas like education, community services, housing and economic development, "we have a countywide integrated service delivery effort. Our goal is to take away the silos between different departments and think about how we can support... families and communities holistically."

The county has developed its own Whole Person Health Score using six categories: physical health, emotional health, resource utilization, socioeconomics, ownership and activation, and nutrition and lifestyle, with the initials spelling PERSON. He presented this as one example of how the county is thinking differently about health, not just about disease. It also is asking if residents have meaning and purpose, stable housing, healthy neighborhoods, social connections; all these "drive how long, and how well, people live."

Perez segued from health to parks, calling the investment in parks an investment in the health of residents, and part of the mission he developed fresh out of college when he first thought of running for office, alongside his friend "Eddie," now Assemblyman Eduardo Garcia. Perez has a long list of parks newly open, under construction or soon to break ground.

Desert Recreation District General Manager Kevin Kalman said Perez's zeal for parks was there when he took over from Supervisor John Benoit, and the projects now completed "were not born yesterday... We were going to build parks where parks didn't exist." Beyond the supervisors, the recreation district also works with county Transportation and Land Management, Economic Development, and Emergency Services. He said the recreation district also provides community emergency shelter with electric generators during outages and distributes food during other emergencies. He said parks and rec played a big part during the pandemic when schools were closed, opening up Learning Hubs at community centers, with teachers and librarians.

Kalman noted that 12,400 students were enrolled in afterschool programs last year in the district. Kalman listed other park projects, all of which were in the desert.

Tanya Torno, deputy director of Housing and Workforce Solutions, described housing as the basis for stabil-

ity and security, saying that last year the board adopted a homelessness action plan, its goal to make homelessness rare, brief and nonrecurring. People struggle to pay for housing, she said, and 46,000 in the valley "do not have access to an affordable home." Of these, "80% pay more than 50% of their income for housing." To bring this to a manageable level, she said, would mean a \$33 hourly wage, more than twice the present minimum

The Housing and Workforce Taskforce, a 2020 initiative, counts over 1,100 homeless in the valley, seeking refuge in emergency shelters, their cars or the streets. The vision is to build a "housing continuum of care." This starts with access to immediate shelter, where victims fleeing domestic abuse can have access to supportive housing, and those struggling with mental health issues or suffering from substance abuse can get treatment. The taskforce's plans include market-rate housing as well, and so is partnering with developers to build all types of housing. "All housing is good," Torno said. "In 2018, we had less than 38 housing units in production. Today... we have over 1,600 units in production here in the Coachella Valley."

Perez told more of his own story; his mother picked grapes for 20 years, working for the KK Larson family. Those with long memories may remember KK's wife, the late Patricia "Corky" Larson, who was the 4th District supervisor from 1982 to 94. Growing up in Coachella, Perez saw people tired and sweaty at the end of the day, and then sleeping in their cars, or under palm trees. He would frequently come home from school to find folk he had never met before in the family house; his mother and father would open up what they had to fellow workers who had no place. Perez choked up recounting this, the longest silence of the event. "We are going to continue to help all our folks, no matter who they are or where they come from. Especially our farm workers." (Another long pause... applause.)

Other community improvement projects Perez listed included new firehouses: House 41 in North Shore, and House 49, in Lake Tamarisk, the first new fire houses in unincorporated areas in over 10 years, both replacing older stations. Desert Hot Springs is also working on a new fire house.

Cástulo Estrada, vice president of Coachella Valley Water District, spoke of the county and state working to push water and sewer lines into the East Valley with a task force and master plan. Estrada is another Coachel-

la native. He remembered being raised in a trailer park, and as youngster noticed, on trips to the city, the difference between east and west. This left an early impression of the importance of infrastructure; the benefits for those who have it, the challenges for those who do not. He said he studied civil engineering to play a part in the development of the valley.

The project to bring safe drinking water to the east valley began with county data locating mobile home parks, usually served by wells, and overlaid this with a map showing existing water distribution and sewer systems. The task force came up with projects for extending pipelines. Estrada showed a map of the eastern Coachella Valley with red dots for these small water systems, over 70 of them.

They are mostly old and are often pulling water from a part of the aquifer with arsenic, chromium and other contaminants. The push is to consolidate these with existing, better systems. The master plan is the roadmap for water and sewer projects. They have created about 40 projects on the water side, and 20 other projects on the sewer side, costing an estimated \$200 million to complete. They then set out to secure funding. Over the years they formed strong relationships with the state water board and Legislature.

California state policy is that water is a human right. All Californians having a right to "clean, safe and affordable drinking water." The state has been making funds available. Last year, it "bundled up about \$100 million" to start executing these projects. "That's huge... we are going to start using the money, making a dent." This also helps with affordable housing projects. It just broke ground on a \$30 million, 5-mile long, 30-inch-diameter pipeline project cutting through the east valley; Oasis, Torres Martinez Reservation, the Mecca region. Estrada believes it will "start transforming that whole region."

This type of regional master plan is unusual in the state and is attracting attention; the state water board is looking to replicate the master plan.

Perez briefly touched on economic development and energy infrastructure, SCE and Integrated Distributed Energy Resources (IDE). This is a program to make the grid a "plug-and-play platform" that integrates small energy sources into the regional system.

In parting, Perez offered two more longterm goals: a four-year university and daily passenger rail service.







as "piles of junk, that will be removed by the end of the summer."

Sauer also addressed one of the issues which had caused friction between IWD and Idyllwild Fire Protection District (IFPD). His operations report includes a note that it was based on data from Feb. 2024, and two items that are part of "non water sales" (water that was lost or used internally and not sold) were "based on data submitted by employees no longer collecting that data, and I will be revisiting those."

These items were WWTP back wash, 10,000 gallons and fire department usage per IFPD, 100,000 gallons. This last was the bone of contention. The previous GM was claiming a uniform monthly 100,000 gallons in nonmetered water IFPD used, but IFPD had stopped using IWD hydrants for training activities and had worked out a plan with Fern Valley Water, collecting hydrant flushing water and reusing it. This, it follows, would have skewed all of the former GM's monthly

One item was removed from the consent calendar, the approval of minutes from the last several months. Director Stephen Olson noticed errors in the submitted corrected versions and asked that these be repaired.

Schelly also noted that the interim GM's contract was included in the board packet. Public employees have public contracts. Sauer is being paid \$144,000 annually, with few perks, one being the use of a district vehicle for commuting, or reimbursement for mileage. Sauer's pay is less than that of the former GM, whose pay was \$168,000, with perks bringing it up to \$180,000, according to publicpay.ca.gov.

Sauer has hired colleagues on a part-time basis to assist while the chief water operator is on leave: Randy Little from Joshua Basin Water District and Bill Rojas from Oceanside. Each comes one day a week. Little's 33 years of water experience includes expertise with the SCADA data acquisition systems the district depends on. Rojas has been coming up Fridays for training.

Thursday and Friday, 11 applicants from a field of 24 were to be interviewed for the operator in training position open with the departure of a commuting employee who found a job a few minutes from his home. In other

HUSD may avoid potential staff layoffs

At its Feb.13 meeting, the Hemet Unified School District (HUSD) Board of Trustees approved two resolutions to reduce staffing levels in the next school year although enrollment is expected to increase slightly.

The proposals would have affected 37 classified positions. Eventually, 42 district employees were given notice of potential action. Many of the positions were initially funded with one-time monies and employees were made aware of this fact when they were hired, according to Sonia Ramirez, HUSD chief communications officer.

The recommendation was the result of changes in estimate of future budget balances. HUSD is anticipating fewer funds available from the state as well as the end of special COVID funding. The total expected revenue decrease is about \$46 million, according to the March 5, 2nd Interim Budget Report. The resulting balance is a \$29.1 million deficit and another \$24.9 million deficit was forecast for the following fiscal year 2025-26.

However, the actual reductions may be obviated before the budget is approved, Ramirez wrote in an email to

"Our intention is to either rescind the notices or find suitable alternative positions as opportunities arise,' Ramirez said. "Due to attrition, we have already identified successful placements for many of these individuals. In fact, please note that 64% of the people identified for official layoff have already retained another position for which they are qualified."

employee news, office manager Kayla Stevens has begun billing system training, and Wilson has received his certification for grades D2 and T2.

After the public session the board went into closed session to discuss exposure to litigation. No action was reported from that session. The next regular session is 6 p.m. Wednesday, April 17.

Those employees who do not find an alternative position will retain re-employment rights, which would allow them to be considered for future vacan-

As early as Jan 16, Deputy Superintendent for Business Services Darrin Watters alerted the board to the evolving deficits. In his presentation two months ago, he estimated that the current year would end with a \$22.2 million deficit and the fiscal year 2024-25, which begins July 1, would have a \$11.9 million deficit.

HUSD has built reserves to help offset these deficits; nevertheless, the short-term projections were not optimistic about the growth of expenditures and the declining revenues. Over two fiscal years, nearly a third of the reservices could be used to offset the lower

At the Feb. 13 board meeting, two resolutions were adopted to reduce classified staffing levels. Classified positions are non-teachers such as aides, food-service workers and custodians.

The first (3045) specified five schools (Bautista Creek, Cawston and Ramona Elementary schools, Cottonwood School and Rancho Viejo Middle School) as well as the Expanded Learning Opportunity Program. None of these were teachers, and most were aides.

The second resolution (3046) simply approved a reduction in staffing totaling 37 positions. While some were office staff, it targets 16 mental health professionals, behavioral intervention assistants and others.

Projected savings was expected to be about \$2.3 million.

HUSD is not the only Riverside County school district taking these precautionary budget steps. Among the others are Alvord, Moreno Valley, Redlands, Riverside and Temecula Valley school districts.

Taryn's Place open in Village Lane

The Village Lane is once again part of Idyllwild's night life, as partners Taryn Scanlon and Rick Caughman opened Taryn's Place, their art gallery and tavern, Friday, March 22. They told the Crier they did a soft opening earlier in the week but were now ready for everyone. Even before 5 p.m., the place was full. We interviewed Scanlon in Dec., and this week Caughman took a few minutes out of the festivities to talk.

He said the project took about eight months from signing the lease to opening for business. "You run into setbacks, you feel defeated, you wake up the next morning, you don't let go of the dream."

During this time, while the county planning department was still deliberating, they gathered over 600 signatures supporting their effort. "What the supervisors look for is community, 'public convenience.'" On the bright side, the process "did allow us time to refine the space. I don't know if it would have turned out the same if we'd rushed." The space glows with the warmth of Scanlon's paintings and the woody interior.

Caughman said the intent was to "create a pub space like you'd see in Dublin or London. Designed for community, that's why you see the long table. You see people together. In the back there is a shelf where you can set a drink and stand." Asked about a favorite pub-crawling experience, he recalled his first try at "bangers and mash with scrumpy jack," a kind of "very hard cider," at a London pub in Piccadilly Circus.

In the future, they intend to add outdoor seating. They already have a railed-off "defined space," a legacy

but "want to make the outdoor space as special as the inside," maybe with black hand-cranked awnings sporting the Guinness logo.

Scanlon has lived here 10 years, much of that time "building a following" bartending. Caughman teaches art at San Bernardino Community College as an adjunct professor, and says he and Scanlon are just as happy working together in the studio as on the project. ICC/county work together to make child care more affordable

After several months of close coordination with the Riverside County Office of Education, Idyllwild Community Center (ICC) President Stephanie Yost announced that ICC is now a county-approved child care vendor. What does that mean? In a few words: subsidized or free child care for income-eligible families.

Yost had the opportunity to meet and work closely with the Early Care and Education Unit (ECE) through her work as a county commissioner with the Riverside County Children and Families Commission (also known as First 5 Riverside County). ECE is a division of Riverside County's Office of Education and can best be described with the words of ECE Coordinator Kosamaria Rodriguez:

"The Early Care and Education Unit is committed to providing exceptional child care and development services to Riverside County families. ECE strives to support families in accessing quality child care while working collaboratively with child care programs to support quality care."

Rodriguez continued: "ECE's California Alternative Payment Program offers subsidized child care services to income-eligible families and connects them with [approved] child care facilities across Riverside County."

About a dozen families have started the enrollment process with ECE through ICC's child care program and three families are already enjoying the benefits.

"ICC has provided child care to local families for years, including to some families who cannot afford to pay ICC's already low child care fees," said Yost. "While ICC has been happy to help these families, it has been a big strain on ICC's finances, as ICC has never received a financial subsidy for these families."

"I think this is a great opportunity for working parents," stated Johnny Wilson, ICC director of programs and recreation, who is currently raising two kids of his own (with his wife Halie.) Wilson continued, "There are so many basic costs associated with raising kids — child care being a major one. This is a great county program, aimed to provide financial relief for those who need it most.'

Leo Rodriguez, ICC director of childrens programming, described the county's enrollment procedure, stating, "The process is pretty quick, as long as the parents are prepared with their [income] paperwork." ICC will help parents throughout the reg-

ICC's child care programs (also known as "Kids Korner") are year-round and located at the Idyllwild Town Hall at 25925 Cedar Street. Child care programs, which are open to all school-age children (whether they attend public school or are homeschooled), include afterschool and holiday day camp care, as well as summer camp

programs. Participation can be weekly or daily, and walk-ins are welcome.




