

"The Riverside County Sheriff's Office and your deputies have not, are not and will not engage in any type of immigration enforcement," said Riverside County Sheriff Chad Bianco on a You-Tube video posted on Feb. 6 (www.youtube.com/watch?v=7najc2EBaLo).

Bianco spoke out personally after the Board of Supervisors debated and passed a resolution two days earlier. The resolu-

"... Riverside County is a vibrant, compassionate, and welcoming county for all law-abiding immigrants and refugees; and commits to safeguarding the civil rights of all our residents to the fullest extent provided by the law."

Bianco stressed that immigration enforcement is the "... sole responsibility of the Federal government."

He was attempting to alleviate concerns and fears raised during the past two County Supervisor's meetings about the role of his office in immigration enforcement.

tween the immigrant community and his deputies is being threatened by misleading information and fear mongering.

... [they] are using our fears to divide what is normally a great relationship between our residents and law enforcement," he explained. "Stories of deputies conducting raids at schools, businesses and churches simply is not true.'

"I will do everything I can within the confines of the Sanctuary State laws of California to cooperate with [Immigration and Customs Enforcement] to remove criminals for our jails," Biance stressed.

While protecting county residents and cooperating with ICE are related, he does not want immigrants afraid to call the Sheriff's Office.

"I am committed to make Riverside County the safest place in California for all residents, nonresidents and visitors," he stated.

Family of Tristin Bourgeois seeks restrictions on highway 74 truck traffic

"We now, as a family, are trying to create some restrictions. We want to make sure this does not happen to another family

There is now a second petition on Change.org intending to make Highway 74 safer from Palm Desert to 371. The first petition sought action from Caltrans to repair the many potholes in the asphalt. The new one seeks to limit the use of 74 by heavy trucks, enforce the prohibition with a weigh station.

The new petition was started by Tina Bourgeois, stepmother of Tristin Bourgeois, who lost his life on the morning of October 31, as he was driving to work from his home in La Quinta. A large dump truck pulling a trailer, both full of sand, lost control coming down the switchbacks above Palm Springs, tipped over, and collided with his Chevy Silverado. "He was 27." She told us, adding that the day we spoke, February 10, was Tristin's 28th birthday. "Today he would have turned 28." After the first three days, the petition had 1,077 signatures. Bourgeois said that "63% are coming from mountain communities." By press time the number had risen to over 1,500.

The Bourgeois family has met with Assemblymember Jeff Gonzalez, who's office has confirmed that he is working on a bill to address the use of 74 as a shortcut for heavy trucks. Tina calls it "Tristin's bill." The petition suggests several possible measures: "We may not get all these big trucks off the highway, but we can take some baby steps, get some scales. At Paradise corners. The truckers will tell their friends."

The petition names three primary hazards: trucks bypassing weigh stations, the steep grade causing brake failure, and the damage to the roadbed from overweight trucks.

The steepest part of 74 is an 8.3% grade, below Vista Point, where Tristin lost his life. The weigh station could be posted at Paradise Corners.

The petition calls for several changes, which the legislative process will have to digest into a passable bill. These include:

- A portable weigh station
- Caltrans enforcing restrictions on truck length and weight
- A Caltrans study on accidents along Highway 74
- Improved signage advising trucks to use pullouts

A GPS warning system advising trucks to avoid Highway 74

Presently, 74 is posted as an "Advisory Route," which merely "advises" that trucks above a certain size should use another route.

The petition says that a Caltrans spokesperson outlined the process necessary to put restrictions in place: local authorities must make a proposal along with supporting data. The office of V. Manuel Perez has confirmed that the Supervisor "is asking the Riverside County Transportation Department to look into this request."


Bourgeois' family has been greatly affected by the crash. "This is the first horrific accident that has happened, but there have been many crashes on this highway." "For over two decades I've commuted it. I have personal knowledge and experiences with these double trailers." Bourgeois noted that last week she had seen a truck pulling a 20-car vehicle transport trailer on 74. "We now, as a family, are trying to create some restrictions. We want to make sure this does not happen to another family."

Bourgeois' family members still struggle with the grief of Tristin's loss and are retraumatized daily. "We don't want anyone to go through what we're going through. All of us are from Anza, all of us commute down 74. We must pass the place where this horrendous accident happened — five days a week, ten times every week.

Rain helped but expect a little more

The latest atmospheric river has finally offered some precipitation to the Hill communities.


The fall and early winter drought is being slightly relieved. Last week, through Friday at noon the National Weather Service reported 4.1 inches of rain fell in Idyllwild from Wednesday through Friday. The Keenwild Ranger Station recorded 4.06 inches of rain during the same period.

More precipitation is not expected in the shortterm. On Feb. 16, the National Weather Service forecast was "Dry weather is expected through next week. . . . it's just a matter of whether temperatures will be slightly below or slightly above normal and how much (if any) marine layer low cloud coverage there will be."

"Well, it has finally rained in Southern California this winter. But nearly the entire region remains woefully behind average. And the much-discussed northsouth precipitation dipole has persisted all the way through mid-February," Dr. Daniel Swain, meteorologist and climate scientist at the Institute of the Environment and Sustainability at the University of California, Los Angeles, wrote on Weather West, his website, Wednesday, Feb.12, "This dipole will probably continue, in some form, for the rest of the season-but [this] heavy precipitation event preferentially focused on the southern half of the state will mitigate it somewhat and probably bring all areas in SoCal out of 'record dry' territory," Swain concluded.

From July through December 2024, only .39 inches of rain was reported at the Idyllwild Fire Station. The long-term average for the last six months of the year is 9.3 inches.

While the state drought map changed little from the Feb. 4 to Feb. 11 data, the Feb. 18 map should show a significant decline in drought areas, particularly along the



to be in a severe drought state as of Feb. 11.

Last week, the Department of Water Resources reported that the Southern California snowpack, as Feb. 13, was about 57% of the normal amount for mid-February and 41% of April 1 amount, an increase from the Feb. 1 estimate of 31%.

diction Center issued its forecast of a weak La Niña through February-April, but there is also a 41% chance of ENSO-neutral emerging in this season.

"Seasonal influenza activity remains elevated and continues to increase across the country," according to the Centers for Disease Control and Prevention on Feb.1.

One week later, on Feb. 8, the CDC reported the news was similar, "... this season is now classified as a high severity season overall and for all age groups (children, adults, older adults) for the first time since 2017-

While California is not one of the ten states with the highest flu rates, the California Department of Public Health advised State residents, "Influenza activity is high and increasing."
Fortunately, COVID-19 and Respiratory Syncytial

Virus cases are low.

But influenza case detections for all age groups is higher than it has been in years and the number of cases increased through Feb. 1 and only slightly decreased in

the next week. State and Federal health officials continue to urge people to get flu vaccine. While the rate of vaccinations has been about 40 % of the population since November, which is about the same as last year, influenza cases are

Hospitalization rates are about equal with the 2017-18 season and the highest since 2010-2011.

"The week ending January 25, 2024, was the first time that the percent of deaths for influenza (1.7%) was higher than the percent of deaths for COVID-19. The percent of deaths for influenza has continued to increase," according to the CDC.


In California, deaths attributed to the flu were higher two weeks ago, and still much higher than the past five years.

Particular concern has been raised for children. During the week ending Feb. 8, there were 11 pediatric deaths nationwide and 68 since the beginning of flu sea-

In California, the rate of influenza vaccinations of children from six months to 17 years is lower than any year in the past six years. In the week of the latest report (Feb 8), there are four deaths of children less than five years old reported and eleven statewide since the beginning of flu season.

Health officials continue to implore people that it is not too late to get an influenza vaccine for themselves or their children.

Outpatient Visits for Influenza-like Illness by Age Group





Monarch butterfly population census plummets

In December, the U.S. Fish and Wildlife Service proposed listing the monarch butterfly as a threatened species under section 4(d) of the Endangered Species Act. But that action may be too late for the venerable and beautiful creature.

On Jan. 30, the Xerces Society, which has organized survey counts of the Monarch for the past 28 years, reported that the population count for the Western Monarch was 9,119 – the second lowest during this period.

Only three years ago, the Xerces Monarch census totaled more than 200,000.

"The population's size is extremely concerning," said Emma Pelton, an endangered species biologist with Xerces Society for Invertebrate Conservation. "We know small populations are especially vulnerable to environmental fluctuations, and we think that's what happened this year. The record high late summer temperatures and drought in the West likely contributed to the significant drop-off we saw in the third and fourth breeding generations."

Scientists note that pesticides, habitat loss and severe weather, attributed to climate change, have all contributed threats to the Monarch's population.

"Research in California's Central Valley by the Xerces Society and University of Nevada-Reno found that milkweed leaves – the food source for monarch caterpillars – were contaminated by 64 different pesticides. One of these, called methoxyfenozide, is likely to be highly toxic to caterpillars and was in 96% of milkweed samples, but it is classified as "practically non-toxic" to adult honeybees – the only insect species currently included in testing by the Environmental Protection Agency before a new pesticide is approved for market," Xerces stated in its press release.

Now, a new threat has occurred according to the Xerces Society. Last month's Los Angeles County fires burned many acres of tree groves in the Monarch's winter area along the coast.

The Monarch has had a small habitat homestead on the Hill. For years, it visited and populated the small area around the Pine Cove Water District office. The PCWD area was a registered monarch habitat, accord-

ing to current PCWD director and former office manager, Becky Smith. And the butterfly has been a very popular visitor to many Nature Center and Earth Fair events on the Hill.

At the Pine Cove Water District Oc-tober 2021 Board meeting, former General Manager Jerry Holldber reported that the office's habitat "broke all records. We had close to 150 butterflies." But similar to the overall Western Monarch population, the Hill visitors have begun to decline. Current PCWD General Manager Jeremy Potter, said only a couple of butterflies were seen and no caterpillars.

The FWS estimated that without help, the Western Monarch probability of extinction is 99% within the next 60 years. This estimate was made before the current census was made and Los Angeles fires occurred.

In 2018, California initiated its own efforts to protect the valued species. The Monarch Butterfly and Pollinator Rescue Program was created by Assembly Bill 2421.

Its purpose is to assist in the recovery and sustaining of monarch butterflies and other pollinators. Grants and technical assistance are available to encourage these actions.



Commenting on the proposal, Isis Howard, coordinator of the Western Monarch Count with the Xerces Society, said in their press release, "A lot of people care about monarchs. Voluntary efforts like pollinator gardens and restoring habitat are probably a reason they aren't in worse shape. However, these actions are not enough. To help monarchs recover, we need to work at a larger scale and address widespread issues like pesticide contamination and climate change that are beyond what voluntary efforts have been able to achieve."

Lara declines immediate approval of State Farm rate increase

California's Insurance Commissioner Richardo Lara has declined to immediately approve State Farm General's request for an emergency rate increase. Instead, in a letter to SFG officials, including Dan Krause, President and Chief Executive Officer of SFG, Lara requested that they, along with representatives from Consumer Watchdog, an intervenor to the SFG request, meet with him on Feb. 26.

Lara's decision and invitation were given in a Feb. 14 letter to SFG, which was his initial response to SFG's Feb. 3 letter requesting that he grant rate increases of 22% for non-tenant homeowners, 15% for tenants (renters), 15% for tenants (condominium unit owners), and 38% for rental dwellings.

"Consumers who are struggling to rebuild their lives after the wildfires should not be forced to pay higher premiums to prop up State Farm's bank accounts," said Carmen Balber, Executive Director at Consumer Watchdog in a press release following release of Lara's

In response to Lara, SFG stated, "We are very disappointed the Commissioner ignored his department's recommendation to take the critical and necessary step to approve State Farm General's request for interim rate increases associated with our June 2024 filings.

"This lack of approval sends a strong message to State Farm General about the support it will receive to collect sufficient premiums in the future to protect Californians against the risk of loss to their homes," the company continued in its Feb. 14 press release.

As of Feb. 5, all of the insurance companies with coverage in the Southern California conflagration areas have paid a total of \$6.9 billion to residential and commercial policyholders. Actual filed claims have been greater than 33,700 and nearly 20,000 have been fully or partially paid, according to the California Department of Insurance.

Consumer Watchdog almost immediately opposed SFG's emergency request. They filed a preliminary response on Feb. 5, two days after the SFG letter to the DOI. On Feb. 7, Consumer Watchdog officially requested a full rate hearing regarding SFG's pending applications in lieu of approving an interim rate.

The questions that Lara will ask at the Feb. 26 meeting with SFG cover a broad range of issues from State Farm's financial stability and further justification for the emergency rate increase to the effect on SFG policy holders. For example, Lara asked how would granting this request affect policyholders, especially those who have already faced premium increases and non-renewals or how SFG's business decisions to pause writing of new residential coverage and non-renew policies will be affected.

"We have gone to great lengths to clearly answer the questions outlined by the Commissioner. While we're positioned to handle all of the claims associated with the most recent wildfires," SFG said in its press release. "State Farm General must seriously consider its options within the California insurance market going

Following Lara's letter, Consumer Watchdog expressed support for the delay and the prospect of a meeting with the insurer.

"The Commissioner is right to call for more scrutiny of State Farm, which has so far stonewalled information requests," said Pam Pressley, Consumer Watchdog's senior attorney on the case, in a press release. "... Lara's refusal to approve this interim rate hike confirms Consumer Watchdog's objections that State Farm needs to provide more data, but it needs to do it in a public hearing, as required by insurance reform Prop 103. We do not agree that the insurance commissioner has the power to approve an interim rate hike without a public hear-

SFG is the largest insurer in the State with more than 3 million policies, nearly 20% of the market. But in 2023, because of its declining financial position, SFG stopped writing new policies in the state. One year later, SFG announced it would not renew 72,000 existing California policies, including 29,000 that were for home-

Even AD 36 election cost millions

Jeff Gonzalez, the Republican candidate, defeated his Democratic opponent, Jose "Joey" Acuna, by 5 % of the vote in the November election. Gonzalez succeeds Eduardo Garcia as the representative for Assembly District 36, which includes southeast Riverside County (including Garner Valley and Anza) and portions of Imperial and San Bernardino counties.

Similarly to AD 47, to the north, the Democratic candidate outspent the Republican opponent.

Acuna's expenditures were more than 40% greater (nearly \$600,000) than Gonzalez's expenses, which totaled \$1.4 million. But Acuna spent almost \$2 million. Gonzalez

The new Assemblyman's largest contributor was obviously the California Republican Party, which sent slightly more than \$825,000 to his coffers. Most of this, nearly \$600,000, was considered a nonmonetary contri-

Nevertheless, Gonzalez's three largest contributions, two greater than \$100,000 and one of \$100,000, came from the state Republican Party.

He also received more than \$170,000 from four County Republican organizations - Imperial, Sacramento, Sonoma, Tulare and Yuba. The largest donor was the Sacramento Republican Party, which sent \$101,000 south to Gonzalez. He had 16 contributions of \$9,000 or more and all were from Party entities.

The largest nonpolitical contribution was \$5,500 and he received 16 for this amount. These contributors included the Riverside Sheriff's Association and the California Peace Officers PAC as well as several PACs for home builders and contractors.

In total Gonzalez reported 365 separate donations, of which 273 were for \$1,000 or less. Of these, 88 were for less than \$100.

Of these contributions, 14 came from outside of California. The total of the non-California contributions was \$15,800, about 1% of Gonzalez's total contributions. The largest was \$5,500 from DaVita, a healthcare company, in Colorado. Most came from Arizona donors and totaled \$750.

Nearly 60% of Acuna's \$2 million in contributions came from California Democratic Party entities. The State Democratic Party was the largest contributor, sending \$1 million to him. Actual cash was only \$439,000, the other \$600,000 was considered non-monetary contributions.

The Riverside and Los Angeles Democratic parties also contributed another \$180,000 to his campaign chest.

Acuna did receive 11 contributions of \$10,900 from various union and employee organizations, such as the American Federation of State, County, and Municipal Employees, SEIU United Healthcare Workers West PAC, United Food and Commercial Workers Western States Council Candidate PAC. Another two contributions of \$10,900 came from the California Real Estate PAC for a total of \$21,800.

There were 73 contributions between \$7,500 and \$5,000. One hundred and forty-one contributions were for \$1,000 or less and totaled \$52,000.

Acuna received 17 contributions, totaling \$37,000, from outside of California. Of these, the largest were two from the United Food and Commercial Workers PAC totaling \$9,000. United Parcel Service also contributed \$6,500 to his campaign. The International Brotherhood of Electrical workers also gave \$4,500.

So, the greatest number and amount of non-California contributions were from PACs headquartered in Washington, D.C. But there were some contributions from other states, such as Alabama, Maryland, New York and Texas.



















FAIR needs money to remain solvent, Lara agrees

Last week, California Insurance Commissioner Ricardo Lara announced that he had approved a request from the State's FAIR Plan to augment its funding.

"I took this necessary consumer protection action with one goal in mind: the FAIR Plan must pay claims just like any other insurance company," Lara said in his press release. "... Wildfire survivors can't cash 'what ifs' to pay for food and rent, but they can cash FAIR Plan checks."

The recent wildfires through Southern California have placed a massive demand on the FAIR Plan funds. As of Feb. 11, the FAIR Plan has paid more than \$914 million to policyholders, including advance payments, to cover claims related to the Palisades and Eaton fires.

The FAIR Plan has estimated its total loss from the Palisades and Eaton fires at approximately \$4 billion and anticipates paying 75%, or \$2.34 billion, of the remaining \$3.125 billion reserved for unpaid losses over the next few months and may be called upon to pay more if there are subsequent events later this year, ac-

As of Feb. 9, the FAIR Plan has received approximately 3,469 claims for damage caused by the Palisades Fire and approximately 1,325 claims for damage caused by the Eaton Fire. In addition, more than 500 claims have been submitted for other reasons, such as windstorms and fire claims unrelated to these wildfires. New claims, including total loss claims, continue to be reported daily, according to FAIR.

The FAIR Plan was established by statute in 1968 as California's insurance safety net. The California FAIR Plan Association was established to meet the needs of California homeowners unable to find insurance in the traditional marketplace. It currently has about 450,000

The FAIR Plan is not a state agency, nor is it a public entity. There is no public or taxpayer funding. Every property insurance company licensed in California automatically becomes a FAIR Plan member as a condition of doing business in California and may be called upon to help fund the FAIR Plan's continued operation in response to extreme catastrophes such as these recent Southern California wildfires.

Lara authorized member companies to provide an additional \$1billion to the current FAIR financial resources. This is commonly referred to as an assessment, the first in more than 30 years. Consumers will not have to pay the full cost of the assessment, with insurance companies responsible for half the assessment under an agreement reached last year.

Before insurers may recoup up to 50 % of their assessment from customers, they must ensure that their costs are not reimbursed from reinsurance or other sources.

Assessments are based on an insurer's market share of dwelling and commercial policies in place from two years ago. Member companies would receive their share of the assessment amount broken down between the 2024 and 2025 pool years and by line of business. Once the FAIR Plan issues an assessment to a member company, the insurer would have up to 30 days to submit the payment to the FAIR Plan, according to its press

With this money, the FAIR plan will be able to hire additional staff needed to process and pay these claims fairly, fully, and quickly.

Lara also required the FAIR Plan to utilize all available funds, including reserves and reinsurance funds.

However, the Consumer Watchdog issued a strong objection to Lara's actions.

"The FAIR Plan is in trouble because insurance companies dumped too many homeowners. That's why insurers are on the hook for FAIR Plan losses," said Carmen Balber, executive director of Consumer Watchdog in a press release. "Homeowners across California should not have to pay a penalty to repair the damage from home insurance companies' predatory behavior. Consumer Watchdog is exploring every legal option to stop a bailout if any insurance company seeks to make consumers pay,'

Further, Consumer Watchdog claimed this action is contrary to the law because the statute enacting the FAIR Plan explicitly put insurance companies, not consumers, on the hook for these losses. The statute requires insurers to participate proportionally in the writings, expenses, profits, and losses" of the Fair Plan.

Subject to the Commissioner's prior approval under Proposition 103, insurance companies may issue a temporary supplemental fee as a percentage of the policy premium and cannot pass assessment costs on to



The FAIR Plan also relies on reinsurance to cover claims. To date, the FAIR Plan has met its \$900 million deductible and has accessed \$350 million in reinsurance. The FAIR Plan can access additional layers of reinsurance based on losses incurred and outstanding reserves up to a \$5.78 billion limit.

"We must take action to improve the financial standing of the FAIR Plan and prevent this situation from recurring," Lara urged in his press release. "I strongly support legislation this session — just as I did last session — that would allow the FAIR Plan to access credit lines and catastrophe bonds to help pay claims in worst-case scenarios. I urge the Legislature to act quickly and send it to the Governor's desk."

"This gift to insurance companies rewards bad behavior and will only incentivize insurers to drop even more homeowners and force them onto the FAİR Plan in future, because there's no consequence for abandoning these families," argued Balber in the Consumer Watchdog press release.

Moving people off the FAIR Plan into comprehensive coverage is the way to protect consumers and stabilize the FAIR Plan, not a bailout, said Consumer Watchdog. The group called for new protections including a requirement for insurance companies to cover homeowners who meet statewide mitigation standards and protect their homes from wildfires.

Idyllwild Forest Health Project founders conduct workshop to build connection, resilience

Mark Yardas and Mara Schoner, founders of the Idyllwild Forest Health Project, conducted a workshop at the Library on Tuesday, February 11, hosted by the Friends of the Idyllwild Library. The IFHP, a 501(c)(3) nonprofit, was created to be an open platform, discovering and matching needs and the resources to address those needs within our community. Although the initial focus was on protecting the community from wildfire and turning the fuels that create fire danger into a useful resource, its best-know project is Mountain Communities Mutual Aid. MCMA is in turn known as a food distribution, but matches many types of needs, and many types of volunteerism.

Schoner said that the purpose of the event was "to find out how much connection and agency we can co-develop in this room together in 90 minutes." The goal was to discover "steps that we can all take toward creating greater resilience in our communities." Yardas asked those who had gathered to define resilience and heard concepts like perseverance and quick recovery from adversity. He asked if recovery meant returning to a previous state or finding a new state, agreeing that "It's never the same."

Yardas asked us to "look around at all the collective intelligence in this room right now, all the lived experience, the range of experience and differing world views." The open platform paradigm nurtures collective intelligence. With that in mind, participants were invited to stand and chose a partner, hopefully someone they did not already know well, to talk to. Once these conversations started they were hard to break off, but attendees were asked to switch partners until we had each developed a little rapport with a handful of familiar strangers. Yardas posed questions, including "What do you consider the greatest challenge to this community's resilience?" and "What strengths or gifts could you bring to work on this challenge?" Eventually these conversations were reported to the group.

Yardas and Schoner also fielded questions about the origin of IFHP and MCMA. He referenced Idyllwild with great results, the Idyllwild Arts Academy's shad-Conversations, a series of public conversations that brought people together to discuss local concerns and solutions. He expressed a desire to explore how we can mass and provide supplemental heating for the school.

"build a culture that has the sense that it is such a privilege to live in a forest, and that we need to understand how to take care of that forest." Reaching that understanding, in Yardas' words, "is a lot of work."

IFHP spent years looking at different uses for "low value biomass" the ladder fuels that enable fire to get up into the canopy, and then into the town, jeopardizing everything, forest, communities, relationships and lives. They found lots of potential approaches, and the challenges posed by "politics" or "culture".

"Then the pandemic broke out and I read about this idea of a mutual aid platform, a very open platform that allows people to say what they need and what they can provide." Yardas recounted the counterintuitive results: volunteers immediately outnumbered requests for help. Within hours of opening up the MCMA platform, 550 volunteers had signed up, but "it took longer for the needs to appear, there is so much shame around needing in our culture. We're very individualistic, which has it strengths, but that shame drives need under the sur-

One of the first needs that emerged was food. Yardas and Schoner discovered the other side of that need, how much food is all around us. "Forty percent of the food in this country goes to the dump." Mara finished the thought: "and so many people in need."

Yardas and Schoner gave an example of a small step ed fuel break. "In 2017 IFHP explored partnering with Idyllwild Arts Academy to generate electricity with bio-

John Newman, the Academy's operations manager at the time, attended IFHP's meetings and learned about the concept of creating shaded fuel breaks around the community. John secured a grant to create a shaded fuel break along the edge of campus. When the Cranston Fire approached the town in 2018, firefighters were able to do a back burn because the fuel loads had been reduced. This prevented the fire from entering the community at its most vulnerable, low-lying location. Incredible things can happen when people come together and exchange information. In this case, it played a key role in saving the town from perishing in the Cranston Fire." The initial idea of a biomass facility did not come to pass, but the conversation that the idea started had long ranging impacts.

Yardas and Schoner floated the idea of a regular series of monthly webinars, a "regular place of discourse and bringing people together." They also have launched a new website, ourmountain.org. It focuses on the concept of flourishing and invites individuals and organizations to take part in co-creating a flourishing community. Visitors can participate in the Global Flourishing Survey, developed as a collaboration between Harvard University's Human Flourishing Program, the Baylor Institute for Studies of Religion, the Center for Open Science, and Gallup.

Meet Paul and Carolyn Fetters, fitness entrepreneurs

Paul and Carolyn Fetters have recently moved to Pine Cove, completing what they call the "California Triathlon," having lived at the beach, in the desert and now in the mountains. Paul is a professional body builder and former Mr. America who helps others build their personal training businesses, while Carolyn provides training for nutritionists at over 175 gyms in the US and Canada. Together they share a lifetime of experience as athletes and entrepreneurs.

Paul came to Venice Beach from Michigan in 1979 to pursue his dream of becoming a professional bodybuilder. He lived out of his car in the parking lot of Gold's Gym until he found a job. By 1982 he had begun to act as a personal trainer, a category that did not exist at the time. With just three clients he was able to quit his job and dedicate himself to training. Initially he thought that six clients were the most he could handle while still focusing on his own training. However, he later developed a new format, semi-private training, and when he reached 100 clients moved from his garage gym to a Huntington Beach location, "The Training Spot," in

In 1997 Paul won the Mr. America title, and has competed in 44 competitions, "unheard of in body building." "If you would have asked the twenty-yearold if he would still be competing at 60, he would have Insagram as "Paulfetts." said you were crazy. Those categories didn't exist in those days." Now builders in their 50s and 60s compete as "Masters" and "Grandmasters."

Carolyn met Paul while she was in college. "I was a serious athlete; competitive road cycling, running, I rowed crew with UCLA." But she struggled with her weight. "I was pudgy; my coaches gave me all wrong information. The coach would bring donuts to practice. Then I met Paul, he taught me how to eat. Within two months I'd probably lost 25 pounds. I had been doing a ton of cardio and starving myself, eating maybe one meal a day, believing that was what I needed to do to be

She found that eating many small, healthy meals was key for her. As she and Paul describe it, regular small meals are like feeding a furnace to keep a small, hot fire burning steadily. Soon she was studying nutrition at Santa Monica City College.

The Fetters owned gyms for 20 years, selling them in 2016. In 2008 Carolyn created a nutrition program for their clients, which became so successful they turned it into a licensing program, now at 175 gyms in North America. Carolyn still runs that company, Balanced Habits, today. Paul worked as a consultant, teaching others how to run successful personal training studios. "Then I was thrown a curvebaÎl."


In 2019 Paul suffered a heart attack and underwent quadruple bypass surgery. "It was a shock," he said.

"After a difficult recovery. I decided to write a program for other people recovering from major surgery. After surgery there is often a time of negative mindset, out-ofcontrol emotions, struggling to get back into the life they knew, and a need for good nutrition. But there was also an opportunity for them to be in better shape afterwards than when they were going into the episode. I help them with strength training and Caroline helps them with nutrition, we do that virtually."

Carolyn says "Our goal has always been to help people develop a better quality of life. Every year we ask ourselves 'what can we do to help more people?' Now we're helping over 200,000... through our nutrition certification program, which is accredited through NASM (National Academy of Sports Medicine.) Clients get a daily lesson, educational-based nutrition, not just what to eat but how to eat, and how food affects them, we don't sell products, it's all real food."

Paul and Carolyn are discovering the gifts of smalltown life. "People are so embracing of us here when they find out we are full-time. It's something we hadn't thought about when we came. We moved to a new house, a new environment and climate, but didn't consider the community aspect of it, what a bonus."



Pine Cover Water to begin trial Idyllwild Arts of new transmission system for meters

The Directors of Pine Cove Water District met on Wednesday, February 12. They heard from General Manager Jeremy Potter that he is ready to start a pilot program to address poor data transmission from the recently installed "smart" meters.

Board president Robert Hewitt appointed Vicki Jakubac and Becky Smith to an ad-hoc committee to review PCWD's pay schedule with an eye towards bringing it up to the level of the other local water districts. They will discuss this with the GM and report back to the full board. This must be completed by May, when the new fiscal year budget is considered.

The Board considered and approved a vacation

compensation package for Jensen Beri, cashing out ten days of vacation time and approving a week off. GM Potter noted that the hiring of Nathan Baldwin has brought staffing up to the point that Beri can take a well-

Office manager Jennifer Hayes provided an update on the consideration of a new billing system. Hayes said she is inclined to accept the offer by gWorks, the successor company to the district's previous provider, UB-Max. The meeting packet included two offers, one with higher up-front costs, the other with higher ongoing costs.

The GM's Operations Report showed that water usage remains lower than the last two years as customers continue to conserve. Water loss was recorded at 4.3% after accounting for one 20-gallon-per-minute leak. The static measuring well fell nearly three feet to 76.21 feet, about where it was this time last year. In dry years it has fallen as low as 130 feet before rising with spring runoff.

GM Potter continues to seek a solution to the poor transmission from the new "smart" meters, which rely on cellular technology. He will begin a trial project to install a "mesh" system on ten meters, selected from more remote locations such as Acorn Lane and Deer Path Road. A mesh system allows meters to send data between themselves until they reach a meter that can communicate directly with the office. This trial, provided by the same company that sold the district the Smart Earth Technologies package of meters and valves, will not cost the district anything and will continue until Potter is satisfied with the results. Until a solution is found, much of the meter reading will be done manually.

Potter also reported that the District's Toyota Tacoma is back in service again. District employees installed a new engine, and with its rebuilt transmission, he believes it will serve for many years for a fraction of \$45 thousand cost of a new vehicle.

Potter asked the board to consider budgeting for a third generator, a portable 50-kilowatt model to allow running additional wells during power outages.

The next meeting is scheduled for Wednesday, March 12.

to host free **Jazz Girls Day**




