# Fifteen years later, Oyler's arson and murder convictions still in appeal

## **Death Row Appeal: Legal Battles Continue Over Esperanza Fire Convictions**

In March 2009, Raymond Lee Oyler was found guilty of arson, igniting the Esperanza Fire in October 2006. The jury also found him guilty of the murder of five U.S. Forest Service firefighters. Three died at the fire site and two, including Mark Loutzenhiser of Idyllwild, were taken to the hospital where they died. Oyler's jury imposed the death sentence. All the convictions and the death penalty were upheld in June 2009.

California law grants an automatic appeal to death sentence convictions and Öyler's appeal is still pending.

Appeals in California death penalty cases proceed automatically to the California Supreme Court, pursuant to Article VI section 11 of the State Constitution The defendant's attorney, either from the Office of the State Public Defender or a private counsel, is appointed by the state Supreme Court. The Attorney General represents the State of California.

In 2013, Michael Clough was appointed as Oyler's attorney for the appeal. The purpose of the capital direct appeal process is to identify and examine errors of law appearing solely in the trial record and determine whether the conviction, special circumstance, and/ or death sentence should be reversed be-

cause of those errors of law. Clough filed the appeal in June 2016.

Two supplemental briefs were filed in November and December of 2024 and focus issues letter on Jan. 24. The Attorney General's Office provided responses and rebuttals to the Clough issues. The oral arguments were presented to the Supreme Court on Feb. 5. A decision is pending and expected in the next few

The 2016 appeal was 464 pages, and Clough raised many questions and issues regarding the trial and its process. The are several claims that Oyler's "due process" was violated by decisions regarding appointment of his lawyers.

Oyler continues to claim that he did not start the Esperanza Fire. This is the most salient issue. Clough argues that the prosecutor, current Riverside County District Attorney Michael Hestrin, did not prove that Oyler started the Esperan-

In response to a request for comment about Oyler's appeal, Amy McKenzie, Communications Director for the District Attorney's Office replied, "Due to this being an active case, DA Hestrin cannot comment at this time. Feel free to reach back out once a decision on the case has been made."

While there is DNA evidence of Oyler's presence at two other fires which occurred in the Spring and Sumer of 2006, there is no substantial and definitive evidence that he ignited Esperanza and

# **IWD** encounters "snag" in Wastewater **Treatment Plant** funding

The February 19 meeting of the board of directors of Idyllwild Water District began with the swearing in of newly-appointed director Wendy Harsha. As Board President Charles Schelly pointed out, this was the first time since April 2023 that the board has had five members.

The board learned from General Manager Bill Rojas that the District has "hit a snag" in its search for grant funding for the project to replace the Wastewater Treatment Plant: Idyllwild did not qualify as an "economically disadvantaged community," and so doesn't "qualify for a grant principal forgive-ness program at this time." The team at Dudek, the firm working on the grant and loan application, has said that currently IWD will only qualify for a low interest loan. Rojas said that he will continue to explore the possibility of isolating the community of sewer customers and using only their data to allow the application to qualify. In most aspects of IWD's business, water and sewer must be considered separately. Rojas said that if grants are not available even low interest loans are very expensive. Until this is resolved the WWTP project will be paused. The GM's report continues: "Currently, Trump has put a freeze on Federal Grants for the next six months."

Rojas said that CRWA (California Rural Water Associates) has submitted an application for a \$10 million grant, separate from the Dudek applications. "We're waiting on the results," he said. Dudek informed him that the community numbers submitted showed Idyllwild in the 83rd percentile. State water code (79505.5) defines a Disadvantaged Community as one with an annual median household income less than 80% of the statewide annual median. The application used numbers from the 2020 census, CFO Hosny Shouman said, and it may be that segregating the 580 sewer customers will give different results. He added that the loan they were offered, at 1.99% interest, would cost \$55 thousand

Director Jessica Preifer had questions regarding the WWTP project, asking if rehabbing the existing system might be possible. Rojas answered that this was "not out of the question." Preifer also asked if there was a projected start date for construction, and Rojas said that would have to wait for the engineering to be completed; the initial 30% of engineering was finished last year by SUSP (Specialized Utilities Services Program Engineering), a benchmark that allows loan and grant applications. SUSP is working on the complete plans incorporating feedback from IWD's management and



# LaFata resigns from Fern Valley Water District

Fern Valley Water District Board Member Mike La-Fata resigned at the end of the Board's Feb. 20 meeting. He felt that his colleagues did not share his sense of detailed "fiduciary duty."

During his 14 months as a director, LaFata mostly concentrated his attention on reviewing the District's monthly expenditures, especially the credit card charges. In an interview shortly after his appointment, he acknowledged that he was unfamiliar with FVWD finances or how they compared with the Idyllwild or Pine Cove Districts, but he planned to focus on the warrants. "Whether it is construction, reconstruction or repair, I'll understand these expenses," he said.

His questions ranged from service contracts for FVWD vehicles to employee expenses. His level of detail seldom attracted mutual support or attention from his colleagues.

Several directors felt the expenditures for lunches, or some employee gatherings were valuable morale boosters. General Manager Victor Jimenez assured him that the District's attorney had verified their legality.

During the time for the Director's comments near the end of the meeting, LaFata announced that as a

member of the District's Budget Committee, he hoped with representatives from the California Employers' to revise the financial system and rely almost exclusively on spreadsheets rather than the current accounting and billing software.

looking for things that seem irregular and want to be confident that expenditures are valid and appropriate and essential for the District," LaFata said, apparently exasperated when his colleagues did not embrace his proposal.

"We should all work to do what's best for the customer and many of the activities I see don't reflect that and it's disheartening to me," he concluded and then gave his resignation letter to Jimenez.

He offered to remain on the Board "... as long as you need me," but Jimenez explained that the District could not fill a position that was not vacant. In response to a specific question, LaFata then confirmed that his resignation was effective that day.

He was unanimously appointed to the Board on Dec. 7, 2023, succeeding former director Gary Erb. At that meeting, he expressed a desire to be involved in the construction program, I'm fascinated by construction," he told the Board. "I know how things work. I'm capable of doing what's asked."

In other business, Jimenez reported that he had met March 26 at 9 a.m. to replace the March meeting.

The Board unanimously approved plans for a major renovation of the District's office building. The Planning Committee, composed of Directors Jon Brown and Robert Krieger, met with Jimenez earlier in the week and approved the proposal.

"Bob and I combed over as engineers do and peppering Vic lots of little questions about thing to make sure all bases were covered. The only real change to the plans that came out of that was adding a exit door to the new GM office. Not strictly required by fire code, but also not a bad idea to have an exit on that side of the building," Brown wrote in an email to the Town Crier.

The Board canceled its next regularly scheduled meeting for March 20 because of conflicts with directors' travel. A special meeting was approved for Wednesday,

caused the death of the firefighters.

Clough also challenges the admission of several pieces of evidence, such as the Anarchist's Cookbook, found at Oyler's home

The sudden change of judges in 2008 and the failure to change the trials venue from Riverside County to another court are examples of procedural issues which affected Oyler's right to a fair trial, Clough claims. Refusing to change the venue impaired Oyler of a fair and impartial jury because of how much news coverage and awareness of the Fire and deaths existed in the county because of its location as well as the firefighter lived locally and worked in Idyllwild.

In the conclusion of the 2016 appeal, Clough argues, "Even where no single error when examined in isolation is sufficiently prejudicial to warrant reversal, the cumulative effect of multiple errors may such that reversal is required."

Another and later issue has risen that involves Ovler's appeal. In 2018, the State legislature passed Senate Bill 1437, which amended the State's definition of murder. Its intent was to ensure that accomplices in a crime in which a murder was committed were not charged unless they were personally involved in the act of murder. Simply driving a get-away vehicle or being an outlook was not sufficient to charge them with the murder committed by another person involved in the crime.

In anticipation of the oral arguments, the Supreme Court asked both Clough and the Attorney General to address this issue. There have been several lower court decisions on this issue before this presentation.

In his Supplement Reply, Clough argues that in 2009 the jury was not instructed about the difference between being an actual killer and involvement in a crime. The State responded that Oyler ignited the Esperanza Fire which caused the death of the five firefighters. No one else was involved and, therefore, he is guilty of murder.

While the Supreme Court decision on the appeal is pending, Clough, who was appointed as Oyler's attorney for habeas corpus issues in 2016, also filed a petition of writ of habeas corpus in May 2019, which is pending at the Riverside Superior Court.

While direct appeal proceedings are limited to legal errors appearing in the trial court record, habeas corpus proceedings in California are limited to death sentences and include constitutional and statutory challenges based on facts outside the trial record, thus allowing for the possible admission of new evidence. The scope of what may be developed and presented on habeas corpus is determined by a thorough investigation of what might have been presented at trial had constitutional and statutory errors not occurred.

"Since April 2020 I have been litigating post-conviction discovery and have obtained thousands of pages of previously undisclosed documents and information including substantial files from the DOJ Riverside Lab," Clough wrote in an email to the Town Crier. "Once that process is completed, I will file an amended/supplemental habeas petition including all of the new evi-

To obtain much of the previously unreleased evidence and data collected during all of the Banning fires, Clough has requested that the Superior Court order the District Attorney or Cal Fire to release the requested information. Three times, the Judge has issued orders requiring the agencies to produce the necessary files.

The result of these steps has produced, "a virtually unprecedented amount of relevant and exculpatory previously undisclosed material," Clough wrote. Consequently, he believes the prosecution team (including Cal Fire) is still in possession of relevant and undisclosed material.

In the 2019 habeas filing, Clough attacked some of the evidence Hestrin presented as well as the lack of evidence for claiming Oyler was the single arsonist for more than 20 fires set in the Banning Pass area prior to Esperanza.

In challenging this claim, Clough prepared a decla-

geles Sheriff's Department, Arson-Explosives Detail, and a full-time criminal investigator since 1990, specializing in arson/bomb investigations since 1997.

Nordskog has written five books, three of which focused on serial arsonists. Consequently, in a written declaration filed in 2019, he opined, "After reviewing the above-mentioned items, it is my strong opinion that based solely on the analysis of the incendiary devices charged in this case, a minimum of two different serial arsonists were associated with the devices and probably more than two."

With respect to Clough's challenge that evidence of another suspect should have been allowed, Nordskag argues that his review of the ignition devices and placement suggests a firefighter may have been one of the arsonists. In fact, the Forest Service and Cal Fire were suspicious of a Forest Service employee who had past produced or submitted during the trial or its discovery charges of arson. 

# Sheriff announces he's seeking governorship

Riverside County Sheriff Chad Bianco is seeking to become the next Governor of California. At a launch party for his Republican nomination, Monday, Feb. 17, Bianco said, "I am running for Governor of our beautiful state which I absolutely love because our head is heading down the wrong track and has been for years."

Gov. Gavin Newsom has been elected twice and cannot run for re-election when his term expires in 2026.

Bianco enumerated the issues which he will address during the campaign. Blaming the current Democratic administration and legislature, Bianco listed rampant crime, higher taxes, a high cost-of-living, over regulation, tent encampments and broken home insurance

Californians have a ". . . desperate need for moral and honest government with integrity, I will be that governor," he promised. Then he described his efforts and support to obtain the passage of Proposition 36 this past November.

As a long-term law enforcement officer, crime issues will be a prominent part of his campaign.

"I will send a message, we're tired of catch and release of criminals, tired of smash and grab robberies and retail theft threatening our businesses and killing our family members," he stressed. "We are tired of billions and billions spent on homelessness with nothing to show for it except more homelessness. We're tired of lawlessness without consequences."

The last Republican to be elected governor in California was Arnold Schwarzenegger in 2006. Bianco is the first Republican to announce his entry for the Republican nomination for the 2026 gubernatorial race, although the state media has suggested that Steve Hilton, former Fox News host, would seek the nomination.

However, there are several announced Democratic candidates including Lt. Gov. Eleni Kounalakis, State Superintendent of Public Instruction Tony Thurmond, former state Senate President Pro-Tem Toni Atkins, former state Controller Betty Yee, former Los Angeles Mayor Antonio Villaraigosa and businessman and philanthropist Stephen Cloobeck.

Bianco was born in 1967 at Hill Air Force Base in Ogden, Utah, the oldest of three boys, and moved to

According to his 2022 campaign site (www.chadbi-

ancoforsheriff.com), his interest in law enforcement actually began as a teenager and he joined the Riverside County Sheriff's Department in 1993.


Bianco, 57, was elected County Sheriff in 2018, defeating the incumbent Sheriff, Stan Sniff. This was his second attempt to unseat Sniff. In 2014, he lost in the pri-

In 2018, Bianco was a Lieutenant of the Hemet Station when he ran for Sheriff and won with 58% of the votes and defeated Sniff by more than 100,000 votes.

In 2022, he easily beat his opponent with 60% of the vote in the June Primary and did not need to be on the November ballot.

"This campaign is not about the divide between Republicans and Democrats. It will be about the common goal we all have for a better California," he said ending his announcement and beginning his campaign.

California's gubernatorial primary is June 2, 2026.



crew, with Dudek reviewing the work.

Priefer asked about how the census data was compiled, and whether resident participation affects the results. Stephanie Yost asked what areas were included in the community census, and Shouman said that he believed the figures were for "Idyllwild/Pine Cove," including Fern Valley. Schelly said the next step was to "look at it more thoroughly and get it to a more accurate rendering of where the district is.'

A member of the public pointed out the importance of the sewer system to the downtown business district, and the importance of that district to areas like Mountain Center, asking about the utility of petitions and contacting elected officials. Schelly answered that the District will be reaching out to everyone with responsibility for Idyllwild, mentioning Representative Ken Calvert. He welcomed public involvement but wanted to get "a few more ducks in a row," including the completion of the engineering, before reaching out to elected officials on behalf of the district. The questioner asked about getting this message out to the community, perhaps through a district-wide email, and Schelly agreed that it could be done.

In response to more questions, Schelly said that until the possibilities for constructing a new WWTP are exhausted they would not go to what he called "Plan B," a more modest rehabilitation. "It's good, better, best. We want to do what's 'best.' If we can't afford what's 'best' then we'll do 'better.' If we can't do 'better 'we'll do 'good.' We need to have a grant to do 'best,' we can't afford to do it on our own. We can't afford to charge the customers, we can't afford to pay the interest on a loan..." Plan C, Schelly opined, would be "patch as it breaks, which is a terrible plan."

The board reviewed bids by two accounting firms for the District's annual audit, and voted to continue with their present firm, Rogers, Anderson, Malody and Scott. The Board also approved a proposal by CFO Shouman to move the District's \$3 million in retirement funds from Voya Financial to Charles Schwab. The annual public hearing on standby fees for undeveloped parcels was set for May 21. Rojas showed slides of the newly completed culvert at the Foster Lake facility and said they had performed well during recent heavy

The board members received a brief overview of Board Member and Meeting Decorum, conducted with the help of legal counsel Ryan Guiboa. State law, AB 1234, requires biannual ethics training. This overview covered identifying conflicts of interest, the Brown Act requirements for meetings, and public comment rules. Tyla Wheeler, at President Schelly's request, reported that Schelly, along with directors Steve Olson and Mitch Davis, had all completed their training.

In response to a question from the public, Schelly said that there was no update on the proposal from David Butterfield to purchase part of the District's parcel of land adjacent to the Idyllwild Brewpub, and that the matter was not on the agenda. The meeting went into closed session to consider another real estate transaction, the possible purchase of two properties, as part of the District's investment portfolio and for use as housing for staff when needed. Schelly communicated that there was no reportable action from that session. The next meeting is scheduled for March 19.



# Idyllwild's HELP Center continues to serve Idyllwild

Since 1992 Idyllwild's HELP Center has lived by a motto: "neighbors helping neighbors." Executive Director Colleen Meyer and Client Services Director Deva Taffel gave the Town Crier an update on the Center's programs. Meyer and Taffel are quick to credit and express gratitude to the many local organizations that support them in their mission. As in the very beginning, groups like the Idyllwild Board of Realtors, the Rotary Club, Soroptimists, the Idyllwild Community Fund, and churches, including the Idyllwild Bible and Idyllwild Community Churches, continue to play major roles with cash, in-kind donations and labor. Fairway Foods Market also provides year-round support.

Taffel explained the HELP Center's food distribution program. "We did 1,306 nonperishable food bags last year and purchased 720 \$25 Stater Bros or Fairway gift certificates. This gives clients access to fresh food that pairs well with the nonperishables. Last Year, Idyllwild Board of Realtors donated \$725. Rotary has donated \$1,000 in the last few years towards Fairway gift certificates. The county Office on Aging comes twice a year, June and Christmas time, and brings Stater Bros cards, so we are able to give them out to all our seniors."

"Clients can access the food pantry every week with staples that come from several sources. There is a weekly food drive at Fairway; volunteer Johnathan O'Keefe provides a shopping list at the front door, people purchase items from the list, he comes back with boxes of food. The Idyllwild Community Church gives \$400 in food staples and household goods. They just had 'Souper Bowl Sunday,' and on Monday they brought boxes of canned goods from their congregants. The Community Church also donates around \$1,000 for food gift certificates for food programs. We also have a special relationship with ICCs Town Hall Feeding America program, providing basic staples. Juan Patlan (Manager at Fairway) is awesome, Fairway matches funds. We have a food basket by the check-out for do-

When Skye Zambrana was Client Services Director, she put together food bags. When she was in an accident, the Center began letting clients pick their own bags, which had a positive outcome: "We have a lot less food waste."

Another important HELP Center program is the Medical Assistance Fund. It provides vouchers for things like gas for trips to doctors' appointments, and prescriptions, over-the-counter medication and other supplies at Idyllwild Pharmacy. There are also vouchers for vision and dental care, as well as chiropractic and acupuncture treatment. Idyllwild Health Center also accepts vouchers. The Soroptimists keep a well-stocked Women's Cabinet for personal hygiene. Everybody needs personal hygiene, and kids and adults can receive bags made by volunteer Theresa Teel. Clients can also make their own bags. "Being able to pick out what kind of things they want is powerful for a client."

With the high price of gas and electricity, many clients have difficulty with utility bills. The Center also has a Utility Assistance Program. "In the current grant year, Idyllwild Community Fund gave 50 residents \$100 each to help with electricity or propane."

Taffel expressed special pride in the Center's Firewood program, run by Mountain Community Fire Safe Council's Woodies. "Last year we provided 926 appointments for firewood. We allow people to come weekly, and encourage them to come every week, even during summer, to stock up. Kim Fryer, with MCFSC is our contact, she works with the local tree companies, like Whitney and Pino, and lets us now when a big load will come in." The firewood program also helps introduce clients to the Center. "It gets a lot of people in the door the first time."

Children's programs help with school supplies, and Target gift cards for back-to -school clothes and shoes.

wish come true. The tree is another part of Fairway Market's collaboration.

Thanksgiving gift certificates for Stater Bros or Fairway help make Holidays brighter. And there are turkeys. "Chris Stroud will call from Idyllwild Arts Academy, will give us frozen turkeys. For Christmas, they give faculty frozen turkeys, those who don't want them donate to us, usually there are 20 to 25 turkeys.'

Meyer points out that the Center focuses on improving clients' situation, not just getting them through the week. They also help clients apply for county and state aid. "We refer out to other programs, like Community Action Partnership of Riverside County, (CAP.) They do utility assistance and weatherization. That is a free program, available even for renters."

The HELP Center's Thrift store, managed by Julia Ledesma, is a frequent stop for thrifty shoppers and those trying to declutter their homes. Volunteering is easy, just ask. The store is open daily, 10:00 AM to 4:00

Meyer acknowledges that Idyllwild's isolation makes it harder for the county to deliver services here. "Our location makes it a little bit harder. We love this community so much that we will find a way. If there is a will, there is a way."

All of these programs are only available based on funding availability. "Any time of year you can donate." And donors can specify which program(s) they want to fund by adding a program name to the memo line of their check. Before making a donation of goods its best to call first and ask, "what do you need?"

The Trump administration's freezes on federal spending have introduced a new uncertainty into this year's planning. In the past, the HELP Center has received federal funding from two sources: FEMA's Emergency Food and Shelter Program, over \$17,000 last year, that



# Pacific Trio in Concert with IAA Orchestra

Within every passage of time, there is a certain space reserved for reflection as well as restitution. This is especially true in small communities -- here on the Hill, we find more than our share of small groupings with large and ever-expanding possibilities and pursuits. Some of the truth of this matter was on display this past Saturday evening, when our very own Pacific Trio used the full ambient expanse of Lowman Concert Hall in conjunction with the Idyllwild Arts Academy Chamber Orchestra to present a program that respected both artistic potential and intentions and gave the listeners both the needed meditative and restorative opportuni-

The Chamber Orchestra's rendering of the opening "Allegro moderato" movement of Johannes Brahms' "Serenade #2 in A Major, Opus 16" served as an example of how such scaled-down resources can in its own way acquire a boldness of spirit. Conductor / Artistic Director Daniel Bassin's handling of the piece with his 20 performers projected a sense of substantial clarity; far from serving as an overture of sorts, the individual players (in particular the winds) proceeded intent on a presentation of the composer's maturing style in such a way as to have that facet well understood. A reflective mood was thus expertly captured by all concerned.

As a precursor to the evening program's main attraction, and as a somewhat unexpected sonic treat, the members of the Pacific Trio -- Edith Orloff, pianist; Roger Wilkie, violinist and John Walz, cellist -- put forth their talents in a short-and-sweet "Piano Trio in C Major" by the Spanish cellist and composer Gaspar Cassado. This 3-movement work brought out resonant piano and string playing in what could be characterized as a delightful potpourri of Spanish dances and rhythms, based on themes from the varied regions of Spain and not solely dependent on flamenco-based flourishes. The audience reaction to this little-known piece was gratifying, and the 3 players took deservedly respectful bows.

Following an intermission which featured a slight change of orchestral arrangement (shifting string sections) and the installation of a platform for the solo cel-

"Triple Concerto in C Major, Opus 56". Even considering the smaller ensemble, which could have given impetus to the general perception of this work as being overshadowed by the composer's then-current projects (particularly the "Eroica" Symphony and the opera "Fidelio"), the opening movement was stated with all the capacity of a fuller orchestral complement. The subsequent entry of each of the solo instruments was positively instructive, in that Beethoven actually did write a concerto for 3 individuals, and not a Baroque-style "Concerto Grosso" or a Classical "Sinfonia Concertante". With John Walz's cello taking the lead, from the open-

list, the forces were in place for Ludwig van Beethoven's ing "Allegro" directly through to the final "Rondo alla polacca", sound production of a quality rarely heard in this work's performance was evinced, emphasizing the blending of the disparate elements of the piano, violin and cello sonorities as the composer most decidedly wished. With that accomplishment, the concert itself succeeded as a live presentation of the first order. And with the audience's approbations, this listener looks forward to Dr. Bassin's next presentation, forthcoming in mid-April for the annual Concerto Competition. One wishes all of Saturday's participants and attendees both good health and happy listening experiences in the meantime.



The fingerprints on sturdy cards were sent home for parents to file. They can be used for identification if a child should ever be abducted or lost, according to officials.






